### **SECOND SUPPLEMENTAL AGREEMENT IN RELATION TO THE MAJOR DISPOSAL OF THE ENTIRE ISSUED SHARE CAPITAL IN AND SHAREHOLDER'S LOAN INCURRED BY SUNLIGHT RISE LIMITED**

References are made to the announcements of the Company dated 30 December 2015, 29 January 2016, 29 March 2016 and 1 September 2016 (the “Announcements”) respectively in relation to, among other things, the Disposal. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

#### **THE SECOND SUPPLEMENTAL AGREEMENT**

The Board announces that, on 12 October 2016 (after trading hours), a supplemental agreement (the “Second Supplemental Agreement”) to the Sale and Purchase Agreement and the Supplemental Agreement was entered into among the Vendor, the Purchaser and the Guarantors, pursuant to which the parties to the Second Supplemental Agreement had mutually agreed in writing to extend the long stop date of the Sale and Purchase Agreement to 30 June 2017, as additional time is required for the Company to fulfill the conditions precedent under the Sale and Purchase Agreement. As at the date of this announcement, save for the passing by the Shareholders at the EGM the necessary resolutions to approve the Sale and Purchase Agreement and the transactions contemplated thereunder, all other conditions precedent under the Sale and Purchase Agreement have been fulfilled.
