The Board is pleased to announce that subsequent to the passing of the special resolution by the Shareholders at the Extraordinary General Meeting held on 13 October 2016 approving the Proposed Change of Company Name, the Certificate of Change of Name was issued by the Registrar of Companies in Hong Kong on 28 October 2016. Accordingly, the name of the Company has been changed from “REORIENT GROUP LIMITED 瑞東集團有限公司” to “Yunfeng Financial Group Limited 雲鋒金融集團有限公司”.

The change of the Company’s name will not affect any of the rights of the Shareholders. All existing share certificates of the Company in issue bearing the previous name of the Company will continue to be valid evidence of title to the Shares and will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for free exchange of the existing share certificates of the Company for new share certificates bearing the new name of the Company. With effect from 9 November 2016, new share certificates of the Company will be issued in the new name of the Company.
