POSITIVE PROFIT ALERT

This announcement is made by Billion Industrial Holdings Limited (the “**Company**” together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions of Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company and potential investors that based on the information currently available to the Company and the preliminary assessment by the Company’s management with reference to the unaudited management accounts of the Group for the eleven months ended 30 November 2016, the Group is expected to record a substantial increase of 50% or more in profit after taxation for the year ending 31 December 2016, as compared to the profit after taxation for the year ended 31 December 2015. The expected increase is primarily due to (i) the increase in the revenue of the Group mainly attributable to the completion of the entire expansion plan for the Group’s production of polyester thin films; and (ii) the recovery of the differentiated polyester filament yarn industry in the second half of year 2016.

The information contained in this announcement is only a preliminary assessment by the Company's management based on the unaudited management accounts of the Group for the eleven months ended 30 November 2016, which have not been audited or reviewed by the Company's auditors. Further details of the Group's performance will be disclosed when the annual results of the Group for the year ending 31 December 2016 are announced.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
