CHANGE OF COMPANY NAME STOCK SHORT NAME AND DEBT SECURITIES SHORT NAME

The Board is pleased to announce that with effect from 11 January 2017, the Company has changed its English name from “Yestar International Holdings Company Limited” to “Yestar Healthcare Holdings Company Limited” and changed the dual foreign name in Chinese of the Company from “巨星國際控股有限公司” to “巨星醫療控股有限公司”.

The English stock short name of the Company will be changed from “YESTAR INTL” to “YESTAR HEALTH” and its Chinese stock short name will be changed from “巨星國際控股” to “巨星醫療控股” for trading in the shares on the Stock Exchange both effect from 9:00 a.m. on 3 February 2017. The stock code of the Company remains unchanged as “2393”.

The short name for trading in Company’s US\$200 million 6.9% senior notes due 2021 senior notes (the “Notes”) on the Stock Exchange will be changed from “YESTAR IH N2109” to “YESTAR HC N2109” with effect from 9:00 a.m. on 3 February 2017. The stock code of the Notes remains unchanged as “4508”.

Reference is made to the announcement of Yestar Healthcare Holdings Company Limited (formerly known as “Yestar International Holdings Company Limited”) (the “Company”) dated 9 December 2016 and the circular of the Company dated 14 December 2016 (the “Circular”) regarding the Proposed Change of Company Name and the announcement of the Company dated 11 January 2017 in relation to the poll results of the EGM. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless the context requires otherwise.

CHANGE OF COMPANY NAME

The Board is pleased to announce that subsequent to the passing of a special resolution in relation to the Change of Company Name by the Shareholders at the EGM, the Company has changed its English name from “Yestar International Holdings Company Limited” to “Yestar Healthcare Holdings Company Limited” and to change the dual foreign name in Chinese of the Company from “巨星國際控股有限公司” to “巨星醫療控股有限公司”. The Certificate of Incorporation on Change of Name was issued on 11 January 2017 by the Registrar of Companies in the Cayman Islands.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 24 January 2017 confirming the registration of the Company’s new English and Chinese names of “Yestar Healthcare Holdings Company Limited 巨星醫療控股有限公司” in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAMES

The English stock short name of the Company will be changed from “YESTAR INTL” to “YESTAR HEALTH” and its Chinese stock short name will be changed from “巨星國際控股” to “巨星醫療控股” for trading in the shares on the Stock Exchange both effect from 9:00 a.m. on 3 February 2017. The stock code of the Company remains unchanged as “2393”.

CHANGE OF DEBT SECURITIES SHORT NAME

The short name for trading in Company’s US\$200 million 6.9% senior notes due 2021 senior notes (the “Notes”) on the Stock Exchange will be changed from “YESTAR IH N2109” to “YESTAR HC N2109” with effect from 9:00 a.m. on 3 February 2017. The stock code of the Notes remains unchanged as “4508”.

EFFECT OF THE CHANGE OF COMPANY NAME

The change of name of the Company will not affect any of the rights of the shareholders. All existing share certificates in issue bearing the current name of “Yestar International Holdings Company Limited 巨星國際控股有限公司” will continue to remain effective as evidence of title and be valid for trading, settlement and registration purposes. Accordingly, there will not be any arrangement for free exchange of existing share certificates of the Company for new share certificates bearing the new name of the Company. New share certificates of the Company will be issued under the new names of the Company with effect from 3 February 2017.
