- 向本公司或香港股份過戶登記分處提供與其各 自業務營運有關的行政、電訊、電腦、付款或 其他服務的任何代理人、承包商或第三方服務 供應商;
- 聯交所、證監會及任何其他法定監管機關或政府部門或遵照其他法例、規則或法規;及
