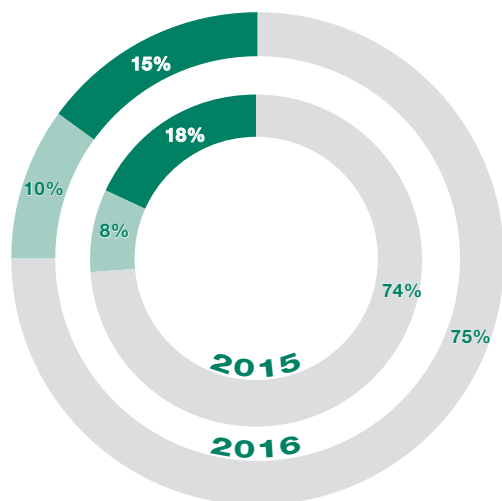

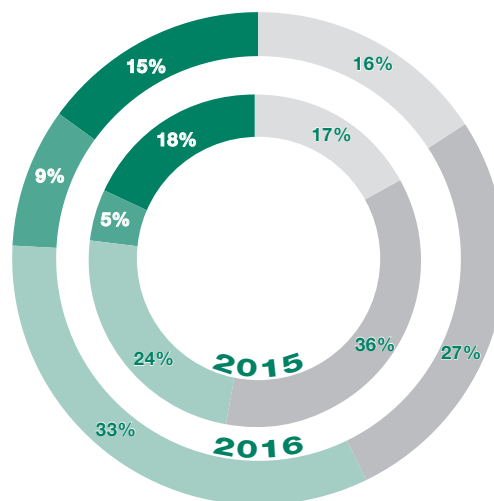

## CHAIRMAN'S STATEMENT

Dear Shareholders,

On behalf of the board (the "Board") of directors (the "Directors") of Ever Harvest Group Holdings Limited (the "Company", together with its subsidiaries collectively referred to as the "Group"), I am pleased to present our first annual report for the year ended 31 December 2016.

Since 1993, the Group has grown to become a regional shipping carrier with a strong reputation. After over 22 years in business as a private company, the Group was successfully listed on the Main Board of Stock Exchange on 6 July 2016. The initial public offering has enabled the Group to access the international capital market while reinforcing its brand awareness and market reputation endeavor to new heights.

The Group is a well-established waterborne trade and freight service providers in China and Hong Kong, provides mainly three kinds of services, namely (i) feeder shipping services, (ii) carrier owned container services, and (iii) sea freight forwarding agency services. Including our headquarters in Hong Kong, we had a total of 19 points of operation, including our branches and representative offices in Fujian Province, Guangdong Province, Guangxi Zhuang Autonomous Region and Hainan Province, as at 31 December 2016. Most of our points of operation are located in strategic transportation ports, which enable our local staff to closely communicate, strengthen relationship with our customers and understand the local market.

In 2016, the market of waterborne trade faced series of challenges. Freight rates for Asia-Europe liners hit record low levels under the impact of new shipping capacity put into market amid a weak economic growth momentum in the Eurozone. On the other hand, China's exports value and imports value in US dollars fell 7.7% and, 5.5% respectively, for the year ended 31 December 2016 as compared with the same period last year, according to the data released by the Ministry of Commerce of the People's Republic of China (the "PRC" or "China"). Keen price competition among the regional shipping carriers was resulted, especially the ports with relatively high profit margin previously.

During the year ended 31 December 2016, the Group recorded a revenue of approximately HK\$364,259,000 (for the year ended 31 December 2015: HK\$459,171,000), representing a decrease of 20.7% over the same period last year. The Group's operating profit decreased by 64.7% from HK\$46,187,000 to 16,304,000.

## 主席報告書

各位股東：

本人謹代表永豐集團控股有限公司（「本公司」，連同其附屬公司統稱「本集團」）董事（「董事」）會（「董事會」），欣然呈報本公司首份截至2016年12月31日止年度的年報。

本集團自1993年起，發展成為享負盛名的地區船運公司。經歷超過22年以私人公司方式經營業務，本集團於2016年7月6日成功在聯交所主板上市。首次公開招股讓本集團能夠進入國際資本市場，同時增強品牌知名度，並力求將市場商譽推向新高。

本集團是聲譽卓越的中港水路貿易及航運服務供應商，主要提供三種服務，分別為(i)支線船服務，(ii)承運人自有箱服務，及(iii)海上貨運代理服務。於2016年12月31日，本集團合計設有包括香港總部在內的19個營運點，包括位於福建省、廣東省、廣西壯族自治區及海南省的分公司及代表處。我們大部分營運點位於戰略性運輸港口，以便我們的當地員工與客戶緊密聯繫、鞏固客戶關係及了解當地市場。

水路貿易市場在2016年面臨多方面的挑戰。儘管歐元區經濟增長動力疲弱，惟仍有新一批航運力投入市場，致令歐亞班輪運費錄得歷史性低位。另一方面，根據中華人民共和國（「中國」）商務部發佈的數據，截至2016年12月31日止年度，中國出口貨品價值及入口貨品價值（以美元計）分別較去年同期下降7.7%及5.5%，形成地區船運公司之間激烈的價格競爭，尤其是在過往利潤相對較高的港口。

截至2016年12月31日止年度，本集團錄得收益約364,259,000港元（截至2015年12月31日止年度：459,171,000港元），較去年同期下跌20.7%。本集團的經營溢利減少64.7%，由46,187,000港元減少至16,304,000港元。

## CHAIRMAN'S STATEMENT

Looking ahead, volatility to China's economic growth, fluctuation of international fuel price, and keen price competition continue to bring uncertainties to the Group. Over our 23 years history in the waterborne trade market, we experienced several economic cycles and industry storms, and thrived to expand our shipping network by capitalising market opportunities. To broaden the customer base and diversify the operating risk, the Group is proactively seeking opportunities in new ports in the southern China. In order to maximise and safeguard shareholders' interest, the Board is reviewing the needs of acquiring new vessels and postpone the development of container depot in Pingtan Free Trade Zone. The Board is cautiously formulating our investment strategies to bring value over medium to long term for our shareholders. We believe that these forward-looking measures will consolidate our leading position of the Group and lay the way for our greater success in the future.

On behalf of the Board, I would like to thank all our staff for their dedication and contributions, and the professional services provided by the parties involved in our listing. I would also like to extend appreciation to our customers, suppliers, business associates and shareholders for their continuous support.

中國經濟增長不穩定，國際燃料價格波動以及價格競爭激烈繼續給本集團帶來不確定性。我們在水路貿易市場已有23年歷史，多番經歷經濟週期及行業風暴，成功把握市場機遇拓展我們的航運網絡。為擴展客戶基礎及分散營運風險，本集團一直積極尋求華南地區新港口的機會。為了最大限度地保護股東利益，董事會正檢討購入新船舶的需要並推遲於平潭片區發展集裝箱堆場。本集團審慎制定投資策略為股東帶來中長期價值。我們相信該等前瞻性措施將鞏固本集團的領先地位，並可引領我們在未來取得更大成就。

本人謹代表董事會感謝本集團所有員工的投入與貢獻，以及參與我們上市的各方所提供的專業服務。同時，本人亦藉此向所有客戶、供應商、業務聯繫人及股東的不斷支持致以衷心謝意。

## MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

### FINANCIAL OVERVIEW

The Group is pleased to report the results for the year ended 31 December 2016.

During the year ended 31 December 2016, the Group recorded a revenue of approximately HK\$364,259,000 (for the year ended 31 December 2015: HK\$459,171,000), representing a decrease of 20.7% over the same period last year. The Group's gross profit decreased by 14.8% from approximately HK\$82,967,000 to approximately HK\$70,680,000, while the gross profit margin slightly increased from 18.1% to 19.4%. The Group recorded government grants of approximately HK\$9,323,000 (for the year ended 31 December 2015: HK\$14,469,000), representing a decrease of 35.6% over the same period last year. Expenses in relation to the initial listing of the Shares on the Main Board of the Stock Exchange of approximately HK\$18,627,000 (for the year ended 31 December 2015: HK\$1,310,000), which was one-off in nature, also contributed to a loss for the year by approximately HK\$7,208,000 (for the year ended 31 December 2015: profit for the year of approximately HK\$39,169,000). The Group's net profit margin decreased from 8.5% to -2.0% during the year ended 31 December 2016. If the effect of the expenses in relation to the initial listing was excluded, the Group recorded a profit for the year of approximately HK\$11,419,000 (for the year ended 31 December 2015: HK\$40,479,000) and the net profit margin would be 3.1% (for the year ended 31 December 2015: 8.8%).

The Shares were listed on the Main Board of the Stock Exchange on 6 July 2016 (the "Listing Date").

### BUSINESS OVERVIEW

During the year ended 31 December 2016, the market of waterborne trade faced series of challenges. Freight rates for Asia-Europe liners hit record low levels under the impact of new shipping capacity put into market amid a weak economic growth momentum in the Eurozone. On the other hand, China's exports value and imports value in US dollars fell 7.7% and, 5.5% respectively, for the year ended 31 December 2016 as compared with the same period last year, according to the data released by Ministry of Commerce of the PRC. Keen price competition among the regional shipping carriers was resulted, especially for those ports with relatively high profit margin previously.

Impacted by the tough operational environment, the Group's feeder shipping services and carrier owned container services recorded a decrease in shipment volume of 10,296 twenty-foot equivalent units (the "TEUs") or 2.7%, from 383,226 TEUs to 372,930 TEUs, and a decrease in gross profit of approximately HK\$9,914,000 or 13.3% from HK\$74,550,000 to HK\$64,636,000, for the year ended 31 December 2016 as compared to the same period last year. Yet, the Group thrived to uphold gross profit margin of the routes ranged from 19.6% to 21.7% (for the year ended 31 December 2015: ranged from 17.2% to 20.6%). This was resulted from prompt response to market condition by switching resources to emerging ports in our existing network and effective cost control measures stated below.

### 財務回顧

本集團欣然呈報截至2016年12月31日止年度業績。

截至2016年12月31日止年度，本集團錄得收益約364,259,000港元（截至2015年12月31日止年度：459,171,000港元），較去年同期下跌20.7%。本集團的毛利由約82,967,000港元下跌14.8%至約70,680,000港元，而毛利率則由18.1%微升至19.4%。本集團錄得政府補助約9,323,000港元（截至2015年12月31日止年度：14,469,000港元），較去年同期下跌35.6%。有關股份於聯交所主板首次上市之一次性開支約為18,627,000港元（截至2015年12月31日止年度：1,310,000港元），亦造成年度虧損約7,208,000港元（截至2015年12月31日止年度：年度溢利約39,169,000港元）。截至2016年12月31日止年度，本集團的純利率由8.5%降至-2.0%。倘排除有關首次上市開支之影響，本集團錄得年度溢利約11,419,000港元（截至2015年12月31日止年度：40,479,000港元），而純利率則為3.1%（截至2015年12月31日止年度：8.8%）。

股份已於2016年7月6日（「上市日期」）在聯交所主板上市。

### 業務回顧

截至2016年12月31日止年度，水路貿易市場面臨多方面的挑戰。儘管歐元區經濟增長動力疲弱，惟仍有新一批航運力投入市場，致令歐亞班輪運費錄得歷史性低位。另一方面，根據中國商務部發佈的數據，截至2016年12月31日止年度，中國出口貨品價值及入口貨品價值（以美元計）分別較去年同期下降7.7%及5.5%。形成地區船運公司之間激烈的價格競爭，尤其是在過往利潤相對較高的港口。

受到經營環境嚴峻所影響，截至2016年12月31日止年度，本集團支線船服務及承運人自有箱服務二十呎標準箱（「標準箱」）裝運量較去年同期減少10,296個或2.7%，由383,226個標準箱減少至372,930個標準箱，而毛利則減少約9,914,000港元或13.3%，由74,550,000港元減少至64,636,000港元。即使如此，本集團成功維持航線的毛利率介乎19.6%至21.7%（截至2015年12月31日止年度：介乎17.2%至20.6%）。此乃迅速應對市況，將資源轉而投放至現有網絡中的新興港口，以及下述有效成本控制措施的成果。

In response to low levels of Asia-Europe freight rates, the Group had less effort on the sea freight forwarding agency services as low profit margin was expected. The shipment volume of such services decreased from 19,642 TEUs to 13,272 TEUs, for the year ended 31 December 2016, as compared to the same period last year.

為應對較低水平的歐亞運費，本集團投放較少資源於海上貨運代理服務，原因為預期有關業務的利潤較低。截至2016年12月31日止年度，海上貨運代理服務裝運量由去年同期的19,642個標準箱降至13,272個標準箱。

The Group's operational costs totalled HK\$293,579,000, representing a decrease of HK\$82,625,000 or 22.0% as compared with the same period last year. The change in operational costs was due to (i) lower bunker charges which were in line with the lower international fuel price in the first half of 2016; (ii) decrease in international freight rates of sea freight forwarding agency service; (iii) rearrangement of shipping routes; and (iv) reinforced effective cost control by the Company's management.

本集團的經營成本合共為293,579,000港元，較去年同期減少82,625,000港元或22.0%。經營成本變動乃由於：(i)燃料費下降，與2016年上半年國際燃油價格下降一致；(ii)海上貨運代理服務的國際運費下降；(iii)重新編排航線；及(iv)本公司管理層加強有效控制成本所致。

The Group recorded allowances for doubtful debts of approximately HK\$3,237,000 during the year ended 31 December 2016 (for the year ended 31 December 2015: HK\$Nil). It was mainly resulted from the bankruptcy of a major customer, which was an international container line company.

本集團於截至2016年12月31日止年度錄得呆賬撥備約3,237,000港元（截至2015年12月31日止年度：零港元）。主要由於一名主要客戶破產，該客戶為一家國際集裝箱運輸公司。

## 管理層討論及分析

### PROSPECTS

Volatility to China's economic growth, fluctuation of international fuel price, and keen price competition bring uncertainties to the Group. Over our 23 years history in the waterborne trade market, we experienced several economic cycles and industry storms, and thrived to expand our shipping network by capitalising market opportunities. In order to maximise and safeguard shareholders' interests, the Group has planned ahead for the upcoming challenges and set our investment strategies cautiously.

#### Extend reach of routes

The Group is headquartered in Hong Kong and has grown to become a regional shipping carrier with 19 points of operation in Hong Kong, Fujian Province, Guangdong Province, Guangxi Zhuang Autonomous Region and Hainan Province. To broaden the customer base and diversify the operating risk, the Group has been continuously exploring to extend reach of routes in new ports located in the southern China since the Listing. After our thoughtful studies, profit margins of previous targeted ports are unsatisfactory due to adverse factors appeared in the second half of 2016. The Group will continue to seek opportunities in new ports and strive to diversify source of income.

Due to uncertainties of profit margins of new routes, the Board is reviewing the needs of acquiring new vessels. Despite the flexibility of resources new vessels would bring, the Board may consider alternative ways to support the possible new routes, for example, (i) rearrangement of existing shipping routes and (ii) chartering vessels with reasonable rental cost.

#### Deepen scope of integrated port and logistics related services

On 18 August 2016, Ever Harvest Shipping Limited ("Ever Harvest"), a subsidiary of the Company, entered into a non-legally binding strategic cooperation framework agreement (the "Strategic Cooperation Framework Agreement") with Pingtan Integrated Pilot Area Management Committee. Pursuant to the Strategic Cooperation Framework Agreement, the parties agree, among other things, to combine the advantage of each of their resources and expertise, to put forward planning, preparation and implementation of the Group's regional headquarter, and to establish extensive close cooperation with a view to setting up its logistics services centre in Pingtan Free Trade Zone. The total investment amount for this project is expected to be approximately RMB60,000,000.

### 前景

中國經濟增長不穩定，國際燃料價格波動以及價格競爭激烈給本集團帶來不確定性。我們在水路貿易市場已有23年歷史，多番經歷經濟週期及行業風暴，成功把握市場機遇拓展我們的航運網絡。為了盡力提升及保障股東利益，本集團已制定計劃應對未來的挑戰並審慎制定投資策略。

#### 延展航線

本集團總部設於香港，並發展為地區船運公司，於香港、福建省、廣東省、廣西壯族自治區及海南省設有19個營運點。為擴展客戶基礎及分散營運風險，本集團自首次上市後一直持續探討延展航線所及範圍至華南地區新港口之可行性。我們經過深入研究，由於2016年下半年出現多方面不利因素，故原先目標港口的利潤並未如理想。本集團將繼續於新港口尋求機遇，致力令收入來源多元化。

由於新航線利潤率不明朗，董事會正檢討購入新船舶的需要。儘管新船舶可帶來資源的靈活性，但董事會或考慮以其他方式支持可能的航線，例如 (i) 重新編排現有航線及 (ii) 租賃租金成本合理的船舶。

#### 擴大與綜合港口及物流有關的服務範圍

於2016年8月18日，本公司之附屬公司永豐船務有限公司（「永豐」）與平潭綜合實驗區管理委員會簽署了無法律約束力之戰略合作框架協議書（「戰略合作框架協議書」）。根據戰略合作框架協議書，各方同意（其中包括）結合各自的資源和專業知識的優勢，共同推動本集團地區總部的規劃、籌備及實施，並在其於平潭保稅區（「平潭片區」）設立物流服務中心之基礎上展開廣泛深入的密切合作。預期本項目的總投資額約為人民幣60,000,000元。

Pingtan Free Trade Zone, located in Fujian Province of the PRC, is an important hub of “One Belt, One Road”. It would be a place for, among other things, imported cargoes to be stored before clearance, further use of imported cargoes in manufacturing and processing, and exhibition of the imported cargoes. It is envisaged that there would be series of encouraging government policy and tax benefits thereby attracting the establishment of various industrial enterprises.

Since the second half of 2016, cross-strait trade faced challenges and the related businesses including shipping industry of the respective regions like Pingtan Free Trade Zone slowed down. It is observed that other corporate investors suspended or postponed their investment plans. The Group considers the bankruptcy of an international container line company and keen price competition of regional shipping carriers to be adverse factors to the industry. Thus, the project in Pingtan would be postponed for the moment to safeguard interests of shareholders.

## LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE

The Group generally finances its operations with internally generated cash flow and banking facilities provided by its principal bankers in Hong Kong. As at 31 December 2016, the Group held bank balances and cash of approximately HK\$124,931,000 (31 December 2015: approximately HK\$57,416,000). The Group had interest-bearing borrowings of approximately HK\$15,367,000 at 31 December 2016 with interests ranging from approximately 2.4% to 2.5% per annum. All bank borrowings were made from banks in Hong Kong and were repayable within one year. The carrying amounts of bank borrowings were denominated in Hong Kong dollars (“HK\$”). The Group’s gearing ratio as at 31 December 2016, calculated based on the total borrowings to the equity attributable to owners of the Company, was 15.9% (31 December 2015: 4.5%). We believe that the Group’s cash holding, liquid asset value, future revenue and available banking facilities will be sufficient to fulfill the working capital requirements of the Group. There has been no material change in the capital structure of the Company during the year ended 31 December 2016. The capital of the Company comprises the Shares and other reserves.

平潭片區位於中國福建省，為「一帶一路」政策的重要樞紐。該地區將成為，其中包括，於清關前儲存進口貨物、進一步利用進口貨物進行製造及加工及進口貨物展覽之地點。預期政府將會有一系列鼓勵政策及稅收優惠，以吸引不同行業企業來此創辦業務。

自2016年下半年以來，海峽兩岸貿易面臨挑戰，包括平潭片區等各個區域的航運業相關業務放緩。據觀察，其他公司投資者暫停或推遲了彼等的投資計劃。本集團認為國際集裝箱運輸公司的破產及地區航運公司的激烈價格競爭為行業的不利因素。因此，平潭項目將會暫時推遲，以保障股東的利益。

## 資金流動性、財政資源及資本結構

本集團一般以內部產生之現金流量及其香港主要往來銀行提供的銀行融資額度撥付其營運所需資金。於2016年12月31日，本集團有銀行結餘及現金約124,931,000港元（2015年12月31日：約57,416,000港元）。本集團於2016年12月31日有計息借款約15,367,000港元，年利率介乎約2.4%至2.5%。所有銀行借款均由香港銀行提供，並須於一年內還款。銀行借款的賬面值以港元（「港元」）為單位。於2016年12月31日，本集團的資產負債比率按總借貸對本公司擁有人應佔權益比例計算為15.9%（2015年12月31日：4.5%）。我們相信，本集團所持有現金、流動資產價值、未來收益及可動用銀行融資額度將足以應付本集團的營運資金需要。截至2016年12月31日止年度，本公司的資本結構並無任何重大變動。本公司股本包括股份及其他儲備。

### Treasury policies

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the year ended 31 December 2016. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the sufficient financial resources are available in order to meet its funding requirements and commitment timely.

### Hedging and exchange rate exposure

The majority of the transactions, assets and liabilities of the Group was made in HK\$, Renminbi and US dollars. During the year ended 31 December 2016, no financial instruments were used for hedging purposes, and the Group did not commit to any financial instruments to hedge its exposure to exchange rate risk, as the expected exchange rate risk is not significant. The Directors and senior management will continue to monitor the foreign exchange exposure and will consider applicable derivatives when necessary. The Group did not have any derivatives for hedging against the foreign exchange rate risk as at 31 December 2016.

### Charge on group assets

As at 31 December 2016, bank deposits amounting to approximately HK\$796,000 (31 December 2015: approximately HK\$450,000) was pledged as security for bank facilities.

### Contingent liabilities

As at 31 December 2016, the Group had no contingent liabilities.

### Air Emissions

Air pollution has become one of the major critical problems in cities. We reckon that every company should take its responsibility to tackle this problem. To mitigate air pollution, we have been taking considerable measures to control our emissions. As a waterborne trade and freight service provider, our air emissions are mainly from the burning of gas oil from vessels.

The Group takes effective measures to minimise adverse environmental consequences during our business operation:

- We and our vessel operators prevent prolonged use of gas & oil fuel consuming systems and switch on the gas & oil fuel consuming systems only when needed.
- Fuel saving measures are in place and supported by management and monitored daily. We consider the shortest routing and maximise utilisation rate of vessels in each route as possible.
- We conduct regular maintenance and cleaning of vessels/generators/vehicles/other machinery

The impact of global climate change is a challenge that businesses and organisations around the world must face and address. The Group is committed to minimising the adverse impact that its operations may have on the environment. Using energy efficiently will help us conserve resources and tackle climate change.

The Group is fully committed to reducing emissions from our vessels by reducing fuel consumption. To reduce our carbon footprint, we have implemented the following measures:

- Vessels are inspected and repaired according to maintenance schedules in compliance with relevant laws and regulations.
- We use energy-efficient equipment and lighting devices in our offices and turn on and off only when use and after. Light zoning was established and we encourage staff to switch off its individual light before leaving for a long time.

- 我們辦公室使用符合能源效益的設備及照明器材，並只會於使用時開啟，及於使用後關閉。辦公室已劃分照明區域，我們亦鼓勵員工於長時間離開前關掉個人的照明裝置。

In this reporting year, we consumed 8,618 tonnes of gas oil and 229,177 kWh of electricity. Burning of gas oil in our vessels is our major source of Greenhouse Gases (“GHG”) emissions. The following tables show our GHG emissions and energy consumption in this reporting year.

### Waste Management and Reduction

We work diligently in reducing our waste produced from operations by sorting of waste, and to reuse materials wherever possible. The Board acknowledges its responsibility for the preparation of the financial statements which give a true and fair view of the state of affairs of the Group. The financial statements set out on pages 70 to 135 were prepared on the basis set out in Note 2 to the financial statements. Financial results of the Group are announced in a timely manner in accordance with statutory and/or regulatory requirements. The declaration of reporting responsibility issued by the external auditors of the Company on the Company's financial statements is set out in the Independent Auditors' Report on pages 61 to 69.

The Company complied with Rules 3.10(1), (2) and 3.10A of the Listing Rules throughout the period from the Listing Date and up to the date of this report. Except as disclosed in the section "Profile of Directors and Senior Management" above, there is no financial, business, family or other material or relevant relationship among members of the Board.

## CONFIRMATION OF INDEPENDENCE

Each of the independent non-executive Directors has made an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive Directors are independent in accordance with the guidelines set out in Rule 3.13 of the Listing Rules.

### CONTINUOUS PROFESSIONAL DEVELOPMENT

Continuing briefings and professional development to Directors will be arranged whenever necessary.

The Directors have attended external training and/or seminars and have read materials covering topics such as business and performance of the Company and accounting issues.

### APPOINTMENT, RE-ELECTION AND REMOVAL

Each of the independent non-executive Directors (except Mr. Kam Leung Ming) has entered into a letter of appointment with the Company for a term of three years from the Listing Date, and Mr. Kam Leung Ming has entered into a letter of appointment with the Company for a term of three years from 1 November 2016, subject to retirement by rotation and re-election at annual general meeting and until terminated by not less than three months' notice in writing served by either party on the other.

In accordance with the articles of association of the Company (the "Article of Association"), at each annual general meeting one third of the Directors for the time being shall retire from office by rotation. However, if the number of Directors is not a multiple of three, then the number nearest to but not less than one third shall be the retiring Directors. The Directors who shall retire in each year will be those who have been the longest in the office since their last re-election or appointment but as for persons who became or were last re-elected as Directors on the same day those to retire will (unless they otherwise agree among themselves) be determined by lot. Such retiring Directors may, being eligible, offer themselves for re-election at the annual general meeting. All Directors appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of shareholders after their appointment and be subject to re-election at such meeting and all Directors appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting and shall then be eligible for re-election.

## PRINCIPAL ACTIVITIES AND BUSINESS REVIEW

The principal activity of the Company is investment holding and those of the principal subsidiaries of the Company are set out in Note 12 to the Financial Statements.

Further discussion and analysis of the Group's principal activities as required by Schedule 5 to the Hong Kong Companies Ordinance, including an analysis using financial key performance indicators, a description of the principal risks and uncertainties facing the Group and an indication of likely future development in the Group's business, can be found in the Management Discussion and Analysis set out on pages 8 to 13 of this report. This discussion forms part of this directors' report.

### Environmental Policies and Performance

The Group continues to update the requirements of the relevant environmental laws and regulations applicable to it to ensure compliance. The Group strive to minimise environmental impact by saving electricity, and encouraging recycle of office supplies and other materials. We also require the vessel operators to operate in strict compliance with the relevant environmental regulations and rules.

## Opinion

## NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

Year ended 31 December 2016

### 1. GENERAL INFORMATION AND BASIS OF PREPARATION

Ever Harvest Group Holdings Limited (the “Company”) was incorporated as an exempted company with limited liability in the Cayman Islands on 15 October 2015. The Company’s immediate and ultimate holding company is Ever Winning Investment Company Limited (“Ever Winning Investment”), a company with limited liability incorporated in the British Virgin Islands (the “BVI”). The registered office of the Company is situated at PO Box 1350, Clifton House, 75 Fort Street, Grand Cayman, KY1-1108, Cayman Islands. The Company’s principal place of business is situated at 28/F., Excel Centre, 483A Castle Peak Road, Cheung Sha Wan, Kowloon, Hong Kong.

The principal activity of the Company is to act as an investment holding company. The Company together with its subsidiaries (the “Group”) are principally engaged in rendering of sea freight transportation and freight forwarding services in Hong Kong and in the People’s Republic of China (the “PRC”).

In preparing for the initial listing of the shares of the Company on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) (the “Initial Listing”), the Group underwent a group reorganisation (the “Reorganisation”) to rationalise the group structure. As a result of the Reorganisation, the Company became the holding company of the Group on 4 May 2016. Details of the Reorganisation are detailed in the section headed “History, Development and Reorganisation – Reorganisation” of the prospectus of the Company dated 23 June 2016 (the “Prospectus”).

The shares of the Company were listed on the Main Board of the Stock Exchange on 6 July 2016.

The Group resulting from the Reorganisation is regarded as a continuing entity under the common control of Mr. Lau Yu Leung (the “Ultimate Controlling Party”) prior to and after the Reorganisation, and that control is not transitory. Accordingly, the consolidated financial statements for the year ended 31 December 2016 (and the comparative information for the year ended 31 December 2015) have been prepared using the principles of merger accounting in accordance with Accounting Guideline 5 “Merger accounting under common control combination” issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”).

永豐集團控股有限公司(「本公司」)於2015年10月15日在開曼群島註冊成立為獲豁免有限公司。本公司的直接及最終控股公司為於英屬處女群島(「英屬處女群島」)註冊成立的Ever Winning Investment Company Limited(「Ever Winning Investment」)。本公司的註冊辦事處位於PO Box 1350, Clifton House, 75 Fort Street, Grand Cayman, KY1-1108, Cayman Islands。本公司的主要營業地點位於香港九龍長沙灣青山道483A號卓匯中心28樓。

本公司的主營業務為投資控股。本公司連同其附屬公司(「本集團」)的主要業務為於香港及中華人民共和國(「中國」)提供海上貨運及貨運代理服務。

為籌備本公司股份首次於香港聯合交易所有限公司(「聯交所」)主板上市(「首次上市」)，本集團已進行集團重組(「重組」)，以整頓集團架構。由於進行重組，本公司已於2016年5月4日成為本集團的控股公司。有關重組的詳情已於本公司於2016年6月23日所刊發的招股章程(「招股章程」)內「歷史、發展及重組—重組」一節詳細說明。

本公司股份已於2016年7月6日在聯交所主板上市。

重組後的本集團被視為於重組前後由劉與量先生(「最終控股方」)共同控制的持續經營實體，該項控制權為不可轉讓。據此，截至2016年12月31日止年度的綜合財務報表(及截至2015年12月31日止年度的對比資料)乃根據香港會計師公會(「香港會計師公會」)所頒佈香港會計指引第5號「共同控制的合併會計處理」所載合併會計處理原則而編製。

The consolidated income statements, the consolidated statements of comprehensive income, the consolidated statements of changes in equity and the consolidated statements of cash flows of the Group for the years ended 31 December 2016 and 2015 have been prepared on the basis as if the current group structure has been in existence throughout the relevant years, or since the respective dates of incorporation or establishment, where there is a shorter period. The consolidated statement of financial position of the Group as at 31 December 2015 has been prepared to present the assets and liabilities of the companies now comprising the Group as if the group structure has been in existence as at that date.

### 2. PRINCIPAL ACCOUNTING POLICIES

#### Statement of compliance

The consolidated financial statements have been prepared in accordance with the Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual HKFRSs, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the HKICPA and accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. The consolidated financial statements also comply with the applicable disclosure requirements under the Rules Governing the Listing of Securities on the Stock Exchange. A summary of the principal accounting policies adopted by the Group in preparing the consolidated financial statements is set out below.

本集團截至2016年及2015年12月31日止年度的綜合收益表、綜合全面收益表、綜合權益變動表及綜合現金流量表乃根據猶如目前的集團架構於相關年度一直存在的基準，或自各自註冊成立／成立日期起(以較短期間為準)而編製。本集團於2015年12月31日的綜合財務狀況表已予編製，以呈列現時組成本集團的公司的資產及負債，猶如有關集團架構於該日已存在。

### 2. 主要會計政策

#### 合規聲明

綜合財務報表已根據香港財務報告準則(「香港財務報告準則」，包括由香港會計師公會頒佈的所有適用個別香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋)、香港公認會計原則及香港公司條例的披露規定編製。綜合財務報表亦遵守聯交所證券上市規則的適用披露規定。本集團編製綜合財務報表時採用的主要會計政策概要載於下文。

#### Statement of compliance (Continued)

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the same as the functional currency of the Company, and rounded to the nearest thousands unless otherwise indicated.

The Group has consistently applied all HKFRSs which are effective for the Group's financial year beginning on 1 January 2015 for the consolidated financial statements, except for the adoption of the new / revised HKFRSs that are relevant to the Group and effective from the current year as set out below.

#### Adoption of new / revised HKFRSs

##### Amendments to HKAS 1: Disclosure Initiative

The amendments include changes in the following five areas: 1) materiality; 2) disaggregation and subtotals; 3) structure of notes; 4) disclosure of accounting policies; 5) presentation of items of other comprehensive income arising from investments accounted for using equity method. It is considered that these amendments are clarifying amendments that do not directly affect an entity's accounting policies or accounting estimates.

The adoption of the amendments did not have any significant impact on the consolidated financial statements.

##### Amendments to HKAS 16 and 38: Clarification of Acceptable Methods of Depreciation and Amortisation

HKAS 16 and HKAS 38 both establish the principle for the basis of depreciation and amortisation as being the expected pattern of consumption of the future economic benefits of an asset. The amendments to HKAS 16 clarify that the use of revenue-based methods to calculate the depreciation of an asset is not appropriate because revenue generated by an activity that includes the use of an asset generally reflects factors other than the consumption of the economic benefits embodied in the asset.

The amendments to HKAS 38 clarify that revenue is generally presumed to be an inappropriate basis for measuring the consumption of the economic benefits embodied in an intangible asset. This presumption, however, can be rebutted in certain limited circumstances.

The adoption of the amendments did not have any significant impact on the consolidated financial statements.

綜合財務報表乃以本公司的功能貨幣港元(「港元」)呈列，除非另有指明，已約整至最接近千位數。

除採用下文所述與本集團相關且於本年度起生效的新訂／經修訂香港財務報告準則外，本集團之綜合財務報表已貫徹採用對本集團自2015年1月1日開始的財政年度生效之所有香港財務報告準則。

#### 採用新訂／經修訂香港財務報告準則

##### 香港會計準則第1號的修訂：披露計劃

修訂包括以下五個範圍的變更：1) 重要性；2) 不合計與小計；3) 附註結構；4) 會計政策披露；5) 使用權益法為投資入賬所產生的其他全面收入項目列報。該等修訂被視為屬澄清修訂，不會直接影響實體的會計政策或會計估計。

採用修訂概無對綜合財務報表造成任何重大影響。

##### 香港會計準則第16號及香港會計準則第38號的修訂：澄清可接受的折舊及攤銷方法

香港會計準則第16號及香港會計準則第38號同時確立折舊及攤銷基準之原則為某項資產未來經濟利益的預期消耗模式。香港會計準則第16號的修訂釐清使用以收益為基準之方法計算資產折舊並不恰當，因為包括使用某項資產的某項活動產生之收益一般反映消耗該資產內含經濟利益以外的因素。

香港會計準則第38號的修訂釐清收益一般被假定為計量消耗無形資產內含經濟利益之不當基準。然而，這種假定可在若干有限情況下遭駁回。

採納修訂概無對綜合財務報表造成任何重大影響。

#### Basis of measurement

The measurement basis used in the preparation of these consolidated financial statements is historical cost, except for financial assets at fair value through profit or loss, which are measured at fair value as explained in the accounting policy as set out below.

#### Basis of consolidation / combinations

The consolidated financial statements comprise the financial statements of the Company and all of its subsidiaries. The financial statements of the subsidiaries are prepared for the same reporting year as that of the Company using consistent accounting policies.

All intra-group balance, transactions, income and expenses and profits and losses resulting from intra-group transactions are eliminated in full. Unrealised losses are also eliminated unless the transactions provide evidence of an impairment of the asset transferred.

#### 1) *Business combinations not under common control*

The Group applies the acquisition method to account for business combinations not under common control. The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred to the former owners of the acquiree and the equity interest issued by the Group, as appropriate. The consideration transferred also includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination not under common control is measured initially at their fair values at the acquisition date.

#### 計量基準

除下文會計政策所解釋按公平值計量的按公平值計入損益的財務資產外，編製綜合財務報表乃以歷史成本為計量基準。

#### 綜合／合併基準

綜合財務報表包括本公司及其所有附屬公司的財務報表。附屬公司的財務報表乃按與本公司相同的報告期間使用一致的會計政策編製。

集團內公司間的交易所產生的所有集團內公司間結餘、交易、收入及開支及盈虧均全數抵銷。未變現虧損亦會對銷，除非有證據顯示交易所轉讓的資產出現減值。

#### 1) *並非受共同控制的業務合併*

本集團應用收購法將並非受共同控制的業務合併入賬。就收購一間附屬公司所載讓的代價即所轉讓資產、對被收購方前擁有人所承擔的負債及本集團所發行的股本權益(視何者適用)的公平值。所轉讓的代價亦包括或然代價安排所產生的任何資產或負債的公平值。於並非受共同控制的業務合併中所收購的可識別資產及所承擔的或然負債，初步按於收購日期的公平值計量。

Acquisition-related costs are expensed as incurred.

Non-controlling interests are presented, separately from equity holders of the Company, in the consolidated statement of comprehensive income and within equity in the consolidated statement of financial position. The non-controlling interests in the acquiree, that are present ownership interests and entitle their holders to a proportionate share of the acquiree's net assets in event of liquidation, are measured initially either at fair value or at the present ownership instruments' proportionate share in the recognised amounts of the acquiree's identifiable net assets. This choice of measurement basis is made on an acquisition-by-acquisition basis. Other types of non-controlling interests are initially measured at fair value, unless another measurement basis is required by HKFRSs.

##### *Allocation of total comprehensive income*

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income is attributed to the owners of the Company and the non-controlling interest even if this results in the non-controlling interest having a deficit balance.

The results of subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date that such control ceases.

與收購相關的成本於產生時支銷。

非控股權益於綜合全面收益表內的本公司權益持有人及綜合財務狀況表內的股權分開呈列。於被收購方的非控股權益(為現有擁有人權益,並賦予持有人權利可於清盤時按比例分佔被收購方資產淨值),初步按公平值或按現有擁有權文據於被收購方可識別資產淨值的已確認金額中所佔的比例計量。計量基準會因應不同收購事項作出選擇。除非香港財務報告準則規定採用其他計量基準,否則其他類別之非控股權益初步以公平值計量。

##### *分配全部全面收益*

損益及其他全面收入各組成部分均歸於本公司擁有人以及非控股權益。全面收入總額歸於本公司擁有人以及非控股權益,即使此舉會導致非控股權益出現虧絀。

附屬公司的業績由本集團取得控股權之日起合併,並將繼續合併直至失去有關控制權當日止。

###### Changes in ownership interest

Changes in the Group's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

##### 2) Merger accounting for common control combinations

The net assets of the combining entities or businesses are combined using the existing carrying values from the Ultimate Controlling Party's perspective. No amount is recognised as consideration for goodwill or excess of acquirer's interest in the net fair value of acquiree's identifiable assets, liabilities and contingent liabilities over cost at the time of common control combination, to the extent of the contribution of the Ultimate Controlling Party's interest. All differences between the cost of acquisition (fair value of consideration paid) and the amounts at which the assets and liabilities are recorded have been recognised directly in equity as part of the capital reserve. The consolidated financial statements include the results of each of the combining entities or businesses from the date of incorporation / establishment or since the date when the combining entities or businesses first came under the common control, where this is a shorter period, regardless of the date of the common control combination.

Transaction costs, including professional fees, registration fees, costs of furnishing information to shareholders, costs or losses incurred in combining operations of the previously separate businesses, etc., incurred in relation to the common control combination that is to be accounted for by using merger accounting, are recognised as an expense in the period in which they are incurred.

###### 擁有權權益變動

並無導致本集團失去對一間附屬公司控制權的擁有權權益變動，乃作為權益交易入賬。控股權益與非控股權益的賬面金額會作出調整，以反映彼等於附屬公司相關權益的變動。非控股權益的調整金額與已付或已收代價公平值兩者間的任何差額，直接於權益確認並歸屬於本公司擁有人。

##### 2) 共同控制合併的合併會計處理

合併實體或業務的資產淨值以最終控股方角度的現有賬面值合併。在最終控股方注入權益的情況下，概不會確認任何金額作為商譽或收購方於被收購方可識別資產、負債及或然負債於共同控制合併之時之公平值淨值所佔權益超出成本之部分之代價。收購成本(已付代價的公平值)與資產及負債入賬金額間的差額直接於權益中確認為資本儲備的一部分。綜合財務報表包括各合併實體或業務由註冊成立／成立之日起或自合併實體或業務首次受共同控制當日起(以較短期間為準)的業績，而毋須理會共同控制合併的日期。

就共同控制合併所產生將以合併會計法入賬的交易成本(包括專業費用、登記費用、向股東發送資料的成本、合併經營先前的獨立業務所產生的成本或虧損)，乃於產生的期間內確認為開支。

#### Subsidiaries

A subsidiary is an entity that is controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group reassesses whether it controls an investee if facts and circumstances indicate that there are changes to one or more of the elements of control.

In the Company's statement of financial position which is presented in Note 30 to the consolidated financial statements, an investment in a subsidiary is stated at cost less impairment loss. The carrying amount of the investment is reduced to its recoverable amount on an individual basis, if it is higher than the recoverable amount. The results of subsidiaries are accounted for by the Company on the dividends received and / or receivable.

#### Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Repairs and maintenance are charged to the profit or loss during the period in which they are incurred.

As the Group's lease payments for its leasehold land and buildings cannot be allocated reliably between the land and buildings elements at the inception of the lease because similar land and buildings are not sold or leased separately, the entire lease payments are included in the cost of the leasehold land and buildings as a finance lease in property, plant and equipment.

#### 附屬公司

附屬公司指受本集團控制的實體。倘本集團就參與實體業務所得可變動回報承擔風險或享有權利，並能透過其於該實體之權力影響該等回報，則本集團對該實體有控制權。如有事實及情況顯示一項或多項控制權要素出現變化，則本集團會重新評估其對被投資者之控制權。

於本公司財務狀況表(綜合財務報表附註30)內，對附屬公司的投資按成本減減值損失列示。倘投資的賬面值高於可收回金額，投資的賬面值減至個別可收回金額。附屬公司的業績列入本公司已收及／或應收股息。

#### 物業、廠房及設備

物業、廠房及設備按成本減累計折舊及累計減值虧損入賬。物業、廠房及設備項目的成本包括其購買價及任何使資產達致其使用狀態及現存地點作預定用途所產生的直接應佔成本。維修及保養開支乃於其產生的期間內於損益中支銷。

由於本集團就其租賃土地及樓宇的租賃付款因相似的土地及樓宇並無分開出售或租賃而無法在租賃開始時於土地及樓宇部分之間可靠地作出分配，故整筆租賃付款均作為物業、廠房及設備的融資租賃計入租賃土地及樓宇的成本中。

Where parts of an item of property, plant and equipment have different useful lives, the cost of the item is allocated on a reasonable basis and depreciated separately:

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the item) is included in profit or loss in the period in which the item is derecognised.

#### Financial instruments

##### Recognition and derecognition

Financial assets and financial liabilities are recognised when and only when the Group becomes a party to the contractual provisions of the instruments and on a trade date basis.

A financial asset is derecognised when and only when (i) the Group's contractual rights to future cash flows from the financial asset expire or (ii) the Group transfers the financial asset and either (a) it transfers substantially all the risks and rewards of ownership of the financial asset, or (b) it neither transfers nor retains substantially all the risks and rewards of ownership of the financial asset but it does not retain control of the financial asset.

##### 確認及取消確認

財務資產及財務負債乃當及僅當本集團成為工具合約條文的訂約方時按交易日基準確認。

財務資產於且僅於以下情況時取消確認：(i)本集團對財務資產產生的未來現金流的合約權利屆滿時；或(ii)本集團轉讓財務資產及(a)本集團已轉移財務資產擁有權的絕大部分風險及回報；或(b)本集團既無轉移亦無保留該項財務資產擁有權的絕大部分風險及回報，但並無保留該項財務資產之控制權時。

A financial liability is derecognised when and only when the liability is extinguished, that is, when the obligation specified in the relevant contract is discharged, cancelled or expires.

##### Classification and measurement

Financial assets and financial liabilities are initially recognised at their fair value plus, in the case of financial assets or financial liabilities not carried at fair value through profit or loss, transaction costs that are directly attributable to the acquisition or issue of the financial assets or financial liabilities.

#### 1) Loans and receivables

Loans and receivables including trade and other receivables, pledged bank deposits and bank balances and cash are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are not held for trading. They are measured at amortised cost using the effective interest method, except where receivables are interest-free loans and without any fixed repayment term or the effect of discounting would be insignificant. In such case, the receivables are stated at cost less impairment loss. Amortised cost is calculated by taking into account any discount or premium on acquisition over the period to maturity. Gains and losses arising from derecognition, impairment or through the amortisation process are recognised in profit or loss.

#### 2) Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss include financial assets held for trading. They are carried at fair value, with any resultant gain and loss recognised in profit or loss, which includes any dividend or interest earned on the financial assets.

財務資產或財務負債初步按公平值計量，而倘財務資產或財務負債並非按公平值計入損益，則加上收購或發行財務資產或財務負債直接應佔的交易成本。

#### 1) 貸款及應收款項

貸款及應收款項(包括貿易及其他應收款項、已質押銀行存款及銀行結餘及現金)為具有固定或可確定付款額、在活躍市場中並無報價，且並非持作買賣的非衍生財務資產。該等資產使用實際利率方法按攤銷成本計量，惟倘應收款項為免息貸款及無固定還款期或其貼現影響並不重大則除外。在此情況下，應收款項按成本扣除減值虧損入賬。攤銷成本經考慮於到期前的期間內收購的任何折讓或溢價計算。因取消確認、減值或於攤銷過程中產生的收益及虧損會於損益中確認。

#### 2) 按公平值計入損益的財務資產

按公平值計入損益的財務資產包括持作買賣的財務資產。其按公平值計量，因而產生的損益(包括就財務資產賺取的股息或利息)於損益中確認。

#### 2) *Financial assets at fair value through profit or loss (Continued)*

Financial assets are classified as held for trading if they are (i) acquired principally for the purpose of selling or repurchasing in the near future; (ii) part of a portfolio of identified financial instruments that the Group manages together and has a recent actual pattern of short-term profit-taking; or (iii) derivatives that are not financial guarantee contracts or not designated and effective hedging instruments.

#### 3) *Financial liabilities*

The Group's financial liabilities include trade and other payables, interest-bearing borrowings and obligations under finance leases. All financial liabilities, except for financial liabilities at fair value through profit or loss, are recognised initially at their fair value and subsequently measured at amortised cost, using effective interest method, unless the effect of discounting would be insignificant, in which case they are stated at cost.

#### 4) *Financial guarantee contracts*

A financial guarantee contract is a contract that requires the issuer of the contract to make specified payments to reimburse the holder of the contract for a loss the holder incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument. Financial guarantee contract is initially recognised as deferred income within trade and other payables at fair value (being the transaction price, unless the fair value can otherwise be reliably estimated.) #### 2) 按公平值計入損益的財務資產(續)

倘財務資產乃(i)主要為於可見將來出售或購回而購入；(ii)本集團集體管理的可識別財務工具組合的一部分，且近期有實質的短期獲利模式；或(iii)並非為財務擔保合約或指定為有效對沖工具的衍生工具，則會分類為持作買賣。

#### 3) 財務負債

##### *Impairment of financial assets*

At the end of each reporting period, the Group assesses whether there is objective evidence that financial assets, other than those at fair value through profit or loss, are impaired. The impairment loss of financial assets carried at amortised cost is measured as the difference between the assets' carrying amount and the present value of estimated future cash flow discounted at the financial asset's original effective interest rate. Such impairment loss is reversed in subsequent periods through profit or loss when an increase in the asset's recoverable amount can be related objectively to an event occurring after the impairment was recognised, subject to a restriction that the carrying amount of the asset at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

#### Cash equivalents

For the purpose of the consolidated statements of cash flows, cash equivalents represent short-term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

At the end of each reporting period, the Group reviews internal and external sources of information to determine whether there is any indication that its property, plant and equipment may be impaired or impairment loss previously recognised no longer exists or may be reduced. If any such indication exists, the recoverable amount of the asset is estimated, based on the higher of its fair value less costs of disposal and value in use. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the smallest group of assets that generates cash flows independently (i.e. cash-generating unit).

If the recoverable amount of an asset or a cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount. Impairment losses are recognised as an expense in profit or loss immediately.

A reversal of impairment loss is limited to the carrying amount of the asset or cash-generating unit that would have been determined had no impairment loss been recognised in prior periods. Reversal of impairment loss is recognised as income in profit or loss immediately.

#### Foreign currency translation

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency").

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at period-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss.

The results and financial position of all the group entities that have a functional currency different from the presentation currency ("foreign operations") are translated into the presentation currency as follows:

- assets and liabilities for each statement of financial position presented, are translated at the closing rate at the end of each reporting period;
- income and expenses for each statement of comprehensive income are translated at average exchange rate;
- all resulting exchange differences arising from the above translation and exchange differences arising from a monetary item that forms part of the Group's net investment in a foreign operation are recognised as a separate component of equity;
- on the disposal of a foreign operation, which includes a disposal of the Group's entire interest in a foreign operation and a disposal involving the loss of control over a subsidiary that includes a foreign operation, the cumulative amount of the exchange differences relating to the foreign operation that is recognised in other comprehensive income and accumulated in the separate component of equity is reclassified from equity to profit or loss when the gain or loss on disposal is recognised;

- from the rendering of sea freight forwarding agency services, when the agency services are rendered.

#### Leases

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

#### As lessee

Assets held under finance leases are recognised as assets of the Group at the lower of the fair value of the leased assets and the present value of the minimum lease payments. The corresponding liability to the lessor is included in the consolidated statement of financial position as finance lease obligation. Finance charges, which represent the difference between the total leasing commitments and the fair value of the assets acquired, are charged to profit or loss over the term of the relevant lease so as to produce a constant periodic rate of charge on the remaining balance of the obligations for each accounting period.

Rentals payable under operating leases are charged to profit or loss on a straight-line basis over the term of the relevant lease.

#### Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income over the years necessary to match the grant on a systematic basis to the costs that it is intended to compensate.

Government grants received by the Group mainly represented incentive grants from the relevant authorities in the PRC in respect of the provision of sea freight transportation and freight forwarding services in specific provinces in the PRC with no future service or other conditions attached. They are recognised as income in profit or loss when they are approved by and the cash for the grants are received from the relevant authorities.

#### 租賃

租賃條款將擁有權大絕大部分風險及回報轉讓予承租人的租賃，均分類為融資租賃。所有其他租賃均分類為經營租賃。

#### 作為承租人

根據融資租賃持有的資產按租賃資產的公平值及最低租賃付款的現值(以較低者為準)確認為本集團的資產。對出租人的相關責任作為融資租賃責任計入合併財務狀況表。融資費用為租賃承擔總額與所收購資產公平值之間的差額，乃於相關租賃年期內於損益中扣除，藉以令各會計期間的責任餘額的期間費率一致。

根據經營租賃的應付租金於相關租賃年期內以直線法在損益中入賬。

#### 政府補助

政府補助於能合理確定將收到補助，且所有附帶條件將獲遵守的情況下按公平值確認。倘補助與開支項目相關，有關補助於需要系統地將補助與其擬補倘的成本配對的期間內確認為收入。

本集團所獲得的政府補助主要為中國相關機關就於中國指定省份提供海上貨運及貨運代理服務所給予的獎勵性補助，並無附帶未來服務或其他條件。有關補助於取得相關機關的批准及收到補助的現金時，於損益中確認為收入。

#### Employee benefits

##### *Short term employee benefits*

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the period in which the associated services are rendered by employees.

##### *Defined contribution plans*

The obligations for contributions to defined contribution retirement scheme are recognised as an expense in profit or loss as incurred. The assets of the scheme are held separately from those of the Group in an independently administered fund.

In accordance with the rules and regulations in the PRC, the employees of the Group's entities established in the PRC are required to participate in defined contribution retirement plans organised by local governments. Contributions to these plans are expensed in profit or loss as incurred and other than these monthly contributions, the Group has no further obligation for the payment of retirement benefits to its employees.

##### *Long service payments*

The Group's net obligation in respect of long service payments under the Hong Kong Employment Ordinance is the amounts of future benefit that employees have earned in return for their services in the current and prior periods. The obligation is calculated using the projected unit credit method and discounted to its present value and after deducting the fair value of any related assets, including those retirement scheme benefits.

#### 僱員福利

##### *短期僱員福利*

薪金、年度花紅、有薪年假、定額供款退休計劃的供款及非現金福利成本乃於僱員提供相關服務的期間累計。

##### *定額供款計劃*

向定額供款計劃作出供款的責任在產生時於損益內確認為開支。計劃資產與本集團的資產分開，由獨立管理的基金持有。

根據中國規則及規例，本集團於中國成立的實體的僱員需要參與由地方政府設立的定額供款退休計劃。向該等計劃作出的供款在產生時於損益內支銷，而除該等每月供款外，本集團再無為僱員退休福利付款的其他責任。

##### *長期服務金*

本集團根據香港僱傭條例就長期服務金的責任淨額，為僱員於本期間及過往期間就提供服務所賺取的未來福利金額。有關責任乃使用預測單位信貸法計算，並貼現至其現值及已扣除任何相關資產(包括該等退休計劃福利)的公平值。

#### Taxation

The charge for current income tax is based on the results for the period as adjusted for items that are non-assessable or disallowed. It is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is provided, using the liability method, on all temporary differences at the end of each reporting period between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, any deferred tax arising from initial recognition of goodwill; or other asset or liability in a transaction other than a business combination that at the time of the transaction affects neither the accounting profit nor taxable profit or loss is not recognised.

The deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is recovered or the liability is settled, based on tax rates and tax laws that have been enacted or substantively enacted at the end of each reporting period.

Deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences, tax losses and credits can be utilised.

Deferred tax is provided on temporary differences arising on investment in subsidiaries, except where the timing of the reversal of the temporary differences is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

即期所得稅支出乃根據本期間的業績計算，並就毋須課稅或不可扣減項目作出調整。計算時所使用的稅率為於各報告期末已頒行或實際上已頒行的稅率。

Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

#### Critical accounting estimates and judgements

Estimates and assumptions concerning the future and judgements are made by the management in the preparation of the consolidated financial statements. They affect the application of the Group's accounting policies, reported amounts of assets, liabilities, income and expenses, and disclosures made. They are assessed on an on-going basis and are based on experience and relevant factors, including expectations of future events that are believed to be reasonable under the circumstances. Where appropriate, revisions to accounting estimates are recognised in the period of revision and future periods, in case the revision also affects future periods.

#### (a) Critical judgements made in applying accounting policies

The Group has entered into usage priority agreements for the preferential use on four vessels with the legal owners of each vessel (the "Usage Priority Agreements"). According to the Usage Priority Agreements, the legal owners and the Group mutually agreed the following key terms:

- the Group has the exclusive preferential right to use these four vessels;
- the Group has the preferential right to acquire the interest or obtain the sales proceeds of disposal (pre-approval by the Group in advance) of these four vessels; and
- any transfer, leasing, write-off or pledge of these four vessels have to be approved by the Group in advance.

In accordance with HKAS 16 "Property, Plant and Equipment" ("HKAS 16"), the cost of an item of property, plant and equipment shall be recognised as an asset if it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably.

The Group can demonstrate the disposal, transfer, leasing, write-off or pledge of these four vessels have to be pre-approved by the Group. In addition, the Group can obtain future economic benefits associated with these four vessels by exercising the exclusive preferential right to use these four vessels to provide logistic services to the customers and obtain the sales proceeds on disposal of these four vessels. Therefore, the management of the Group considered that the future economic benefits associated from the exclusive preferential use of these four vessels are expected to flow to the Group. Accordingly, the aggregate net carrying amount of these four vessels of approximately HK\$7,512,000 (2015: HK\$8,972,000) was recorded under property, plant and equipment.

In accordance with HKAS 38 "Intangible Assets" ("HKAS 38"), some intangible assets may be contained in or on a physical substance. In determining whether an asset that incorporates both intangible and tangible elements should be treated under HKAS 16 or as an intangible asset under HKAS 38, the entity uses judgement to assess which element is more significant.

The management of the Group, based on the terms set out in the Usage Priority Agreements and the actual usage of these four vessels, considered that in substance the Group is able to use these four vessels and obtain the future economic benefits through the usage of these four vessels physically as if it was the legal owners throughout the period covered by the Usage Priority Agreements. Accordingly, these four vessels are recorded by the Group as property, plant and equipment under HKAS 16.

(i) *Useful lives of property, plant and equipment*

The management determines the estimated useful lives of the Group's property, plant and equipment based on the historical experience of the actual useful lives of the relevant assets of similar nature and functions. The estimated useful lives could be different as a result of technical innovations which could affect the related depreciation charges included in profit or loss.

(ii) *Impairment of property, plant and equipment*

The management determines whether the Group's property, plant and equipment are impaired when an indication of impairment exists. This requires an estimation of the recoverable amount of the property, plant and equipment, which is equal to the higher of fair value less costs to sell or the value in use. Estimating the value in use requires the management to make an estimate of the expected future cash flows from the property, plant and equipment and also to choose a suitable discount rate in order to calculate the present value of those cash flows. Any impairment will be charged to profit or loss.

(iii) *Allowance for bad and doubtful debts*

The provisioning policy for bad and doubtful debts of the Group is based on the evaluation by management of the collectability of the trade and other receivables. A considerable amount of judgement is required in assessing the ultimate realisation of these receivables, including assessing the current creditworthiness and the past collection history of each debtors. If the financial conditions of these debtors were to deteriorate, resulting in an impairment of their ability to make payments, allowance will be required.

The Group is subject to income taxes in several jurisdictions. Significant estimates are required in determining the provision for income taxes. There are transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business, where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impair the income tax and deferred tax provision in the period in which such determination is made.

In subsequent measurement, depreciation (and, if applicable, impairment loss) and interest will be recognised on the right-of-use assets and the lease liabilities respectively, of which the amount in total for each reporting period is not expected to be significantly different from the periodic operating lease expenses recognised under HKAS 17. According to the Usage Priority Agreements, the Group has the exclusive preferential right to use these four vessels and to acquire the interest and to obtain the sales proceeds of disposal, which has to be approved by the Group in advance, of these four vessels. The Group considers that it, in substance, is able to use these four vessels and obtain the future economic benefits through the usage of these four vessels physically as if it was the legal owners throughout the period covered by the Usage Priority Agreements. Accordingly, the aggregate net carrying amount of approximately HK\$7,512,000 (2015: HK\$8,972,000) was recorded under property, plant and equipment. The sensitivity analysis has been determined assuming that the changes in foreign exchange rates had occurred at the end of the reporting period and had been applied to Group's exposure to currency risk for financial instruments in existence at that date, and that all other variables, in particular interest rates, remain constant.

The stated changes represent management's assessment of reasonably possible changes in foreign exchange rates over the year until the end of the next reporting period.

In the opinion of the management, the sensitivity analysis is unrepresentative of the inherent foreign exchange risk because the exposure at the end of the reporting period does not reflect the exposure during the reporting period.

#### Credit risk

Credit risk refers to the risk that debtors will default on their obligations to repay the amounts due to the Group, resulting in a loss to the Group. The Group's credit risk is mainly attributable to trade and other receivables, pledged bank deposits and bank balances and cash. The Group limits its exposure to credit risk by selecting the counterparties with reference to their past credit history and / or market reputation. The Group's maximum exposure to the credit risk is summarised as follows:

The Group trades with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures.

The management considers the credit risk in respect of pledged bank deposits and bank balances and cash is minimal because the counter-parties are authorised financial institutions with high credit ratings.

The management limits the Group's exposure to credit risk by taking timely actions once there is any indication for recoverability problem of each individual debtor.

The management also reviews the recoverable amount of each individual debtor, including related and third parties, at the end of each reporting period to ensure adequate allowance are made for irrecoverable amount.

At 31 December 2016, the Group had a concentration of credit risk as approximately 26% (2015: 23%) of the total trade receivables was due from the Group's largest customer, and approximately 50% (2015: 43%) of the total trade receivables was due from the Group's five largest customers.

Except for the pledged bank deposits, none of the Group's financial assets are pledged.
