Chairman's Statement

主席報告

Dear Shareholders.

On behalf of the board ("the Board") of directors ("the Directors") of the Company, I am pleased to present you the results of the Company and its subsidiaries ("the Group") for the year ended 31 December 2016 ("the Year").

FINANCIAL PERFORMANCE

During the Year, the revenue of the Group amounted to RMB442 million, representing a 31% decrease as compared with the year ended 31 December 2015. Loss attributable to shareholders during the Year amounted to RMB22.3 million, which was a result of the macro-economic downturn and a significant decrease of revenue of the Group together with an increased production cost. The Board recommended not to declare any dividend for the Year.

BUSINESS PERFORMANCE

The world shows a diverse but challenging economic picture during the Year. Europe has maintained continuous growth in the property market and the economy. The property market of United States of America ("the US") remained steady. As for China, confronting the downward pressure on its economy, slowdown in market demand resulting the trading of timber and sales in the PRC decreased significantly. During the Year, the Group's revenue from the Europe market has a rapid growth of 45% to RMB44.0 million attributed to the solid sales of the leisure household products in the Europe, while the revenue from the Chinese market decreased sharply by 70.5% to RMB88.0 million. This was mainly attributable to the economic slowdown in China. The North America market was relatively stable and revenue slightly decreased 5.5% to RMB273.8 million. The Group successfully develop new business in Australia. The revenue from the Australia market is RMB20.3 million.

On 2 June 2016, the Company changed the English name of the Company from "Merry Garden Holdings Limited" to "China Environmental Technology and Bioenergy Holdings Limited" and the Chinese name of the Company from "美麗家園控股有限公司" to "中科生物控股有限公司". In consideration of the best interests of the Company and the Shareholders as a whole, the Company believes that the change of company name will better reflect the Group's business development, its leading technology in the industry and its dedication to the expansion of the environmentally friendly and renewable bioenergy field.

各位股東:

本人謹代表本公司董事(「董事」)會(「董事會」), 向各股東提呈本公司及其附屬公司(「本集團」)截 至二零一六年十二月三十一日止年度(「本年度」) 的業績。

財務表現

於本年度,本集團的收入為人民幣442百萬元,較截至二零一五年十二月三十一日止年度下降31%。本年度股東應佔虧損為人民幣22.3百萬元,乃由於宏觀經濟放緩及本集團收入大幅下跌以及生產成本增加所致。董事會建議不就本年度宣派任何股息。

業務表現

本年度各國經濟表現不一,但經濟狀況仍面臨挑戰。歐洲房地產市場及經濟持續增長。美利堅合眾國(「美國」)的房地產市場維持穩定。就中國而言,其經濟面臨下行壓力,市場需求放緩導致國內木材貿易和銷售大幅減少。本年度,受惠於洲休閒家居用品的強勁銷售,本集團歐洲市場的收入迅速增長45%至人民幣44.0百萬元。但中國市場收入急劇減少70.5%至人民幣88.0百萬元,該下降主要受中國經濟增長放緩所影響。北美市場相對穩定,收入略為下降5.5%至人民幣273.8百萬元。同時,本集團成功在澳洲發展業務,澳洲市場收入為人民幣20.3百萬元。

於二零一六年六月二日,本公司將其英文名稱由「Merry Garden Holdings Limited」更改為「China Environmental Technology and Bioenergy Holdings Limited」以及將本公司的中文名稱由「美麗家園控股有限公司」更改為「中科生物控股有限公司」。經考慮本公司及股東的整體最佳利益,本公司相信更改公司名稱將可更好地反映本集團之業務發展、其行業領先技術及其在環保及可再生生物能源領域的擴張努力。

As "Merry Garden" is still the major trade name in the Group, the Group keeps the logo and website address unchanged.

PROSPECTS

The pace of interest rates rise remained slow in 2016. However, the market generally expects that the interest rate rises relatively faster in 2017 than that in 2016 and 2015, this may imply that the US economy is more stable than the previous years and higher interest rates and higher inflation typically cool demand in the housing sector. The China's economy seems to have a sign of stable, hoping that the demand will gradually recover in China and greater demand for the Group's products in the Asia-Pacific region will be seen. The Group will endeavor to capture all opportunities presented by the emerging markets.

During the Year, the Group successfully developed new business in sales of timber houses and their related parts and structure and trading of timber in new geographical areas such as Australia and Korea. This could help the Company to develop a more diversified customer base. The Group will continue to seek for new business opportunity.

Meanwhile, standing on the well establishment of the Group's selfowned "Merry Garden" brand and the impeccable strategy for the Group in the development of renewable energy products, the Group looks forward to making further breakthroughs and expanding our market shares internationally.

The development during the Year has provided a solid foundation for the Group's further growth in the coming years.

During the Year, the Group continued to consolidate its core business into the following segments: manufacturing and sales of wooden products, retail business and projects relating to outdoor wooden products. The Group's relatively new business in the manufacturing and sales of renewable energy products has successfully continued operation for the third year since its commencement in 2014. The revenue derived from each of the four business segments during the Year were RMB421,761,000, RMB7,930,000, RMB132,000 and RMB12,505,000 (2015: RMB605,982,000, RMB11,044,000, RMB200,000 and RMB22,773,000), representing 95.4%, 1.8%, 0.0% and 2.8% of the total revenue derived (2015: 94.7%, 1.7%, 0.0% and 3.6%) respectively.

Note 1: Reported segment (loss)/profit has excluded the after tax effect of government subsidies.

本年度,本集團繼續將其核心業務整合為以下分部:即生產及銷售木製品、零售業務以及與戶外木製品有關之項目。本集團於生產及銷售再生能源產品方面的相對較新業務自二零一四年開始營運以來順利持續營運三年。本年度,四個業務分部各自產生的收入分別為人民幣421,761,000元、人民幣7,930,000元、人民幣132,000元及人民幣12,505,000元(二零一五年:人民幣605,982,000元、人民幣11,044,000元、人民幣200,000元及人民幣22,773,000元),分別佔所源自總收入95.4%、1.8%、0.0%及2.8%。(二零一五年:94.7%、1.7%、0.0%及3.6%)。

管理層討論與分析隱

Manufacturing and sales of wooden products remains the Group's largest business. However, the revenue derived from such business decreased by 30.4% which was attributable to the slowdown in the emerging economies and increased competition in the domestic and overseas timber house and structure markets. Also, a drop in selling price of the products met by an increase in processing and production cost to improve product competitiveness caused by stiff competition led to a significant decrease in the gross profit margin. This turns from profit to a loss of RMB31.9 million in 2016. (2015: RMB25.7 million profit). However, in light of the recent recovery of the economies of US and Europe, the Group will monitor the performance of each market and hope to stabilize the overall revenue of the Company.

生產及銷售木製品仍然是本集團的最大業務。然而,受新興經濟體經濟增長放緩加上國內外木屋構件市場競爭加劇,使得收入減少30.4%。此外,產品售價下跌及激烈競爭導致產生額外加工生產成本以提高產品競爭力導致毛利率大幅下跌。二零一六年轉盈為虧至人民幣31.9百萬元(二零一五年:人民幣25.7百萬元溢利)。然而,由於近期歐美經濟復甦,本集團將會監察各個市場的表現,有望使本公司整體收入保持穩定。

The Group's self-owned brand is engaged in the retail of leisure household products. Since its establishment in 2010, its sales network has grown to include major cities in more than 10 provinces in the PRC with over 50 self-operated stores and distribution outlets. The Group aims to improve the operation by improving its cost controls.

本集團自有品牌涉及零售休閒傢俱用品。自二零一零年成立以來,其銷售網絡已覆蓋超過十個中國主要省份的主要城市,並設有50多個自營及分銷網點。本集團致力加強成本控制以改善經營狀況。

As mentioned above, the Group has continued its renewable energy business for a third successful year. This aspect of the business involves the recycling of residue, such as leftover sawdust from the production of our wooden products, into biomass pellet fuel. The biomass pellet fuel and its production process, are fully compliant with the national development directions on new energies in the PRC.

如上所述,本集團再生能源業務已順利連續經營 3年。該業務涉及回收木製品生產過程中產生的 廢屑,然後將其轉化為生物質顆粒燃料。有關生 物質顆粒燃料及其生產工藝完全符合中國新能源 的國家發展方針。

The Group's renewable energy business recorded a decrease in revenue of 45.1% to RMB12.5 million and a decrease in profit of 84.7% to RMB1.2 million (2015: revenue of RMB22.8 million and profit of RMB8.2 million) during the Year. Despite the drop in revenue and profit, the Group will continue to develop the renewable energy business.

本年度本集團再生能源業務錄得收入減少45.1%至人民幣12.5百萬元及溢利減少84.7%至人民幣1.2百萬元(二零一五年:收入人民幣22.8百萬元及溢利人民幣8.2百萬元)。儘管收入及溢利下跌,本集團將繼續發展可再生能源業務。



The Group has strategically positioned itself "to align with the trend of Chinese tourism and leisure market and to capitalize on the recovery of the US and European property markets". The Group's aim is to take advantage of the opportunities in the market and to develop the Group's business at a faster pace whilst complying with all relevant laws, rules and regulations.

本集團以「緊扣中國休閒旅遊市場的趨勢,把握 歐美房產市場復甦」為策略定位,旨在於遵守所 有相關法律、規則及法規的同時利用市場機遇快 速發展本集團業務。

During the Year, revenue from the PRC market decreased sharply by 70.5% to RMB88.0 million (2015: RMB298.2 million), representing 20% (2015: 47%) of the total revenue. This was mainly attributable to the economic slowdown in the PRC. In 2016, the growth of the PRC's investments in fixed assets further decelerated. The Group expects that the sluggish economy in the PRC will persist in 2017. In order to maintain its competitiveness in the PRC market, the Group will continue to strengthen its products portfolio.

本年度,中國市場收入急劇減少70.5%至人民幣88.0百萬元(二零一五年:人民幣298.2百萬元),佔總收入的20%(二零一五年:47%),該下降主要受中國經濟增長放緩所影響。二零一六年中國固定資產投資增速進一步放緩。本集團預期二零一七年中國經濟會持續低迷。為了保持在中國市場的競爭力,本集團將繼續提升產品組合。

According to the US Department of Commerce, the new housing increased by approximately 6% to 14 million units in the 2016. Due to the economic stability in the US and the decline in the PRC market, the North America became the largest market of the Group. Although the revenue from the North America market slightly declined by 5.5% to RMB273.8 million (2015: RMB289.8 million), the revenue contributes 62% (2015: 45%) to the Group's total revenue. The Group expects that, with the further recovery of the US economy, the Group will be able to capture further opportunities and business so as to help stabilize the Group's total revenue.

據美國商務部公佈,二零一六年新屋增長約6%至14百萬戶。由於美國經濟平穩及中國市場下滑,北美成為本集團最大的市場。儘管源自北美市場的收入略為下降5.5%至人民幣273.8百萬元(二零一五年:人民幣289.8百萬元),但收入佔本集團總收入的62%(二零一五年:45%)。本集團預計,隨著美國經濟進一步復甦,本集團將能獲得其他機會與業務,進而有助穩定本集團的總收入。

During the Year, the Group's revenue from the Europe market increased by 45% to RMB44.0 million (2015: RMB30.4 million). Germany became the largest market of the Group in Europe. According to the data from the Federal Statistics Office of Germany, the construction of a total of 375,400 dwellings was permitted in Germany in 2016, which is about 22% increase compared to the same period in 2015. The Group expects to capture further opportunities and business as a result of the acceleration in construction of new housing this year.

本年度,本集團歐洲市場收入增加45%至人民幣44.0百萬元(二零一五年:人民幣30.4百萬元)。 德國成為本集團在歐洲的最大市場。根據德國聯邦統計局的最新數據,二零一六年德國合共375,400個住宅建設獲得許可,與二零一五年同期相比增加約22%。本集團預期本年度將因新建住宅建設加速而帶來更多機會及業務。

During the Year, the Group successfully developed new business in sales of timber houses and their related parts and structure and trading of timber in new geographical areas such as Australia and Korea. This could help the Company to develop a more diversified customer base. The Group will continue to seek for new business opportunity.

Sales of timber houses and their related parts and structures remained the largest income stream of the Group by product category in 2016. Revenue from such category decreased by 44.7% to RMB243.4 million, representing 55.0% (2015: 68.7%) of total sales for the Year, mainly due to the decline of domestic sales.

本年度,木屋及具相關部件及構件銷售按產品類別劃分仍是本集團最大收入來源。有關類別收入減少44.7%至人民幣243.4百萬元,佔本年度銷售總額的55.0%(二零一五年:68.7%),主要由於國內銷售下降。

During the Year, there was an overall decrease in trade within the timber market which provides an explanation to the decrease in revenue recorded by the Group. Despite the uncertain and slowly recovering global economy, the Group intends to balance the growth with stability in the foreseeable future.

本年度,木材市場整體貿易量的減少為本集團收入錄得下跌提供了解釋。儘管存在不明朗因素及全球經濟復甦緩慢,本集團擬於可預見將來兼顧穩定與增長,平衡發展。

Other revenue

During the Year, our other revenue decreased to RMB29.3 million (2015: RMB32.9 million) mainly due to the decrease in government subsidies amounting to RMB23.0 million (2015: RMB26.5 million).

Other net loss

The Group recorded other net loss of RMB21.9 million for the Year (2015: RMB7.0 million). The losses were primarily due to the exchange loss, impairment of goodwill and written-off of inventories.

Selling and distribution expenses

Our selling and distribution expenses incurred during the Year were RMB20.2 million (2015: RMB22.7 million). This slight decrease was mainly due to the decrease in revenue.

Administrative expenses

Our administrative expenses incurred during the Year decreased to RMB46.5 million (2015: RMB55.6 million), which was a result of stringent in cost control.

Finance costs

Our finance costs decreased to RMB9.0 million during the Year (2015: RMB16.6 million), and this was attributable to the active management to the fund.

其他收入

本年度,我們的其他收入減少至人民幣29.3百萬元(二零一五年:人民幣32.9百萬元),主要是由於獲得政府補貼減少至人民幣23.0百萬元(二零一五年:人民幣26.5百萬元)所致。

其他虧損淨額

銷售及分銷開支

我們於本年度的銷售及分銷開支為人民幣20.2百萬元(二零一五年:人民幣22.7百萬元)。是次輕微下降是由於收入下跌。

行政開支

由於嚴格的成本控制,本年度我們的行政開支減少至人民幣46.5百萬元(二零一五年:人民幣55.6百萬元)。

融資成本

我們的融資成本於本年度下降至人民幣9.0百萬元(二零一五年:人民幣16.6百萬元),此乃由於積極的資金管理所致。

Income tax expense

Our income tax decreases significantly to RMB1.6 million (2015: RMB9.7 million), primarily due to the decrease in profit before taxation of subsidiaries recorded during the Year.

(Loss)/profit for the Year

As a result of the foregoing factors, loss for the Year is RMB22.3 million (2015: profit of RMB43.8 million). Loss for the Year excluding the after tax effect of government subsidies is RMB41.8 million (2015: profit of RMB21.4 million).

Dividend

The Board does not recommended a final dividend for the Year (2015: Nil).

Liquidity and capital resources

The Group principally meets its working capital and other liquidity requirements through operating cash flows and proceeds from bank borrowings. The Group anticipates that it can sufficiently meet funding needs for working capital and capital expenditure. As at 31 December 2016, the Group had current assets of RMB882.5 million (31 December 2015: RMB961.1 million), of which bank deposits and cash (including pledged deposits) were RMB321.2 million (31 December 2015: RMB332.2 million). To better manage our funds, the Group's cash is generally deposited with banks and denominated mostly in RMB and USD. As at 31 December 2016, total available banking facilities of the Group amounted to RMB532.0 million (31 December 2015: RMB652.9 million), banking facilities utilized as at 31 December 2016 were RMB396.4 million (31 December 2015: RMB396.9 million) and these were denominated in RMB, EURO and USD. All of the Group's banking facilities were subject to the fulfilment of certain covenants, as are commonly found in lending arrangements with financial institutions. Details of the covenants are set out in note 24(c) to the financial statement.

所得税開支

我們的所得稅大幅減至人民幣1.6百萬元(二零 一五年:人民幣9.7百萬元),主要是由於本年度 附屬公司錄得的稅前盈利減少所致。

年內(虧損)/溢利

基於上述因素,本年度虧損人民幣22.3百萬元(二零一五年:溢利人民幣43.8百萬元)。未計及政府補貼之稅後影響之年內虧損人民幣41.8百萬元(二零一五年:溢利人民幣21.4百萬元)。

股息

董事會不建議派發本年度的末期股息(二零一五年:無)。

流動資金及資本來源

As at 31 December 2016, the ratio of total borrowings to total assets and net borrowings to total equity of the Group were 25.5% and 8.2% respectively (31 December 2015: 25.5% and 7.2% respectively), current ratio and guick ratio were 2.1:1 and 1.3:1 respectively (31 December 2015: 2.5:1 and 1.7:1 respectively).

Pledge of assets

At 31 December 2016, the Group pledged its plant and machinery, lease prepayments and buildings held for own use and accounts receivable with net book value of RMB229.4 million (31 December 2015: RMB213.1 million) and deposits with banks of RMB147.2 million (31 December 2015: RMB135.3 million) mainly for the purpose of securing bank loans and financial derivative contracts issued by banks to the Group.

Capital expenditure

During the Year, the Group's total expenditure in respect of property, plant and equipment and non-current prepayments for acquisitions of property, plant and equipment amounted to RMB89.2 million (2015: RMB174.5 million).

Capital commitment and contingent liabilities

Save as disclosed in note 29(a) of the consolidated financial statements, there were no significant capital commitments for the Group. There were no significant contingent liabilities for the Group as at 31 December 2016.

SIGNIFICANT INVESTMENT, MATERIAL **ACQUISITIONS AND DISPOSALS OF** SUBSIDIARIES, FUTURE PLANS FOR MATERIAL INVESTMENTS OR ACQUISITION OF CAPITAL **ASSETS**

During the Year, there were no significant investments, material acquisitions or disposals of subsidiaries by the Company. The Group currently has no plan to make any substantial investments in or acquisitions of capital assets, but will continue to seek out potential investment or acquisition opportunities according to the Group's development needs.

FOREIGN CURRENCY RISKS

The Group's sales are mainly denominated in USD and RMB while our cost of sales and operating expenses are mainly denominated in RMB. Therefore, the Group's profit margin would be affected if RMB appreciates against USD as the Group may not be able to reflect the appreciation in selling prices to overseas customers that were determined in USD. In response to this, the Group manages fluctuations in the exchange rate of RMB against USD by entering into foreign currency forward contracts mainly denominated in USD and RMB with banks when sales contracts were entered with overseas customers. As at 31 December 2016, the Group has net outstanding USD denominated forward foreign currency contracts of USD37.9 million (31 December 2015: USD51.9 million). All the contracts are to be settled within one year.

With the increasing level of our overseas purchases, the Group also manages foreign exchange risk by matching the cash inflow from our export sales denominated in USD with the cash outflow from our import of timber denominated in USD.

USE OF NET PROCEEDS FROM THE GLOBAL OFFERING, PLACING AND SUBSCRIPTION

The shares of the Company were listed on the Main Board of the Stock Exchange on 6 July 2012. Net proceeds from the global offering were approximately HK\$144.3 million (after deducting the underwriting commission and relevant expenses).

On 26 June 2014, the Company issued 200,000,000 new ordinary shares of HK\$0.01 each at HK\$0.80 per share by way of placing (the "June 2014 Placement"). On 7 October 2014, the Company issued 165,000,000 new ordinary shares of HK\$0.01 each at HK\$0.93 per share by way of placing (the "October 2014 Placement"). On 5 August 2015, the Company issued 272,600,000 new ordinary shares of HK\$0.01 each at HK\$0.55 per share by way of placing (the "August 2015 Subscription"). On 21 December 2015, the Company issued 857,945,000 new ordinary shares of HK\$0.01 each at HK\$0.20 per share by way of Open Offer (the "December 2015 Open Offer"). The net proceeds from the issue of new shares under the June 2014 Placement, October 2014 Placement, August 2015 Subscription, December 2015 Open Offer after deducting related transaction costs, were HK\$155.0 million, HK\$148.0 million, HK\$149.7 million, HK\$170.0 million respectively.

貨幣風險

本集團的銷售主要以美元及人民幣計值,而銷售成本及經營開支則主要以人民幣計值。由於本集團可能無法在向海外客戶銷售時,將人民幣兑民元的升值反映於以美元釐定的售價中,故如人民幣升值,溢利率將受影響。為此,本集團在與內容戶訂立銷售合約的同時透過與銀行主要訂立以美元及人民幣計值的遠期外幣合約以管理人民幣兑美元的匯率波動。於二零一六年十二月三十一日,本集團有淨值37.9百萬美元(二零一五年十二月三十一日:51.9百萬美元)以美元計值的未結算遠期外幣合約。所有合約將於一年內結算。

隨著本集團的海外採購增加,本集團亦透過以美元計值的出口銷售現金流入配合以美元計值的木 材進口現金流出管理外匯風險。

HUMAN RESOURCES

As at 31 December 2016, we employed a total of 547 (2015: 690) full time employees, mainly in the PRC and Hong Kong which included management staff, product designers, technicians, salespersons and workers. The Group's total expenses on the remuneration of employees for the Year were RMB38.8 million (2015: RMB42.0 million), representing 8.8% (2015: 6.6%) of the revenue of the Group. The Group has been consistently increasing production process automation, strengthening the training of staff with an emphasis on high-technique processing with a mission on the continuous development and enhancing of competitiveness. The Group offered highly competitive salary packages, as well as discretionary bonuses and contribution to social insurance to its employees.

The Group's emolument policies are formulated based on the performance of individual employee which will be reviewed periodically. Apart from the provident fund scheme (operation in accordance with the provisions of the Mandatory Provident Fund Schemes Ordinance for Hong Kong employees) or social insurance (including retirement pension insurance, medical insurance, unemployment insurance, injury insurance and maternity insurance for the PRC employees), discretionary bonuses are also awarded to employees and directors according to the assessment of individual performance. Since the adoption of the share option scheme on 15 June 2012 and up to 31 December 2016, no options have been granted.

EVENTS AFTER THE REPORTING PERIOD

On 24 January 2017, the Company entered into the subscription agreement with the subscribers pursuant to which the subscribers have conditionally agreed to subscribe for and the Company has conditionally agreed to allot and issue a total of 514,500,000 subscription shares of HK\$0.01 each at the subscription price of HK\$0.13 per subscription share. Completion took place on 10 February 2017 in accordance with the terms and conditions of the subscription agreement.

Pursuant to the subscription agreement, on 10 February 2017, 514,500,000 subscription shares, representing approximately 16.66% of the issued share capital of the Company as enlarged by the allotment and issue of the subscription shares as at 10 February 2017, were allotted and issued to not less than 6 and not more than 10 independent subscribers at the subscription price of HK\$0.13 per subscription share. Hong Kong Run De Holdings Limited, at Completion held 13.92% of the enlarged issued share capital of the Company and hence became a substantial shareholder and

The Board may delegate aspects of its management and administration functions to the management. In particular, the day-to-day management of the Company is delegated to the chief executive officer of the Group, Mr. Wu Zheyan, and his management team.

Mr. Wu Dongping is the father of Mr. Wu Zheyan. Save and except this, there is no relationship (including financial, business, family or other material relevant relationship) between Board members and between the Chairman and the Chief Executive Officer.

The Company has throughout the Year met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors with at least one independent non-executive Director possessing appropriate professional qualifications, accounting or related financial management expertise. At all times during the Year, the independent non-executive Directors represent at least one-third of the Board.

Each Director, upon reasonable request, is given access to independent professional advice in circumstances he may deem appropriate and necessary for the discharge of his duties to the Company, at the expense of the Company.

APPOINTMENTS, RE-ELECTION AND ROTATION OF DIRECTORS

Each of the executive Directors has entered into a service contract with the Company for a term of three years commencing from 15 June 2015, which may be terminated by not less than three months' notice in writing served by either party on the other. Each of the non-executive Directors and the independent non-executive Directors have been appointed for a term of three years commencing from 15 June 2015. None of the Directors has entered into a service contract with any member of the Group (excluding contracts expiring or determinable by the employer within one year without payment of compensation (other than statutory compensation)).

Pursuant to the Articles, at each annual general meeting one-third of the Directors for the time being shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. A retiring Director shall be eligible for re-election.

Under its terms of reference, the Audit Committee shall assist the Board in fulfilling its corporate governance and overseeing responsibilities in relation to financial reporting, risk management and internal control systems and internal and external audit functions. The Audit Committee is further authorised by the Board to investigate any activity within its terms of reference, and is tasked with recommending to the Board appropriate actions emanating from such investigations. The Audit Committee has unrestricted access to personnel, records, internal and external auditors, risk assessment and assurance and senior management, as may be appropriate in the discharge of its functions.

The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

However, the management would provide detailed updates to all the Directors on a half-yearly and yearly basis. In the event there are any significant updates to be provided, the management will update all the Directors as early as practicable for discussion and resolution. The Company also has in place a system for every Director to make enquiries with the senior management about the business operation of the Group and to give suggestions or feedback in the event such Director is not able attend the monthly on-site updates session.

Waste paint bucket and spray section for the adsorption of waste wood chips of waste paint and other hazardous wastes, shall not be mixed with other solid wastes, and must be stored in hazardous wastes reservoir pool constructed strictly in accordance with the relevant requirements under the "Pollution Control Standards for Hazardous Wastes Storage" GB18597-2001. The disposal, collection, temporary storage and management of hazardous solid wastes should be implemented according to relevant provisions of "Hazardous Chemicals Management Regulations" and "Precursor Chemicals Management Regulations" and all such hazardous wastes should be entrusted to Xiamen Oasis Environmental Stock Company Limited* (廈門綠洲環保產業股份有限公司) for disposal;
- 6. Recyclable solid wastes should be classified for centralized storage and recycling upon reaching a certain amount;
- Daily non-recyclable production and household garbage should be collected by the qualified contractor for processing;
- 8. Enter into the environmental protection notice with relevant parties on a regular basis.

Through a series of control measures, the Group's environmental protection work was highly recognized by environmental protection, forestry and other relevant departments.

通過一系列的管控措施,集團的環保工作得以環保、林業等相關部門的高度認可。

The Group attached great importance to the overall condition of energy consumption, and has established and fulfilled the "energy management regulations" to clarify the norms of energy utilization and responsibilities of various departments, and set up monitoring groups to monitor and check the energy usage of production system and non-production system. A sound energy-saving incentive and restraint mechanism and energy-saving funds have been set up to award groups and individuals achieving outstanding results in the energy-saving management, energy-saving invention and creation, energy-saving, potential excavation and consumption reduction. There are currently three teams and two individuals who have received this award.

本集團非常重視能源消耗的整體狀況,建立並實施《能源管理規定》,明確各能源的使用規範及各部門職責,並設立監察小組,監督和檢查生產系統和非生產系統的能源使用情況。並建立健全節能激勵約束機制,設立了節能獎勵資金,對在節能管理、節能發明創造、節能挖潛降耗等工作中取得優秀成績的集體和個人進行獎勵。目前已有3個班組及2個個人獲此殊榮。

Water Resources:

The Group's water consumption mainly includes the domestic water and boiler water. To further save and recycle of water resources, the Company actively advocated group employees to establish the concept of water conservation. Regarding the domestic sewage treatment, the Group has built a domestic sewage treatment system, and treated domestic sewage can be discharged after reaching the standard for discharge for irrigation. In addition, a large number of slogans relating to water conservation have been posted on wash basins, commodes and kitchen sinks to fulfilling "turning off the faucet while leaving".

With respect to boiler water, the boiler steam condensate recovery system put into construction by the Company could not only save fuel, but also effectively improve circulating use

of water to reduce water waste. Sewage emissions are mainly ammonia nitrogen, chemical oxygen demand and suspended solids, the total emission of which amounted to 583 kg in 2016.

水資源:

集團公司用水主要是在生活用水和鍋爐用水兩大方面。為進一步節約和迴圈利用水資源,公司積極宣導集團員工樹立節約用水的觀念。在生活污水處理方面,本集團自建生活污水處理系統,處理後的生活污水可達標排放,用於農田灌溉。另於洗手台、洗眼台、洗碗池等處大量張貼關於節約用水標語,要求做到「人走水關」。

在鍋爐用水方面,公司投入建設的鍋爐蒸 汽冷凝水回收系統不僅可節省燃料,還可 有效提高水的迴圈利用,減少水資源的浪 費。污水的排放物主要為氨氮、化學需氧 量及懸浮物,2016年總排淤為583公斤。

Exhaust Emission:

In order to maintain the air quality of the workplace and safeguard the health of employees, all the central processing plants of the Group are equipped with a central dust removal system to effectively reduce dust concentration, noise level and exhaust emission. Establishing closed spray device has protected staff from exposing to exhaust and ensure the safety of the working environment.

In addition, the cabins that the Group sold were equipped with the state-of-the-art and first-class silicon-based thin film photovoltaic power generation system. Each dealings of wooden house can save an annual generating capacity of 1,392kwh, standard coal of 557kg, carbon dioxide of 1,388kg and sulfur dioxide of 41kg.

The total production electricity consumption in 2016 was 10.6 gigawatt hours.

Waste Recycling:

In line with the concept of energy conservation, the Group has been actively committed to the integrated transformation of energy-saving system, to promote low-carbon recycle and pollution reduction in environmental protection facilities. After the operation of the biomass wood pellet fuel production line with an annual output of 50,000 tons, wood residue and other wastes generated from the wood processing will be made full use of to make wood pellet fuel, making an integrated utilization rate of 100%. The total production and sales of biomass wood particles amounted to 14,639 tons and 14,652 tons respectively in 2016. Biomass pellet fuel, which does not contain sulfur phosphorus, will not corrode the boiler and can extend the service life of the boiler, from which the enterprise will benefit. It will neither lead to acid rain, nor will it pollute the atmosphere or the environment.

During the Year, the Group complied with all relevant laws and regulations relating to emissions.

廢氣的排放:

為保持工作場所的空氣品質及保證從業人員的健康,本集團所有的加工車間全部安裝中央除塵系統,可以有效降低粉塵的濃度和雜訊的分貝,減少廢氣的排放。通過建立封閉式噴塗裝置,使尾氣不會外露以保障員工安全的工作環境。

此外,集團所銷售的木屋均採用國內領先國際水準一流的矽基薄膜光伏發電系統。每銷售一棟木屋即可節約年發電量1,392kwh,每年節約標準煤557kg,二氧化碳1,388kg,二氧化硫41kg。

於2016年,生產總用電為10.6吉瓦時。

廢料迴圈利用:

本著節約能源的觀念,本集團積極致力於能源系統節能整合改造,促低碳迴圈綜合利用,環保設施促減污。年產5萬噸生物質木顆粒燃料生產線建成投產後,充分利用木材加工後的木屑等三剩廢棄物,製成木顆粒燃料,使公司木材的綜合利用率達100%,2016年分別生產和銷售生物質木顆粒14,639噸及14,652噸。生物質顆粒燃料不含硫磷,不僅不腐蝕鍋爐,可延長鍋爐的使用壽命,企業將受益匪淺不含硫磷,不值不會導致酸雨產生,不污染大氣,不污染環境。

於本年度內,本集團遵守了所有相關排放物的法律法規。

2. Society

Stakeholders Contact

The Group's business contacts with global shareholders, customers, employees, suppliers, business partners and local communities were based on the responsibility to the community. The Group has formulated policies and practices on a range of topics such as human rights, anti-discrimination, social responsibility and environmental management, demonstrating its commitment to social responsibility.

Product Responsibility

During the Year, the Group complied with the Law of the People's Republic of China in relation to product quality. The Group's "Merry Garden 美麗家園" brand's anti-corrosive wood was accredited as "Fujian Users Satisfaction Product", "Anti-corrosion Wood Engineering Application Demonstration Enterprise" and "Fujian Top Brand Product in 2014" and other honorary titles. Its product obtained sustainable praise from consumers. Our employees must strictly abide by the Group's anti-corruption policies to maintain the Group's reputation.

To ensure that customers are offered with the highest quality products, the Group has developed a set of strict quality control system, covering supplier selection, material testing, production process control, product factory inspection, thirdparty inspection and certification, after-sales service, product quality tracking and other processes. The management system of "survival with records, flow traceability, information accessibility and quality retroactivity", the quality inspection mechanism of first inspection, self-inspection, line inspection, cross inspection and final inspection, the abnormal reporting and correction system and the regular quality analysis mechanism for export products have been set up and implemented. Publicity and promotion meetings, training sessions, site-meetings and seminars were organized on a regular basis to organize staff to learn relevant laws, regulations and rules, building the concept that "quality is the life of a company, who is the first responsible person for the quality", and developing a professional team comprising 25 quality management staff through strict product quality training assessment, thereby enhancing our staff's main responsibilities for quality and safety and quality control awareness.

2. 社會

利益相關者聯繫

本集團與全球股東、客戶、雇員、供應商、 業務夥伴及各地社區的往來,均本著對社 會大眾負責任的態度。本集團就人權、反 歧視、社會責任及環境管理等一系列課題 擬訂相應政策與常規,體現對社會責任的 承諾。

產品責任

於本年度內,本集團遵守中華人民共和國產品質量法。集團旗下防腐木品牌被授予「福建省使用者滿意產品」、「防腐木材工程應用示範企業」、「2014年度福建名牌產品」等榮譽稱號,產品持續獲得消費者的讚譽。 集團員工必須嚴格遵守集團反貪污政策,以維持集團聲譽。

為確保給客戶提供最高品質的產品,本集 團制訂了一套嚴密的品質管制體系,覆蓋 從供應商選擇、材料檢驗、生產程序控制、 產品出廠檢驗、協力廠商檢查認證、售後 服務、產品品質追蹤等過程。建立實施出 口產品品質「生存有記錄、流向可追蹤、資 訊可查詢、品質可追溯」的溯源管理制度。 建立實施首檢自檢線檢互檢終檢的品質監 督機制。建立實施異常情況報告和糾偏制 度。建立實施出口產品品質定期分析機制。 定時召開宣傳推進會議、培訓會、現場會、 座談會,組織員工學習相關的法律法規和 規章,樹立「品質就是企業生命,企業就是 品質第一責任人」的思想,並通過嚴格產品 品質崗位培訓考核,培育一支25名專職品 管專業隊伍,從而提升公司員工的品質安 全主體責任和品質管制意識。

Products are made from woods which are from all over the world and certified by the FSC and PEFC forest management systems. Both are provided by qualified suppliers and should be accompanied by a certificate issued by the supplier and require a sample inspection record for traceability. Such materials should be sent to CNAS approved laboratory at least once a year to test the content of heavy metals (such as lead, cadmium, mercury and chromium), free formaldehyde and other toxic and hazardous substances. All the wood used for the production have accepted epidemic prevention treatment and each batch of finished product subject to approval by the quality control department, while samples selected at random should be sent to the inspection room for testing before delivery.

產品所用木材來自全球各地並通過FSC和PEFC森林管理體系認證,均需由評價合格的供應商提供,同時應附有供應商出具的合格證書,並要求進行抽樣檢驗記錄,以便追溯。每年至少一次送樣至經過CNAS認可實驗室檢測重金屬(鉛、鎘、汞、鉻)、游離甲醛等有毒有害物質含量。所有用於生產的木材都經過烤房烘乾的防疫處理,每一批成品需經品管部檢驗合格,同時隨機抽取樣品送檢測室檢測合格方可發貨。

During the Year, the Group complied with all relevant laws and regulations relating to health and safety, advertising, labeling and privacy matters relating to products and services provided and methods of redress.

Supply Chain Management

In the selection of suppliers, the Group shall, after checking the relevant qualifications, conduct a on-spot inspection and divide the suppliers into three classes, namely: A-class, B-class and C-class three classes according to their production scale, production capacity, production environment, staffing, safety management organization, quality control system and other indicators. Purchasing department regularly organizes the production department, the department of administration and other relevant departments to conduct an integrated assessment on the safety management and performance and product after-sales service of qualified suppliers to choose the fittest ones. For a small number of suppliers with high security requirements, dedicated staff can be arranged to conduct onsite assessment if necessary.

本集團在選擇供應商時,核查具備相關資質後,須到實地考察,根據其生產規模、生產能力、生產環境、人員配備、安全管理組織機構、品質管制制度等指標,劃分A級、B級及C級三個等級供應商。採購部定期組織生產部、行政部等相關部門,對定合格供應商安全管理及表現以及產品售後服務等綜合情況進行評價考核,考核結果實行優勝劣汰。對少數供應商安全管理要求較高的,必要時可組織專人到供應商現場進行考核。

Human Resources Investment

The Group complies with and also requires its suppliers to comply with the guiding principles of ILO Declaration on Fundamental Principles and Rights at Work and the United Nations Guiding Principles on Business and Human Rights, which include freedom of association, collective bargaining, the elimination of the use of child labor, the abolition of all types of forced or compelled labor or workplace discrimination and other relevant principles. During the Year, the Group abided by national labour laws and regulations including but not limited to the prohibition of employment of child and forced labour.

Recruitment:

The Group has developed a comprehensive and well-established human resources management system, which clearly stipulates our requirements and operational norms on interviews, evaluation, background checks and admission notice in the recruitment process of staff. With respect to the training, there are not only trainings on pre-job corporate systems and on-job requirements, but also special trainings for on-job management skills improvement and business skills enhancement.

Salary and Benefits:

The Group attracted many talented people to serve the Company with its perfect remuneration and a lucrative and flexible welfare system. All employees of the Group have more than two promotion or salary promotion opportunities each year by virtue of their monthly assessment results. In addition, all managers can receive more than 2 times the year-end bonus by virtue of the annual assessment results. In addition, the Group provided house purchase subsidy, car subsidies, oil subsidies, phone subsidies and subsidies for meals for excellent management and technical staff, and more than 85% of the management staff are enjoying this treatment.

It is the Group's norms and targeted talents development policy of "selection, cultivation and retention" that attracted many outstanding people to serve the Company and cultivated a large number of splendid talents and leadership.

本集團制定了一套齊全而又完善的人力資源管理制度,其中明確規定了集團在人員招聘過程中面試、測評、背景調查、錄取通知書等相關要求及操作規範。就培訓方面,不僅有崗前公司制度、本崗位任職要求的培訓,更有崗中管理技能提升、業務技能提升的專項培訓。

薪酬與福利待遇:

本集團以其完善的薪酬和豐厚靈活的福利制度吸引眾多有才之人到公司服務。本集團所有的員工一年均有兩次以上憑藉每月考核結果得以崗位晉升或者薪資晉級的機會。此外,所有管理人員均可憑藉當年度的考核結果獲發2倍以上的年終獎金。不僅如此,集團特為優秀的管理技術人員制定了購房補貼、購車補貼、油費補貼、話費補貼,餐費補貼等福利待遇,目前現有85%以上的管理人員享受此待遇。

Training and Development:

To enable all our employees to further enhance their management skills and expertise, the Group has conducted and organized various types of training activities targeted to different technical and managerial positions.

The Group launched a comprehensive training and development program, i.e. the "bring in and walk out" plan for employees in 2016 with two terms a year and each for about 30-50 people. Candidates selected by the head and vice president of each department for current training session can officially join the "Sunshine Group Training Camp" after passing the interview. During the training period, the training instructor will tailor an integrated occupational improvement program according to each student's own situation. Students who passed the training, would further enhance his/her creativity and professional skills, and generate greater benefit for the Group. Besides, the Company has also organized targeted business skills training based on the actual job requirements, such as the IP management system training, Fsc management system training, occupational health management systeminternal auditor training and national forestry standardization training, enabling the staff to give full play effect.

In addition, the Group has formed a harmonious atmosphere of "the excellent training the greener, the experienced training the old and unity and cooperation" based on the actual production and staff skills to speed up the standardization and specialization of staff skills, while opening up an aisle for skilled talents to stand out, thereby enhancing the overall brand image of "Merry Garden" and holding the "King Wood Sophisticated Technology" competition once a quarter, thus creating a group of highly-skilled craftsmen, promoting the Company's new leap forward development.

HEALTH AND SAFETY

The Group is committed to providing employees with a healthy and safe working environment and protecting the social environment. The Company has always put our employee's occupational health and safety and environmental protection in the first place, and firmly believe that the excellent environment, health and safety performance will bring sustainable growth for the Company. We have set following goals:

- to create a healthy and safe working environment and further control the occurrence of occupational hazards;
- 2. all exhaust, sewage and waste residues meet respective standard of discharge.

The Group attaches great importance to the protection of work environment of the staff and the social environment. In respect to providing employees with a healthy and safe environment, the Company has developed a sound occupational health and safety management system, including issuing compliance labor insurance products on a monthly basis and requiring relevant personnel to wear the specified respirators, earplugs, goggles and other protection supplies with reference to relevant laws and regulations. In addition, the Company has launched corresponding reward and punishment mechanism, and established supervision branch to check and supervise. The company also invested in the construction of the central dust removal system, to avoid the secondary pollution and noise pollution caused by the dust, creating the cleanest operating environment.

The Group has actively taken the following measures to ensure the occupational health and safety of employees:

 to provide staff with a seven-day pre-job safety training and on-job special safety production operations training from time to time;

健康及安全

The Group has been committed to establishing and continuing to improve the internal control system to prevent corruption and fraud. Honesty, impartiality, transparency and accountability are all reflected in the Group's policies and operating procedures.

Internal exchanges will be organized on a regular basis to disseminate relevant knowledge, skills and experience.

The Group strengthens the anti-corruption supervision, while ensuring the daily supervision of the pipeline. The Group has established a fair and honest report platform to encourage realname reporting of all corruption and theft behaviors in the course of production and operation. The public Wechat account, telephone and office automation systems on the platform enabled grass-roots staff to communicate with the management in a faster and effective way and an incentive system has set up to award effective informants.

Since 2010, the Group has donated more than RMB6 million for social welfare undertakings and comforting garrisons. Over the years, we have been funding schools to build teaching facilities and donating piano, computer and other teaching equipment, supporting underdeveloped countryside for road construction and donating education funds, and have absorbed a large number of poor workers. In 2016, the Group donated a total of RMB833,000.

PRINCIPAL ACTIVITIES

The principal activity of Company is investment holding and the principal activities of its subsidiaries are set out in note 17 to the financial statements

BUSINESS REVIEW

A fair review of the Group's business and its outlook are set out in the sections of Chairman's Statement and Management Discussion and Analysis. Certain financial key performance indicators are provided in the section of Financial Summary. Particulars of important evert affecting the Company that have occurred since the end of the Year are set out in note 35 to the consolidated financial statements of the Company.

The Group complies with the requirements under the Companies Ordinance, the Listing Rules and the Securities and Futures Ordinance (the "SFO") for the disclosure of information and corporate governance. The Group also complies with the requirements of Employment Ordinance and ordinances relating to occupational safety for the interest of employees of the Group.

The Group respects the environment and is committed to minimizing its carbon footprint as a socially responsible enterprise. Carbon footprint is defined as the total amount of direct and indirect emissions of Green House Gases (GHGs) expressed in terms of the equivalent amount of Carbon Dioxide of (CO₂) emission. Nonhazardous wastes produced from the Group mainly consist of used paper such as office papers and marketing materials. To minimize the impact on carbon footprint and the environment, the Group implements the following practices to use paper efficiently:

- Duplex printing is set as the default mode for most network printers;
- Employees are reminded to practice photocopying wisely;
- Employees are encouraged to use both sides of paper;
- Paper is separated from other waste for easier recycling; and
- Boxes and trays are placed beside photocopiers as containers to collect single-sided paper for reuse purpose.

- 於影印機旁放置紙箱及紙盤收集單面紙張 以供循環再用。

Electricity consumption is identified as having an adverse impact on the environment and natural resources. A typical commercial building uses more energy for lighting than for other electric equipment. The Group is determined to reduce energy consumption and implement conservation practices to reduce the effect of carbon footprint. Air conditioning and light zone arrangements reduce unnecessary electricity usage; employees enforce good practices in maintenance of lighting and electric equipment to ensure they are kept in good and proper condition to maximize efficiency.

The Group closely monitors changes in government policies, regulations and markets as well as conducting studies to assess the impact of such changes. As far as the Board and management are aware, the Group has complied with all related laws and regulations in all material aspects which may have significant impact on the Group during the Year.

Third-Party Risks

The Group has been relying on third-party service providers in parts of business to improve performance and efficiency of the Group. While gaining the benefits from external service providers, the management realizes that such operational dependency may pose a threat of vulnerability to unexpected poor or lapses in service including reputation damage, business disruption and monetary losses. To address such uncertainties, the Group engages only reputed third-party providers and closely monitors their performance.

The Group had goodwill amounting to RMB4,300,000 relating to its cash generating units (the "CGU") under the operation of research, production and sale of intelligent home electronic equipment which arises from a group of subsidiaries acquired in 2015.

Management has performed an impairment test on goodwill in accordance with the Group's accounting policies. Management has concluded that there is an impairment of RMB4,300,000 in respect of the goodwill. This conclusion was based on fair value less costs to disposal calculations as the recoverable amount.

We have identified impairment assessment of goodwill as a key audit matter because of its significance to the consolidated financial statements and the fair value calculations involved significant management judgement. (Refer to note 15 to the consolidated financial statements and the Group's critical accounting estimates and assumptions in relation to the impairment of goodwill set out in notes 2g)

The collectability of the Group's trade receivables and the valuation of the allowance for impairment of trade receivables is a key audit matter due to the significant management judgment involved. 1 GENERAL INFORMATION

China Environmental Technology and Bioenergy Holdings Limited ("the Company") was incorporated in the Cayman Islands on 17 October 2011 as an exempted company with limited liability under the Companies Law, Cap 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The Company was listed on the Stock Exchange on 6 July 2012.

The consolidated financial statements for the year ended 31 December 2016 comprise the Company and its subsidiaries (together referred to as "the Group"). The consolidated financial statements were authorised for issue by the Directors on 24 March 2017.

2 SIGNIFICANT ACCOUNTING POLICIES

(a) Statement of compliance

These financial statements have been prepared in accordance with all applicable International Financial Reporting Standards ("IFRSs"), which collective term includes all applicable individual IFRSs, International Accounting Standards ("IASs") and Interpretations issued by the International Accounting Standards Board ("IASB") and the requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). A summary of the significant accounting policies adopted by the Group is set out below.

The IASB has issued certain new and revised IFRSs that are first effective or available for early adoption for the current accounting period of the Group and the Company. Note 2(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these financial statements.

(b) Basis of preparation of the financial statements

These consolidated financial statements are presented in RMB, rounded to the nearest thousand. The measurement basis used in the preparation of the financial statements is the historical cost basis except that derivative financial instruments are stated at their fair value (see note 2(i)).

The preparation of financial statements in conformity with IFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of IFRSs that have significant effect on the consolidated financial statements and major sources of estimation uncertainty are discussed in note 3.

(d) Business combination and basis of consolidation

The consolidated financial statements comprise the financial statements of the Group. Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated statement of comprehensive income from the dates of acquisition or up to the dates of disposal, as appropriate. Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with those used by other members of the Group.

Acquisition of subsidiaries or businesses is accounted for using the acquisition method. The cost of an acquisition is measured at the aggregate of the acquisition-date fair value of assets transferred, liabilities incurred and equity interests issued by the Group, as the acquirer. The identifiable assets acquired and liabilities assumed are principally measured at acquisition-date fair value. The Group's previously held equity interest in the acquiree is re-measured at acquisition-date fair value and the resulting gains or losses are recognised in profit or loss. The Group may elect, on a transaction-by-transaction basis, to measure the non-controlling interests that represent present ownership interests in the subsidiary either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other noncontrolling interests are measured at fair value unless another measurement basis is required by HKFRSs. Acquisition-related costs incurred are expensed unless they are incurred in issuing equity instruments in which case the costs are deducted from equity.

Any contingent consideration to be transferred by the acquirer is recognised at acquisition-date fair value. Subsequent adjustments to consideration are recognised against goodwill only to the extent that they arise from new information obtained within the measurement period (a maximum of 12 months from the acquisition date) about the fair value at the acquisition date. All other subsequent adjustments to contingent consideration classified as an asset or a liability are recognised in profit or loss.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interest. Amounts previously recognised in other comprehensive income in relation to the subsidiary are accounted for in the same manner as would be required if the relevant assets or liabilities were disposed of.

Subsequent to acquisition, the carrying amount of non-controlling interests that represent present ownership interests in the subsidiary is the amount of those interests at initial recognition plus such non-controlling interest's share of subsequent changes in equity. Total comprehensive income is attributed to such non-controlling interests even if this results in those non-controlling interests having a deficit balance.

(e) Subsidiaries

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see note 2(m)).

(f) Associates

An associate is an entity in which the Group or Company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

An investment in an associate is accounted for in the consolidated financial statements under the equity method. Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment (see note 2(m)(i)). Any acquisition-date excess over cost, the Group's share of the post- acquisition, post-tax results of the investees and any impairment losses for the year are recognised in the consolidated statement of profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognised in the consolidated statement of profit or loss and other comprehensive income.

When the Group's share of losses exceeds its interest in the associate, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method together with the Group's long-term interests that in substance form part of the Group's net investment in the associate.

Unrealised profits and losses resulting from transactions between the Group and its associate are eliminated to the extent of the Group's interest in the investee, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

In the Group's statement of financial position, investments in associates are stated at cost less impairment losses (see note 2(m)).

Investments in equity securities are initially stated at fair value, which is their transaction price unless it is determined that the fair value at initial recognition differs from the transaction price and that fair value is evidenced by a quoted price in an active market for an identical asset or liability or based on a valuation technique that uses only data from observable markets. Cost includes attributable transaction costs, except where indicated otherwise below. These investments are subsequently accounted for as follows, depending on their classification:

Investments in equity securities held for trading are classified as current assets. Any attributable transaction costs are recognised in profit or loss as incurred. At the end of each reporting period the fair value is remeasured, with any resultant gain or loss being recognised in profit or loss. The net gain or loss recognised in profit or loss does not include any dividends earned on these investments as these are recognised in accordance with the policies set out in note 2(w).

Investments in equity securities which do not fall into any of the above categories are classified as available-forsale securities. At the end of each reporting period the fair value is remeasured, with any resultant gain or loss being recognised in other comprehensive income and accumulated separately in equity in the fair value reserve. As an exception to this, investments in equity securities that do not have a quoted price in an active market for an identical instrument and whose fair value cannot otherwise be reliably measured are recognised in the consolidated statement of financial position at cost less impairment losses (see note 2(m)). Dividend income from equity securities are recognised in profit or loss in accordance with the policies set out in note 2(w)(v).

(i) Derivative financial instruments

Derivative financial instruments are recognised initially at fair value. At the end of each reporting period the fair value is remeasured. The gain or loss on remeasurement to fair value is recognised immediately in profit or loss.

(j) Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses (see note 2(m)(ii)).

The cost of self-constructed items of property, plant and equipment includes the cost of materials, direct labour, the initial estimate, where relevant, of the costs of dismantling and removing the items and restoring the site on which they are located, and an appropriate proportion of production overheads and borrowing costs (see note 2(y)).

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

Cost is calculated using the weighted average cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

(o) Construction contracts

Construction contracts are contracts specifically negotiated with a customer for the construction of an asset or a group of assets, where the customer is able to specify the major structural elements of the design. The accounting policy for contract revenue is set out in note 2(w)(ii). When the outcome of a construction contract can be estimated reliably, contract costs are recognised as an expense by reference to the stage of completion of the contract at the end of the reporting period. When it is probable that total contract costs will exceed total contract revenue, the expected loss is recognised as an expense immediately. When the outcome of a construction contract cannot be estimated reliably, contract costs are recognised as an expense in the period in which they are incurred.

Trade and other receivables are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method, less allowance for impairment of doubtful debts (see note 2(m)(i)), except where the receivables are interest-free loans made to related parties without any fixed repayment terms or the effect of discounting would be immaterial. In such cases, the receivables are stated at cost less allowance for impairment of doubtful debts (see note 2(m)(i)).

(q) Interest-bearing borrowings

Interest-bearing borrowings are recognised initially at fair value less attributable transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost with any difference between the amount initially recognised and redemption value being recognised in profit or loss over the period of the borrowings, together with any interest and fees payable, using an effective interest method.

(t) Employee benefits

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(u) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Apart from certain limited exceptions, all deferred tax liabilities and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

(w) Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Provided it is probable that the economic benefits will flow to the Group and the revenue and costs, if applicable, can be measured reliably, revenue is recognised in profit or loss as follows:

(i) Sale of goods

Revenue is recognised when the customer has accepted the goods and the related risks and rewards of ownership. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

(ii) Contract revenue

When the outcome of a construction contract can be estimated reliably, revenue from a fixed price contract is recognised using the percentage of completion method, measured by reference to the percentage of contract costs incurred to date to estimated total contract costs for the contract.

When the outcome of a construction contract cannot be estimated reliably, revenue is recognised only to the extent of contract costs incurred that it is probable will be recoverable.

Dividend income from unlisted investments is recognised when the shareholder's right to receive payment is established.

Foreign currency transactions during the period are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates.

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

The capitalisation of borrowing costs as part of the cost of a qualifying asset commences when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are in progress. Capitalisation of borrowing costs is suspended or ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are interrupted or complete.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

Key sources of estimation uncertainty

The Group believes the following critical accounting policies involve the most significant judgements and estimates used in the preparation of the consolidated financial statements.

(i) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and distribution expenses. These estimates are based on the current market condition and historical experience of selling products of similar nature. It could change significantly as a result of competitor actions in response to severe industry cycles or changes in market conditions. Management reassesses these estimations at the end of the reporting period to ensure inventory is shown at the lower of cost and net realisable value.

(ii) Impairment of trade receivables

Management determines the impairment of trade receivables on a regular basis. This estimate is based on the credit history of its debtors and current market conditions. If the financial conditions of the customers were to deteriorate, actual write-off would be higher than estimated. Management reassesses the impairment of trade receivables at the end of the reporting period.

(iii) Depreciation

Items of property, plant and equipment are depreciated on a straight-line basis over the estimated useful lives of the assets, after taking into account the estimated residual value. The management reviews the estimated useful lives of the assets regularly in order to determine the amount of depreciation expense to be recorded during any reporting period. The useful lives are based on the Group's historical experience with similar assets and taking into account anticipated technological changes. The depreciation expense for future periods is adjusted if there are significant changes from previous estimates.

(ii) 貿易應收款項的減值

管理層會定期釐定貿易應收款項的減值。該等估計乃基於其債務人的信譽 記錄及現行市況作出。倘客戶的財務 狀況惡化,則實際銷賬將高於估計。 管理層會於報告期間結束時重估貿易 應收款項的減值。

(iii) 折舊

物業、廠房及設備項目乃經計及估計剩餘價值後於資產的估計使用年期內按直線基準折舊。管理層會定期審閱資產的估計使用年期,以釐定任何報告期間內所記錄的折舊開支金額。使用年期乃根據本集團的類似資產的過往經驗及經計及預計技術變動計算。倘實際情況與過往估計存在重大差異,則會調整未來期間的折舊開支。

(iv) Income tax

Determining income tax provisions involves judgement on the future tax treatment of certain transactions. Management carefully evaluates tax implications of transactions and tax provisions are set up accordingly. The tax treatments of these transactions are reconsidered periodically to take into account all changes in tax legislations. Deferred tax assets are recognised for deductible temporary differences. As those deferred tax assets can only be recognised to the extent that it is probable that future taxable profits will be available, management's judgement is required to assess the probability of future taxable profits. Management's assessment is constantly reviewed and additional deferred tax assets, if any, are recognised if it becomes probable that future taxable profits will allow the deferred tax asset to be recovered.

(v) Impairment of goodwill

The Group tests annually whether goodwill has suffered any impairment in accordance with the accounting policy. The recoverable amounts of cash-generating units have been determined based on fair value less costs of disposal calculations. These calculations require the use of estimates.

(vi) Fair value measurement

A number of assets and liabilities included in the Group's financial statements require measurement at, and/or disclosure of, fair value.

The fair value measurement of the Group's financial and non-financial assets and liabilities utilises market observable inputs and data as far as possible. Inputs used in determining fair value measurements are categorised into different levels based on how observable the inputs used in the valuation technique utilised are (the "fair value hierarchy"):

- Level 1: Quoted prices in active markets for identical items (unadjusted);
- Level 2: Observable direct or indirect inputs other than Level 1 inputs;
- Level 3: Unobservable inputs (i.e. not derived from market data).

The classification of an item into the above levels is based on the lowest level of the inputs used that has a significant effect on the fair value measurement of the item. Transfers of items between levels are recognised in the period they occur.

The Group measures a number of items at fair value:

Financial instruments (note 31(f)(i)).

During 2016 and 2015, all of the Group's banking facilities were subject to the fulfilment of certain covenants, as are commonly found in lending arrangements with financial institutions. If the Group were to breach the covenants, the drawn down facilities would become payable on demand. The Group regularly monitors its compliance with these covenants.

The Group has an unsecured bank loan with a carrying amount of RMB12,567,000 at 31 December 2015. The loan agreement contains certain ratio covenants for which the Group did not meet the net profit ratio of not less than 20% and inventory turnover ratio of not less than 2 during 2015. The loan was repaid on 27 January 2016.

The Group has two secured bank loans with carrying amounts of RMB10,000,000 and RMB32,580,000 with maturity date on 12 November 2016 and 29 October 2018 respectively. The loan agreements contain certain ratio covenants for which the Group did not meet the current assets turnover ratio of not less than 1 during year 2015.

The Company complies with its obligation to pay and will repay the principals when they fall due. The Bank considered it not necessary at present to exercise its rights given by the loan agreements upon the Group not meeting the abovementioned ratio covenant prior to the respective maturity dates of the loans in 2015.

The acquisition was completed on 13 May 2015 upon which the fair value of the Consideration Shares were HK\$0.723 per share. The principal activity of the Acquired Subsidiaries is research, production and sale of intelligent home electronic equipment. Taking control of the Acquired Subsidiaries enabled the Group to effectively facilitate intellectualisation of the Group's timber house products, constituting a more value adding business to the Group.

In the seven months to 31 December 2015, Unicreed contributed revenue of RMB13,047,000 and loss of RMB1,250,000 to the Group's results. If the acquisition had occurred on 1 January 2015, management estimates that consolidated revenue would have been RMB644,337,000 and consolidated profit for the year would have been RMB44,882,000 respectively. In determining these amounts, management has assumed that the fair value adjustments, determined provisionally, that arose on the date of acquisition would have been the same if the acquisition had occurred on 1 January 2015.

Exposure to credit, liquidity, interest rate, currency and commodity price arises in the normal course of the Group's business.

The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

(a) Credit risk

The Group's credit risk is primarily attributable to trade and other receivables and cash and cash equivalents. Management has a credit policy in place and the exposure to these credit risks is monitored on an ongoing basis.

In respect of cash and cash equivalents, the Group only places deposits with major financial institutions, which management believe are of high credit rating.

In respect of trade and other receivables, the Group usually requires upfront payment for sales of goods to new customers. For export sales, the Group generally requests settlement by letter of credit issued by financial institutions or by wire transfer for certain customers with good trading history. Individual credit evaluations are performed on all new customers requiring credit over a certain amount and are also performed on existing customers on a periodic basis. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and may take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. The Group offers 90 days of credit to export sales customers with good trading history and offers 180 days of credit to the existing domestic sales customers. Generally, debtors with significant overdue balances are requested to settle all outstanding balances before any further credit is granted. Normally, the Group does not obtain collateral from customers.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. At 31 December 2016, 1% (2015: 4%), of the total trade and other receivables was due from the Group's largest customer and 15% (2015: 7%), was due from the five largest customers.

The maximum exposure to credit risk is represented by the carrying amount of each financial asset in the consolidated statement of financial position after deducting any impairment allowance. The Group does not provide any guarantees which would expose it to credit risk.

Further quantitative disclosures in respect of the Group's exposure to credit risk arising from trade receivables are set out in note 20.

(b) Liquidity risk

The Group's policy is to regularly monitor its liquidity requirements and its compliance with lending covenants to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

The Group is also exposed to currency risk associated with the bank borrowings as the Group's borrowings are denominated in RMB, USD, HKD and EURO.

During the years presented, the Group entered into foreign currency forward contracts with major state-owned banks in the PRC mainly to acquire RMB to mitigate against currency risk on receivables denominated in USD, HKD and EURO. All of the forward exchange contracts have maturities of less than one year.

At 31 December 2016, the Group had foreign currency forward contracts with their fair values recognised as derivative financial instruments (assets) of RMB9,561,000 (2015: RMB3,064,000) and derivative financial instruments (liabilities) of RMB7,692,000 (2015: RMB5,112,000) and are included within "Trade and other receivables" (note 20) and "Trade and other payables" (note 23) respectively. The changes in fair value of the foreign currency forward contracts were recognised in the consolidated statement of profit or loss (note 5(b)).

The sensitivity analysis assumes that the change in foreign exchange rates had been applied to remeasure those financial instruments held by the Group which expose the Group to foreign currency risk at the end of reporting period. The analysis excludes differences that would result from the translation of the financial statements of foreign operations into the Group's presentation currency. The analysis at 31 December 2015 has been performed on the same basis.

(e) Commodity price risk

The major raw materials used in the production of the Group's products include, fir and pinewood. The Group is exposed to fluctuations in the prices of these raw materials which are influenced by the global market as well as regional supply and demand conditions. Fluctuations in the prices of raw materials could adversely affect the Group's financial performance. The Group historically has not entered into any commodity derivative instruments to hedge the potential commodity price changes. The Group monitors its commodity price risk by widening its supply base and performs bulk purchase when the price of raw materials is low.
