- 向本公司或香港證券登記處提供與其各自業務運作有關的行政、電訊、電腦、付款或其他服務的任何代理、承辦商或第三方服務供應商;
- 香港聯交所、證監會及任何其他法定監管機 關或政府部門或法例、規則或法規規定的其 他機構;及

4. 個人資料的保留
