POSITIVE PROFIT ALERT

This announcement is made by Huarong International Financial Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2017 (the “**Relevant Period**”) and the information currently available to the Board, the Group is expected to record a significant increase in profit attributable to owners of the Company for the Relevant Period, which would represent not less than 150% increase when comparing to the profit of approximately HK\$217.7 million attributable to the owners of the Company for the six months ended 30 June 2016 (the “**Corresponding Period**”). The significant increase in the profit for the Relevant Period compared to the Corresponding Period was mainly due to the following factors:

- (i) the increase in operating profit from the asset management and direct investment segment as a result of the expansion of direct investment business;
- (ii) the increase in financial advisory fees and underwriting commission generated by the corporate finance segment as a result of the increase in financial advisory services and underwriting services provided during the Relevant Period; and
- (iii) the growth of the fee income and interest income from the securities segment as a result of the expanded margin loans portfolio during the Relevant Period comparing to that of the Corresponding Period.

As at the date of this announcement, the Company is in the process of finalizing the consolidated interim results of the Group for the Relevant Period. The information contained in this announcement is based on a preliminary review by the management of the Company of information currently available to the Board, and is not based on any figure or information which has been audited or reviewed by the independent auditors of the

Company. Shareholders and potential investors are advised to read carefully the announcement of the interim results of the Group for the Relevant Period which is expected to be released in August 2017.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
