- 聯交所、證監會及任何其他法定監管機關或政府部門或其他由法例、規則或法規所規定者;及
- 證券持有人與其進行或擬進行交易的任何人士 或機構,例如彼等的銀行、律師、會計師或股 票經紀等。

4. 保留個人資料
