Election of Means of Receipt of Corporate Communication

- (2) to receive the printed copies of all future Corporate Communication only.

If the Company does not receive the enclosed Reply Form or receive a response indicating the objection from you by 12 September 2017 and until you inform the Company c/o the Hong Kong Branch Share Registrar by reasonable prior notice in writing or sending a prior notice by email to hanergy-ecom@hk.tricorglobal.com, you will be deemed to have consented to receiving the Website Version for all future Corporate Communication, and a printed notification letter of the publication of the Corporate Communication on the Company's website will be sent to you in the future. If an email address is provided in the Reply Form, an electronic version of notification letter of the publication of the Corporate Communication on the website will be sent to you.

You have the right at any time by reasonable prior notice in writing or sending a prior notice by email to hanergy-ecom@hk.tricorglobal.com to the Company c/o the Hong Kong Branch Share Registrar to change the choice of means of receipt of the Corporate Communication. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communication using electronic means (i.e. the Website Version) but for any reason have difficulty in receiving or gaining access to the Website Version of the Corporate Communication, the Company will upon your request in writing or by email promptly send the Corporate Communication to you in printed form free of charge.
