- 香港聯交所、證監會及任何其他法定監管機關 或政府部門或法例、規則或法規所規定的其他 機構;及
- 證券持有人與其進行或擬進行交易的任何人士或機構,例如彼等的銀行、律師、會計師或股票經紀等。

#### 4. 個人資料的保留

本公司及其香港股份過戶登記分處將按收集個 人資料所需的用途保留證券申請人及持有人的 個人資料。無需保留的個人資料將會根據條例銷 毀或處理。
