UPDATE ON DEVELOPMENT OF SUSPENSION OF TRADING

Reference is made to the announcements made by Trony Solar Holdings Company Limited (the “**Company**”) dated 26 July 2017, 11 September 2017 and 1 November 2017 relating to, among others, the decision of the Listing Committee of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) to cancel the listing of the Company, the lodging of a request by the Company that the decision of the Listing Committee be referred to the Listing (Review) Committee of the Stock Exchange pursuant to Rule 2B.06 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the submission by the Company of a resumption proposal (the “**Resumption Proposal**”) to the Listing (Review) Committee in support of the Company’s review of the decision of the Listing Committee respectively.

DECISION OF THE LISTING (REVIEW) COMMITTEE

On 20 November 2017, the Stock Exchange issued a letter informing the Company that, among others, the Listing (Review) Committee considered the Resumption Proposal fell short of the expectation of the Stock Exchange of an acceptable viable resumption proposal and decided to uphold the abovementioned decision of the Listing Committee and to cancel the listing of the Company under Rule 6.01(4) of the Listing Rules.

APPLICATION FOR A REVIEW BY THE LISTING APPEALS COMMITTEE

On 28 November 2017, the Company has submitted a request for a review of the abovementioned decision of the Listing (Review) Committee by the Listing Appeals Committee under Rule 2B.07(5) of the Listing Rules. Further announcement will be made by the Company on the development of this matter as and when appropriate in accordance with the Listing Rules.

Shareholders of the Company who have any queries about the implications of the Stock Exchange’s proposal to cancel the Company’s listing are advised to obtain appropriate professional advice.

GENERAL

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended from 9:00 a.m. on 21 June 2012 and will remain suspended until further notice.
