- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本公司證券持有人的名册;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利,例如股息、供股和紅股等;
- 一 分發本公司及其附屬公司的通訊;
- 編製統計數據和證券持有人資料;
- 一 披露有關資料以便就權益索償;及

- (如證券申請人要求將證券存於中央結算系統)香港結算或香港結算代理人。彼等將會就中央結算系統的運作使用有關個人資料;
- 一 向本公司或香港證券登記處提供與其各自業務營運有關的行政、電訊、電腦、付款或其他服務的任何代理人、承包商或第三方服務供應商;
- 一聯交所、證監會及任何其他法定監管機關或 政府部門或遵照其他法例、規則或法規;及一證券持有人與其進行或擬進行交易的任何人 士或機構,例如彼等的銀行、律師、會計師 或股票經紀等。

4. 個人資料的保留

本公司及其香港證券登記處將按收集個人資料所需的用途保留證券申請人及持有人的個人資料。 無需保留的個人資料將會根據《條例》銷毀或處理。
