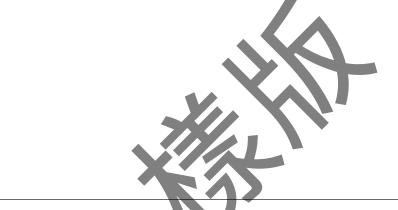

  - 聯交所、證監會及任何其他法定監管機 關或政府部門或法例、規則或法規所規 定的其他機關;及
- 整券持有人與其進行或擬進行交易的任何人士或機構,例如彼等的銀行、律師、會計師或股票經紀等。

#### 4. 個人資料的保留

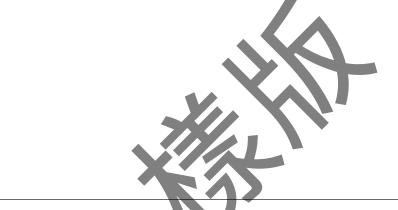
