POSITIVE PROFIT ALERT

This announcement is made by the Company under Part XIVA of the SFO and pursuant to Rule 13.09(2)(a) of the Listing Rules.

The Board wishes to inform that based on a preliminary assessment, the Group is expected to record a substantial increase of approximately 40% in its consolidated profit after taxation attributable to the Shareholders for the year ended 31st December, 2017 as compared with that of HK\$876 million for the corresponding period in 2016.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Tomson Group Limited (the “**Company**”, and when together with its subsidiaries, the “**Group**”) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (“**SFO**”) and pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board of directors of the Company (the “**Board**”) wishes to inform shareholders of the Company (the “**Shareholders**”) and potential investors that the Group is expected to record a substantial increase of approximately 40% in its consolidated profit after taxation attributable to the Shareholders for the year ended 31st December, 2017 as compared with that of HK\$876 million for the corresponding period in 2016, despite a decrease in gross proceeds from operations in 2017.

Such expected increase in profit is mainly attributable to the recognition of a gain on disposal of (i) 51% equity interest in Tianjin Jinwan Property Co., Limited upon completion in January 2017; and (ii) 100% equity interest in Tianjin Tomson Development Co., Limited upon completion in August 2017.

As the Company is in the process of finalizing the annual results of the Group for the year ended 31st December, 2017, the information contained in this announcement is only based on a preliminary assessment by the Company with reference to the information currently available

and the consolidated management accounts of the Group, which have neither been confirmed nor audited by the Company's auditor. Details of the audited consolidated annual results of the Group for the year ended 31st December, 2017 are expected to be announced by the Company in late March 2018.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
