# 3. 轉交個人資料

- 本公司委任的代理,例如財務顧問、收款銀行和主要海外股份過戶登記處;
- (如證券申請人要求將證券存於中央結算系統)香港結算或香港結算代理人,彼等將會就中央結算系統的運作使用有關個人資料;
- 向本公司或香港股份過戶登記分處提供與其 各自業務營運有關的行政、電訊、電腦、付 款或其他服務的任何代理、承包商或第三方 服務供應商
- 聯交所、證監會及任何其他法定監管機關或 政府部門或遵照其他法例、規則或法規;及
- 證券持有人與其進行或擬進行交易的任何人 士或機構,例如彼等的銀行、律師、會計師 或股票經紀等。

# 4. 個人資料的保留
