### Corporate Profile

### 公司簡介

MOBI Development Co., Ltd. (the "Company") was incorporated in the Cayman Islands as an exempted company with limited liability on 16 December 2002. The shares of the Company were listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 17 December 2009 (Stock Code: 947).

We operate through our subsidiaries MOBI Antenna Technologies (Shenzhen) Co., Ltd. ("MOBI Shenzhen"), MOBI Telecommunications Technologies (Ji An) Co., Ltd. ("MOBI Jian"), MOBI Technologies (Xi An) Co., Ltd. ("MOBI Xian"), MOBI Technology (Hong Kong) Limited ("MOBI HK"), MOBI Technology (Shenzhen) Co., Ltd., Shenzhen MOBI Industry Development Co., Ltd., Xian Shengrong Communication Technology Co., Ltd. and Shenzhen Shengyuzhihui Network Technology Co., Ltd..

We are one of the few one-stop providers of wireless communication antennas and base station Radio Frequency ("RF") subsystems in China. Our business consists of the design, manufacture, marketing and sale of antennas, base station RF subsystem and solutions that are the required components of mobile communication coverage systems, including, wireless access systems (WiFi and PHS), 2G (GSM and CDMA), 3G (TD-SCDMA, CDMA 2000, W-CDMA and WiMax), 4G (TD-LTE and FDD-LTE), 5G, MIMO Antenna, satellite communication and microwave transmission networks. We sell our products to network operators in China and overseas directly for deployment into the networks they are constructing and operating. We also sell our products to some of the world's leading wireless network solution providers who incorporate our products into their wireless coverage solutions, such as their proprietary base stations, which they then sell to network operators worldwide.

We are committed to providing quality and sophisticated products and building long term relationships with our customers.

本公司透過子公司摩比天線技術(深圳)有限公司(「摩比深圳」)、摩比通訊技術(吉安)有限公司(「摩比吉安」)、摩比科技(西安)有限公司(「摩比西安」)、摩比科技(香港)有限公司(「摩比香港」)、摩比科技(深圳)有限公司、深圳市摩比實業發展有限公司、西安晟容通訊技術有限公司及深圳市晟煜智慧網絡科技有限公司經營業務。

本公司為中國少數的一站式無線通信天線及基站射頻(「射頻」)子系統供應商之一。本公司的業務包括設計、製造、營銷和銷售天線、基站射頻子系統與解決方案,該等產品是移動通信覆蓋系統的必需部件,包括無線接入系統(WiFi和PHS)、2G(GSM及CDMA)、3G(TD-SCDMA、CDMA 2000、W-CDMA和WiMax)、4G(TD-LTE和FDD-LTE)、5G、MIMO天線、衛星通信網絡及微波傳輸網絡。本公司直接向中國和海外的網絡運營商銷售產品,以供配置於其構建及經營的網絡。我們亦向若干全球領先的無線網絡方案供應商銷售產品,而後者將本公司產品整合於其無線覆蓋方案(如其專有基站)中,繼而銷售予世界各地的網絡運營商。

本公司致力提供高質量的先進產品並與客戶建立長期的關係。

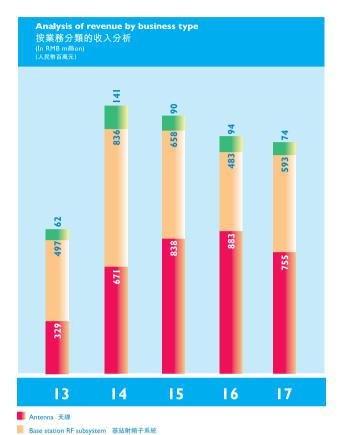

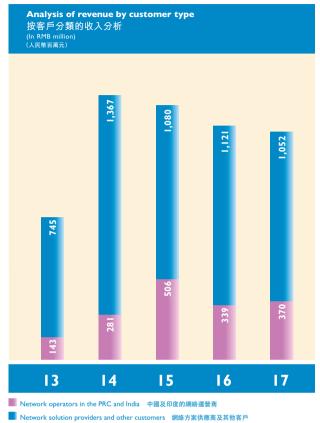

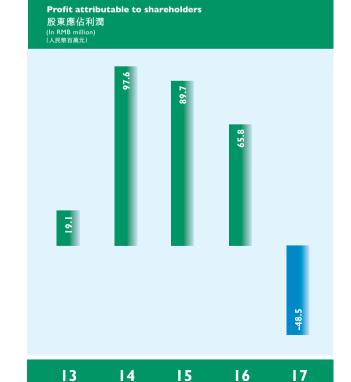

#### DEAR SHAREHOLDERS.

On behalf of the Board of Directors of MOBI Development Co., Ltd., I am pleased to present to the shareholders the business development of the Group and its subsidiaries (the "Group") for the year ended 31 December 2017 (the "Year").

In the immediate past year of 2017, global political and economic turbulence as well as present domestic transition of 4G and 5G industry development challenged the Group's business development. However, it is pleased to note that, through product and technical innovation and continuous market expansion, the Group maintained a leading market share in the industry and stood out from most of its competitors in terms of 5G wireless communication technology.

#### **OPERATING RESULTS**

In 2017, the Group realized approximately RMB1,422.44 million of operating revenue, representing a year-on-year decrease of approximately 2.6%, while net loss amounted to approximately RMB48.51 million, representing a year-on-year decrease of 173.7%; basic loss per share was approximately RMB0.06.

#### 尊敬的各位股東:

我謹代表摩比發展有限公司欣然向各位股東報告摩比發展有限公司及其子公司(「本集團」)截至2017年12月31日止年度(「本年度」)的業務發展狀況。

剛剛過去的2017年,全球政治與經濟仍然動盪,國內處於4G與5G產業發展的交替期,這都給本集團的業務發展帶來挑戰。但欣喜的看到,經過產品技術創新與市場持續拓展,本集團繼續穩固在行業中的領先份額,並在5G無線通訊技術上領先多數競爭對手。

#### 經營業績

2017年,本集團實現營業收入約14.2244億元人民幣,同比略減2.6%;實現淨虧損約4,851萬元人民幣,同比減少173.7%;每股基本虧損約人民幣0.06元。

#### **BUSINESS DEVELOPMENT**

There are cyclical fluctuations in the network construction and equipment investment of China's domestic mobile communications. The last complete cycle covered the period form the issuance of the 3G license in January 2009 to the issuance of the 4G license in December 2013, and the current cycle is expected to lay in the period from the issuance of 4G license to commercial use of 5G in the future. Each cycle change means upgrading of technology, switching of market focuses and major adjustment of customer structure. As such, it is also the reshuffle process of every market competition.

In 2017, the market situation also underwent major changes. Firstly, after the start of TD-LTE Phase 5 network building, the total amount of demand reduced significantly followed by sharply dropped price, which resulted in a substantial reduction of approximately RMB296.09 million (or 86.3%) in the Group's TD/TD-LTE antenna sales, being equivalent to approximately 20% of sales revenue in 2016. Secondly, hot-spot opportunities for domestic low-band refarming and IoT antennas mainly concentrated on the refarming of 800-900M band and most of its direct sales were to China Telecom and China Mobile. We successfully took the advantage of this adjustment so that our sales revenue in lowband refarming and IoT accounted for approximately 31% of the Group's total revenue. Thirdly, golden opportunity window was open for us in the international market. Despite the increasingly fierce international competition and the booming demand for high quality product with an attractive pricing level, our products were recognized by customers in Europe, while it remained difficult for overseas counterparts to reduce costs. That's to say, it's European customers who opened the door to opportunities for us. In 2017, the scale of our international direct sales business increased by almost 60% compared with the same period of last year, and the revenue from sales to Nokia increased by more than 42.2%. In addition, we were brought into Ericsson's short list of suppliers and obtained antenna supply contracts with some European operators for major supply and even the exclusive supply in the entire network.

#### 業務發展

中國國內移動通信的網路建設及設備投資存在週期波動。自2009年1月3G牌照頒發至2013年12月4G牌照頒發,這是上一次的完整週期。從4G牌照頒發至未來5G商用,預計是當前的週期期間。每一次的週期變化,都意味著技術的升級、市場熱點的切換和客戶結構的重大調整,因此也是每一次市場競爭的洗牌過程。

在2017年,市場形勢同樣出現了重大變化。 首先是TD-LTE網路建設進入第五期之後, 需求總量顯著減少,且價格大幅下降,使得 本集團的TD/TD-LTE天線銷售額大幅減少約 2.9609億(或減少約86.3%),相當於2016年 銷售收入的約20%。其次是國內低頻重耕與 物聯網的熱點機會,這是集中於800-900M 頻段的重耕機會,直接銷售的主要客戶是中 國電信和中國移動。我們成功的抓住了這個 調整,使得我們在低頻重耕及物聯網的銷售 收入佔到本集團收入總額的約31%。第三是 國際市場出現黃金機會窗。隨著國際競爭的 日益激烈,對高性能價格比的產品需求在快 速上升,而海外的同行在降成本上難度很 大,與此同時我們的產品在歐洲的使用中得 到了客戶的認可,因此眾多歐洲客戶對我們 打開了機會的大門。2017年,我們國際直銷 的業務規模較上年同期增長了接近60%,對 諾基亞的銷售收入增長了超過42.2%,並且 進入了愛立信的供應商短名單,拿到了歐洲 一些運營商的主力供應、甚至是全網獨家天 線供應合同。

Certainly, these adjustments also led to phased cost mainly including the substantial increase in research and development investment and the decline in gross profit margin caused by fierce domestic competition, which altogether resulted in a decrease in profitability in 2017. But we believe these declines are phased. On the one hand, research and development investment is an investment that can bring returns which will continue to be reflected in the business growth in the coming years. On the other hand, the appropriate adjustment of product structure and customer structure has laid the foundation for the recovery and growth of future profitability.

To sum up the above analysis, the Group is one of the world's few RF technology providers with leading-edge technologies in both TD-LTE and FDD-LTE and is also one of the few providers that can provide the multi-frequency and multi-system antenna technology. The Group believes that the Group is a leader of 4G and 5G antenna and RF subsystem product technologies.

#### **DIVIDEND DISTRIBUTION**

In 2017, the Board of Directors of the Company recommended the payment of a final dividend of HK\$0.04 per ordinary share.

#### **FUTURE PROSPECTS**

Looking forward, the Group believes that the popularity of smart terminals has driven the application of mobile internet into a rapid development pace.

The Work Report of the Central Government in 2017 suggested "to fully implement the plan for developing strategic emerging industries, accelerate the development of new materials, artificial intelligence, integrated circuits, bio pharmaceuticals, fifth generation mobile communications technology research and development and transformation, and develop industrial clusters in these fields". It is expected that 5G standard-setting and trial commercial operation will be completed between 2018 and 2020, and will be officially on use since 2020. Certain upgrading opportunities will be provided by 5G, including the demand for the construction of new base station and reconstruction of the roof of existing base station. Due to the non-independent networking standard of 5G at the current stage which requires to share the core network with 4G, the roof of base station will be overlapped on a large scale, bringing a huge demand for reconstruction, which means that the existing antennas such as GSM, TD-LTE and NB-IoT will be replaced by multi-frequency and multi-system antennas with high technical sophistication. With the Group's leading position in customer channels and 5G technology, the Group is in place to capture early opportunities riding on the development waves of 5G.

當然,這些調整也會帶來階段性的代價,主要是研發投入的大幅增加,以及國內激烈競爭導致的毛利率下滑,綜合導致2017年的盈利結果下滑。我們相信這些下滑是階段性的。一方面,研發投入是能帶來回報的投資,這將連續體現在未來幾年的業務增長上。另一方面,產品結構與客戶結構調整到位對未來利潤率的恢復及增長奠定了基礎。

綜上所分析,本集團是全球少數在TD-LTE 與FDD-LTE都具有領先技術的射頻技術供應 商,也是少數能提供多頻多系統天線技術的 供應商。本集團相信,本集團是中國4G及 5G天線與射頻子系統產品技術的領導者。

#### 未來展望

展望未來,本集團相信,智慧終端的普及使得移動互聯網應用已進入高速發展。

根據2017年中國中央政府工作報告:「全面 實施戰略性新興產業發展規劃,加快新材 料、人工智慧、積體電路、生物製藥、第五 代移動通信等技術研發和轉化,做大做強產 業集群。| ,預計在2018年至2020年5G將 會完成標準和試商用,從2020年開始正式商 用。5G會帶來若干的機會升級機會,包括 新建基站的需求,以及現存基站的天面改造 需求。由於現階段的5G標準主要是非獨立 組網標準,需要和4G共用核心網,因此基 站天面將大規模重合,從而帶來大量的改造 需求,即使用高技術難度的多頻多系統天線 來取代現有的GSM、TD-LTE及NB-IoT等天 線,而本集團在客戶管道和5G技術方面的 領先地位,使得本集團將在5G的發展浪潮 中佔得先機。

In the global arena, the overseas 4G cycle will last much longer than that in China. Although 5G is coming soon, 4G technology will still be the mainstream in the global network construction for a long time in the future. With its leading product technology of overseas multi-frequency system, the Group achieved satisfying breakthroughs in European operators in 2017 particularly its significant improvement in various aspects such as product technology, quality standards and technical process experiences. In the future, the Group will further develop the markets of overseas network operators, continuously enter the short lists of multinational and major regional network operators and continue to increase the Group's share in the global market on a long-term basis. It is foreseeable that the global market share of the Group is still extremely small at present, as such, the continuous expansion in the global market will not only push the way up in periodic development for the next few years, but also achieve sustained growth in a longer period.

Meanwhile, the Group will also actively explore the development of new businesses, including exclusive network coverage for governmental enterprises and the application of wireless solutions, to expand new growth momentum for the business of the Group. The Group believes that 5G development will bring huge opportunities for mobile communication. Wireless will be widely applied no matter in man-to-man communication, man-to-object communication or object-to-object communication. The Group will grasp the opportunity to achieve a record high result in the next few years.

I would like to express my sincere gratitude to our shareholders and customers for their kind support and trust, and to our Directors and staff for their diligent work. The Group and the Board will continue to optimise the customer base and structure, adapt strategies of product differentiation based on technology and costs to enhance the integrated competitiveness and ensure the stable growth of the operating results of the Group. The Group strives to become a top class global provider of radio frequency technology for mobile communication in order to maximise the returns to its shareholders and the society.

就全球而言,4G週期長度將遠長於中國國內。儘管5G即將到來,但在未來很長已時間內,4G技術仍將佔據全球網路建設的主流。本集團的海外多頻系統產品技術的領先,特別是2017年在歐洲運營商的領察,等別是2017年在歐洲運營商的領察,產品技術、品質水準與工藝經驗等面,都得到了顯著的提升。在未來,斷進一步拓展海外運營商市場,不長期持一步拓展海外運營商的短名單,長期持入事,本集團當前在全球的市場份額仍非常未聚與區域主要運營商的短名單,表續看到,本集團當前在全球的市場份額仍非常未來,持續拓展全球市場,不僅可以推動未來幾年向上週期發展,更可以在更長的時間內實現持續增長。

與此同時,本集團也將積極探索新業務拓展,包括政企的專網覆蓋以及無線解決方案運用,不斷拓展本集團業務的新增長動力。 本集團相信,5G的發展,將帶來移動通信的 巨大機遇,在傳統的人與人通信場景外,還 有人與物、物與物的通信場景,無線應用極 為廣闊。本集團將努力抓住這一機遇,在未 來數年內將公司業績帶入新的高度。

本人衷心感謝廣大股東與客戶對本集團的信賴與支持,也感謝各位董事與員工的辛勤努力。本集團與董事會將繼續推行客戶規模與結構的優化以及技術領先、成本領先的差異化競爭策略,提升本集團的綜合競爭力,實現本集團業績的穩健發展,不斷向全球一流的移動通信射頻技術供應商的願景目標前進,創造價值回饋股東和社會。

#### **BUSINESS AND FINANCIAL REVIEW**

#### Revenue

When compared with last year, revenue decreased by approximately RMB37.26 million, or approximately 2.6%, to approximately RMB1,422.44 million in 2017 (2016: approximately RMB1,459.70 million).

Sales of antenna system decreased by approximately 14.5% to approximately RMB754.79 million (2016: approximately RMB882.65 million), while sales of base station RF subsystem increased by approximately 22.8% to approximately RMB592.81 million (2016: approximately RMB482.85 million). In addition, sales of products of coverage extension solution decreased by approximately 20.6% to approximately RMB74.84 million (2016: approximately RMB94.21 million).

#### 業務及財務回顧

#### 收入

2017年收入較去年減少約人民幣3,726萬元 (約2.6%)至約人民幣14.2244億元(2016年: 約人民幣14.5970億元)。

天線系統的銷售額減少約14.5%至約人民幣7.5479億元(2016年:約人民幣8.8265億元),而基站射頻子系統的銷售額增加約22.8%至約人民幣5.9281億元(2016年:約人民幣4.8285億元)。此外,覆蓋延伸方案產品的銷售額減少約20.6%至約人民幣7,484萬元(2016年:約人民幣9,421萬元)。

### 管理層討論及分析

There were periodic fluctuations in domestic mobile communication network building and equipment investment. The last complete cycle was from January 2009, the time of granting of 3G license, to December 2013, the time of granting of 4G license. The current cycle is expected to be from the time of granting of 4G license to the commercial use of 5G in the future. Every periodic change means technological upgrade, switch of market focuses and significant adjustment of client structure, thus a process for the restructuring of market competition.

In 2017, there were also significant changes in market conditions. The first was that since the entering of TD-LTE Phase 5 network building, the total demands had dropped sharply with a significant decrease in the prices, which led to a large decline of approximately RMB296.09 million (or approximately 86.3%, equivalent to approximately 20% of the sales revenue in 2016) in the sales of the Group's TD/TD-LTE antennas. The second was the hot spot of low-band refarming/IoT in China, which was a refarming opportunity centering on 800-900M band, and the major clients of direct sales were China Telecom and China Mobile. We successfully seized such adjustment so that our sales from lowband refarming/IoT accounted for approximately 31% of the Group's total revenue. The third was the golden opportunity in international market. With the increasingly intense international competition, the demands for products with high price-to-performance ratio are growing rapidly, whereas the overseas peers have great difficulties in cost reduction, and in the meantime, our products are well-received by European users. Therefore, many European clients offered opportunities to us. In 2017, our business scale of international direct sales increased almost 60% as compared with the corresponding period of last year, and sales to Nokia grew over 42.2%. Moreover, we entered the supplier short lists of Ericsson, and secured major supply contracts, or even the whole-network exclusive antenna supply contracts, with some European operators.

The Group also believes that as the Group is a leader in the antenna and RF subsystem product technology in the PRC and by leveraging its product technology and market advantages, it is positioned to generate greater benefits from network building in the future.

在2017年,市場形勢同樣出現了重大變化。 首先是TD-LTE網路建設進入第五期之後, 需求總量顯著減少,且價格大幅下降,使得 本集團的TD/TD-LTE天線銷售額大幅減少 約人民幣2.9609億(或減少約86.3%),相當 於2016年銷售收入的約20%。其次是國內 低頻重耕與物聯網的熱點機會, 這是集中 於800-900M頻段的重耕機會,直接銷售的 主要客戶是中國電信和中國移動。我們成功 的抓住了這個調整,使得我們在低頻重耕及 物聯網的銷售收入佔到本集團收入總額的約 31%。第三是國際市場出現黃金機會窗。隨 著國際競爭的日益激烈,對高性能價格比的 產品需求在快速上升,而海外的同行在降成 本上難度很大,與此同時我們的產品在歐洲 的使用中得到了客戶的認可,因此眾多歐洲 客戶對我們打開了機會的大門。2017年, 我們國際直銷的業務規模較上年同期增長 了接近60%,對諾基亞的銷售收入增長了超 過42.2%,並且進入了愛立信的供應商短名 單,拿到了歐洲一些運營商的主力供應、甚 至是全網獨家天線供應合同。

本集團亦相信,本集團是中國天線與射頻子 系統產品技術的領導者,憑藉產品技術與市 場優勢將在未來建設中獲得更大收益。

### 管理層討論及分析

#### Antenna system

In 2017, the Group's antenna products continued to maintain a leading position in the domestic market, and our continuously improving antenna product technologies and reliability were recognized by more and more international clients.

Revenue from antenna products is greatly affected by periodic adjustment and switch of focuses. In 2017, sales of the Group's TD/TD-LTE antennas decreased significantly by approximately 86.3% to approximately RMB47.20 million as compared with last year. Sales of low-band refarming/IoT antennas increased significantly by approximately 3,528.7% to approximately RMB235.94 million as compared with last year. Sales of Pre5G antennas increased significantly by approximately I21.6% to approximately RMB12.25 million as compared with last year. As promoted by both domestic technological upgrade and increasing demands of overseas operators, sales of multi-frequency multi-system antennas grew greatly by approximately I56.8% to approximately RMB202.84 million. Multi-frequency multi-system antennas are expected to be a major growth driver for antennas business in the coming period.

In addition, the Group continued to actively develop the overseas operator market in 2017 and won positive feedback from the customers. The Group's direct sales to overseas operators are primarily antenna products, which also recorded substantial increase in 2017. The Group believe that the upgrades in 5G technology and overseas growth will be the powerhouses for growth in antennas business of the Group in the years to come.

#### 天線系統

2017年,本集團的天線產品繼續保持在國內的領先地位,同時天線產品技術與可靠性的不斷進步也得到更多國際客戶的認可。

天線產品收入變化受週期調整及熱點切換的影響最大。2017年,本集團TD/TD-LTE天線銷售額較上年大幅下降了約86.3%至約人民幣4,720萬元。低頻重耕/物聯網天線銷售額則較上年大幅增加了約3,528.7%至約人民幣2.3594億元。Pre5G天線的銷售也較上年大幅增長約121.6%至約人民幣1,225萬元。受國內技術升級和海外運營商需求增長雙重推動,多頻多系統天線大幅增長約156.8%至約人民幣2.0284億元。多頻多系統天線相信會是未來一段時期的天線業務主要增長點。

另外,2017年本集團在海外運營商市場上繼續積極拓展,並獲得客戶積極評價。本集團的海外運營商直銷是天線產品為主,2017年亦錄得強勁增長。本集團相信,5G升級和海外增長將為本集團未來若干年內的天線業務增長帶來強大動力。

#### Base station RF subsystem

The competition of base station RF subsystem was more intense in 2017. The Group continued to maintain a leading supplier position among leading global telecommunication equipment manufacturers. The revenue from the Group's base station RF subsystem in 2017 increased by 22.8% to approximately RMB592.81 million and we maintained speedy growth in the sales to the clients of ZTE Corporation and Nokia. Meanwhile, in 2017, the Group was officially approved and certified by Ericsson and became a qualified supplier of its global RF subsystem.

In the first half of 2017, competition was particularly intense in the prices of RF subsystem products, thus the price and gross profit of the Group's RF subsystem business were affected in the second quarter of 2017. However, with the emergence of the Group's cost competitiveness and product structural adjustment since the second half year, our gross profit began to recover gradually, and sales revenue sped up growing, with more excellent quality performance than some competitors. The Group believes that, after the market baptism in 2017, our product competitiveness is better recognized by the clients, with further enhanced market share. In particular, the Group's securing of more overseas projects will bring about more opportunities for the Group's growth in 2018.

#### Coverage extension solution

In 2017, revenue from the Group's coverage extension solutions decreased by approximately 20.6% to approximately RMB74.84 million, mainly due to an decrease of approximately 75.8% in its revenue from other constructions to approximately RMB4.02 million. The aesthetic antenna is actually one of the achievements in business in 2017. The Group has secured major shares in China Mobile and China Telecom's national bidding exercise for aesthetic antennas. However, as it has not reached the large-scale delivery stage, the revenue is yet to be recognised. We believe that very encouraging performance will be recorded in 2018.

#### 基站射頻子系統

基站射頻子系統的競爭在2017年更加激烈, 本集團繼續保持在全球領先電信設備商中的 主力供應商份額,2017年本集團的基站射頻 子系統收入增加約22.8%至約人民幣5.9281 億元,並且對中興通訊與諾基亞客戶的銷售 都保持較快增長。與此同時,在2017年本集 團正式獲愛立信認證通過,成為其在全球射 頻子系統的合資格供應商。

射頻子系統產品的價格競爭在2017年上半年 尤為激烈,因此本集團射頻子系統業務的價 格與毛利率在2017年二季度也受到影響。但 從下半年開始,隨著本集團的成本競爭力顯 現,以及產品結構的調整,毛利率開始逐步 回升,銷售額亦加快增長,品質表現亦優於 部分競爭對手。本集團相信,經過了2017年 的市場洗禮,本集團的產品競爭力更得到了 客戶的認可,市場佔有率進一步增強,特別 是得到了客戶的更多海外專案,在2018年會 給本集團增長帶來更多的機會。

#### 覆蓋延伸方案

2017年本集團覆蓋延伸方案的收入減少約20.6%至約人民幣7,484萬元。主要由於其他工程收入減少約75.8%至約人民幣402萬元。美化天線實際上是2017年的業務收穫之一,本集團在中國移動與中國電信的美化天線全國集採招標中皆斬獲主要份額,但由於尚於進入大規模交付階段,因此尚未能確認收入,相信在2018年會有非常積極的表現。

#### Customers

In 2017, the Group noted that a change in market pattern resulted in a change in customer revenue structure, and the Group's in-depth cooperation with telecommunication equipment manufacturers and telecommunication operators allowed the Group to enjoy distinctive competitive strengths in changing market opportunities. In addition, the Group proactively made adjustment and took the initiative in the industry cycle and hotspot switching in 2017, and successfully realized the optimization of its revenue structure.

As affected by the subdivision of TD-LTE Phase 5 procurement and decline of demands in 2017, the Group's sales to the PRC equipment manufacturer customers decreased by approximately 21.9% to approximately RMB662.71 million, and its proportion in sales revenue also dropped by approximately 9 percentage points to approximately 46.6%, while the proportion in total revenue was approximately 46.6%. In addition, the Group's sales to other major client groups also recorded growths.

#### 客戶

2017年本集團注意到,市場格局的變化亦帶來客戶收入結構的變化,而本集團在電信設備商與電信運營商均有深入的合作,令本集團在市場機會變化中擁有獨有的競爭優勢。並且,本集團積極調整,在2017年的行業週期和熱點切換中掌握了主動,順利實現了客戶收入結構的優化。

受TD-LTE五期採購拆包及需求下滑影響, 2017年本集團對中國設備商客戶的銷售規模 減少約21.9%,至約人民幣6.6271億元,佔 銷售收入的比重也下降約9個百分點,佔總 收入的比重約為46.6%。除此之外,本集團 對其他主要客戶群的銷售收入皆錄得增長。

### 管理層討論及分析

In particular, sales to PRC operators increased by approximately 7.2% to approximately RMB369.97 million, and its proportion in total revenue increased by approximately 2 percentage points to approximately 26.0%. Moreover, the sales to PRC operators was still dominated by China Unicom clients in last year, but in this year, sales to China Telecom grew significantly by approximately 224.5%. In 2017, the Company's leading share in China Mobile NB-IoT antenna collective procurement bidding and aesthetic antenna bidding successfully realized the optimization of client structure, and laid a foundation for the continuing growth in 2018.

In addition, the Group's sales to international equipment manufactures in 2017 increased by approximately 38.7% to approximately RMB250.91 million, and its proportion in total revenue increased by approximately 5 percentage points to approximately 17.6%. Apart from the increase in sales, the Group's quality performance was also recognized by clients, thus secured many overseas projects with a more reasonable project structure, which could contribute to the sales and profit growth in 2018.

In 2017, the Group's direct sales to international operators and other international customers increased significantly by approximately 67.8% to approximately RMB112.25 million, and its proportion in total revenue increased by approximately 3 percentage points to approximately 7.9%. The Group believes that there is golden opportunity in international market. With the increasingly intense international competition, the demands for products with high price-to-performance ratio are growing rapidly, whereas the overseas peers have great difficulties in cost reduction, and in the meantime, our products are well-received by European users. Therefore, many European clients offered opportunities to us. In 2017, apart from the significant year-on-year increase in the business scale of international direct sales, we also secured major supply contracts, or even the whole-network exclusive antenna supply contracts, with some European operators.

The deployment of the Group's products in the network systems of our diversified international customers strengthened worldwide awareness of the brand name of MOBI.

其中,對中國運營商的銷售規模增長約7.2% 至約人民幣3.6997億元,佔總收入的比重上 升約2個百分點至約26.0%。並且從過去以中 國聯通客戶為主,到2017年對中國電信的收 入大幅上升約224.5%,以及在2017年的中 國移動NB-IoT天線集採招標及美化天線招標 中斬獲領先份額,成功實現了客戶結構的優 化,並且為2018年的繼續增長打好了基礎。

另外,2017年本集團對國際設備商的銷售規模增長約38.7%至約人民幣2.5091億元,佔總收入的比重約上升5個百分點至約17.6%。除了銷售規模增長之外,本集團的品質表現亦得到客戶認可,因此獲得多個海外專案,專案結構亦更加合理,有利於2018年的銷售與盈利增長。

2017年本集團對國際運營商及其他國際客戶銷售大幅增長約67.8%至約人民幣1.1225億元,佔總收入的比重約上升3個百分點至約7.9%。本集團相信國際市場出現了黃金機會窗。隨著國際競爭的日益激烈,對高性能價格比的產品需求在快速上升,而海外的同行在降成本上難度很大,與此同時我們的產品在歐洲的使用中得到了客戶的認可,因此眾多歐洲客戶對我們打開了機會的大門。2017年,我們除了國際直銷的業務規模較上年同期大幅增長外,還拿到了歐洲一些運營商的主力供應、甚至是全網獨家天線供應合同。

本集團的多元化國際客戶將本公司產品配置 於彼等的網絡系統,提升了摩比品牌的世界 知名度。

#### Gross profit

In 2017, gross profit of the Group declined by approximately 30.4% to approximately RMB246.09 million (2016: approximately RMB353.47 million), and gross profit margin decreased from approximately 24.2% in 2016 to approximately 17.3% in this year, which includes the effect of provision for inventory depreciation. If excluding the effect of provision for depreciation, the gross profit would decrease approximately 14.8% to approximately RMB301.32 million. The gross margin is approximately 21.2%. The Group will improve the overall gross profit margin through continuous upgrading of product mix and effective control of internal costs.

The dropped gross profit margin is the price paid in such stages for business adjustment and fierce competition in 2017. With the structure adjustment of product and customer in place for 2017, the Group was full of confidence both in the future recovery and growth of profit margins.

#### Other income and expenses

Other income and expenses increased to approximately RMB32.37million, which was mainly attributable to the increase in compensation income of the Group.

#### 毛利

2017年,本集團毛利減少約30.4%至約人民幣2.4609億元(2016年:約人民幣3.5347億元),而毛利率由2016年的約24.2%減少至本年度的約17.3%。這裡面包含存貨減值準備的影響因素,若剔除減值準備的影響,則毛利減少約14.8%至約人民幣3.0132億元,毛利率為約21.2%。本集團將透過產品結構的不斷升級以及有效的內部成本控制來提高整體毛利率。

毛利率下滑是2017年業務調整和激烈競爭的 階段性代價,隨著2017年產品結構與客戶結 構調整到位,本集團對未來利潤率的恢復及 增長充滿了信心。

#### 其他收入及開支

其他收入及開支增加至約人民幣3,237萬元,主要是由於本集團補償收入增加所致。

#### Distribution and Selling Expenses

Distribution and selling expenses decreased by approximately 1.4% from approximately RMB92.99 million in 2016 to approximately RMB91.71 million in 2017, primarily due to the decrease in business expenditures and transportation costs resulted from the strengthened cost management and the reduced business activities.

#### Administrative expenses

Administrative expenses increased by approximately 11.4% from approximately RMB113.19 million in 2016 to approximately RMB126.04 million in 2017, mainly due to the increases in expenses on wages, depreciation charges, exchange loss, rents and social insurance.

#### Research and development costs

During the year, the Group recognized development costs of approximately RMB18.25 million as intangible assets. After the capitalization, development costs increased by approximately 19.0% from approximately RMB89.68 million in 2016 to approximately RMB106.75 million in 2017, which was mainly attributable to the increase in salaries for research and development activities, surcharge on wages, travelling expenses, social security contributions, testing fees and depreciation charges. Due to the significantly rise in the demand for development in 5G technologies and overseas projects, the Group's investment in research and development was in rapid growth for 2017, which is expected to provide business opportunities in the future.

#### 分銷及銷售開支

分銷及銷售開支由2016年約人民幣9,299萬元減少約1.4%至2017年約人民幣9,171萬元。主要由於費用管控加強以及業務活動減少,使得業務支出與運輸費用減少。

#### 行政開支

行政開支由2016年約人民幣1.1319億元增加約11.4%至2017年約人民幣1.2604億元,主要由於工資、折舊、滙兑損失、房租費及社會保險費增加所致。

#### 研發成本

本年度,本集團確認約人民幣 I,825萬元開發成本為無形資產。資本化後,開發成本由2016年約人民幣 8,968萬元增加約 I9.0%至2017年約人民幣 I.0675億元,主要是由於研發工資、工資附加費、差旅費、社會保險費、測試費及折舊費增加所致。由於5G技術的開發需求和海外專案的開發需求顯著上升,因此2017年本集團的研發投入上升較快,這些研發投入預計將在未來帶來業務機會。

#### Finance Costs

Finance costs increased by approximately 11.2% from approximately RMB13.10 million in 2016 to approximately RMB14.57 million in 2017. In 2017, bank borrowings of the Group increased by approximately RMB31.20 million to approximately RMB287.46 million.

#### **Profit Before Taxation**

Profit before taxation significantly decreased by approximately 184.7% to a loss before taxation of approximately RMB60.98 million (2016: a profit before taxation of approximately RMB71.96 million). Net profit margin before taxation charges decreased from approximately 4.9% in 2016 to approximately -4.3% in 2017.

The decrease in profit before tax for the year was mainly attributable to the impact of the periodic adjustment, the decline in gross profit margin, the increase in research and development costs and the increased provision for asset impairment. In respect of sales to domestic operators, the Group adopted the business model of "purchase on credit first and recognize sales revenue when contract receives after" which is also a business practice for domestic operators to purchase communications equipment and components. The Group has some stocks of products dispatched to domestic operators for the past, of which are mainly 2G antenna spare parts. In view of the upcoming 5G, the Group expects that the use of 2G antennas will be reduced sharply, leading to the possible significantly decrease in the realisable value of the dispatched 2G products, as such, provision for impairment has been increased.

The Group believes that these adjustments will not have impact on the competitiveness in the industry and long-term profitability of the Group, being confident in the future business performance.

#### 融資成本

融資成本由2016年約人民幣1,310萬元增加約11.2%至2017年約人民幣1,457萬元。 2017年,本集團銀行借款增加約人民幣3,120萬元至約人民幣2,8746億元。

#### 税前利潤

税前利潤大幅減少約184.7%至錄得税前虧損約人民幣6,098萬元(2016年:稅前利潤約人民幣7,196萬元)。扣税前的純利率由2016年約4.9%減少至2017年約-4.3%。

本年度税前利潤的減少,主要是由於受週期的調整影響,主要是毛利率下滑、研發成本上升和資產減值準備增加。本集團對國內運營商的銷售是先借貨、然後後收到銷售合同時確認銷售收入的商業模式,這亦是國內運營商採購通信設備及部件的商業慣例。本集團過去對國內運營商有一些發出商品的存貨,主要是2G天線的備件。由於5G即將來臨,本集團預計2G天線的使用會大幅減少,2G的發出商品可實現價值將有可能顯著降低,因此提取減值準備增加。

本集團相信這些調整不會影響本集團在行業 中的競爭能力和長期盈利能力,並對未來的 業績充滿信心。

### 管理層討論及分析

#### **Taxation**

Current income tax expenses decreased by approximately 96.6% from approximately RMB12.61 million in 2016 to approximately RMB0.426 million in 2017. Effective tax rates calculated from the tax charged to the profit before taxation of the Group were approximately 0.7% and 17.5% for 2017 and 2016, respectively.

#### Profit for the year

Profit for the year 2017 decreased by approximately 173.7% to a loss of approximately RMB48.51 million (2016: a profit for the year of approximately RMB65.85 million). The Group's net profit margin was approximately -3.4% in 2017, compared to approximately 4.5% in 2016. The decrease in our net profit margin was mainly due to the decrease in revenue and the increase in administrative expenses, research and development costs and provision for asset impairment.

#### Relationships with equipment manufacturers, operators and suppliers

The Group mainly sells antenna products and RF subsystem products to telecommunication equipment manufacturer customers (such as ZTE) who builds complete networks for delivery to telecommunication operators (such as China Mobile), thus enabling the Group to establish close and stable relations with equipment manufacturers.

The Group is also one of the few domestic technology providers offering RF solutions to both global and domestic telecommunication operators (such as China Mobile, China Unicom and China Telecom) and telecommunication equipment manufacturers (such as ZTE and Nokia), which enables the Company to maintain a leading edge in product technology and continuous expansion of customer channels, and thus to build close and solid relations with global and domestic telecommunication operators.

Suppliers of the Group include raw material suppliers and contract manufacturers. The Group has developed solid and steady relationships with many of its key suppliers. Given solid and steady relationships with the suppliers, the Group believes that its suppliers generally provide supplies to the Group with a priority and the Group has not experienced any material shortage or delays in receiving supplies or services from the suppliers during the track record period.

#### 税項

當期所得税開支由2016年約人民幣1,261萬元減少約96.6%至2017年約人民幣42.6萬元。本集團於2017年及2016年就稅前利潤計算的實際稅率分別約為0.7%及17.5%。

#### 年內利潤

2017年利潤減少約173.7%至錄得年內虧損約 人民幣4,851萬元(2016年:年內利潤約人民 幣6,585萬元)。本集團於2017年的純利率約 為-3.4%,而2016年約為4.5%。純利率下降 主要是由於銷售收入下降,行政開支、研發 成本以及資產減值準備增加所致。

#### 與設備商、運營商及供應商的關係

本集團主要出售天線產品、射頻子系統產品 給電信設備商客戶(如中興通訊等),其建設 成完整的網路後交付給電信運營商(如中國 移動等),這使本集團與設備商建立了密切 且穩定的關係。

本集團亦是國內少有的能同時為全球及國內電信運營商(如中國移動、中國聯通及中國電信)及電信設備商(如中興通訊、諾基亞等)提供射頻解決方案的技術供應商,這使得本公司始終能保持產品技術的領先和客戶管道的不斷拓展,從而與全球及國內電信運營商建立了密切且穩定的關係。

本集團的供應商包括原材料供貨商及外包生產商。本集團與其多家主要供應商建立了密切且穩定的關係。因與供應商有密切且穩定的關係,本集團相信,本集團供應商一般會優先向本集團供貨,而本集團於往績記錄期間向供貨商收取供應或服務並無經歷任何重大短缺或延誤。

### 管理層討論及分析

#### Principal Risks and Uncertainties

A number of factors may affect the results and business operations of the Group. Major risks and uncertainties are summarised below.

#### Brand/Reputation Risk

The Company has established and maintained its MOBI brand that aims to brand the products of the Group including antenna system, base station RF subsystem and coverage extension solution, primarily targeting leading system equipment manufacturers and telecommunication operators worldwide for provision of its RF solution. If the Group is unsuccessful in promoting its MOBI brand or fails to maintain its brand position and market perception, system equipment manufacturers and telecommunication operators' acceptance of its MOBI brand may erode, and the Group's business, financial condition, results of operations and prospects may be materially and adversely affected.

Any negative publicity or dispute relating to the Group's MOBI brand, products, sponsorship activities or management, the loss of any award or accreditation associated with the Group's MOBI brand or products or the use of the "MOBI" trademark or brand name by other businesses could materially and adversely affect the Group's business, financial condition, results of operations and prospects.

#### Market Trend

The Group's success depends on the market perception and customer acceptance of MOBI brand and the Group's products, which in large part, rely on the Group's ability to anticipate and respond to different market demands in a timely manner.

If the Group is unable to utilise new technologies and processes, anticipate and respond to market and new technology trends and customer preferences in a timely manner, demand for MOBI products may decrease. The Group's business would also suffer if product creations or modifications do not respond to the needs of customers, are not appropriately timed with market opportunities or are not effectively brought to market. Any failure by the Group to offer products that respond to changing market and customer preferences, or any shift in market or new technologies and processes and customer preferences away from MOBI brand and the Group's products, could adversely affect customers' interest in the Group's products.

#### 主要風險及不確定因素

本集團的業績及業務營運受不同因素的影響。主要風險及不確定因素概述如下。

#### 品牌/聲譽風險

本公司已創立及持有其摩比品牌,作為旨在 提供本集團產品包括天線系統、基站射頻子 系統及覆蓋延申方案產品品牌,該品牌主要 鎖定對全球各領先的系統設備商與電信運營 商提供射頻技術解決方案。倘本集團未能成 功推廣其摩比品牌或未能維持其品牌地位及 市場觀感,則系統設備商與電信運營商對本 集團摩比品牌的接受程度或會降低,本集團 的業務、財務狀況、經營業績及前景可能受 到重大不利影響。

有關本集團摩比品牌、產品、贊助活動或管理層的任何負面報導或糾紛、失去與本集團的摩比品牌或產品有關的任何獎項或認證或其他業務所使用的「摩比」商標或品牌,可能會對本集團的業務、財務狀況、經營業績及前景帶來重大不利影響。

#### 市場趨勢

本集團的成功依賴市場對摩比品牌及本集團 產品的觀感與客戶對摩比品牌及本集團產 品的接受程度,這在很大程度上視乎本集團 能否預測不同的市場需求並及時作出回應而 定。

倘本集團未能及時利用新技術及工藝、預測市場、新技術的走勢以及客戶喜好並作出相應配合,則對摩比產品的需求可能會下降。 倘本集團的產品創新或修改未能回應客戶所需、未能適時配合市場機會或未能有效推出市場,本集團的業務亦會蒙受損失。本集團未能提供配合不斷轉變的市場及客戶喜好偏離摩比品牌及本集團產品,均可能令客戶對本集團產品的與趣造成不利影響。

#### Competition

Currently, the Group's antenna system products, base station RF subsystem products and coverage extension solution products face different levels of competition in their respective market sectors. As competitors with similar brand positioning may emerge and intensify the current competition, there can be no assurance that the Group will be able to compete effectively against competitors who may have greater financial resources, greater scales of production, superior technology, better brand recognition and a wider and more diverse distribution network. To compete effectively and maintain the Group's market share, the Group may be forced to, among other actions, reduce prices and increase capital expenditures, which may in turn negatively affect the Group's profit margins, business and financial conditions and results of operations

#### **Environmental Policies and Performance**

The Group's production process is carried out with low emissions and low energy consumption, and it will not produce great amount of pollutants. The Group has been endeavouring to ensure that the production process is in compliance with relevant environmental rules and regulations.

#### 競爭

目前,本集團的天線系統產品、基站射頻子系統產品及覆蓋延伸方案產品在其各自的市場分部面對不同程度的競爭。而具有相似品牌定位的競爭對手可能出現並加劇現有競爭,本集團不能保證可有效地與可能擁有較多財務資源、較大生產規模、較先進的技術、較高品牌知名度、較廣泛及較多元化的競爭對手競爭。為提高競爭效率及維持本集團市場份額,本集團可能被迫(其中包括)減價及增加資本開支,因而或會為本集團的利潤率、業務、財務狀況及經營業績帶來負面影響。

#### 環境政策及表現

本集團的生產過程低排放、低耗能及不會產 生大量污染物。本集團一直致力確保生產過 程中遵守相關環保規則及法規。

In the past, the Group has not been in breach of any relevant environmental rules and regulations and has not been imposed any relevant penalty. It is expected that the future operational activities of the Group would not be affected by the environmental policies. The Group strives for energy conservation and consumption reduction. In reducing the operating costs, the Group also puts efforts in environmental protection.

#### Compliance with Laws and Regulations

The Group's operations are mainly carried out by the Company's subsidiaries in mainland China while the Company itself is listed on the Stock Exchange. The Group's operations accordingly shall comply with relevant laws and regulations in mainland China and Hong Kong. During the year ended 31 December 2017 and up to the date of this report, to the best of our knowledge, the Group has complied with all the relevant laws and regulations in mainland China and Hong Kong, and there was no material breach of or non-compliance with the applicable laws and regulations by the Group.

#### **FUTURE PROSPECTS**

#### **Prospects**

Looking forward, the Group will pay attention to both domestic and international markets simultaneously and will continue to focus on the area of RF technology for wireless communication, especially on base station RF technology and RF technology for other wireless communications.

The Group believes that the popularity of smart terminals has driven the application of mobile internet into a rapid development pace. Pursuant to the Work Report of the Central Government in 2017 suggested "to fully implement the plan for developing strategic emerging industries, accelerate the development of new materials, artificial intelligence, integrated circuits, bio pharmaceuticals, fifth generation mobile communications technology research and transformation, and develop industrial clusters in these fields". It is expected that 5G standard-setting and trial commercial operation will be completed between 2018 and 2020, and will be officially on use since 2020. Certain upgrading opportunities will be provided by 5G, including the demand for the construction of new base station and reconstruction of the roof of existing base station. Due to the non-independent networking standard of 5G at the current stage which requires to share the core network with 4G, the roof of base station will be overlapped on a large scale, bringing a huge demand for reconstruction, which means that the existing the antennas such as GSM, TD-LTE and NB-IoT will be replaced by multi-frequency and multi-system antennas with high technical sophistication. With the Group's leading position in customer channels and 5G technology, the Group is in place to capture early opportunities riding on the development waves of 5G.

In the global arena, the overseas 4G cycle will last much longer than that in China. Although 5G is coming soon, 4G technology will still be the mainstream in the global network construction for a long time in the future. With its leading product technology of overseas multi-frequency system, the Group achieved satisfying breakthroughs in European operators in 2017 particularly its significant improvement in various aspects such as product technology, quality standards and technical process experiences. In future, the Group will further develop the markets of overseas network operators, continuously enter the short lists of multinational and major regional network operators and continue to increase the Group's share in the global market on a long-term basis. It is foreseeable that the global market share of the Group is still extremely small at present, as such, the continuous expansion of the global market will not only push the way up in periodic development for the next few years, but also achieve sustained growth in a longer period.

本集團相信,智慧終端的普及使得移動互聯 網應用已進入高速發展。根據2017年中國 中央政府工作報告:「全面實施戰略性新興 產業發展規劃,加快新材料、人工智慧、積 體電路、生物製藥、第五代移動通信等技術 研發和轉化,做大做強產業集群。」,預計 在2018年至2020年5G將會完成標準和試 商用,從2020年開始正式商用。5G會帶來 若干的機會升級機會,包括新建基站的需 求,以及現存基站的天面改造需求。由於現 階段的5G標準主要是非獨立組網標準,需 要和4G共用核心網,因此基站天面將大規 模重合,從而帶來大量的改造需求,即使用 高技術難度的多頻多系統天線來取代現有的 GSM、TD-LTE及NB-IoT等天線,而本集團 在客戶管道和5G技術方面的領先地位,使 得本集團將在5G的發展浪潮中佔得先機。

就全球而言,4G週期長度將遠長於中國國內。儘管5G即將到來,但在未來很長已時間內,4G技術仍將佔據全球網路建設的主流。本集團的海外多頻系統產品技術的領先,特別是2017年在歐洲運營商的領人,特別是2017年在歐洲運營商的領際,在未來,產品技術、品質水準與工藝經驗等面,都得到了顯著的提升。在未來,斷進一步拓展海外運營商市場,不長期以主要運營商的短名單,本集團當前在全球的市場份可以推動未來,持續拓展全球市場,不僅可以推動未來,持續拓展全球市場,不僅可以推動未來,與軍力以在更長的時間內實現持續增長。

#### Customers

The Group adheres to the visionary target of "becoming a global leading provider of RF technology for mobile communications", and strives to offer its RF solution to leading system equipment manufacturers and telecommunication operators around the world.

The Group is also one of the few domestic technology providers offering RF solutions to both global system equipment manufacturers and telecommunication operators, which enables the Group to maintain a leading edge in product technology and continuous expansion of customer channels.

In 2017, successfully completed structural adjustments in the domestic operator market, the Group experienced a substantial increase in sales to China Telecom and obtained a leading share in China Mobile's procurement tender while still maintaining powerful cooperation with China Unicom. As such, in 2018, the Group will maintain the dominant position in the implementation of projects by Chinese operators including low-band refarming and NB-loT, as well as China Unicom's procurement of 900M antenna.

#### 客戶方面

本集團堅持「成為全球一流的移動通信射頻 技術供應商」的願景目標,致力於為全球各 領先的系統設備商與電信運營商提供射頻技 術解決方案。

本集團亦是國內少有的能同時為全球系統設 備商與電信運營商提供射頻解決方案的技術 供應商,這使得本集團始終能保持產品技術 的領先和客戶管道的不斷拓展。

2017年,本集團在國內運營商市場中已經順利完成結構調整,對中國電信的銷售收入大幅上升,並且在中國移動的採購招標中獲得領先份額。與此同時,仍然保持與中國聯通的強力合作。因此,本集團在2018年中國運營商的低頻重耕、NB-IoT等專案的執行落地,以及中國聯通的900M天線採購中,都將保持優勢的位置。

In terms of domestic equipment manufacturers, the Group still possess advantage as a leading supplier with its leading competitiveness in aspects such as product technologies and customer communications.

As for international equipment manufacturers, in 2017, the Group recorded an overall increase in sales of antenna and RF subsystem products to Nokia, representing over 40% in overall growth rate. Meanwhile, the Group also obtained the supplier qualification of Ericsson's global radio frequency subsystem products in 2017. It is believed that the Company will make a promising business performance regarding international equipment manufacturers in 2018.

After years of efforts, the Group believes it will embrace a window for golden opportunities in direct sales to international operators. In 2017, the Group's revenue of direct sales to international operators significantly increased by nearly 60% as compared to the previous year, which was recognized by many European customers. The Group believes that the direct sales growth in international operators will become another strong driving force for the business growth of the Group in the next few years.

#### **Products**

5G is approaching closer. Pursuant to the Work Report of the Central Government in 2017, it is expected that 5G standard-setting and trial commercial operation will be completed between 2018 and 2020, and will be officially on use since 2020. Certain upgrading opportunities will be provided by 5G, including the demand for the construction of new base station and reconstruction of the roof of existing base station. These will contribute to the increasing demand for high-end antennas, including TD-LTE multifrequency and multi-system antennas. The Group believes that the technical threshold of advanced high-end antennas can be favourable for the Group's competition, while with the increasing complicated 5G radio frequency subsystems, the Group has received some demands from customers. In general, the Group believes that by virtue of the Group's leading position in technologies of 5G antennas and radio frequency subsystems, the Group is in place to capture early opportunities riding on the network construction of 5G.

在國內設備商方面,本集團仍然擁有主力供 應商的優勢,在產品技術、客戶溝通等方面 擁有領先競爭力。

在國際設備商方面,2017年本集團對諾基亞的天線及射頻子系統產品全面錄得增長,整體更是增長了超過40%。與此同時,2017年本集團還獲得愛立信的全球射頻子系統產品供應商資格。相信本公司在2018年對國際設備商的業務表現值得期待。

經過多年努力,本集團相信對國際運營商的 直銷迎來黃金機會窗。在2017年,本集團對 國際運營商直銷的收入較上年大幅上升了接 近60%,得到了眾多歐洲客戶的認可。本集 團相信國際運營商的直銷增長會成為未來幾 年內本集團業務增長的又一強勁動力。

#### 產品方面

5G已日益走近。根據2017年中國中央政府工作報告,預計在2018年至2020年5G將會完成標準和試商用,從2020年開始正式商用。5G會帶來若干的機會升級機會,包括新建基站的需求,以及現存基站的天面改造需求。這都將帶來對高端天線的需求增加,包括TD-LTE的多頻多系統天線。本集團相信,前沿高端天線的技術門檻對本集團的競爭有利。與此同時,5G的射頻子系統也將更複雜,本集團已經接到客戶的若干需求。綜合而言,本集團相信本集團在5G的天線與射頻子系統技術方面處於國內行業的領先位置,能夠在5G的網路建設中佔得先機。

Globally, the overseas 4G cycle will last much longer than that in China. Although 5G is coming soon, 4G technology will still be the mainstream in the global network construction for a long time in the future. Further technology upgrading of multi-frequency and multi-system antennas will be provided by overseas LTE network construction and multi-network stations, getting closer to limit design. The Group has been accumulating experience for many years in the technology of multi-frequency and multi-system antennas, the Group believes, which enables the Group to accomplish the upgrading of antenna development platform with its capability, catering for the ever-evolving demand for international operators.

For coverage extension products, the Group obtained leading shares in the centralized procurement tender of aesthetic antenna for China Mobile and China Telecom in 2017, while the Group will step up efforts in promoting the delivery under contract of aesthetic antenna and achieving a positive growth in business in 2018.

#### Conclusion

The Group is one of the few one-stop solution providers of RF technology for global network operators and system equipment manufacturers in the PRC, capitalizing on a wide range of well-known customers and diversified income sources positive for its healthy and stable growth.

The Group believes that the telecommunication equipment industry is expected to see another growth cycle as the 4G network continues to develop over the next few years. The Group and the Board will continue to optimise the size and mix of customer base and adopt differentiated competition strategies underpinned by technology and cost advantages to maximise the market opportunities in 3G, LTE and next generation wireless technologies, thus enhancing Group's overall competitiveness to ensure robust business performance and create more value for shareholders and the society.

#### 總結

本集團是國內少數能為全球運營商與系統設備商提供一站式解決方案的射頻技術供應商,擁有廣泛的知名客戶和多元化的收入來源,這有利於本公司保持積極而穩定的增長。

本集團相信,未來幾年隨著4G建設的不斷發展,電信設備行業有望迎來新的一輪增長週期。本集團與董事會將繼續推行客戶規模與結構的優化以及技術領先、成本領先的差異化競爭策略,最大化3G、LTE與下一代無線技術的市場機會,提升本集團的綜合競爭力,實現集團業績的穩健發展,創造價值回饋股東和社會。

#### CAPITAL STRUCTURE, LIQUIDITY AND FINANCIAL RESOURCES

We have funded our operations and capital requirements from cash generated from our operations, trade credit from our suppliers and short-term bank borrowings. Our primary uses of cash have been for our increased working capital needs, capital expenditures on purchases of production equipment and acquisition of land use rights for our real properties in Shenzhen, Ji'an and Xi'an in the PRC.

As at 31 December 2017, the Group had net current assets of approximately RMB649.26 million (2016: approximately RMB842.98 million) including inventories of approximately RMB413.38 million (2016: approximately RMB340.20 million), trade receivables and notes receivable of approximately RMB905.57 million (2016: approximately RMB872.33 million) and trade payables and notes payable of approximately RMB720.69 million (2016: approximately RMB538.12 million).

#### 資本結構、流動資金及財務資源

本集團已從業務、供應商提供的貿易信貸及 短期銀行借款所產生的現金支付本集團營運 及資本需求。本集團的現金主要用作滿足本 集團更大的營運資金需求、購買生產設備所 需資本開支及收購本集團在中國深圳、吉安 和西安的房地產的土地使用權。

於2017年12月31日,本集團有淨流動資產約人民幣6.4926億元(2016年:約人民幣8.4298億元),包括存貨約人民幣4.1338億元(2016年:約人民幣3.4020億元)、應收貿賬款及應收票據約人民幣9.0557億元(2016年:約人民幣8.7233億元)以及應付貿易賬款及應付票據約人民幣7.2069億元(2016年:約人民幣5.3812億元)。

The Group maintained effective management of its working capital. For the year ended 31 December 2017, average inventories turnover, average receivables turnover and average payables turnover are approximately 117 days (2016: 116 days), 228 days (2016: 225 days) and 195 days (2016: 192 days) respectively. We offer credit terms generally accepted in the antenna and base station RF subsystem manufacturing industry to our trade customers. In general, the average credit period for local network operators is longer than global network operators and solution providers.

As at 31 December 2017, the Group recorded a pledged bank balance of approximately RMB166.66 million (2016: approximately RMB124.61 million), cash and bank balances of approximately RMB190.46 million (2016: approximately RMB291.48 million) and recorded bank borrowings of approximately RMB287.46 million (2016: approximately RMB256.27 million). The current ratio (current assets divided by current liabilities) decreased from approximately 1.98 times as at 31 December 2016 to approximately 1.56 times as at 31 December 2017. The gearing ratio (bank borrowings divided by total assets) was approximately 12.2% as at 31 December 2017 as compared with a gearing ratio of approximately 11.7% as at 31 December 2016. The interest rates on the Group's bank borrowings are designated as fixed rates or floating rates based on prevailing market rates.

The Board is of the opinion that the Group has a solid and stable financial position and adequate resources to satisfy necessary operating capital requirements and foreseeable capital expenditures.

於2017年12月31日,本集團錄得已抵押銀行結餘約人民幣1.6666億元(2016年:約人民幣1.2461億元)、現金及銀行結餘約人民幣1.9046億元(2016年:約人民幣2.9148億元),並錄得銀行借款約人民幣2.8746億元(2016年:約人民幣2.5627億元)。流動比率(流動資產除流動負債)由2016年12月31日的約1.98倍下降至2017年12月31日約1.56倍。2017年12月31日的槓杆比率(銀行貸款除以總資產)約為12.2%,而2016年12月31日的槓杆比率為約11.7%。本集團銀行借款指定按固定利率及因應當時市場水準浮動的利率計息。

董事會認為本集團財務狀況穩固,財務資源 足以應付必要的經營資金需求及可預見的資 本開支。

#### FOREIGN EXCHANGE EXPOSURE

RMB is the functional currency of the Group. Currencies other than RMB expose the Group to foreign currency risk. We have foreign currency sales and purchases and certain trade receivables and bank balances are denominated in USD, Euro, CHF and HKD. We currently do not have a foreign currency hedging policy. However, the management monitors and will consider hedging of foreign currency exposure when the need arises.

#### **EMPLOYEES AND REMUNERATION POLICIES**

As at 31 December 2017, the Group had approximately 3,901 staff. The total staff costs amounted to approximately RMB349.94 million for the year ended 2017. The remuneration of the Group's employees is determined on the basis of their responsibilities and industry practices. Regular training is provided to improve the skills and expertise of relevant staff. The Group also grants share options and discretionary bonuses to eligible staff based on their performance.

#### **CHARGE ON ASSETS**

As at 31 December 2017, bank balances of approximately RMB166.66 million and note receivables of approximately RMB70.66 million were mainly pledged to bank to secure the bills payables and bank loans of the Group.

#### **CONTINGENT LIABILITIES**

As at 31 December 2017, the Group did not have any significant contingent liabilities.

# PURCHASE, REDEMPTION OR SALE OF LISTED SECURITIES OF THE COMPANY

During 2017, a total amount of 295,000 shares of the Company had been repurchased at prices ranging from HK\$1.15 per share to HK\$1.19 per share by the Company via Stock Exchange. The Company had subsequently cancelled all these shares repurchased during the year. Save as mentioned above, neither the Company nor the Company or any of its subsidiaries had purchased or sold any of the Company's listed securities during the current year.

#### **Board Meetings**

The Board conducts meetings on a regular basis and on an ad hoc basis, as warranted by business needs. During the year ended 31 December 2017, four Board meetings, two audit committee (the "Audit Committee") meetings, one remuneration committee (the "Remuneration Committee") meeting and one nomination committee (the "Nomination Committee") meeting were convened. Details of attendance of Board meetings of each of the members of the Board are set out in "Attendance of Individual Directors at Meetings" below.

Notices for regular Board meetings are given to each Director at least 14 days prior to the meeting, whereby the Directors can put forward his proposed items into the agenda. The agenda and the relevant Board papers are then circulated to the Directors not less than 3 days before a Board meeting in order to enable the Directors to make an informed decisions. For other Board meetings, reasonable notices are given.

#### Independent Non-Executive Directors

During the year ended 31 December 2017, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors with one of them possessing appropriate professional qualifications or accounting or related financial management expertise.

The Company has received an annual confirmation of independence from each of the independent non-executive Directors. The Company is of the view that all the independent non-executive Directors meet the guidelines for assessing independence as set out in Rule 3.13 of the Listing Rules and considers them to be independent.

#### Chairman and Chief Executive Officer

As at the date of this report, Hu Xiang is both the chairman of the Board and chief executive officer of the Company, responsible for the leadership and effective running of the Board to formulate overall strategies and business development directions for the Group and for the daily management of the business of the Group, implementation of the policies, business objectives and plans set by the Board and is accountable to the Board for the overall operation of the Group.

#### Code Provision A.2.1

This code provision stipulates that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. Currently, Mr. Hu Xiang is both the Chairman and chief executive officer of the Company. Mr. Hu is one of the founders of the Group and has extensive experience in the telecommunication industry. Given the current stage of development of our Group, the Board believes that vesting the two roles in the same person provides our Company with strong and consistent leadership and facilitates the implementation and execution of our Group's business strategies. We shall nevertheless review the structure from time to time in light of the prevailing circumstances.

#### Non-Executive Directors

The term of appointment of all the non-executive and independent non-executive Directors of the Company is three years. Under the Company's Articles of Association, one-third of all Directors (whether executive or non-executive) is subject to retirement by rotation and re-election at each annual general meeting provided that every Director shall be subject to retirement at least once every three years.

#### REMUNERATION OF DIRECTORS

The Board established the Remuneration Committee with specific written terms of reference which deal clearly with its authority and responsibilities. The Remuneration Committee comprises all the independent non-executive Director, namely Li Tianshu, Zhang Han and Li Guinian and one non-executive Director, namely Qu Deqian. The Remuneration Committee is chaired by Li Tianshu.

The Remuneration Committee is responsible for assisting the Board in achieving its objective of attracting and retaining Directors and senior management of the highest caliber and experience needed to develop the Group's business successfully. #### **AUDITORS' REMUNERATION**

Deloitte Touche Tohmatsu, Certified Public Accountants ("Deloitte"), the external auditors of the Company, were responsible for providing services in connection with the audit of the financial statements of the Group for the year ended 31 December 2017.

For the year ended 31 December 2017, the total remuneration in respect of audit services provided by Deloitte for the Group amounted to approximately RMB2.55 million.

The Audit Committee recommended to the Board (which endorsed the view) that, subject to shareholders' approval at the forthcoming AGM, Deloitte be re-appointed as the external auditors of the Company for 2018.

#### FINANCIAL REPORTING

The Board aims to present a comprehensive, balanced and understandable assessment of the Group's performance, position and prospects. The management provides such explanations and information to enable the Board to make an informed assessment of the matters put before the Board for approval.

The Directors acknowledge their responsibilities for preparing the financial statements of the Group and for ensuring that the financial statements are prepared in accordance with applicable statutory requirements and accounting standards.

The Group has announced its annual results in a timely manner within the limits of three months after the end of the financial period, as laid down in the Listing Rules.

#### RISK MANAGEMENT AND INTERNAL CONTROL

The main objectives of the Group's risk management and internal control systems are to provide a clear governance structure, policies and procedures, as well as reporting mechanism to facilitate the Group in managing risks across its business operations.

The Group has established a risk management framework, which consists of the Board of Directors, the Audit Committee and the Risk Management Taskforce. The Board of Directors determines the nature and extent of risks that shall be taken in achieving the Group's strategic objectives, and has overall responsibility for monitoring the design, implementation and effectiveness of the Group's risk management and internal control systems.

The Group has formulated and adopted a Risk Management Policy for providing direction in identifying, evaluating and managing significant risks on at least an annual basis, the Risk Management Taskforce identifies risks that would adversely affect the achievement of the Group's objectives, and assesses and prioritizes the identified risks according to a set of standard criteria. Risk mitigation plans are established and risk owners are then assigned for the management of those risks considered to be significant.

In addition, the Group has established an internal audit function to assist the Board of Directors and the Audit Committee with ongoing monitoring of the risk management and internal control systems of the Group. Deficiencies in the design and implementation of internal controls are identified and recommendations are proposed for their remediation. Significant internal control deficiencies are reported to the Audit Committee and the Board of Directors on a timely basis to ensure that they are promptly addressed.

Risk management and internal control reports are submitted to the Audit Committee and the Board of Directors at least once a year. The Board of Directors performs an annual review of the effectiveness of the Group's risk management and internal control systems including, but not limited to, changes in the nature and extent of significant risks after the review in the prior year, the Group's ability to cope with its business transformation and changing external environment; the scope and quality of the management's ongoing monitoring of risks and internal control systems; results of internal audit work; the extent and frequency of communication of the results of monitoring of risk management and internal control systems to the Board of Directors; significant failures or weaknesses identified and their related implications; and the effectiveness of the Group's processes for financial reporting and Listing Rules compliance. Following its review for the year ended 31 December 2017, the Board of Directors considers the Group's risk management and internal control systems are effective.

The risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

# PROCEDURES AND INTERNAL CONTROLS FOR THE HANDLING AND DISSEMINATION OF INSIDE INFORMATION

The Board has established an Inside Information Policy for the handling and dissemination of Inside Information. The Group complies with requirements of the Securities & Futures Ordinance ("SFO") and the Listing Rules. It discloses inside information to the public as soon as reasonably practicable unless the information falls within any of the Safe Harbours, as provided in the SFO. Before information is fully disclosed to the public, the Group ensures it is kept strictly confidential. If the Group believes that the necessary degree of confidentiality cannot be maintained or that confidentiality may have been breached, the Group would immediately disclose the information to the public. The Group is committed to ensuring that information contained in announcements is not false or misleading as to material fact, or omission of material fact, and to presenting information in a clear and balanced way, including through equal disclosure of both positive and negative information.

#### SHAREHOLDERS' RIGHTS

As one of the measures to safeguard shareholders' interests and rights, separate resolutions are proposed at general meetings on each substantial issue, including the election of individual Directors for shareholders' consideration and voting.

Resolutions put forward at our shareholders' meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of our Company and of the Stock Exchange after each shareholders' meeting.

An extraordinary general meeting may also be convened on the written requisition of any one member of the Company which is a recognised clearing house (or its nominee(s)) deposited at the principal office of the Company in Hong Kong or, in the event the Company ceases to have such a principal office, the registered office specifying the objects of the meeting and signed by the requisitionist, provided that such requisitionist held as at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company which carries the right of voting at general meetings of the Company. If the Board does not within 21 days from the date of deposit of the requisition proceed duly to convene the meeting to be held within a further 30 Days, the requisitionist(s) themselves or any of them representing more than one-half of the total voting rights of all of them, may convene an extraordinary general meeting in the same manner, as nearly as possible, as that in which meetings may be convened by the Board provided that any meeting so convened shall not be held after the expiration of three months from the date of deposit of the requisition, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to them by the Company.

We are one of the few one-stop providers of wireless communication antennas and base station Radio Frequency ("RF") subsystems in China. Our business consists of the design, manufacture, marketing and sale of antennas, base station RF subsystem and solutions that are the required components of mobile communication coverage systems, including, wireless access systems (WiFi and PHS), 2G (GSM and CDMA), 3G (TD-SCDMA, CDMA 2000, W-CDMA and WiMax), 4G (TD-LTE and FDD-LTE), 5G, MIMO antennas, satellite communication and microwave transmission networks.

本公司的所有管理人員均是環境、健康和安全第一理念的傳播人,並身體力行實現其理念,所有員工均需遵守公司的安全規範和制度。員工是公司的最重要財富,每個員工對公司作出的貢獻都具有獨特性和增值性。公司鼓勵、認可和獎勵員工對本公司的環境、安全、健康業績的積極貢獻。

The Company hires, manages and assigns, employees in accordance with the provisions of the Labor Law to pay the salaries of employees at standards higher than local minimum wages and complies with the provisions of the Labor Law on working hours, overtime compensation and remuneration. We strictly prohibit the recruitment of child labor.

The Company undertakes not to use any form of forced or involuntary labor and does not require employees to pay a "deposit" or hand in identification documents at the beginning of their employment.

The Company has appointed a senior management representative to be responsible for the health and safety of all employees, and has formed the Safety Production Committee which is responsible for ensuring and achieving safe production on the part of the Company. The Company has established an occupational health and safety mechanism to effectively identify sources of danger and to reduce and prevent potential threats to employees' health and safety through hazard assessment, preventive measures and emergency response mechanisms.

The Company is committed to providing a safe, clean, healthy and productive working environment for all employees by providing necessary drinking water, medical and sanitation facilities, fire safety and proper ventilation. The Company will also take necessary measures to minimize possible hazards in the workplace in order to avoid work-related accidents and health hazards.

The Company regularly reviews health and safety conditions in the workplace, canteens and dormitories, and makes constant improvements based on issues identified.

The Company provides training for all employees on health and safety, energy conservation, environmental protection and various management systems and standards. It also provides induction training for new staff, and retraining for transferring staff.

The Company has formed a trade union which helps its members to safeguard their legitimate rights and interests and assists with solving any special difficulties they have. The Company respects the freedom of all employees to participate in the trade union, and collective bargaining as well as their freedom of association.

本公司承諾為全體員工提供一個安全、清潔、健康和有生產力的工作環境,提供必要的飲用水、醫療和衛生設施、消防安全及適當的通風條件。本公司亦會採取必要的措施,在可能條件下最大限度地降低工作環境中的危害隱患,以避免在工作中發生與工作有關的事故對健康的危害。

本公司定期對工作場地、食堂和宿舍的健康 及安全情況予以重點檢查,對發現的問題進 行持續改進。

本公司對所有員工進行健康與安全培訓,節約能源保護環境的培訓以及各項管理制度和標準的培訓。此外,本公司亦對新晉員工進行入職培訓,對調換崗位員工重新進行培訓。

本公司組建了工會。工會幫助會員維護自身的合法權益,協助解決工會會員特殊困難。 本公司尊重所有員工自由參加工會、集體談 判和結社自由之權利。

The Company is strictly prohibited from engaging in or supporting matters based on race, ethnicity, social hierarchy, nationality, religion, physical disability, gender, age, sexual orientation, trade union membership or political discrimination in matters relating to the appointment, remuneration, welfare, training opportunities, promotion, discipline, dismissal or retirement.

The Company fully respects the personal religious beliefs and ethnic customs of employees. We prohibit any personal discrimination and infringement of rights. The Company does not interfere with the rights of employees to observe their religious beliefs and customs.

The Company respects and treats every employee impartially. It prohibits compulsive, abusive or exploitative acts of intrusion in the form of gesture, language and physical contact. The Company does not engage in or support corporal punishment, mental or physical persecution and verbal humiliation.

The Company actively takes measures against extortion and bribery or any form of corruption.

The Company promotes fair and orderly competition and prohibits unfair competition.

In assessing and shortlisting suppliers, the Company considers the ability of suppliers to meet the requirements of this policy and prioritizes them on the basis of their ability to meet the requirements.

If necessary, the Company may provide information and communicate with stakeholders on, including but not limited to, the results of its management reviews and audits. The Company may provide stakeholders with reasonable information and access to information for them to determine whether the Company fulfills its social responsibility and ethical commitments. If there is any doubt as to whether the Company fulfills its obligation on social responsibility and ethical commitments, the Company will conduct timely investigations before handling and responding to related enquiries. If any employee presents a question as to whether the Company complies with the requirements of those provisions, the Company will not penalize, dismiss or discriminate against the employee for it. If any violation of corporate social responsibility and ethical commitments is found, the Company will take appropriate remedial measures and correctible actions against in accordance with the severity of its nature.

The Company engages third parties to conduct annual tracking and auditing of the relevant management system to ensure that it complies with relevant management system requirements and standards. In recent years, the Company has also received more surveys on the environment, safety and health, carbon emissions, conflict minerals from key customers, to which the Company has given positive feedback. The Company has not received any complaints and penalties from government, third parties and customers in these respects.

DEVOTION TO ENVIRONMENTAL PROTECTION

The Company persists in operating its business in an environmentally responsible manner and adheres to the concept of sustainable development by taking various measures to reduce the environmental impact arising from its production and business activities with an aim of achieving harmonious coexistence with society, the environment and its stakeholders. The concept of innovation and environmental consciousness have also been infiltrated into our entire product life cycle and all business processes from research and development, production, logistics to customer service. We spare no effort in reducing energy consumption, resource consumption and carbon dioxide emissions.

The Company has been monitoring and managing our emissions for many years. In recent years, we have also begun to monitor greenhouse gas emissions and energy consumption. We hope to strike a balance between business growth and environmental protection by improving our business operations and practice, and encouraging employees to work in an environmentally responsible manner in the workplace.

The Company complies with the EU RoHS and China RoHS-related Directive. We conduct comprehensive management of hazardous substances from product design, procurement, production to delivery, to avoid the use of prohibited substances, and to ensure that the volume of restricted substances is within relevant restricted ranges. The Company also provides declarations of hazardous substances and the content of substances for customers that require them. Where necessary, the Company may also provide inspection reports from third parties on the composition of substances to customers as required.

The Company complies with the EU WEEE Directive and adopts ecological product design with full consideration of recyclability of products, generalized design and the most economical design principle, to satisfy the recovery rate and the recycling rate of products and to minimize the environmental impact on the product life cycle from the source.

公司每年都會請第三方機構對相關管理體系 進行年度跟蹤及稽核,以確認公司遵循相關 管理體系要求和規範的符合性。近年來,公 司也越來越多接到來自重點客戶就環安衛、 碳排放、衝突礦方面的客戶調查,公司均進 行了積極的回饋。本公司沒有接到過政府、 第三方和客戶在這些方面的投訴和處罰。

### 推進環境保護

本公司堅持透過對環境負責的方式經營業務,堅持貫徹可持續發展理念,並採取各種措施以減少生產及業務活動對環境可能造成的影響,實現社會、環境及利益相關者的和諧共生。我們將創新和綠色理念貫穿到整個產品生命週期以及研發、生產、物流、客戶服務等全過程,為實現降低能耗、資源消耗和二氧化碳排放努力不懈。

本公司多年來持續對排放物進行監控和管理,近年來也嘗試開始監控溫室氣體排放量和能源消耗,我們希望通過改善營運實踐,取得業務增長和環境保護之間的平衡,鼓勵員工在工作場所中採取對環境負責的行為。

公司遵從歐盟RoHS及中國RoHS有關等指令,從產品設計、採購、生產、交付等環節進行全流程有害物質管理,避免使用禁用物質,並確保限用物質含量在規定範圍內。對於有需要的客戶,公司會向客戶提供有害物質保證聲明以及物質成分表資料。於必要時,公司亦可按照要求向客戶提供物質成分第三方機構檢測報告。

公司遵從歐盟WEEE指令,在產品設計階段採用生態化設計理念,充分考慮產品的可回收設計、通用化設計和最省化設計原則,滿足產品的可回收率和再利用率要求,從源頭上將產品全生命週期中對環境的影響降低到最低。

In general, the Group's production process and business nature enable low-emission, low-energy consumption and low pollutant generation. We are committed to operating our entire business in compliance with relevant environmental laws and regulations. The Group has not violated any relevant environmental regulations and has yet to be subject to any related penalty.

#### **EMISSIONS**

The Company focuses on the waste management arising from its operating process.

The Company mainly adopts mechanical processing, assembly and testing for its production and does not discharge industrial wastewater.

The Company's domestic wastewater mainly comes from the drainage of office washrooms and water from its kitchen. There is no discharge of toxic, hazardous or special substances. For oily waste water produced from cleaning canteen kitchens, solid waste is first filtered through cleaning tank filters. Preliminary filtered kitchen wastewater will flow towards a three-stage grease trap, where major pollutants are removed during grease treatment before being discharged into the municipal sewage pipe network. Toilet sewage will go through septic tank treatment in the industrial area, and will be discharged through the local municipal sewage pipe network.

Industrial air emissions arising from the production process of the Company mainly come from residual lead-free solder exhaust, which is collected from exhaust gas collection devices installed in the workshops and led to the top floor of the workshops through pipelines to achieve high-altitude emissions. Meanwhile, we continue to improve the ventilation of our workshops. The emission of exhaust gases after treatment meet the "air pollutant emission limit" standards and produces little impact on the surrounding environment.

The noise sources of the Company include certain production equipment, such as the CNC punch press, stamping equipment, die-casting equipment, air conditioning units, air compressors, cooling towers, fans, pumps and other ancillary power equipment. With reasonable layout of the workshops and routine regular equipment maintenance, the noise generated in the production process meets the "Standard of Boundary Noise of Industrial Enterprise" and has limited impact on the surrounding environment.

總體而言,本集團的生產過程和業務性質屬 於低排放、低耗能和低污染物產生。我們承 諾整個業務運行遵循相關環保法律及法規。 本集團未曾違反任何相關環保法規,也未遭 受過任何相關的處罰。

### 排放物

本公司注重營運過程中產生的廢棄物的管理。

本公司生產以機加工、組裝和測試為主,生 產過程中不產生工業廢水。

本公司生活廢水主要來源於辦公衛生間排水和廚房的生活用水,並無有毒、有害或特殊物質排放;對於食堂廚房清洗產生的含油廢水,首先需經過清洗池濾網過濾掉固體雜物,經初步過濾的廚房廢水集中流向三級隔油池,經過隔油處理去除主要污染物後再排入市政污水管網。衛生間生活污水經工業區化糞池處理後,通過當地市政污水管網排放處理。

本公司生產過程中的工業廢氣主要是極少量的無鉛焊錫廢氣,通過車間內部設置的廢氣收集裝置,收集後通過管道引致車間外頂樓實現高空排放,同時加強車間通排風,處理後外排的廢氣可達到《大氣污染無排放限值》標準,對周圍環境影響不大。

本公司噪音源包括一些生產設備,如數控衝床、衝壓設備、壓鑄設備以及空調機組、空壓機、冷卻塔、風機、水泵等輔助動力設備。生產過程中產生的噪音,基於車間的合理佈局和日常定期的設備維護保養,廠界噪音能夠滿足《工業企業廠界環境雜訊排放標準》,對周圍環境影響較小。

The solid waste produced by the Company includes general industrial solid waste, domestic waste and hazardous waste. Among these, the general industrial solid waste mainly comprises of production packaging materials, metal scrap, lead-free slag and plastic scrap, which are sold to relevant external parties after collection by category, for recycling treatment. Household waste is handled by environmental and health departments after collection by category. Residual hazardous waste produced during the production process mainly comprises of oily rags, oily gloves and waste oil, the volume of which falls below the minimum requirements for transport, and so are regularly delivered to external parties with relevant qualifications in hazardous waste disposal for collective treatment.

In addition, through continuous improvement of our production process, including the gradual shift to semi-automatic or fully automated production methods, the Company strives to enhance production capacity and reduce labor input to increase production efficiency, while improving staff training and management to improve operating performance, consummating and standardizing the management system of the Company, vigorously promoting clean production, and actively pursuing energy-saving measures by using environmentally friendly materials and improving the utilization of raw materials. We always use recyclable packaging materials (consumed total of 2,678 tons in 2017) to reduce pollutant emissions and achieve advanced circular economic standard.

The Company's statistics on waste in 2017 are as follows:

- I. Industrial wastewater: none
- Domestic sewage: 215,752 tons discharged through the local municipal sewage pipe network
- 3. Lead-free solder exhaust: traces without significant environmental impact
- 4. Factory noise: in compliance with regional environmental standards

本公司產生的固體廢棄物包括一般工業固廢、生活垃圾和危險廢棄物。其中,一般工業固廢主要是一些生產包裝材料、金屬邊角料、無鉛錫渣及塑膠邊角料等。這些一般固廢經分類收集後,均出售給外部相關單位,由其回收處理利用;生活垃圾經分類收集後,均出售給外部相關單位,生,交由環衛部門清運處理;生產過程中發生的少量危險廢棄物主要是含油廢抹布、含油廢手套、廢機油等,這些廢棄物處理資質的外部機構統一進行處理。

除此之外,公司還會通過持續的生產工藝改進,包括逐步採用半自動化或全自動化生產方式等,提高產品產量,減少勞動力投入,增加生產效率,同時加強員工培訓和管理,提高員工操作水準,完善和規範公司管理制度,大力推行清潔生產,積極推行優化節能措施,選用環保材料及增加原料的利用率,儘量使用可回收利用的包裝材料(2017年度總消耗量2,678噸),減少污染物排放,達成迴圈經濟先進水準。

General solid waste (recyclable): 141.34 tons, due to the expansion of production lines in Ji'an Plant (newly added RF assembly workshop) and the increase in the production of Computer Numerical Control (CNC) in Xi'an Plant, increased waste aluminum scrap and disposal of more idle equipment and scrap, representing an increase as compared with 2016.
- 6. Household waste: 521.2 tons, due to the increase of personnel in the three places, the amount of household waste increased compared with that in 2016.
- 7. Hazardous waste: 4.96 tons

The Company consumed total electricity of 12,724,338 KWh in 2017, which was equivalent to approximately 11,684.76 tons of indirect carbon emissions (carbon dioxide (CO2) equivalent); 64,650 liters of liquefied gas, 54,376 liters of gasoline and 321,585 liters of diesel oil, which were equivalent to 458.88 tons of direct carbon emissions (carbon dioxide (CO2) equivalent).

(Note: As the Company's products have different statistical units and processing procedures, the disclosure of density values is not yet applicable. The Company is improving internal statistics, indicators and calculation methods and plans to disclose more scientific and rational density information starting from next year.)

#### USE OF RESOURCES: ENERGY, WATER AND OTHER RAW MATERIALS

The main raw materials consumed in the Company's production are aluminum, copper, steel, plastic, PCB boards and others. At the product level, we focus on the efficient use of resources. In the product development stage, we conduct rigorous design and assessment to assure product features and performance while using a variety of materials in the most frugal manner by the use of environmentally friendly and recyclable or reusable materials. This not only ensures that costs can be controlled, but also reduces the consumption of resources. We promote clean production and strengthen equipment maintenance while improving energy efficiency.

In our daily office operations, we advocate the concept of energy-saving. Through regular self-examinations, inspection and reporting, we enhance the awareness and capability of our staff in energy-saving and reducing emissions. We advocate a paperless office to reduce the use of paper, and always reuse recyclable wastepaper such as paper for printing and copying.

### 資源使用:能源、水及其它原材料

本公司生產所消耗的主要原材料為鋁材、 銅材、鋼材、塑膠及PCB板材等。在產品層 面,我們注重資源的有效使用,在產品開發 階段,我們通過嚴格的設計和評審,確保在 滿足產品功能和性能的同時最節儉地利用各 種材料,使用環保的可回收或再利用的材 料,既保證成本的受控,亦同時減少了資源 的消耗。我們宣導清潔生產,加強設備維護 保養,提高能源使用效率。

日常辦公活動中,宣傳節能降耗資訊,通過 定期自查自糾和檢查通報等方式,提升員工 節能減排意識和能力。推廣無紙化辦公,以 減少紙張的使用,對於回收的廢棄紙張,如 列印和複印用紙,進行回收利用。

The Company attaches great importance to energy conservation, and puts great effort into the promotion of environmental protection and energy conservation policies and measures implemented. For example, we make full use of natural light when the weather is bright. We always choose energy-saving products when purchasing lamps and electrical appliances. We switch off idle lights, computers and electrical appliances. Our air conditioning is generally set at room temperature of above 26 degrees. We conduct timely maintenance of air conditioners to ensure their good operation. We use video conferencing systems to reduce business travel. We also post some energy-saving tips on our intranet to remind employees to practice energy-saving ideas.

Water in the Company comes from the city water supply system. It is mainly used as domestic water in our offices. Our production process does not involve industrial water and therefore does not have a serious adverse impact on rivers, lakes and underground water. We develop and refine water-saving management system with the use of a water saving faucet, to ensure that the concept of water-saving is implemented in practice.

Achieving the efficient use of resources not only requires a sound management system, and implementation of relevant policies, but also the cooperation and support of staff. The Company strives to create a corporate culture that treasures resources, enhances employee awareness of environmental issues, and encourages employees to participate in environmental protection and fulfill our environmental commitments.

The major energy and resources consumed by the Company are electricity, water, paper, natural gas, gasoline and diesel. The following table shows the use of energy resources for 2017 and 2016:

公司用水取自城市供水系統,主要用途為辦公生活用水,在生產過程中並不涉及工業用水環節,因此不會對陸上的河流、湖泊、地下水造成嚴重影響。我們制定和完善節水管理制度,使用節水型水龍頭等,確保節水理念確切實行。

有效使用資源,不僅需要完善的管理制度, 相關政策的落實更有賴於員工的配合和支 持。本公司努力營造珍惜資源的企業文化, 提高員工的環保意識,鼓勵員工積極參與和 實踐環保承諾。

本公司日常消耗的主要能源和資源為電力、水、紙張、天然氣和汽油柴油。下表列示 2017年度和2016年度的能源資源使用情況:

Among which the consumption of electricity, water, liquefied gas, motor gasoline and diesel in 2017 increased over that in 2016, mainly due to: 1) a 35.41% increase in personnel; 2) a 6.91% increase in shipments of various types of antennas/RF products, a 27.21% increase in shipments of cables and the increased difficulty in antenna processing; 3) newly built RF assembly plants in Ji'an, additional office area for research institute in Xi'an; 4) new purchase of a truck and a commercial vehicle; 5) dining frequency increased from three meals a day to four meals a day (an additional dining time at 20:30). As the Company's products have different statistical units and processing procedures, the disclosure of density values is not yet applicable. The Company is improving internal statistics, indicators and calculation methods and plans to disclose more scientific and rational density information starting from next year. Shipments of various products in 2017 and 2016 are as follows:

#### **CONFLICT MINERALS**

Since late 1990s, most of the minerals mining in the Democratic Republic of the Congo and its neighboring countries and territories has contributed to local armed conflicts, leading to long-term instability in the region and creating serious human rights and environmental problems. Since 2012, the US Securities and Exchange Commission has required all securities issuers whose production processes involve the use of four types of minerals, namely tantalum, tin, tungsten and gold, to disclose their mineral sources. These four types of conflict minerals are widely used in the information and communications technology products manufacturing industry. The Company takes the initiative to refrain from using minerals from conflict-affected and other high-risk areas and conducts surveys on conflict minerals every year in cooperation with clients. The Company has signed Conflict Minerals Agreements with a total of 236 related suppliers of which 45 were newly-added in 2017, and has undertaken not to procure and use metal minerals from conflict-affected or high-risk areas.

#### **ESTABLISHMENT OF A TEAM OF EXCELLENCE**

The Company is committed to creating a good working environment for its employees. We attach great importance to the value of fine caliber, carry out eclectic selection of high-quality talent and make good use of their talents. We mainly recruit through oncampus and general recruitment. Our recruitment procedure is open, fair and reasonable. The Company has established a serious of standardized human resources recruitment and training programmes and systems, which has been strictly implemented. In 2016, the Company set up the MOBI Academy to provide educational training and training functions for all levels of the Company, providing valuable seminars to support and strengthen the knowledge and skills of employees for the benefit of their career development and promotion. The Company provides competitive remuneration and its working hours policy complies with relevant national policies and regulations. We also provide various types of paid leave, as required by the government, and do not allow any inequality or discrimination in respect of job opportunities and other aspects.

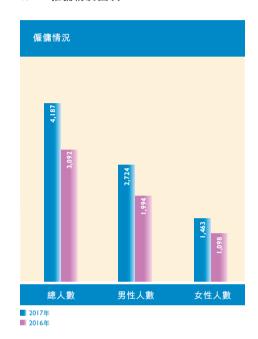

#### **HEALTH AND SAFETY**

The Company established an occupational health and safety management system which was recognized by the OHSAS18001. The day-to-day operation of the Company follows national laws and regulations and its health and safety policy and regulations ensure a safe and healthy working environment to protect the physical and mental health and safety of our employees.

- Staff health examination: the Company provides staff health examinations on an annual basis. Funded by the Company, all staff are entitled to physical health checks at medical institutions where medical reports as well as health advice will be provided.
- Occupational Disease Inspections: The Company conducts occupational disease inspections on annual basis for employees identified with potential exposure to minimize the risks. In 2017, a total of 208 employees have been arranged for occupational disease inspections.
- Work injury data: In 2017, zero work-related fatalities, one minor work-related injury with a loss of 987 working hours were recorded.
- 4. Health and safety manual: The Company has provided a health and safety pocket manual for every employee to enable employees systematically understand the Company's health and safety concepts, strategies, measures and safety guidelines. Through illustrations and descriptions, employees can have better understanding of the right and wrong for risk prevention, and can therefore reduce the occurrence of health and safety accidents.

#### **Product Liability**

The Company emphasizes the management of product liability. During the product development stage, we carry out stringent implementation of product management, not only to identify product features and performance requirements, but also to identify the demand in environment, safety, reliability and other aspects for the products. We strictly adhere to the industry and international standards to meet customer and legal requirements in all respects. During production and delivery, in accordance with the processes and standards developed by the Company, we carry out product checks and tests at all stages from stocking, manufacturing to product delivery to ensure the safety of products delivered. In 2017, the Company did not receive any product returns due to product health and safety problems and customer satisfaction reached 89.44%. The Company has implemented an intellectual property policy, documenting procedures and systems over the years to regulate the management and operation of the Company's intellectual property rights. At the end of 2017, the Company had applied for 508 patents, with 424 patents being granted. No patent infringement incidents occurred in 2017. The Company also established a product recall system, and there were no product recalls due to product quality and safety issues in 2017. In accordance with customer requirements, the Company will sign business framework agreements on mutual cooperation with its customers to ensure that confidential information of both sides will not be disclosed. In 2017, the Company did not receive any complaints or litigation caused by leakage of customer information and confidential data. The Company has established a corresponding customer complaint and handling procedure to regulate the follow-up of customer complaints and product returns or exchange; In addition, the Company will maintain product liability insurance for customers' products in response to their individual requirements.

#### COMPLIANCE IN OPERATION

#### Compliance with laws and regulations

It is the basic principle of the Company to carry out operational compliance by abiding by business ethics and observing the laws and regulations of China and other countries where the Group operates. The Company is committed to ethical management and legal compliance in operations. We practice "zero tolerance" of any violation of laws and regulations, and any breaches of business ethics. We carry out compliance in operations in a proactive, effective and scientific manner, and are willing to work with global customers, suppliers and other business partners to achieve sustainable development.

The business of the Company is mainly carried out by its subsidiaries in Mainland China, and it is listed on the Hong Kong Stock Exchange. The operations of the Company strictly comply with relevant laws and regulations of Mainland China and Hong Kong. During the Reporting Period, to the best of our knowledge, there was no serious breach or noncompliance with relevant laws and regulations.

The Directors present their annual report and the audited consolidated financial statements for the year ended 31 December 2017.

#### CORPORATE REORGANISATION

The Company was incorporated with limited liability in the Cayman Islands on 16 December 2002.

The shares of the Company were listed on the Stock Exchange on 17 December 2009.

#### PRINCIPAL ACTIVITIES

The principal activity of the Company is investment holding. The principal activities of the subsidiaries comprise the research, development, manufacture and sale of antenna system, base station radio frequency subsystem and products of coverage extension solution. There were no significant changes in the nature of the Group's principal activities during the year.

#### **BUSINESS REVIEW**

A business review as required by Schedule 5 to the Hong Kong Companies Ordinance, including a discussion of the principal risks and uncertainties facing the Group and an indication of likely future developments in the Group's business, can be found in the Management Discussion and Analysis set out on pages 10 to 30 of this annual report. #### **RESULTS AND APPROPRIATIONS**

As stipulated by the relevant laws and regulations for foreign investment enterprises in the People's Republic of China (the "PRC"), the Company's PRC subsidiaries are required to maintain two statutory reserves, being an enterprise expansion fund and a statutory surplus reserve fund which are non-distributable. Appropriations to such reserves are made out of net profit after taxation reported in the statutory financial statements of the PRC subsidiaries while the amounts and allocation basis are decided by their respective boards of directors annually. The statutory surplus reserve fund can be used to make up their prior year losses, if any, and can be applied in conversion into capital by means of capitalisation issue. The enterprise expansion fund is used for expanding the capital base of the PRC subsidiaries by means of capitalisation issue.

Under the Companies Law of the Cayman Islands (2009 Revision), the share premium of the Company may be applied for redemption or purchase of any shares of the Company, payment of distributions or dividends to shareholders provided that immediately following the date on which the distribution or dividend is proposed to be paid, payment of its debts as they fall due in the ordinary course of business. During the year ended 31 December 2017 and 2016, dividends were funded out of its share premium.

Special reserve represents the difference between the paid-in capital of 摩比天線技術 (深圳)有限公司MOBI Antenna Technologies (Shenzhen) Co., Ltd. ("MOBI Shenzhen"), a subsidiary of the Company, and the nominal value of the Company's shares issued in connection with the acquisition of MOBI Shenzhen. MOBI Shenzhen was acquired pursuant to the group restructuring completed on 19 December 2002, at which time the Company entered into an equity transfer agreement for the acquisition of the entire equity interest in MOBI Shenzhen.

#### I. GENERAL

MOBI Development Co., Ltd. (the "Company") is a public limited company incorporated in the Cayman Island and its shares are listed on The Stock Exchange of Hong Kong Limited ("Stock Exchange") on 17 December 2009. The address of its registered office is Maples Corporate Services Limited P.O. Box 309, Ugland House, Grand Cayman KYI-1104, Cayman Islands and its principal place of business is 7 Langshan First Road Science and Technology Park, Nanshan District, Shenzhen, Guangdong Province, the PRC.

The consolidated financial statements are presented in Renminbi ("RMB"), which is the same as the functional currency of the Company and its principal subsidiaries.

The principal activities of the Company and its subsidiaries (the "Group") are production and sale of antennas and radio frequency subsystems.

In general, the directors of the Company anticipate that the application of the expected credit loss model of HKFRS 9 will result in earlier provision of credit losses which are not yet incurred in relation to the Group's financial assets measured at amortised costs and other items that subject to the impairment provisions upon application of HKFRS 9 by the Group.

Based on the assessment by the directors of the Company, if the expected credit loss model were to be applied by the Group, the accumulated amount of impairment loss to be recognised by Group as at I January 2018 would be increased as compared to the accumulated amount recognised under HKAS 39 mainly attributable to expected credit losses provision on trade and other receivables. Such further impairment recognised under expected credit loss model would reduce the opening retained earnings and increase the deferred tax assets at I January 2018.

#### HKFRS 15 Revenue from Contracts with Customers

HKFRS 15 was issued which establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. HKFRS 15 will supersede the current revenue recognition guidance including HKAS 18 *Revenue*, HKAS 11 *Construction Contracts* and the related interpretations when it becomes effective.

The core principle of HKFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the standard introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer.
- Step 2: Identify the performance obligations in the contract.
- Step 3: Determine the transaction price.
- Step 4: Allocate the transaction price to the performance obligations in the contract.
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation.

Under HKFRS 15, an entity recognises revenue when (or as) a performance obligation is satisfied, i.e. when 'control' of the goods or services underlying the particular performance obligation is transferred to the customer. Far more prescriptive guidance has been added in HKFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by HKFRS 15.

In 2016, the HKICPA issued Clarifications to HKFRS 15 in relation to the identification of performance obligations, principal versus agent considerations, as well as licensing application guidance.

The directors of the Company anticipate that the application of HKFRS 15 may result in more disclosures, however, the directors of the Company do not anticipate that the application of HKFRS 15 will have a material impact on the timing and amounts of revenue recognised in the respective reporting periods.

#### HKFRS 16 Leases

HKFRS 16 introduces a comprehensive model for the identification of lease arrangements and accounting treatments for both lessors and lessees. HKFRS 16 will supersede HKAS 17 *Leases* and the related interpretations when it becomes effective.

HKFRS 16 distinguishes lease and service contracts on the basis of whether an identified asset is controlled by a customer. Distinctions of operating leases and finance leases are removed for lessee accounting, and is replaced by a model where a right-of-use asset and a corresponding liability have to be recognised for all leases by lessees, except for short-term leases and leases of low value assets.

The right-of-use asset is initially measured at cost and subsequently measured at cost (subject to certain exceptions) less accumulated depreciation and impairment losses, adjusted for any remeasurement of the lease liability. The lease liability is initially measured at the present value of the lease payments that are not paid at that date. Subsequently, the lease liability is adjusted for interest and lease payments, as well as the impact of lease modifications, amongst others. For the classification of cash flows, the Group currently presents upfront prepaid lease payments as investing cash flows in relation to leasehold lands for owned use while other operating lease payments are presented as operating cash flows. Upon application of HKFRS 16, lease payments in relation to lease liability will be allocated into a principal and an interest portion which will be presented as financing cash flows by the Group.

Under HKAS 17, the Group has already recognised an asset and a related finance lease liability for finance lease arrangement and prepaid lease payments for leasehold lands where the Group is a lessee. The application of HKFRS 16 may result in potential changes in classification of these assets depending on whether the Group presents right-of-use assets separately or within the same line item at which the corresponding underlying assets would be presented if they were owned.

In contrast to lessee accounting, HKFRS 16 substantially carries forward the lessor accounting requirements in HKAS 17, and continues to require a lessor to classify a lease either as an operating lease or a finance lease.

Furthermore, extensive disclosures are required by HKFRS 16.

As at 31 December 2017, the Group has non-cancellable operating lease commitments of RMB7,639,000 as disclosed in note 26. A preliminary assessment indicates that these arrangements will meet the definition of a lease upon application of HKFRS 16, the Group will recognise a right-of-use asset and a corresponding liability in respect of all these leases unless they qualify for low value or short-term leases.

In addition, the Group currently considers received refundable rental deposits paid of RMB450,000 and refundable rental deposits received of RMB434,000 as rights and obligations under leases to which HKAS 17 applies. Based on the definition of lease payments under HKFRS 16, such deposits are not payments relating to the right to use the underlying assets, accordingly, the carrying amounts of such deposits may be adjusted to amortised cost and such adjustments are considered as additional lease payments. Adjustments to refundable rental deposits paid would be included in the carrying amount of right-of-use assets. Adjustments to refundable rental deposits received would be considered as advance lease payments.

Furthermore, the application of new requirements may result in changes in measurement, presentation and disclosure as indicated above.

Except as described above, the directors of the Company consider that the application of the other new and revised HKFRSs is unlikely to have a material impact on the Group's consolidated financial statements.

#### 3. SIGNIFICANT ACCOUNTING POLICIES

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules") and by the Hong Kong Companies Ordinance ("CO").

The consolidated financial statements have been prepared on the historical cost basis at the end of reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKAS 17 Leases, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

In addition, for financial reporting purposes, fair value measurements are categorised into Level I, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level I inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

#### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

#### Investments in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. Changes in net assets of the associates other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

An investment in an associate is accounted for using the equity method from the date on which the investee becomes an associate.

The requirements of HKAS 39 are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in an associate. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When a group entity transacts with an associate of the Group, profits and losses resulting from the transactions with the associate are recognised in the Group's consolidated financial statements only to the extent of interests in the associate that are not related to the Group.

#### Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Revenue is reduced for estimated customers returns, rebates, and other similar allowance.

Revenue is recognised when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the Group and when specific criteria have been met for each of the Group's activities, as described below.

Revenue from the sale of goods, including sale of antenna system, base station RF subsystem and coverage extensive solution, is recognised when the goods are delivered and titles have passed.

The Group's accounting policy for recognition of revenue from operating leases is described in the accounting policy for leasing below.

#### Property, plant and equipment

Property, plant and equipment including buildings held for use in the production or supply of goods or services, or for administrative purposes (other than construction in progress as described below) are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Construction in progress for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include professional fees and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Such construction in progress are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Depreciation is recognised so as to write off the cost of assets other than construction in progress less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### Leasehold land and building

When the Group makes payments for a property interest which includes both leasehold land and building elements, the Group assesses the classification of each element separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group, unless it is clear that both elements are operating leases in which case the entire property is accounted as an operating lease. Specifically, the entire consideration (including any lump-sum upfront payments) are allocated between the leasehold land and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element at initial recognition.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "prepaid lease payments" in the consolidated statement of financial position and is amortised over the lease term on a straight-line basis. When the payments cannot be allocated reliably between the leasehold land and building elements, the entire property is generally classified as if the leasehold land is under finance lease.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. Share option scheme

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date.

The fair value of the equity-settled share-based payments determined at the grant date without taking into consideration all non-market vesting conditions is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity (share option reserve).

At the end of each reporting period, the Group revises its estimate of the number of equity instruments expected to vest based on assessment of all relevant non-market vesting conditions. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to the share option reserve.

When share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained earnings.

#### Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before tax as reported in the consolidated statement of profit or loss and other comprehensive income because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

#### 税項

#### Taxation (Cont'd)

Deferred tax is recognised on temporary differences between the carrying amount of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Current and deferred tax are recognised in profit or loss, except when they relates to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

#### Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

#### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

#### Retirement benefits costs

Payments to state-managed retirement benefit schemes which are classified as defined contribution plans are recognised as an expense when employees have rendered service entitling them to the contributions.

#### Short-term and other long-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

Liabilities recognised in respect of other long-term employee benefits are measured at the present value of the estimated future cash outflows expected to be made by the Group in respect of services provided by employees up to the reporting date. Any changes in the liabilities' carrying amounts resulting from service cost, interest and remeasurements are recognised in profit or loss except to the extent that another HKFRS requires or permits their inclusion in the cost of an asset.

#### Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

#### The Group as lessee

Operating lease payments are recognised as an expense on a straight-line basis over the lease term.

## The Group as lessor

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset.

#### 4. KEY SOURCES OF ESTIMATION UNCERTAINTIES

In the application of the Group's accounting policies, which are described in note 3, the directors of the Company are required to make judgments, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The followings are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

#### Write down of inventories

The Group writes down inventories based on an assessment of the net realisable value of inventories. Allowance is applied to inventories where events or changes in circumstances indicate that the net realisable value is lower than the cost of inventories. The identification of obsolete inventories requires the use of judgment and estimates on the conditions and usefulness of the inventories. The management may consider the aging analysis, technology development of the industry, net realisable value for obsolete and slow-moving inventories that are no longer suitable for use in operation and subsequent sales or usage. Where the actual outcome or expectation of the net realisable value of inventories is different from the original estimate, such difference will impact the carrying value of inventories and write-down for inventories in the period in which such estimate has changed. The carrying amount of inventories at 31 December 2017 was RMB413,384,000, net of write down of RMB69,005,000 (2016: RMB340,202,000 (net of write down of RMB19,768,000)).

#### 存貨撇減

本集團以存貨可變現淨值的評估為基 準撇減存貨。倘有事件或環境變化顯 示存貨的可變現淨值低於成本,則須 對存貨計提撥備。陳舊存貨的識別 須對存貨的狀況及是否可用作出判 斷及估計。管理層可能考慮賬齡分析 及行業技術發展以及不適合作經營 及後續銷售或使用的陳舊及滯銷存 貨的可變現淨值。倘存貨可變現淨 值的實際結果或預期與原先估計不 同,有關差額將影響有關估計出現變 動的期間內的存貨及存貨撇減賬面 值。於2017年12月31日,存貨的賬 面值為人民幣413,384,000元(扣除撇 減人民幣69,005,000元)(2016年:人 民幣 340,202,000元(扣除撇減人民幣 19.768.000元))。

#### Estimated allowance for doubtful debts

The Group makes allowance for doubtful debts based on an assessment of the recoverability of trade receivables. Allowance is applied to trade receivables where events or changes in circumstances indicate that the balances may not be collectible. The identification of doubtful receivables requires the management's judgment and estimation of future cash flows. The management may consider the credit history including default or delay in settlement, subsequent settlements, ageing analysis of the trade receivables and financial position of debtors. Where the actual outcome or expectation of the recoverability of trade receivables is different from the original estimate, such difference will impact the carrying value of trade receivables and allowance for doubtful debts in the period in which such estimate has changed. As at 31 December 2017, the carrying amount of trade receivables was RMB485,929,000 (net of allowance of RMB11,660,000) (2016: carrying amount of RMB454,648,000 (net of allowance of RMB5,628,000)).

#### Income taxes

As at 31 December 2017, a deferred tax asset of RMB17,994,000 (2016: RMB6,622,000) in relation to unused tax losses has been recognised in the Group's consolidated statement of financial position. No deferred tax asset has been recognised on the tax losses of RMB10,323,000 (2016: RMB4,270,000) due to the unpredictability of future profit streams. The realisability of the deferred tax asset mainly depends on whether sufficient future profits or taxable temporary differences will be available in the future. In cases where the actual future taxable profits generated are less or more than expected, or change in facts and circumstances which result in revision of future taxable profits estimation, a material reversal or further recognition of deferred tax assets may arise, which would be recognised in profit or loss for the period in which such a reversal or further recognition takes place.

#### 所得税

於2017年12月31日, 有關未動用 税項虧損的遞延税項資產為人民 幣 17,994,000元(2016年: 人民幣 6,622,000元) 已於本集團綜合財務 狀況表中確認。由於無法預知未來 溢利來源,故並無就稅項虧損人民 幣 10.323.000元(2016年: 人民幣 4,270,000 元) 確認遞延税項資產。遞延 税項資產的變現主要有賴於是否有足 夠未來溢利或應課税暫時差額將來可 供利用而定。倘若產生之實際未來應 課税溢利少或多於預期,或事實及情 況的變動造成未來應課税溢利之估計 修訂,則可能產生遞延税項資產的重 大撥回或進一步確認, 而有關數額將 於有關撥回或進一步確認產生期間在 損益內確認。

Development costs on antenna system (LTE antennas and Multi-system Antennas) and base station RF subsystem (LTE filters and new models dedicated for some customers) are internally generated and amortised on a straight-line basis over the 3 years when they are ready for use. Included in the development costs of approximately RMB33.7 million (2016: RMB27.0 million) were relating to development of systems not ready for the intended use and, accordingly, no amortisation was made. The developments of systems not ready for the intended use are expected to generate net cash flow to the Group, and no impairment loss has been recognised.

At 31 December 2017 and 2016, the Group conducted a review of those Group's intangible assets, which are not ready for the intended use.

The recoverable amount is determined from value in use calculations. The key assumptions for the value in use calculations are those regarding the discount rates, the new products' growth rates and expected changes to selling prices and direct costs during the period that cash flow forecasts are made. The management estimates discount rates using pre-tax rates that reflect current market assessments of the time value of money and the risks specific to the intangible assets. The growth rates are based on industry growth forecasts. Changes in selling prices and direct costs are based on past experience and expectations of future changes in the market.

For impairment purpose, the Group prepared cash flow forecasts based on financial budgets approved by the management covering a 3-years period, taking into account the anticipation of further expansion of 3G, 4G and 5G market in which the intangible assets are developed for.

As at the end of the reporting period, any reasonably possible change to key assumptions applied are not likely to cause the recoverable amounts to be below the carrying amount of intangible assets.

The Group offers credit terms generally accepted in the antenna system, base station RF subsystem and coverage extension solution manufacturing industry to its trade customers, which range from 30 to 240 days (2016: 30 to 240 days), for a significant number of the Company's products. For the Group's major customers which are network operators and domestic and overseas wireless network solution providers with good reputation and repayment records, a longer credit term may be extended to them, depending on price, the size of the contract, credibility and reputation of them. Amounts due from these major customers as at 31 December 2017 amounted to approximately RMB389,913,000 (2016: RMB333,103,000), representing 78.4% (2016: 72.4%) of trade receivables (before making allowance for doubtful debt). In order to manage the credit risks associated with trade receivables effectively, credit limits of customers are evaluated periodically. Before accepting any new customer, the Group conducts research on the creditworthiness of the new customer and assesses the potential customer's credit quality. Trade receivables that are neither past due nor impaired have the high ranking record attributable to their corresponding research on the creditworthiness.

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of bank borrowings, net of cash and cash equivalents and equity attributable to owners of the Company, comprising issued share capital, share premium and other reserves.

The directors of the Company review the capital structure on a semi-annual basis. As a part of this review, the directors consider the cost of capital and the risks associated with each class of capital. Based on recommendation of the directors, the Group will balance its overall capital structure through the payment of dividends, new share issues and share buy-backs as well as raising of new bank loans.

#### Credit risk

The Group's maximum exposure to credit risk in relation to financial assets at the end of the reporting period. The Group's credit risk is primarily attributable to trade receivables and notes and bills receivable. The credit risk on trade receivables and notes and bills receivable are concentrated on top five customers of the Group. In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. The Group reviews the recoverable amount of each individual trade receivable and notes and bills receivable at the end of the reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the directors of the Company consider the Group's credit risk is significantly reduced.

The credit risk of the Group on liquid funds is limited because the majority of the counterparties are international banks and state-owned banks with good reputation.

The Group sells most of the products to a limited number of customers in the PRC. If the Group is unable to broaden the customer base and expand relationships with major wireless network solution providers and major network operators, the business may continue to be impacted by unanticipated demand fluctuations which can have a negative impact on the revenues and business, and an adverse effect on the results of operations and financial condition.

The Group's concentration of credit risk by geographical locations is mainly in Mainland China, which accounted for 72.5% (2016: 87.9%) of the total trade receivables as at 31 December 2017.

As for the year ended 31 December 2017, the Group has concentration of credit risk as 22.4% (2016: 28.3%) and 78.4% (2016: 72.4%) of the total trade receivables was due from the Group's largest customer and the five largest customers respectively. These major customers are network operators and domestic and overseas wireless network solution providers with good reputation and repayment records.

The Group has foreign currency sales and purchases and certain trade receivables, bank balances, trade payables and bank borrowings of the Group are denominated in HKD, USD, Euro ("EUR"), and Swiss franc ("CHF"), currencies other than the functional currency of the Company's principal subsidiaries, which expose the Group to foreign currency risk. The Group currently does not have a foreign currency hedging policy.
