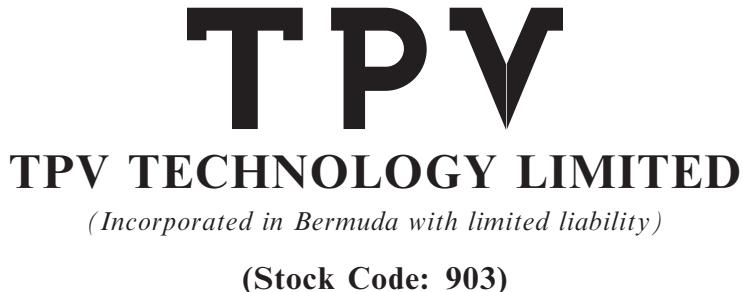

AMENDMENTS TO THE TRADEMARK LICENSING AGREEMENTS
WITH PHILIPS

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

Reference is made to the announcements of the Company dated 30 March 2015 in relation to the MMD TMLA and the announcement of the Company dated 30 December 2016 in relation to TP Vision TMLA.

The Directors are pleased to announce that on 18 May 2018, TPV Europe, TVI HK, the Company and Philips agreed on the following material amendments to the TP Vision TMLA and the MMD TMLA:

(1) TP VISION TMLA

With effect from 1 June 2018, the scope of territory for the TP Vision TMLA has been extended to include India and LATAM. As a result of this amendment, TPV Europe, the Company and Philips agreed to amend (i) the royalty and the guaranteed minimum royalty payable by TPV Europe to Philips under the TP Vision TMLA; and (ii) certain provisions relating to consumer care to cover such additional territories.

(2) MMD TMLA

With effect from 1 April 2018, the scope of IT accessory products for the MMD TMLA has been extended to include Wireless Home Network Solutions. As a result of this amendment, TVI HK, the Company and Philips agreed to amend the royalty and the guaranteed minimum royalty payable by TVI HK under the MMD TMLA.

The parties also agreed to amend certain provisions relating to quality as a result of this amendment.

Save as disclosed in this announcement, there are no other material amendments to the TP Vision TMLA and MMD TMLA and the other terms and conditions of the TP Vision TMLA and MMD TMLA remain the same.

The entering into of these amendments to the TP Vision TMLA and MMD TMLA offer a valuable opportunity for the Group to continue to develop the relevant scope products in the respective territories leveraging its strong sales and distribution channel and to maintain its long term business relationship with Philips.

DEFINITIONS

In this announcement, the following expressions shall have the following meanings unless the context requires otherwise:

“Company”	means TPV Technology Limited.
“Directors”	means the directors of the Company.
“Group”	means the Company and its subsidiaries.
“LATAM”	means Panama, Guatemala, Belize, Honduras, Nicaragua, El Salvador, Costa Rica, Venezuela, Colombia, Ecuador, Peru and Chile.
“MMD TMLA”	means the trademark licence agreement dated 30 March 2015 between TVI HK, the Company and Philips whereby Philips agreed to grant an exclusive right to TVI HK and its affiliates in relation to the use of the Philips trademarks on monitors and public signage products.
“Philips”	means Koninklijke Philips N.V..
“TP Vision”	means TP Vision Holding B.V..
“TPV Europe”	means TPV Europe Holding B.V..

“TP Vision TMLA” means the trademark licence agreement dated 30 December 2016 between TP Vision, the Company and Philips whereby Philips agreed to grant an exclusive right to TP Vision and its affiliates in relation to the use of the Philips trademarks on TVs worldwide, other than the PRC, India, the United States of America, Canada, Mexico and certain South American countries.

“TVI HK” means Top Victory Investments Limited.

“Wireless Home Network Solutions” means (i) wireless (modem) routers; (ii) wireless access point; (iii) wireless bridge; (iv) wireless signal boosters/repeaters/range extenders; (v) wireless dongles/adapters; (vi) accessories for wireless routers; and (vii) power line communication networking devices.
