**APPLICATION FOR RECOGNITION OF  
APPOINTMENT OF JOINT PROVISIONAL LIQUIDATORS  
BY THE HIGH COURT OF HONG KONG**

This announcement is made by Centron Telecom International Holding Limited (the “**Company**”) pursuant to Rule 13.09 and Rule 13.25 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”), and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**SFO**”).

References are made to the Company’s announcement of 29 May 2018 in relation to, among other matters, the filing of the winding-up petition by the Company in the Grand Court of the Cayman Islands and a summons for the appointment of joint provisional liquidators, and the Company’s announcement of 14 June 2018 (the “**Announcement**”) in relation to, among other matters, the appointment of joint provisional liquidators pursuant to the Grand Court Order granted on 12 June 2018, the winding-up petition of the Company having been listed for hearing in the Grand Court on 21 November 2018, and that the powers of management of the Company being retained by the Board following the appointment of the JPLs. Capitalised terms used in this announcement have the same meanings as in the Announcement unless the contexts require the otherwise.

## **APPLICATION FOR RECOGNITION OF APPOINTMENT OF JPLS BY THE HIGH COURT OF HONG KONG**

Following the appointment of the JPLs pursuant to the Grand Court Order, the JPLs filed an application to the High Court of Hong Kong on 22 June 2018 for an order that, among other matters, the Grand Court Order and the appointment of the JPLs be recognised by the High Court of Hong Kong, such that the Grand Court Order be treated in all respect in the same manner as if it has been made, and the JPLs had been appointed, by the High Court of Hong Kong.

As at the date of this announcement, the Company has not yet been informed of the hearing date of the abovementioned application to the High Court of Hong Kong.

Further announcement(s) will be made by the Company in compliance with the Listing Rules and/or the SFO in respect of the above matters.

### **SUSPENSION OF TRADING**

Trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on 3 April 2018 and will continue to suspend until further notice.
