As far as the whole country is concerned, the cement industry saw stable progress in its growth rate, development quality, and people's livelihood indicators, and at the same time forms and constantly perfects the economic policy framework that adapts to the new economic development. West China Cement Limited, as the largest cement producer in Midwest China, will take concrete actions to resolve excess production capacity, actively carry out off-peak production, perform social responsibilities and make due contributions to the sustainable development of the cement industry.

looking up compared with previous years, the development of the cement industry is still facing severe challenges and risks. The overcapacity situation in the industry has not changed. Market synergy cannot completely change the fundamental facts of overcapacity, and the risks of market synergy always exist. With the improvement of the international economic situation, the prices of bulk materials, oil and natural gas continue to rise, which will inevitably lead to the rise of costs in cement production and manufacturing, and freight costs; domestic environmental protection and safety requirements are getting stricter, the government is increasing its efforts in environmental protection, and measures are becoming increasingly strict, which indicates that environmental protection has become an issue that corporates must emphasize in production activities. Due to various other factors, companies must restructure its competitiveness and gradually shift its reliance from costs and prices to technology and quality.

Facing 2018, our company has become fully prepared to remain modest and calm, and carefully analyze the current situation, take the time to take effective measures, focus on innovation and make unremitting efforts to achieve the devel–opment goal of "reshaping Yaobai".

Company profile

West China Cement Limited. (stock code 2233.HK) is a large conglomerate company integrating cement production and sales. The wholly-owned subsidiary, Yaobai Special Cement Group Company Limited is located at No. 336, 4th Shenzhou Road, Aerospace, Chang'an District, Xi' an, Shaanxi Province. The Yaobai Group consists of 33 branches and subsidiaries, distribut-ed in Shaanxi, Xinjiang, and Guizhou.

In order to further adapt to the development trend of internation– alization, enhance the management level of enterprises, and enhance the competitiveness of enterprises, the company was successfully listed on the AIM market of the London Stock Exchange on December 4, 2006 and was listed on Stock Exchange of Hong Kong on August 23, 2010. Since its listing, it has won high recognition from international investors and invest– ment institutions. In May 2012, the company became a strategic partner with world giant Italian Cement Group.

The company's main products include: ordinary portland cements of various strength grades, moderate-heat portland cements of various strength grades, low-temperature portland cement, low-heat slag portland cement, road cement, high (moderate) sulfate resistance portland cement, oil well cement, nuclear

With the construction of the second states of the

power cement, common sulphoaluminate cement, marine sulphoaluminate, and other special cements. At the same time, the company successfully produced calcium aluminate powder for water treatment and fine home improvement gelling agent and various concrete admixtures, etc in 2017. The company has a sound marketing network and a sound after–sales service system. The products are available in the Shaanxi region, Xinjiang Hetian region, Xinjiang Yining region, Guizhou Huaxi region and are widely used in highways, railways, airports, bridges, tunnels, water conservancy, oil wells, gas wells and other national key projects and urban and rural construction markets.

As of the end of 2017, the company had 22 new dry process cement production lines with cement production capacity reaching 30 million tons. The company possessed total assets of RMB 11.7 billion, and employed more than 4450 employees. The total output in 2017 was 19.1 million tons and its main operating revenue was RMB 4.8 billion. The annual growth rate was 28%, and the total annual profit was RMB 730 million. The year-on-year profit increased by 4761%, and the total annual tax payment was RMB 680 million. The value-added rate reached 100%.

In the future, we will continue to deepen the integration and development strategy of the industry chain, take the development of the "Belt and Road" as an opportunity, focus on the development of high–end products, comprehensively promote intelligent manufacturing, green manufacturing, and in–depth integration of resources, and strive to develop into a leader in China's special cement.

The business environment in which the Group is located has improved. Sales in Shaanxi Province remained stable with some growth. Continued low demand in Xi'an City and Guanzhong District caused all manufacturers to intermittently suspend production during the off-season. Sales growth in Xinjiang and Guizhou provinces remained low and recorded a slight increase during the year.

Effective progress of the national supply-side reform, strengthening of reform measures in the inland cement industry and carrying out periodic off-peak production.

Business integrity

We actively nplement the concept of green development put forward at the Fifth Plenary Session of the 18th CPC entral Committee, adhere to the green development road, actively explore energy–saving and environ–nentally–friendly production, living and working methods, comprehensively improve the energy management level of enterprises and commit ourselves to the harmonious coexistence of enterprises and nature to contribute to the development of China.



Environmental management



In 2017, our company continued to increase investment in environmental protection. Direct investment in environmental protection totaled RMB 96.6 million, an increase of RMB 11.6 million compared with 2016. More than RMB 2 million was invested into the production of 17 kiln–head flue gas on–line monitoring equipment for 17 production plants, and invested more than RMB 24 million in the kiln–head and tail dust collector upgrades at the production plants of Shifeng, Fuping, Yaowangshan and Luonan. For the Zhen'an production line, the company invested more than RMB 70 million in the reform of environmental protection standards and invested more than RMB 600,000 to upgrade the denitrification facilities of Pucheng, Shifeng, Fuping, Lantian and Danfeng.

Environmental management system In 2017, our company further strengthened environmental management to control and reduce pollution, improve environmental quality, improve the competitiveness of the industry and ensure the sustainable and healthy development of the company. We have established a leading group for environmental management. The team is responsible for the operation and management of the ISO14001:2004 environmental management system, and has formulated environmental management systems such as the corresponding plans for environmental protection management, implementation, inspection, and improvement. At the same time, we have further improved the "environmental management system" and equipped with full-time environmental management personnel. The company's subordinate units and mines strictly implement the environmental impact assessment and acceptance of the final inspection in accordance with relevant environmental protection laws and regulations, and carry out environmental monitoring on schedule. Each month, the factory conducts a special environmental inspection. Through on-line monitoring of pollution sources, environmental protection facility operation, and unorganized emission control inspections, it ensures the effective implementation of environmental protection policies and the effective operation of the environmental protection system.

Environmental protection publicity and training The company actively participates in and carries out environmental protection activities. In July 2017, we participated in the "Disseminating Green Ideas, Send You Books on Environmental Protection" event organized by Shaanxi Provincial Ecological Civilization Construction Promotion Association and the Provincial Environmental Protection Publicity and Education Center and won the title of "Environmental Friendly Unit". At the same time, the company continued to strengthen its environmental protection training work. In 2017, it organized three special environmental protection facilities manufacturers for participating personnel. Through WeChat, OA, AM and other electronic platforms, we will conduct periodic learning on environmental protection laws and regulations and environmental protection policies every month and regularly review the study notes of environmental protection management professionals.

Pollutant emission management

In the day-to-day environmental management work, our company focuses on improving the software and improving the hardware and promoting the work of environmental protection through mandatory implementation. In addition, we formulate Emergency Response Plans for Emergency Environmental Accidents and Emergency Response Plans for Heavy Pollution Weather; put Kiln-head online monitoring equipment on line; publicize major pollutant data for public use; implement clean production audit to improve storage and disposal of dangerous wastes and discharge permits certificate legal procedures. On-site governance adheres to the principle of "starting from a small place and managing from details", establishes a dynamic ledger for equipment of the workshop of the cement plant. We build raw material sheds, upgrade Kiln-head electric dust collection and effectively curb the pressure on environment brought about by dusts.

The company has effectively reduced the emission of dust through the technical renovation of the kiln-head and kiln-end dust collectors; through the implementation of denitration spray guns and automated techno-logical innovation in five production plants such as Pucheng, the consumption of nitrogen oxide emissions and ammonia water are effectively reduced.

Application of alternative raw mat

In 2017, our company consumed 2.02 million tons of raw coal and unit raw coal consumption is 107.11kg/Ton. Over the year, power consumption was 116,852KWh and unit production energy consumption was 90.52Kg TCE/ton. Our company actively cooperated with research institutes and business partners to research and sought alternative fuels which can effectively replace coal and electricity. In 2017, our company developed a detailed evaluation system for the use of alternative materials and the use processes and fully considered the impact of the use of alternative materials on quality and comprehensive costs, making it more standardized and meeting product quality and cost requirements so as to form a multi–point breakthrough, multiple alternative situation, registering the total cost savings of RMB 7.76 million through–out the year. Through practice, a total of 450,000 tons of alternative raw materials were used in modified phosphogypsum, fluorinated gypsum, solid wastes from smelters, etc., saving 30,300 tons of standard coal. Through the above measures, it does not only bring direct benefits to the production and operation of enter–prises, but also effectively handles the solid wastes and protects the ecological environment.

Energy management

Our company always adheres to the use of pure low-temperature waste heat recovery power generation technology for cement kilns. Starting with the 9MW generation capacity assembly in 2008, 7.5MW was expanded in 2009, 22.5MW was expanded in 2011, 13.5MW was expanded in 2012, and 17.5MW was expanded in 2013: 5MW was expanded in 2015. There were 11 waste heat power recovery generation units with the total generation capacity of 75MW. In 2017, the two projects added 7.5MW. The project has been completed and is currently under commissioning. It is about to put into operation and expect a total of 13 waste heat power generation projects with the total generation capacity reaching 82.5MW. In 2017, the cement production line generated 338 million kWh of power, achieved economic benefits of RMB 169 million, saved about 134,400 tons of standard coal from the conversion of waste heat into electrical, and reduced emissions of CO2 by approximately 335,600 tons, reduced SO2 of about 10,200 tons and NOx of about 5100 tons.

In order to promote the development of enterprises and improve quality and efficiency, our company takes the lead in adopting a high solid-gas ratio preheating pre-decomposition technology (XDL cement clinker calcining new technology), making full use of the kiln head, grate cooler waste heat and heat discharged from the kiln end preheater as drying heat source for raw material preparation and blast furnace slag grinding system so as to reduce the exhaust gas temperature by 28% and improve thermal efficiency of the system by more than 20%, save heat consumption per kilogram of clinker of 489 kJ and control the coal consumption per tonne of clinker at 140 kilograms. The comprehensive power consumption of clinker does not exceed 55 degrees for three consecutive years. At present, the integrated power consumption of the cement at Hancheng Plant of our group can be controlled within 65 degrees per ton. The energy consumption indicators have reached the advanced value of the national cement industry. While increasing the strength of cement production, the energy consumption is greatly reduced and the overall resource utilization level of the production line is enhanced.

In 2017, the Group successfully launched the on-line energy control data analysis system, which effectively solved the passive situation of incomplete energy control and delayed energy control.



Our company actively responded to the national policy of energy saving and consumption reduction and timely transformed the cement and raw material system of Zhen' an Company with higher energy consumption, and realized that the integrated power consumption of cement decreased by more than 11 degrees. For the high-temperature fans and circulating fans without frequency conversion equipment in Pucheng, Luonan and Lantian production plants, new frequency conversion equipment were installed to maximize energy conservation and consumption reduction. We leveraged on the technical reform and QC topics at the beginning of the year to tap the internal potential of the company and achieve energy conservation and consumption reduction. The comprehensive energy consumption of the company's comparable cement reached 90.52 kce/t. Off-peak production is the national industrial policy. It is an environmental protection action that cement companies take initiative to undertake social responsibilities and is the government's requirement for the industry. At the moment, the peak load production has become an important measure for the cement industry to "decrease overcapacity and increase profitability". Our company dare to assume the responsibility in the supply-side structural reforms, to be a model of honesty and self-discipline and set an example of energy conservation and emission reduction as well as environmental protection. In response to the market demand, production energy consumption and the impact on air quality, our company actively responds to the relevant national policy requirements. According to the State Council's "The off-Peak Requirements of Cement Clinker Plant during the Spring Festival and the Summer Peak Season, the production plants actively carried out limited production of cements in off-peak periods. This measure has laid a good foundation for decreased production capacity, increased efficiency, and has also been 荣誉证书 highly recognized by the industry. Green development

According to the "Overall Planning for Green Engineering of Limestone Mines for Cement in Xiaozhai" and "Overall Design of Eco-environmental Governance for Laoshan Cement Lime Mine". a total of RMB 35 million was invested in 2017 for road hardening and standardized safety vehicles for mines and signage, slope-land planting and anchorage for hanging nets, planting tall shrubs, cutting drainage systems, digital mines, etc. To promote the construction of green mines, the mining industry adheres to the production concept "mining while managing." According to the national of "five-in-one" strategic deployment general requirements, with a high degree of social responsibility, we are actively practicing the "good environment conditions bring benefits" scientific decree put forward by General Secretary Xi. Under the general design of Tianjin Cement Industry Design and Research Institute, we strive to build the first-class non-coal mine recovery model project, and the first limestone mine closed pit recovery and restoration project in China's cement industry. By the end of 2020, the Group strives to achieve 17 limestone mines, all reaching the advanced level of national green mine standards.

The construction of our company's "green mine" project, as a highlight project for the benefit of the people, has established a full-time agency to conduct unified and coordinated management

and clarify management responsibilities. In the process of governance, we took into account the "reasonableness of planting grass trees, the level of planting height, the landscape of different seasons, and the sustainability of ecological construction", and constantly improved the ecological environment protection mechanism and actively carried out environmental protection and governance. We work to create a harmonious environment in which the ecological environment and business operations are in harmony. Considering that the implementation and operation of the project will have a certain degree of influence on the ecological environment such as the soil and mines in the area, the company will include the reclamation of soil and mine re-green into the mid-term development plan for production. Through scientific mining methods, efficient use of resources, and comprehensive standardized management and other methods, we minimize the negative impact on the soil and mines that may be caused by the operation process. In 2017, the company continued to carry out re-greening work for mines such as Pucheng Company, Xunyang Company and Lantian Company, completing the mine's re-greening of 8.63 hectares, an increase of 3.62 hectares of re-greening area compared with that of 2016.

It strictly implements the management of environmental protection "three simultaneous" at different stages of the project, infrastructure, operation, etc., pays attention to soil reclamation and mine re-greening during the construction process and advocates employees to carry out environmental protection public activities, actively protects the environment and strives to build a win-win situation in the rational development and utilization of resources and ecological and environmental protection. The concept of green environmental protection has become an inevitable trend for the long-term development of the Chinese economy and it is also a sign of the Chinese economy entering a new era of development. In recent years. Yaobai Group has attached great importance to the construction of environmental protection of enterprises, and has continued to practice the concept of green environmental protection while building a green corporate image and actively participating in various environmental protection and public welfare activities. For example, at the end of September 2017, it invested heavily in the construction of Yaoshan Ecological Park, carried out trees planting in mines company-wide and invested in building new industrial parks, which fully demonstrated that the company adhered to the concept of sustainable development, attached importance to environmental protection, focused on establishing a green corporate image and seek to become a modern, highly socially responsible company. Under the background of the increasingly stringent environmental protection and environmental protection policies of the cement industry, environmental-friendly, resource-saving, healthy and sustainable development model enterprises will be increasingly favored by the market and more competitive. Based on this understanding, the company invested RMB 20 million to carry out the construction of a garden-style plant at each of the group's plants and raise it to a strategic height to promote and consolidate it.

full economic and social benefits of the company.

Our company advocates green office. The company's leading cadres take the lead and include the following measures: air conditioning temperature is set above 26° C in summer; the office area uses energy-saving lighting and lights out when no one is present; office water is recycled for watering flowers and grasses; collaborative office system are fully used and paperless office is implemented; for daily printed paper, both sides of the paper are used; scientific classification of office waste is applied as the company's garbage is put in classified garbage pool; video conferencing is promoted to reduce staff travel and so on.

The company attaches great importance to the protection of the ecological environment and takes the function of "green mines, harmonious mines, and ecological mines" as its position. It actively promotes clean and environmentally friendly production. The mine must be "exploited both rich or poor, both easy or hard", coupled with low-grade ore. Dumping chaotically in the mine area is strictly prohibited. The comprehensive utilization of resources is implemented under the production policy of "mining while restoration." RMB 10 million and RMB 6 million were respectively input in ecological management of the slopes of Xunyang Company and Lantian Company. The greening pipeline facilities are built to timely re-green exposed slopes. Yaoshan Mine fully exploits the powerful conditions of broad sight and adequate illumination of hillside mining steps and builds photovoltaic power generation to realize the

The company will take the construction of the Yaoshan Ecological Park as a starting point and take the concept of "innovation, coordination, green, openness, and sharing" as its development philosophy. It will persist in building a green ecological cement enterprise and take the responsibility of building green mines, ecological mines, and beautiful mines. With ecological green cycling development, we steadily advance on the road of resource development and ecological environment protection to achieve sustainable development of the company.

Resource recycling

According to the national industrial development policy, "three wastes" comprehensive utilization of "13th Five–Year Plan", local economic development and industrial development trends, and cement industry "three wastes" basic requirements, our company targets at the efficient use of resources and recycling, follows the principle of "minimization, recycling and reclamation", strictly following the requirements of advanced technology, low energy consumption, low pollution, and controlled investment, leverage on economic mode of natural ecological system material recycling and energy flowing pattern to maximize the economic value.

Water resources management

In 2017, we further strengthened the management of water resources, relied on advanced water–saving technologies, comprehensively promoted the use of water–saving appliances, advanced treatment of sewage and other measures, reduced the useless water consumption, and improved the utilization of water resources. The total water consumption in the year was 3.6 million tons, and the unit output value of water consumption was 7.65 cubic meters per ten thousand RMB, a year–on–year decrease of 8.2%. The unit output water consumption was 0.19 liters per ton, a year–on–year decrease of 6.9%.

Equip with production, living and fire water supply systems

The production, living, and fire water supply systems are mainly used for cement production lines, domestic water, firefighting, and supplementary water for the circulatory system; for production lines with waste heat power generation systems, the make-up cooling water of the waste heat power circulating generation system is also supplied from this water supply system. The system can effectively prevent water wasting due to excessive water pressure. As of 2017, the company has applied this system to 11 numbers of production lines.

Promote to use water-saving appliances

Water supply systems use upper and lower level control valves, level gauges, electromagnetic flow meters, water meters, water flow indicators, thermometers, pressure gauges, etc. to facilitate the moni-toring of water usage and water-saving appliances and equipment.

Sewage treatment

The company's cement production plants are equipped with complete sewage treatment equipment and follows the "urban miscellaneous water of urban waste water reuse" (GB/T 18920–2002) standard for the advanced treatment of the sewage generated for the supply plant area greening and sprinkling water on the road. In the whole year of 2017, a total of 1 million tons of sewage have be treated and produced 1 million tons of reclaimed water.

Rainwater recycling

In order to realize the resource utilization of the initial rainwater, our company upgraded the rainwater collection system on the basis of 2016 to recover, treat and use the initial rainwater. Rainwater is used for road sprinkling and greening after precipitation. 15,000 tons of accumulated rainwater was used through–out the year.

Co-disposal of municipal sludg

Our company has formulated a strategic deployment of solid waste disposal. Currently, it is in a critical period of national environmental governance. Enterprises that actively implement the national environmental protection policy will also receive strong support from the government. All types of industrial solid waste, construction waste, and urban waste can be described as the "illnesses" of environmental governance work. It is imperative for the building materials industry to do a good job in the disposal of various solid wastes. The so-called "scientific and technological advancement is the primary productive force" means that relying on advanced technologies is an important measure for promoting environmental protection. Yaobai Group can use technology to achieve high-capacity and low-energy consumption, while using new processes and new technologies to dispose of hazardous waste and turn waste into treasure. produce high value-added products and create a new industry-related circular economy industrial chain. In view of the fact that the construction solid waste dumps generated in the development and construction process in Xi' an and its surrounding areas occupy a large amount of land, our company started the experimental research on urban construction solid waste as early as in 2007. Now it has been applied and promoted in production. It can consume about 100,000 tons of urban construction waste in Xi'an every year. From 2009 to now, the Yaobai Group has absorbed a total of 660,000 tons of urban construction waste in Xi' an, saving a lot of land resources and protecting the ecological environment. From 2014 to 2018, hazardous wastes were co-deployed at Lantian, Fuping and Jixian companies, respectively, and the current annual processing capacity is about 150,000 tons.

For the management of packaging materials, the packaging materials consumed by the company's affiliated companies in 2017 were mainly packaging bags and cartons. The total volume of bagged cement was 8.8234 million tons, and an average of 20 bags per ton of cement were used. Each bag had a weight of 70 grams, and consumed about 12,400 tons of packaging materials. Unit output of packaging materials consumed 0.0014 kg/ton.

In terms of comprehensive utilization of industrial wastes, the company will produce a large amount of industrial waste residues such as desulfurized gypsum, fly ash, wet coal slag, bottom slag, and slag during the production process. These waste slags are non-toxic, but improper treatment will have a negative impact on the environment. In 2017, the company generated 0 tons and 120 tons of hazardous and non-hazardous wastes respectively. In accordance with the principle of "minimization, recycling and reclamation". The company actively absorbs all types of industrial waste that it produces, reduces waste residue to secondary pollution of the environment, and recycles it. In 2017, the company's waste recycling capacity was 1,200,000 tons.

Industrial gas emission control

Industrial waste discharge standards

The company's production plants have two types of discharge standards, among which the Shaanxi Guanzhong region implements special emission limits and achieves annual discharge standards; the southern Shaanxi, Xinjiang, and Guizhou implement national discharge standards and achieve discharges standards throughout the year; in 2017, there were 18 production plants under our company whereby no excessive emissions of related pollutants were reported. The annual NO_x emissions were 7,376.06 tons (emissions per unit of production: 0.50 kg/ton), SO₂ emissions were 809.91 tons (SO₂ emissions per unit of output: 0.06 kg/ton), and dust emissions were 418.75 tons, which was decreased by 1977.94 tons, 52.09 tons, and 325.25 tons respectively compared with that of 2016.

Greenhouse gas emissions

The company has adopted measures such as shifting peak production, increasing production per unit, reducing electricity consumption, and improving the quality of raw coal entering the factory, to control greenhouse gas emissions. In 2017, the company had a total of 9.48 million tons of greenhouse gas CO_2 emissions and a unit output of CO_2 emissions of 0.07 kg/ton of clinker. In view of the high pollution weather in the Guanzhong area of Shaanxi Province, senior management of our company actively participated in the "Hardline Haze Treatment Conference", actively implemented shifting peak production, and strictly implemented specific plans for air pollution environmental management and coal abatement plan.

Operate according to law and strengthen legal management

Our company pays attention to improving the ability to manage the enterprise according to the law, providing legal support services for major decisions at the group level, focusing on strengthening the guidance, coordination, and supervision of major legal disputes at the branch level and enhancing the awareness of legal risk prevention among all employees. At the same time, the company also carried out legal education in order to enhance the legal awareness of all members by holding lectures on legal knowledge and printing "Management Cadres Laws and Regulations Study Manual (2017 Edition)" . In 2017, the company strictly reviewed more than 6,000 different types of contracts, drafted and revised some of the contracts in a timely manner to prevent and resolve potential contractual legal risks, and corrected more than 850 problematic contracts throughout the year.

Strengthen supervision and examination and avoid corporate risks

Being risk-oriented, with internal control as the main line, we continued to carry out comprehensive internal control audits, special audits of business management, and promote the company to improve the level of internal control. In 2017, it carried out various audit activities for 30 times, including 30 internal audits, 215 audit findings, 2 external audits, and 5 audit findings. At the end of the year, the internal audit supervision rectification rate reached 95.00%. The external audit's discovery rectification rate was 100%

Remain targeted and deepen strategic management

Strengthening strategic management can help enterprises correctly evaluate the crisis and opportunities of the external environment and help them obtain long-term competitive advantages. In 2017, based on the domestic and international macroeconomic and cement industry developments and business conditions, our company carried out "institutional adjustments, transformation and upgrades", optimized and adjusted strategic management work, and based on a comprehensive and objective analysis of opportunities and challenges in the development of enterprises, constantly explored the integration of the national strategy of "Belt and Road" and the company's development strategy and business operations and carried out many researches on special cement R&D, financial leasing business, intelligent chemical plant, garden factory construction, ecological park construction and cost control.

In 2017, the company's financial work was carried out on the basis of annual business objectives. the company continued to strengthen financial management by improving comprehensive budget management, strengthening cost control, standardizing asset management, raising basic management standards and conducting financial skill competitions to continue to strengther financial management work, achieve lower cost and higher efficiency and create economic value. In the whole year of 2017, the company achieved cost reduction and efficiency increase of RMB 38 million and direct economic benefits of RMB 26 million.

Anti-commercial bribery

We strictly abide by the relevant provisions of the Law against Unfair Competitions and Interim Provisions on Prohibiting Commercial Bribery in conducting our business activities. In 2017, the Company was not involved in any litigation cases concerning corruption, bribery, blackmailing, frauds and money laundering.

We have always attached great importance to the improvement of independent research and development capabilities. To this end, the company has established a scientific and technological innovation platform consisting mainly of the Institute of Technology and Information of Construction Industry and Technology Centers to comprehensively promote the company's scientific and technological innovation. In terms of scientific and technological innovation management, we set up a scientific and technical committee with Chairman Yaobai as director and executive director to be fully responsible for the overall management of scientific and technological innovation-related matters. In terms of R&D infrastructures, Tianjin Cement Industry Design Institute, the epitome of China's cement industry partnered with us to jointly carry out research on products, technologies and processes. In 2017, our company was invited to participate in the drafting work of GB/T200-2017 "Medium Heat Portland Cement and Geothermal Silicate organized by the China Special Cement Association.

The innovation and development of enterprises cannot be separated from the support of a high-level talent team. West China Cement pays great attention to improving the institutional environment for scientific and technological innovation, focusing on cultivating innovative talents and high-skilled talents. Through the establishment of medium and long-term incentive mechanisms for scientific and technological talents and the cultivation of innovative culture, it continues to accelerate the cultivation and gathering of leading talents in science and technology and strives to build a group of innovation team which are influential in indus-tries and countries.

In 2017, our company continued to increase investment in scientific and technological innovation, raised funds for scientific research through multiple channels, effectively increased the technological content of products and businesses, and obtained two scientific research patents in half a year. In 2017, West China Cement invested RMB 110 million in technological innovation and the conversion rate of innovation results was 98.4%.



Our company pays close attention to product innovation, and strives to develop a series of high-performance professional decorative gelling agents, tile adhesives, ground adhesives and other healthier and pollution-free home improvement materials such as "Yaobai New Materials" to enhance the use of new materials, constantly meet customer needs and establish a good brand image.

Our company has signed a strategic cooperation agreement with the Institute of Building Materials Information to accelerate the advancement of technology research and development in the special cement sector. It is also a key process for achieving

"innovation promotion, development demand, and high-end development". This strategic cooperation is of great significance and plays an important role in the R&D and innovation of our company. Our company will fully utilise its advantages in regional brands, business management, and technological advancement to provide a solid assurance for long-term cooperation between the two parties.

Honor of technological innovation

Through our commitment to various scientific research projects and participation in the formulation of national and industry standards, we are committed to making a contribution to promoting technological progress in the industry. In 2017, our company successfully developed nuclear power cement and successfully developed a new calcium aluminate material for water treatment agent. The successful production of this material on the outside pre-decomposition calciner still ranks the first in the country and is not yet documented in the world.

In 2017, West China Cement Yaowangshan Company obtained the API product certificate of the oil well cement after obtaining the API certification with "Yaobai" oil well cement last year. This is the second time that our company's subordinate units have obtained this honor. The acquisition of this certificate marked a new level in the company's production technology and quality management, and also marked the company's convergence with international standards in fierce market competition. The acquisition of the API system certification not only helped the company improve the level of technology and quality management, but also laid a solid foundation for the company to further broaden the domestic market and participate in international competition.

At the same time, it obtained the comparative certificate of the chemical composition analysis laboratory for oil well cement issued by the National Oil Industry Oil Well Cement and Admixture Quality Supervision and Inspection Center.

Our group won several honors in Shaanxi Province's technological innovation projects. Among them, Fuping Company's "Energy Saving Improvement of Cement Kiln System", "Using Steel Slag to Improve the Burnability of Cement Clinkers," and Shifeng Company's "Application of Gasification Slag in Cement Production Process", Zhenan Company's "Development of Sulfate Resistant Portland Cement" "Production of Class G High-Resistance Oil Well Cement Using Lead-Zinc Tailings", Pucheng Company's "Adjustment of Insertion Depth of Inner Tube of Cement Preheater", Mianxian Company's "Pulverized Coal Rotor Scale Improvement for the Purpose of Stabilizing Production and Reducing Consumption", Yangxian Company' s "Grate Cooler Fan and Waste Heat Reuse Technology to Increase Power Generation", Xixiang Company's "Replacement of Natural Gypsum Using Modified Gypsum as Retarder to Produce Cement" etc. won many honors in the "Shaanxi Yaoshui Cup" technological innovation project. The application of the above-mentioned new technologies is a summary of experience and technical innovation of Yaobai Cement in production and ultimately achieves the goal of energy saving and emission reduction, cost reduction and efficiency increase. The "Application of Gasified Slag in Cement Production Process" of the Shifeng Company was successfully applied to cement ingredients through repeated experiments, replacing part of the coal with gasified slag which occupies large amounts of land and pollute the ecological environment with its own heat. The raw material prepared by gasified slag is

easy to burn, the clinker of which is easier to calcine. The coal consumption per ton is reduced by 9kg. The ultimate goal is to turn waste into treasure, change damage into profits, reduce cement production costs, meet the needs of economic construction, and also meet the need to protect the environment

Our company succeeded in producing wear resistant composite steel plates. With the effective development of this new business, Yaobai Group will gradually bid farewell to the history of externally purchased wear resistant composite steel plates. The company's trial-produced wear-resistant composite steel plates are economical and durable, saving about RMB 450 per square meter compared with similar wear-resistant steel plates. The wear-resistant composite steel plate has the characteristics of high wear resistance, good impact resistance, strong weldability, easy processing, and convenient use. The product is widely used in the stone crusher, conveyor, chute, fan blade and other parts of the cement production equipment. This is the result of the continuous innovation and technological advancement of the Yaobai Group. It specifically shows the performance of effective advancement of steel processing and color steel production of our group.

The independently-developed KS1.0 mine management system was put into trial operation. The main functions include changes in equipment information, daily report of equipment operation, maintenance records of equipment and accessories and other functions. The functions of uploading and downloading photos and exceptions perfect the system. It is of great significance to simplify data reporting, achieve data sharing, strengthen supervision, and increase work efficiency. Yaobai Group was invited to attend the 9th "Belt and Road" China Nuclear Power Frontier Summit Forum. During the development of nuclear power cement, the Yaobai Group used the laboratory to simulate the industrialized intermediate test. The trial production was successful, the production process was simple and the product quality was excellent and a set of mature production technology and cost control experience was summed up to form a set of reasonable, complete and effective technical work instructions. The nuclear power rate, and dry shrinkage, which is suitable for the key links in the construction of nuclear power plants.



Intelligent manufacturing is a deep integration of "two transformations". It is the application of smart products and autonomous and controllable intelligent devices. Safe production

The effective fulfillment of safety responsibilities and the achievement of safe development are the basic prerequisites for ensuring the employees' healthy and happy work, and they also build a solid foundation for achieving sustainable development. For many years, the company has always regarded safety as one of its core ralues, adhered to the principle of "people–oriented, safety first", put staff health and safety as top priority, and continued to promote safe production management. We will carry out safety standardization construction, way attention to safety education and training for all employees, actively carry out various forms of investigation and management of hidden dangers, strive to create a safe production and work environment for all employees, and ensure the safety and physical and mental health of each employee.



Safety production management system

Safety prevention dual mechanism

The company implements the dual prevention mechanism of hidden trouble management and risk classification management, implements the risk management of red, orange, yellow and blue colors in the mines and production lines and implements responsible management personnel; implements group-level, company-level, department-level, workshop-level, and team-level hidden trouble checking and management system, identifies the number of inspections, records hidden dangers, rectification and verification and achieves closed-loop PDCA management.

Safety emergency management mechanism

In 2017, the company revised and improved the safety emergency response plan, which was filed by the safety supervision authority after being reviewed by experts. In order to strengthen the emergency handling capacity and methods of all employees for safety accidents, the cadres were trained to respond quickly and calmly to various safety emergencies and reduce the risk of safety accidents. Combined with the preplan and the actual situation of the company, a part-time emergency rescue team is established and emergency supplies are equipped. It regularly organizes personnel to conduct drills on emergency plans and evaluate and improve the preplans based on drills. In 2017, various subsidiaries of our company organized 76 types of drills, directly involved 7,600 people and directly invested RMB 380,000 in emergency drills.

Safety production management system

In 2017, a large number of amendments were made to the "Safety Management System", and the handling of accidents and the handling of reported accidents were dealt with seriously. New "Safety Production Liability Management System", "Post Standards Management System" and "Class Safety Management System", "Employee Behavior Observation System", "Three Violations on Site and Safety Foundation Management Assessment Methods" were added to refine the on-site management foundation and extend the various systems to the grass-roots employees throughout the range of daily production.

Implementing safety production responsibility system

In 2017, the company improved the "Safety Production Responsibility System", covering the company's general manager, security leader in charge, security management personnel, the heads of various departments/workshops, party committees, trade unions, special operations personnel and employees in various positions and signed safety pledges to ensure the effective implementation of the responsibility for safe production. A total of 285 safety production responsibility documents were signed throughout the year, and all employees signed a total of 4,528 safety pledges.



Launching special activities for safe production In 2017, our company took 17 days and traveled more than 2,000 kilometers to carry out the "safety production-led" event based on the "accidents case" and gathered more than 1800 participants. We carried out comprehensive dust explosion-proof, limited space, welding machines, and forklifts governance activities, aiming to increase the level of security protection and personnel security awareness.

Safety training education system and conference The Group invited security experts to conduct four-day professional training for management and security management personnel. The company's safety and environmental protection department conducted a two-day security training and site visits for security management personnel. Each of the subsidiaries invited the District Safety Supervision Bureau and fire protection armed police to carry out different types of safety training for the entire staff. Through safety training and education, the staff's safety management concepts and safety responsibility awareness have improved, laying a solid foundation for the Company's safety, sustainable development and standardized safety management concepts. In 2017, the company-level safety training, based on the principles of comprehensive coverage and full-staff coverage, involved more than 65,000 participants with per capita safety training of 27.14 hours. The company organized security conferences on a regular basis to analyze the potential safety hazards in the daily work and to analyze the safety incidents that occurred. The accident analysis meeting held in the year totaled 1434 times (including 1424 attempted accident analysis conferences and 10 safety accident analysis conferences).

Occupational health protection

In 2017, Yaobai Group revamped the "Occupational Health Management System" and made it clear that the general manager of the company is the first responsible person for occupational health management. Each department and each workshop fulfill its responsibility according to professional requirements and include the notification, publicity, declaration, monitoring and equipment management of occupational hazards in daily production management to ensure the effective implementation of occupational health measures. In the Occupational Health Management System, employees who require occupational hazards to contact are required to perform pre-post, in-post, and after-post physical examinations and specify the physical examination details of each post; the company's safety management department establishes occupation health monitoring files for each employee in accordance with laws and regulations, which record the annual physical examination, the monitoring of hazard factors, etc., and are kept along with the personal files of employees. In 2017, the occupational health examination rate of our employees was 100%, and the warning rate of occupational hazards was 100%. None of the employees in the entire year had an occupational health problem.

Work environment safety

In accordance with the unified deployment in 2017, the production unit is equipped with a HD night vision recorder mobile inspection device, which is used for safety dynamic inspection, fulfilling the main responsibilities of the general manager and safety management personnel of the company; and is equipped with a secondary decompression protector for the welding machine to prevent injuries caused by daily work; Photoelectric sensors are installed for the dough mixers of daily use of the restaurant to prevent damage caused by daily misuse; fall prevention nets are installed on both sides of the pipe mill to prevent injury brought by the illegal use of personnel; a reversing alarm system for forklifts is equipped; and gas detector for limited space operations is also equipped.

The Group successfully passed the inspection and assessment of Shaanxi Provincial Work Safety Supervision Bureau, and will take this inspection and assessment as an opportunity to further strengthen the awareness of the red line, firmly establish the "safety first" ideology, and unswervingly implement the important instruction on work safety of State Administration of Work Safety and governments at all levels to implement responsibility for safety management to the production line, grasp the general system, prevent major accidents and ensure the safe production and operation of the group.

Creation of safe mine standardization

Mine standardization management is an important part of modern cement company's safety management and it is a new way to fundamentally solve and protect the life safety and health of workers. Our company attaches great importance to the standardization management and standardized mining work. At present, the company has three mines that have passed the safety production class-II standard assessment, and two mines that have passed the safety production class-III standard assessment. There are three production lines that have passed the class-III standard assessment. In August 2017, 5 production lines and mines were also completed to carry out the class-II standard assessment.

Staff development

Employees are the key factor in the steady development for enterprises and they are the source of intellectual treasures and strengths of companies. The continuous introduction of excellent talents and the stabilization of their talent pool are the driving force for the sustainable development of enterprises.

Our company always adheres to the people–oriented equal employment concept, estab– lishes a fair and open mechanism for selecting and employing people, implements equal pay for equal work, and insists on equal employment. Employees of different races, genders, ages, religions, and cultures are intertwined to form complementary advantages to tap the full potential of talents.

While retaining and inheriting traditional production technologies and management experience, our company is also advancing with time, carrying out recruitment work through multiple channels, strengthening talent reserve and echelon construction and striving to create a learning-oriented, professional and knowledgeable talent team. We continue to inject fresh blood into the company's development. In 2017, the company has participated in a number of college job fairs and special job fairs organized by the talent market to actively accept veterans. In the whole year, our company recruited 132 undergraduates and graduates who mainly come from Shaanxi, Henan, Shanxi, Gansu, Sichuan, Ningxia, and many other universities and from more than 20 majors including design. By the end of 2017, the total number of employees in our company was 4,453, including 887 female employees, 245 female employees, and 138 minority nationalities. The annual employee turnover rate was 11.73%, and 923 new employees were employed.

Democratic management

Our company has always adhered to democratic management, continuously improved the system of workers' congresses and formed a democratic management structure of "group unified leadership, administrative responsibility, implementation of trade union organizations and active participation of employees" to ensure employees' right to information and supervision rights, expression rights, and participation rights in decision-making. In 2017, re-election was successfully carried out in the staff representative meeting. The training rate of new-term employee representatives reached 100%, and grassroots democratic management organizations were further improved. The company built a multi-channel, effective internal communication platform so that employees can express opinions and suggestions through various channels such as employee representative conferences, employee forums, corporate mailboxes, collaborative office systems, WeChat and AM's internal instant messaging software to reflect reasonable demands to company. After receiving relevant news, the company's relevant departments will promptly summarize the discussion, actively adopt reasonable suggestions from employees, and strive to build a harmonious labor relationship so as to enhance the sense of belonging and ownership of all employees.

Career development

Our company attaches great importance to the training of employees' teamwork and learning ability, gives them full development space and learning opportunities, and ultimately realizes the common growth of the company and its employees. Our company provides employees with a vertical and horizontal combination of professional career development channels, vertical promotion channels, and horizontal development of basic knowledge and management skills. The two business promotion channels of the business manage– ment personnel and professional and technical personnel were established, supplemented with the supporting salary management and professional development system, which ensured the career develop– ment of the employees and met the occupational needs of staff growth and self–worth. Our company established an internal talent training plan for grassroots management personnel. Through performance appraisal methods, we selected outstanding employees with outstanding business abilities and manage– ment potential as backup management personnel to provide employees with a good development platform.

Staff training

Our company attaches great importance to the training of employees, have established and improved the "Employee Training System", collected training plans at the level of our company and its subsidiaries, organized training plans at different levels and priorities, and actively innovated training methods to ensure the effectiveness of training. The training content covers professional and technical knowledge, general workplace skills, etc., and comprehensively enhances the overall quality of employees. In 2017, the company's training coverage rate was 100%. In the year, it organized a total of 736 first–level and second–level trainings. The per capita training time was 29.9 hours and the total training investment was RMB 2.3951 million.

In the "Shanshui Cup" national building materials industry occupational energy conservation competition – cement central control room operator (cement kiln) occupation skill competition, our company selected 15 out of 50 kilns to participate in the national competition and won the title of gold medal kiln. Fan Haibin, an employee of our company, is dedicated to his work and won the second prize of "Shaanxi Provincial Technological Innovation in Building Materials Industry", "Excellent Employee", "Excellent Trade Union Employee" and other honors. With "Craftsman Spirit", he won the National May 1st Labor Medal as a post–80s worker, setting an example for all the cadres and employees, hence an invaluable asset for the company's development.

Providing assistance to employees

Our company attaches great importance to the help of employees in difficult situations, in particular to ethnic minority employees in Xinijang and Guizhou. We establish and maintain files for employees in difficult situations, implement dynamic management, provide economic and material assistance each year, provide basic livelihood protection for employees in difficulties and effectively resolve employees' actual difficulties. The Group's functional departments helped employees use medical insurance and assist in the process of reimbursement for medical insurance. Subordinate subsidiaries voluntarily donated funds through APPs such as "water droplets" and "love planning" to help individuals and families in need of help.

Providing assistance to employees

Our company pays attention to employees' physical and mental health, irregularly organizes rich and colorful employee culture and entertainment activities to enrich the employees' spiritual and cultural life and strives to create a positive and healthy and full of positive energy culture atmosphere for the majority of employees. Through various forms of speeches, chess, football, badminton, table tennis, tug-of-war, and relay long-distance races, outdoor education and training are organized to not only create a fair and equitable growth environment for employees, but also to ensure the balance of work and life of employees.

Providing assistance to employees

Our company attaches importance to the protection of the rights and interests of female employees and actively carries out various tasks. Our company gives female employees the same labor compensation, management positions, professional training and career development opportunities. The maternity insurance is paid for female employees and antenatal care leave, maternity leave, and breastfeeding leave are provided for pregnant women. In addition, we actively carry out activities and facilitate female employees. For example, on "Women's Day", we distribute life and work essentials to female employees, and provide more female workers with more convenience services for the family.

Efforts are made to create a good work environment for employees and prevent all forms of employment discrimination, child labor and forced labor. Our company has signed labor contracts with each employee and paid social pension insurance, medical insurance, unemployment insurance, work-related injury insurance, maternity insurance, and housing accumulation fund for employees. The coverage rate of social insurance reached 100%, and employee compensation was paid on time and in full. Employees can enjoy statutory holidays in accordance with national policies and relevant laws and regulations, enjoy effective protection of the legitimate rights and interests. Our company provides free regular medical examinations for all employees every year. The coverage rate for physical examination is 100%. At the same time, we constantly improve and perfect the employees' occupational health files. Employees' work information and personal privacy information are not allowed to be read or photographed by employees in unpermitted scope and are kept for good whether employees are in service or not.

Our company has established a wage distribution system that includes basic wages and performance-based wages as its main body. It continues to improve the annual salary system and optimizes the assessment program, fully mobilizing the enthusiasm of employees. Based on the characteristics of the industry and the consumption situation in different regions, our company will adjust the employee's compensation subsidy every year. In 2017, the employee's salary per employee was increased by 10% year-on-year.

Regulating Employment Management

The equal opportunity policy gives zero tolerance in relation to any workplace discrimination, harassment or vilification in accordance with local ordinances and regulations, such as Disability Discrimination Ordinance and Sex Discrimination Ordinance and the Labour Protection of Female Staff and Workers. As an equal opportunity employer, the company is committed to creating a fair, respectful and diverse working environment by promoting anti-discrimination and equal opportunity in all its human resources and employment decisions.

Employees are encouraged to report any incidents involving discrimination to the human resources department of the company. The company will take responsibility for assessing, recording and taking any necessary disciplinary actions in relation to such incidents.

The company strictly abides by the Employment Ordinance, Labour Law of the PRC, Labour Contract Law of the PRC and other related labour laws and regulations in Hong Kong, the PRC and other operating regions to prohibit any child or forced labour employment.

To combat against illegal employment on child labour, underage workers and forced labour, the staff of human resources in the company requires job applicants to provide valid identity documents before confirmation of employment to ensure that the applicants are lawfully employable. The human resources department of the company is also responsible for monitoring and ensuring the compliance by the company with the latest relevant laws and regulations that prohibit child labour and forced labour.

During the year under review, the company was not in violation of any of the relevant laws and regulations in relation to the prevention of child and forced labour that have a significant impact on the company.

Supply chain management Supply chain management has always been a systematic task that needs to be upgraded. In 2017, our company managed the unified organization of warehouses by various production units, managed to allocate the company's backlog of materials from the source of procurement, and reduced the occupation of funds. We also collected and recovered waste materials that had been in disrepair for a long time. Ultimately, we achieved a healthy state of "procurement, utilization and saving control." At the same time, we used the China Cement Network, China Cement Spare Parts Network, and all types of raw materials website as our big data platform to keep abreast of market information in the province and surrounding markets, flexibly adjusted our procurement strategies, and completed our 2017 procurement tasks to secure production and operation of all units.

Procurement system and measures

In 2017, Yaobai Group formulated the "Management System of Wubai Group's Materials Procurement" and the "Yaobai Group Economic Contract Management System" in order to take advantage of centralized procurement and further standardize business processes and optimize the approval process so as to greatly improve efficiency of procurement. In view of the extension of our Group's industrial chain, our company immediately established a temporary method for the procurement of spare parts and provided guidelines and directions for solving a large number of procurement plans. At the same time, semi-annual internal audits and annual external audits promptly pointed out problems in the management and management and in particular controlled the procurement risks.

Fair purchase platform construction

Our company and suppliers have always adhered to the principle of "fair and open", open registration, strict selection and regular review. Since 2017, our company has continuously expanded procurement channels, fully promoted open tendering and procurement, and formulated and issued the "Administrative Measures for the Yaobai Group Bidding", further established and improved a relatively independent procurement supervision and management mechanism. The company mainly invited bids on major materials of major equipment or management demand in the technological transformation and invited the company's supervision and examination department and financial department to conduct supervision throughout the process, which effectively promoted the Group's standardized management of bid procurement. In 2017, there were a total of 19,608 procurement plans. The procurement contract was signed at a rate of 100% and the contract compliance rate was 100%, of which 2,896, namely 15% were for local procurement.

Product and service evaluation system of supplier

Standards and normative business processes are provided for the procurement supply chain systems, resulting in an excellent supplier base. While ensuring the successful completion of the company's collaborative product centralized procurement task, the procurement process is standardized, the supplier group is optimized, the procurement information is shared, the procurement process is monitored, the procurement cost is reduced, the procurement information level is improved, the task division of work, performance assessment, etc. thus achieving the win-win goal with suppliers. The company set up a special team to comprehensively evaluate and analyze the price level, product quality, delivery status, and management situation and to cooperate with outstanding suppliers to provide funds in the future management to tilt or strengthen the depth of cooperation. Our company seeks common development with strategic partners in the supply chain, develops a stricter supplier access mechanism for various material attributes and considers the suppliers' performance of social responsibilities as an important consideration. Under the same conditions, we give priority to compa-

nies that pay great attention to public welfare undertakings and social reputation. Most of the suppliers we cooperate with have certain scale advantages and strong quality control and research and development capabilities. They are well–known enterprise or listed ones with brand advantages, capital advantages, price advantages and quality advantages in the industry. On the other hand, in keeping with the concept of common development, mutual benefit, and mutual benefit, we actively invite suppliers to visit and communicate with the company and guide suppliers to understand the technological changes in the cement industry, the direction of product upgrades, and the goals of the company's process innovation. Through exchange on customized demand materials, trials and exchange of advanced products, etc., the upgrading of procurement materials is promoted and suppliers' R&D capabilities and market competitiveness are promoted at the same time.

Our company actively explores new modes of cooperation with suppliers and strives to create a win-win situation for cooperation. For example, in electricity peaks during the Spring Festival and summer, we carry out price negotiations with local power plants and leverage on our own inventory advantages to absorb waste residue resources of the power plant, which not only creates economic benefits for the company, but also contributes to the environmental protection cause and realizes cooperation reciprocity with suppliers.

Product quality assurance and quality service

Customer service system

The Group implements a unified cement management system for its subsidiaries and builds a unified customer service system based on this. The sales head office exercises the unified marketing management and customer service functions of the group company, covers the sales service and daily management of the cement products of the whole group, provides standardized pre-sales, sales and after-sales services for customers and ensures normal development of various marketing activities. The sales customer service center is responsible for concrete sales and service work for the local cement users and is responsible for customer's cement delivery, settlement, bills, recon-ciliation, and other services.



Innovative service measures

In the face of increasingly fierce market competition, our group establishes and perfects the distribution of sales networks, sinks channels to villages and households and provides "one household, one policy" and accurate professional customer service. We regularly arrange professional and technical personnel to visit customers to help them solve difficult problems in production, reduce customer operating costs; through the promise of shipping time and encouraging customers to monitor, etc., we improve our product delivery efficiency, ensure normal supply, reduce customer time costs, customize services guided by customer needs, establish a service awareness based on customer needs, accurately analyze customer needs, effectively customize services for customers to achieve mutual benefit and realize the win–win development of the company and its customers.

Customer rights protection system

In order to protect the rights and interests of customers and avoid various risks of customers, our company has specially formulated customer instructions to let every customer understand the business process, matters needing attention and related rights and interests. First, in order to ensure the safety of funds, customers can directly transfer the payment into the designated bank account of each branch company of our group when making payment. The individual customer carries an ID card (a power of attorney/introduction letter issued by the unit is required for individual' s payment to the unit) to pay through POS machine or finance department handles payment procedures. All business between the customer and our group are not entrusted to the relevant business personnel of our company. Second, we have clear marked price, the pre–collection and cash sales delivery price follow the company's customer service center window the same day; third, security of the ticket – we ensure that the user name of the invoice is consistent with the name of the payment; at the same time, we ensure that the receipt is issued for the goods delivered of the same month to facilitate financial checking of customers.



Customer information protection

Our company has integrated customer information protection into a comprehensive risk management system and continuously established and improved customer information protection systems, mechanisms and processes. Each customer service center took the lead in the management of customer information protection, clarified the responsibilities for attribution and use of information, and strictly followed the principles of "competency takes the charge" and "host takes the charge" to implement the responsibility system and clarify the responsible persons and responsibilities. Work measures and processes will be continuously refined to strengthen the customer information protection responsibility system. At the same time, through meetings and weekly meetings, regular information security training is carried out to constantly improve the awareness of sales and customer information protection. Through communication, the customer's own level of safety awareness will be improved, and the service flow optimization and customer education will continue to be emphasized after the occurrence of customer information leakage.

To respect the privacy of customers, ensure the confidentiality of customer information, and protect the security of customer information, we must first strictly abide by the company's rules and regulations, enhance the employees' own information security awareness, strengthen the concept of the legal system, enhance confidentiality awareness; ensure the confidentiality of customer's files, complaints content, information, etc.,and shall not cause casual leakage of customer information or arbitrarily add, delete or leak relevant information.

Our company has a huge customer information system, establishes a multi-dimensional customer information control system, safeguards confidential customer information, and regularly upgrades the system to improve its reliability and security. According to the product classification and operating characteristics of each sector, the customer service management system is formulated separately. In order to meet the different needs of different types of customers, our company establishes links with each type of customer, strengthens communication and understanding, and understands customer needs. Based on this, we provide targeted and personalized services to customers.

At the same time, the Group is committed to improving the quality of all its employees and brand awareness, and promoting brand value through long-term guality-awareness training and education, linking guality and performance assessments and improving the technical skills of technicians and sales personnel.

The customer service center is the customer's complaint recipient and is the first person responsible for handling the complaint. After receiving customer complaints, it is necessary to fill out the "Customer Complaint Processing Registration Form" in detail. The process technicians and customer service personnel shall solve the problem on site and fill out the investigation process, cause analysis, treatment measures, processing results, and correction on the "Customer Complaint Processing Registration Form"; sales coordinators should communicate with the complainant, be responsible for obtaining the verification of the processing results, the signing and confirming of the sales responsible person, and finally record the "Customer Complaint Processing Registration Form" and report it to the Group Company's technical center. The Central Customer Technical Service Department is responsible for monitoring the review of corrective and preventive measures by all units. In 2017, a total of 13 complaints were received, and the customer complaints handling rate reached 100%.

Customer Communication System and Channels

Our company's customer communication system is complete and effective. It requires that the customer service staff must manage the following in the process of communicating with the customer:



Our company's customer service center hangs the service supervision sign publicity card in a conspicuous place at the entrance of the business office, publicizes the contact information of the responsible person in order to facilitate customers' contact with the relevant person in charge and establish a WeChat contact group to timely contact the relevant customer.

Customer satisfaction survey

In the aspect of satisfaction survey, the Group collects real experience of customers in various channels, sets up on-site complaints, business office window mailboxes, customer service center complaints telephone hotline, production department complaints telephone hotline, group company complaints telephone hotline, general manager mailboxes, etc. The Department of Strategic Development will visit the market from time to time to obtain real customer satisfaction from the market. The customer service personnel will ask the customer to fill out the satisfaction survey form during the visit to the market, and then the department and the Group's Department of Strategic Development will make spot checks. The Satisfaction Survey for 2017 showed that across the Group's 18 production units, 16 of which obtained a customer satisfaction of over 98%. Customer comprehensive satisfaction reached 98.5%, an increase of 13% from 2016.
