Preface

Summary of the Report

The Report is the second annual Sustainability Report of Fu Shou Yuan International Group Limited and its subsidiaries (hereinafter referred to as "We", "the Group" or "Fu Shou Yuan"). It covers our work during the period from January 1 to December 31, 2017. 1. Company Profile

1.1 About us

Fu Shou Yuan International Group Limited (HK.01448), founded in Shanghai in 1994 and listed on the HKEX in 2013, is China's largest death care service provider, and the leader and integrator of death care service industry in China. Also, Fu Shou Yuan is a place where memories and emotions are preserved and enshrined, a culture-oriented company that is dedicated to the preservation and promotion of the quintessence of traditional values, and a corporate citizen with a deep sense of responsibilities. At present, our businesses cover various segments such as cemeteries, funeral services, cremation machines, pre-need funeral contracts, planning and design, and life education, and have expanded to more than 20 cities in 12 provinces, autonomous regions and municipalities including Shanghai, Henan, Chongqing, Anhui, Shandong, Liaoning, Fujian, Zhejiang, Jiangxi, Jiangsu and Guangxi.

1.2 Business Performance

During the reporting period, we have continued to strengthen our core business, improved our service quality and solidified our performance. As before, we have been continuously investing in the landscape and cultural construction of existing cemeteries, improving service quality, and innovating in services, products and methods, which have been widely recognized by our customers. During the reporting period, Fu Shou Yuan has enjoyed remarkable growth in its business performance:



Business Performance

During the reporting period, with the expansion of the Group, Fu Shou Yuan's brand awareness and experience advantage gradually spread over the whole country. During the reporting period, our main business highlights included:

- •We acquired 80% equity interest in Luoyang Xianhe Memorial Cemetery, 60% equity interest in Guangxi Huazuyuan, and 51% equity interest in the Temshine Cemetery Design Group.
- •We started death care services at four funeral parlors in Huaibei, Tai'an, Ningde and Lujiang County, Hefei.
- •We signed a "BOT" cooperation agreement with the funeral parlor of Gaoyou, Jiangsu Province.
- •We are about to put into use the funeral facilities of two projects in Bishan District in Chongqing and Xuancheng City in Anhui Province.
- •A total of 1,174 pre-need funeral contracts were signed and received good market response.
- •The environmental-friendly cremator was awarded a national invention patent and received great attention from the market during its promotion.



1.3 Corporate Governance

Fu Shou Yuan fully understands the importance of corporate transparency and accountability mechanisms for corporate sustainable development. The Group adopts the Ccde of Corporate Governance in Appendix 14 to the Listing Rules as our corporate governance guidelines. We are committed to achieving high standards of corporate governance and better performance, and enhancing our corporate image through effective corporate governance procedures. By continuously strengthening our budget management, internal controls, and information system, we have enhanced our internal governance. As a result, our operational efficiency has been significantly improved, operating expense ratio has been declining, and operational risks have also been effectively controlled during our rapid development.

Fu Shou Yuan hopes to become a public company that is law-abiding and conducive to social supervision, and a prospective model for Chinese death care companies. In our efforts against corruption, the Group has set up an internal control department which is responsible for establishing an anti-corruption system and conducting internal risk-based audits to strictly control the corruption risks the company might run into in procurement and land use applications. The internal control department has established the "Anti-corruption Work System", clearly defining bribery, corporate staff accepting bribes, duty encroachment, misappropriation of funds and other corrupt activities that violate national laws, and detailing the management responsibilities, content and methods, reports, and records of anti-corruption and reporting. During the reporting period, the Group had no corruption lawsuits.





2. Sustainability at Fu Shou Yuan

Over the past more than 20 years, Fu Shou Yuan has been at the forefront of innovation, development and reform of China's modern death care industry in terms of concept, product, environment, service, technology, etc. In recent years, Fu Shou Yuan has also been devoted to environmental protection, making great efforts to innovate and achieve breakthroughs, improve the environment, and benefit the people. Fu Shou Yuan is not merely "a weathervane for growth" in the industry and investment sector in China. Moreover, with our sense of responsibility for the business, society, industry, and history, we have integrated the values of humanism, environmental protection, charity and care into our daily operations to facilitate the long-term growth of the enterprise and the industry.

2.1 Concept of Sustainable Development

Fu Shou Yuan practices the sustainable development concepts of "to transform cemeteries into parks, to transform farewells into beautiful moments, to transform treatment into enshrinement, and to transform darkness into splendor". We hope to deliver to the public with the ideas of respecting the departed, people-orientation, environment protection and harmony, and gu de the market to understand the death care service industry from a new perspective. Meanwhile, it is also our hope that Fu Shou Yuan can leverage our influence as the market leader to further enhance the standardization and facilitate the cultural transformation of the industry. Fu Shou Yuan not only provides customized and diversified professional services to meet the needs of different customer groups, it also helps people to seek warmth and strength from memories through humanistic commemorations.

We believe that sustainable death care service is more than planting trees, flowers, and grass, or providing diversified forms of ecological burials such as tree burials, sea burials and lawn burials. It is, in fact, a new topic in "Death Education" concerning how the whole nation and society should face the end of a life's journey. Therefore, in order to lead the trend of the new concept over time, Fu Shou Yuan officially proposed the life philosophy "Learn to Bid Farewell" on Qingming Festival in 2017.





From our point of view, by developing and inheriting thoughts and culture, we cannot stop the aging and death of people's biological life, but still can extend the spiritual one. In the Report, we follow this life philosophy to compile the trajectory of Fu Shou Yuan's sustainable development through three dimensions namely nature, society and spiritual culture, so as to deliver our thoughts and report our actions to society.

2.2 Governance of Sustainable Development

During the reporting period, Fu Shou Yuan's environmental, social and governance working team (hereinafter "ESG reporting team") was in charge of coordinating the implementation of ESG policies and reported regularly to the board of directors and management of Fu Shou Yuan. The organization structure and responsibilities for different roles to promote the governance of sustainable development are as follows:



During the reporting period, the ESG reporting team, together with the head of each functional department, has reviewed the results of Fu Shou Yuan's efforts to promote sustainable development and discuss the future work priorities. In addition, the ESG reporting team conducted field inspections of Fu Shou Yuan's subsidiaries for any potential social and environmental risks, and further assessed the effectiveness of the risk management and internal control systems of Fu Shou Yuan.

During the reporting period, we required every subsidiary to include all environment-related indicators as part of operational data subject to quarterly report and reviews. They are also required to submit the information to the ESG reporting team for assessment, so as to reach our environmental goals. In addition, we have fully implemented the Fu Shou Yuan International Group Supplier Management Measures and the Fu Shou Yuan International Group Annual Tombstone and Related Products Procurement Measures to ensure that the social responsibility performance of suppliers is one of the criteria that we consider when screening and approving suppliers for the Group.



2.3 Communications with Stakeholders

We communicate with different groups of stakeholders through a wide range of channels in our daily operations. Apart from finding out issues that different stakeholders have concerns through transparent and regular two-way communications, and regularly reporting and reviewing the effectiveness of related actions, we hope that we can respond more comprehensively to cifferent stakeholders' concerns through the Report.

2.4 Materiality Analysis

During the preparation of the Report, we followed the assessment process of material issues in sustainability, which was set up last year, and conducted surveys by means of questionnaires and in-depth interviews to learn about stakeholders' comments on the report of preceding year and their expectations of the Report this year.

During the reporting period, we broadened the scope of invitation for the employee auestionnaire survey to the entire Group

including newly acquired companies and invited over 200 external stakeholders to participate in our survey. Finally, we received more than 400 valid questionnaires and conducted telephone interviews or face-to-face interviews with more than 40 stakeholders from different groups.



Apart from material issues of previous year, issues such as corporate culture, training and development, occupational safety and compliance with laws and regulations are also included in the list of the issues about which Fu Shou Yuan's stakeholders were closely concerned this year. We will detail the relevant contents later in the Report.



Sustainable Environment

Compose the Chapter of Nature

Mr. Zhang, an elderly gentleman, lives near the Henan Fu Shou Yuan. Before he moved into a new house in the vicinity of Fu Shou Yuan, he has been extremely worried, like many other people, that his quality of life would be seriously disrupted by the cemetery. In his mind, a cemetery was always associated with a gloomy and depressing atmosphere, flying dust and ashes, and dealening noises of lirecrackers

However, after Mr. Zhang has moved into his new house, his perception of cemeteries completely changes, because the cemetery is just like a park! Looking out from his

balcony, he can appreciate the scenery of lakes, wetlands, waterfalls, and rills. When walking around, he can quietly contemplate life. Even on Qingming Festival, Mr. Zhang does not suffer from the noises of firecrackers because people have replaced the disturbing traditional commemorations with civilized and ecofriendly observances such as lighting candles, paying floral tribute and planting willows to remember and honor their departed loved ones. As a result, Mr. Zhang's life is not bothered at all. Every time he invites his friends home, they feel as if he were living by a big park!



Fu Shou Yuan is not only committed to transforming cemeteries into parks, it also strives to create a cemetery culture in which "the natural scenery and cultural landscape enhance each other's beauty". To this end, the concept of green operation is applied to every aspect of the operations of the Group. We strictly manage resource usage and pollutant emissions from our operations, and continue to explore and promote eco-friendly burial forms, so that more people can enjoy clean and beautiful environment, and the society can benefit from it.

We pay great attention to environmental policies and trends in environmental protection at home and abroad, and regard environmental protection as a major component of corporate social responsibility and sustainable development. We are concerned about the challenges posed by issues such as climate changes, energy shortages, depletion of natural resources and environmental pollution. As a result, we make continuous efforts to enhance policies and measures regarding energy conservation, emission reduction and environmental improvement, and to explore more ways to protect the environment, so that we can keep on reducing adverse impact on the envronment when we provide our services.



3.1 Green Operation

We adopt an integrated approach to manage energy and resources concerned in our operations. The Engineering Department regularly analyzes the usage of energy and resources, and formulates plans and goals for energy saving. Fu Shou Yuan has more than 2C years of experience which has proven that our green operation concept is in line with our vision of protecting global energy and resources. Through improving our energy and resource management systems, we have been guiding our company to respond to the global energy shortage and the depletion of natural resources.

Increasing Efficiency in

Water Usage

As Fu Shou Yuan promotes the planting of green plants in all operating areas, we use water for irrigation, which is an important part of our operating activities. We select different water sources for irrigation in accordance with the local conditions of our subsidiaries at different locations. In addition, we have built detailed feedback channels for water use, through which every subsidiary is required to regularly report its water use to the headquarters. After collecting and analyzing the data, the headquarters determines water use plans for the future. The water used during the reporting period was mainly for irrigation.

Implementing Different Measures Based on Local Conditions to Reduce Irrigation Water Use

When we develop greenery plans, we select plant species that suit local environmental conditions. Take Henan Fu Shou Yuan as an example, we have selected plant species in accordance with the local climates, and scientifically controlled the proportion of trees, lawns, and shrubs. Consequently, a natural balance among a variety of plants is cleated and a sustainable growth is achieved. As a result, we reached the goal of reducing daily water use for irrigation. We have also installed automated sprinklers and drip irrigation equipment. The refined irrigation method greatly reduces the consumption of irrigation water when compared with irrigation by manual labor.

In areas with unstable climates or in relatively dry zones, we select as many drought-resistant plants as possible, such as the sedum lineare thunb which has strong adaptability and drought tolerance, so that we can reduce the water consumption from manual irrigation while mainteining cemetery greenery.

Using Energy Rationally

Fu Shou Yuan is committed to vigorously promoting energy-saving measures. Considering that our energy consumption mainly comes from purchased electricity, all subsidiaries set their own annual energy-saving targets and track their electricity consumption on a regular basis. Moreover, they formulate reasonable plans to control the use time of electricity, and implement measures to stagger the peak times of electricity consumption. Fu Shou Yuan also requires cemeteries to build a specific energy conservation team to routinely inspect the electricity consumption in different offices, in order to reduce the occurrence of unreasonable low temperature set for air conditioning system and to prevent lighting and other equipment from being set to ready mode in most time. Apart from regular inspections, we also actively enhance employees' awareness of energy conservation. For instance, Shanghai Fu Shou Yuan took an active part in the campaign for energy conservation and emission reduction organized by the government in 2017, and won the "Three-Competing -and-Two-Reduction" energy saving and emission reduction knowledge contest.



We formulate targeted electricity-saving measures after we have collected and analyzed different types of electricity consumption data from each subsidiary, such as the amount of purchased electricity for irrigation and offices equipment in cemeteries. Through implementing a series of measures, such as designing and optimizing irrigation intervals for different seasons, staggering the peak times of electricity consumption, and regulating the upper and lower limits of the indoor air-conditioning temperature, we have succeeded in confining resource consumption to a reasonable range and reducing the occurrence of waste. In the future, we will further reduce the use of natural resources for various purposes by analyzing and cross-checking energy consumption data.

Controlling Emissions of Greenhouse Gases

Adhering to the concepts of green and eco-friendly operation, Fu Shou Yuan has been committed to creating cultural and eco-friendly cemeteries that can be rooted in people's hearts for more than 20 years. Global climate change is an issue that deserves the attention and efforts of all enterprises and individuals. Ever since China formally submitted its Intended Nationally Determined Contribution to the United Nations in 2015, Fu Shou Yuan, like other socially responsible companies in every industry, has regarded the tasks of actively responding to climate change and reducing carbon emissions as one of the major aspects of realizing corporate value and enhancing corporate social responsibility. The main source of our greenhouse gas emissions is the usage of purchased electricity. In order to further reduce the emissions of corporate greenhouse gases and forge an atmosphere for green operation, we are proactively exploring new energy, such as the use of solar LED lawn lights and solar outdoor music playe s.





Saving Land Resources

Fu Shou Yuan has always been a firm advocate of ecological burials that are eco-friendly and land-saving. We recognize the irreplaceable value and role of land resources in people's lives. With land resources becoming scarce, especially in the first-tier cities where there have been serious shortage of land supply, it is more important than ever to adopt "land-saving burials".



In recent years, Fu Shou Yuan has been vigorously promoting land-saving burials which occupy no or little land space, consume less resources and use less non-degradable material, so as to realize the harmonious development of humans and nature, and to further respond to the principles in the Guidelines on Promoting Land-saving and Ecological Burial jointly issued by 9 ministries including the Ministry of Civil Affairs.

During the reporting period, on the basis of existing burial types offered by us, including flowerbed burial, forest burial, sea burial, wall burial and lawn burial, we have continued to innovate and launch new types of

burials, such as

European-style copper plate burials and ecological forest burials. These new types of burials not only incorporate modern and fashionable elements, they also allow the sharing of space by the living and the deceased.

We have made innovations in land saving through various ways As



of December 31, 2017, the average area per burial plot in our cemeteries was 0.91 square meters. In particular, the average area per burial plot was only 0.45 square meters in the two cemeteries located in Qingpu and Lingang, Shanghai,.

Starting from 2002, when we first tried promoting land-saving burials at the beginning of our cemetery construction, to 2007, when we officially started

promoting them, more and more people recognized and accepted land-saving burials. These types of burial have also moved from being the least popular option to the most popular option at our cemeteries. As a strong advocate of green burials and ecological burials. Fu Shou Yuan has introduced a series of green burial forms such as flowerbed burials and forest burials, and has continuously innovated our services and led a new trend in the market.

Although "Great Snow", the 21st solar term of the year, had just passed, the scenery surrounding the Dashushan Culture Cemetery didn't look bleak and desolate. On December 9, the 2017 Hefei Winter Ecological Burial Ceremony was solemnly held jointly by Hefei Civil Affairs Bureau and Hefei Dashushan Culture Cemetery, a subsidiary of Fu Shou Yuan. More than 300 family members of the deceased attended the group memorial service and bid farewell to 75 departed people who had permanently returned to nature.

Arridst beautiful flowers and flowing music, family members of the departed recalled wonderful moments spent with their loved ones, wrote down their wishes and feelings, and lit cardles to pray. At the end of the ceremony, attendees followed the service personnel to the areas for flowerbed and forest burials for the final burial of their loved ones, and created a cozy setting where their dearly departed could rest in peace.

We presented the ecological burial certificates to family members of the departed to recognize the unselfish deeds of both the departed people who had opted for ecological burials and their family members who had chosen to preserve the environment for future generations and to allow the living and the deceased to share greenery resources.

Promoting New Burial Materials

Stone is a widely used traditional material for burial, but its mining and processing are harmful to the environment. By vigorously promoting the use of new eco-friendly materials, Fu Shou Yuan can greatly diversify our product portfolio, and enhance the artistic and humanistic value of its products. It can also reduce customer's expenses, decrease the consumption of non-renewable stone resources, and reduce noise pollution and dust emissions caused by stone processing. In short, the introduction of new burial materials can provide benefits in many ways.

Promoting New Materials and Reducing Resource Consumption

Shanghai Fu Sho J Yuan is at the forefront of the industry in exploring the use of new burial materials. In recent years, Shanghai Fu Shou Yuan has actively conducted research and participated in a variety of innovation conferences in the industry. It has introduced new cemetery materials, such as glass, stainless steel, man-made composite materials, and copper to replace traditional stone materials. Caskets made from these new materials, compared with the traditional ones, not only save space, also significantly reduce the consumption of stone and excessive dependence on resources.

For instance, as of December 31, 2017, Shanghai Fu Shou Yuan used a total of 824 caskets built from man-made composite materials, representing a reduction of 131 cubic meters in the consumption of stone resources.

3.2 Green Value Chain

Fu Shou Yuan strictly complies with laws and regulations such as the Environmental Protection Law of the People's Republic of China, the Prevention and Control of Water Pollution of the People's Republic of China, and the Technical Policies on Urban Wastewater Treament and Pollution Prevention, to further enhance green operations as well as reduce and eliminate pollution in our operations. According to the requirements for the death care industry set by related regulators, we have vigorously promoted a new trend for civilized funeral services to reduce emissions in daily operations.



The irrigation water used during normal business operations are infiltrated into the ground without causing additional pollution. The other source of waste water is mainly from domestic use which is directly discharged to the municipal pipe network connecting to municipal sewage treatment plants. In addition, for the small amount of waste water generated during the cleaning of the deceased in the Wuyuan and Ningbo funeral parlors, we discharge the waste water after treatment when it meets discharge standards.



The solid waste produced is mainly the sacrificial offering rubbish, household garbage during operations, and the construction and garden waste generated during the development of the parks. In 2017, we continued to make our cemeteries green by reducing waste during operation and making good use of waste. Through our efforts, a total of 3,457 tons of waste was generated within a year, decreased by 6% as compared with last year.

The air emission in the parks of Fu Shou Yuan is primarily originated from the emissions of firecrackers, incense, and joss paper brought by customers without permission. This type of fugitive emissions is not collected or analyzed by professional equipment. For a long time, Fu Shou Yuan has been advocating new trends in civilized funerals. During the reporting period, Fu Shou Yuan reduced air emissions in its parks through promotion, guidance and patrolling efforts, and optimized the environment of the parks, which now has delivered satisfactory results. In areas where traditional burial customs and concepts are persistent, we also provide customers with centralized incineration facilities for disposal of the items left by the deceased. Additional air pollution treatment equipment is also installed to ensure the park's air quality. In the future, we will strive to achieve smoke-free operation of our cemeteries.

Apart from providing our customers with comprehensive and solemn funeral services, we also make every possible effort to identify and reduce pollution in our operations. We have noticed that many common practices during funerals, such as burning incerse and floral wreaths and setting off firecrackers, seriously impact on air quality both indoor and outdoor, as well as on residents living in the neighborhood, and harm the respiratory system of family members and guests at funerals. Therefore, we have carried out many measures to reduce the pollution generated during funerals.

Pollution Reduction in Funeral Services

Environmentally Friendly Smokeless Incense

Funeral parlors affiliated to Fu Shou Yuan have all adopted environmentally friendly smokeless incense altars where smokeless incense and electronic candles are used to avoid pollution and ensure fresh air flowing at funerals.

Recyclable Floral Wreaths

Floral wreaths placed in mourning halls are mostly recyclable. We try to minimize pollution as much as possible in the process of paying tribute to the deceased and prohibit burning floral wreaths after funerals.

Electronic Firecrackers

Taking into account of traditional Chinese funeral culture as well as safety, controllability, and the reduction of air emissions such as carbon dioxide during funerals, we have replaced traditional firecrackers with electronic firecrackers.

Thanks to our relentless efforts in R&D and optimization of technologies and techniques, we have launched an industry-leading, environmentally friendly and smart cremator named "Jiesheng'. This product provides fully automatic control over the cremation process, which can be achieved by pushing a button. It also fundamentally addresses the pollution issues from cremation and has passed standard evaluation and gained approval from professional institutions.

We submitted a patent application for the environmentally friendly and smart cremator during the reporting period and gained an approval from relevant authority in January 2018.

The highly automated, smart and environmentally friendly cremator has been put into use in Wuyuan Fu Shou Yuan, which has improved the air quality and surrounding environment significantly. We have received both domestic and overseas orders for the cremators, which helps to expand our market further. In the future, we will keep on upgrading and optimizing our techniques to ensure that we will continue to lead the industry. We believe that the environmentally friendly smart cremator will bring significant contribution to us in the future.







We have long been committed to low-carbon and environmentally friendly operations. Shanghai FSY Industry Development Co., Ltd has obtained ISO9001 International Quality System and ISO14001 International Environment Management System certifications. We advocate green and regulated operational practices.

We strictly adhere to the policy requirements of the Civil Affairs Bureau to prohibit burning and setting off firecrackers. Burning dry branches and fallen leaves is also banned. We implement a series of measures, such as no burning, low-carbon transportation and green operation in our cemeteries in different places. We ban and promptly stop family members of the deceased from setting off firecrackers and burning joss paper in cemeteries to reduce air pollutant emission.





No Burning and Firecrackers—— Paying Tribute in an Eco-friendly Manner

In order to prevent the family members of the deceased from feeling disappointed at failing to express their reminiscence after we banned the burning and setting off firecrackers, we took action by enhancing our publicity. We encouraged customers to sign a "Commitment Letter" to raise their awareness of eco-friendly tomb-sweeping practices. To lead the public to change outdated traditions and develop eco-friendly and low-carbon practices of paying tribute, we introduced a variety of innovative practices such as exchanging joss paper for flowers and giving out yellow ribbons, wish cards, heaven postcards as well as paper cranes.

Meanwhile, we have also increased our efforts in patrolling and cooperating with regulators to enforce laws and regulations. During the peak time of tomb-sweeping such as Qingming Festival and Winter Solstice Festival, branches of Fu Shou Yuan in different places formed special patrolling teams, led by responsible persons of the companies, with specialized positions assigned to each team member, and in cooperation or coordination with Civil Affairs Bureau, to prevent the burning and setting off of firecrackers so as to minimize the impact on the environment and residents nearby.

At the same time, we pledge to establish prominent signs on banning burning and firecrackers in prominent locations, complemented by promotional banners and leaflets, to warn customers not to set off firecrackers. We hope to deliver the concept of the smokeless cemetery to each of our customers.

Low-carbon Transportation—— Energy Conservation and Emission Reduction

Fu Shou Yuan uses battery-powered buses to pick up and drop df customers to reduce air emissions and traffic congestion caused by private cars. Such action helps to lower emissions of carbon dioxide and to maintain a quiet and solema environment in the cemetery.

We encourage tomb-sweeping guests to take public transportation. Our official website and sales and services staff recommend our customers the best public transport to visit our cemeteries.

In Shanghai, we help place "sharing bicycles" at subway station exits and the entrances of our cemeteries. We also arrange shuttle buses that run between subway station exits and entrances of our cemeteries to facilitate the transportation during major festivals as well as protecting the environment.

At Guanlingshan in Liaoning, we have launched free direct shuttle buses for multiple routes, which operate on a regular schedule every day. Meanwhile, we also work with coach companies so that our customers can take the coaches for free and we will cover the cost. During peak tomb-sweeping seasons, such as holidays and festivals, we increase the frequency and routes of the shuttle buses to ease the traffic and improve efficiency while ensuring environmentally friendliness.



We uphold the concept of exploration and innovation, learn advanced gardening techniques and sustainable green development strategies from abroad. We choose plants corresponding to different seasons, and make coordinated plans and layouts based on local conditions. In addition, the layout of the plants is carefully designed according to their growing seasons, different colors, and fragrances, so that green plants and flowers can be seen throughout the year, establishing a greenery culture for cemeteries. As of December 2017, the greenery coverage rate of the Group reached 41.6%.

All-dimensional Greenery— Park-like Environment

All cemeteries affiliated to Fu Shou Yuan have set up alldimensional greenery landscaping with different themes, which not only enriches the spatial structural level and the aesthetics of the landscape, but also expands greenery coverage.

At the beginning of the construction of these cemeteries, we considered thoroughly and designed the layout for a variety of plants scientifically by planting a combination of flowers and grass, shrubs, trees and vine plants throughout the cemeteries, so that visitors can enjoy the beautiful scenery wherever they stay in our cemeteries.

We have also increased our investment in landscape features. For example, we have transformed the green landscape from a 2-dimensional form to 3-dimensional form by placing moveable pottery jars, wooden planters on lawns and making flowerpots out of discarded tires, aiming at developing ecological cemeteries.

Ecological Park—— Green ano Organic

Fu Shou Yuan actively promotes the concept of building ecological gardens. Due to the use of waterlogged compost in nursery gardens and the increasing use of organic fertilizers, the proportion of chemical fertilizers has been reduced year by year. We also constantly reduce the proportion of pesticides by utilizing biological controls, living organisms and their metabolites, to suppress the growth of harmful organisms, so as to avoid the harm of chemical pesticides on water sources, soil, and other living organisms and to reduce damage to the ecological balance.

After regularly pruning trees in cemeteries, we never directly burn the branches and other materials produced. Instead, we transport them altogether to the nursery garden where they are chopped into chips with wood shredders and then recycled to protective mulch.





Fu Shou Yuan's current achievements would not have been possible without the dedicated work of our employees. Over the years, together with our employees, we have been finding our way, moving forward, growing up, and becoming mature. While driving the apid development of funeral services in China and promoting our perspective on life and death to the whole society, we strive to maximize our employee value.

Compose the Chapter of Teamwork

Zhang Houshi works as a shuttle bus driver at Shanghai Fu Shou Yuar. It might just be an ordinary job from many people's perspective, but he devotes himself to his work. He works hard every day without complaint, pursuing the spirit of a craftsman honored by every Fu Shou Yuan employee.

When it comes to his career path, he said, "I started my career in Fu Shou Yuan and now I have been working here for ten years. Although all of our shuttle buses, powered by renewable energy, only run within the working area of Fu Shou Yuan, they follow the same safety standards as the vehicles running on highways, namely, they have all been registered and are subject to regular examination. I feel very safe in the driving seat. Thanks to the training on service standard, we deliver the most comprehensive service to every passenger. I feel very proud every time I hear customers' praise, "All of you bus drivers are so familiar with Fu Shou Yuan, and introduce Fu Shou Yuan in great details. You are such brilliant living business cards for Fu Shou Yuan!"

Although it is not a glamorous job and his outstanding performance is not easily observed, Zhang Houshi, with his simplicity and sincerity, is completely dedicated to his work, which is ordinary but also remarkable at the same time. Under the unanimous recommendation from his colleagues, he was named one of the outstanding employees of the year by the company in Shanghai.



4.1 Employee Overview

We strictly abide by relevant national labor laws and regulations and manage human capital in accordance with the Fu Shou Yuan human resource management system and the five key tasks of "clarifying functions, employing talent, cultivating and using talent, performance management, and talent retention through incentive".

On December 31, 2017, Fu Shou Yuan had a total of 1,836 employees, an increase of 6% when compared with that of last year.

Our employees come from all over the country and are full of vitality.



We respect the differences between each individual and provide a diversified workplace which allows people from different backgrounds to work together. We provide equal opportunities to all employees in their career paths. Fu Shou Yuan is committed to providing a supportive workplace free from discrimination based on gender, age, marital status, family status, race, or ethnic origin, etc.

Fu Shou Yuan is also committed to providing equal opportunities to every applicant in recruitment process. We adopt open and fair recruitment procedures and resolutely eliminate discrimination on the basis of gender, age, ethnicity, religion, and sexual orientation. After selecting candidates that meet the job requirements and have the competence to perform job responsibilities, we follow approval procedures to hire those who are the perfect fit for the positions. Fu Shou Yuan strictly adheres to the Labor Law and other applicable laws, regulations, and practices, and commits to preventing child or forced labor. Within the reporting period, no case of child labor or forced labor occurred in the Group.



4.2 Salary and Benefit

Under the guidance of our "people-oriented" corporate value, we have adopted various methods to enhance employees' sense of well-being and belonging. We strive to create a dignified living and working environment for our employees through establishing a welfare system covering various benefits.

From September 25 to 28, the 2017 "Self-cultivation" training program was held in two batches at Futuo Temple in Anji, Zhejiang Province. In this event, our employees not only enjoyed the beautiful natural and cultural scenery of Longshanyuan, Bamboo Garden, and Futuo Temple, they also participated in a series of self-cultivation activities, including meditation, Buddhist worship, and vegetarian culsine.



"Know your own mind and discover your nature, and you will attain the way of Buddha" Mr. Ge Qiansong, Senior Consultant to President of Fu Shou Yuan International Group, shared his thoughts. Then, lecturer Xiang Xuelan gave a speech on "Mind Cultivation and Health Care" in which she shared her experience and thoughts to help us better understand the topics.

In order to enhance our competitive advantages and cultivate internal talent in the long term, we strive to maintain the staff turnover rate at a stable and acceptable level. Regarding to our competitive salaries and welfare and transparent employee communication channel, our staff turnover rate was only 7.72% during the reporting period.

4.3 Education and Development

In order to help employees enhance their personal and professional competence, we continue to focus on the training and development of our employees. Taking into account the characteristics of employees, we provide them with good education and development opportunities by summarizing internal experience and introducing external resources. We have set up transparent employee feedback channels through

We provide a wide range of education and development opportunities for employees, including training on profession skills, professional ethics, life vision and soft skill enhancement. Therefore, Fu Shou Yuan has

In terms of the numbers of participants, training hours, and other indicators, we have achieved a significant improvement compared with the previous year.



In the future, we plan to provide more extensive and targeted trainings covering more employees and hours, and further expand the depth and breadth of our training.

4.4 Work Safety

Safety management is the foundation of Fu Shou Yuan's construction and production management. We pay high attention to the health and safety of employees and strive to create a safe work environment for our employees. We are dedicated to prevent accidents and implement the policy of "safety first, prevention-oriented, comprehensive management".

Due to the high greenery coverage rate in Fu Shou Yuan and its location in forest terrain, fire safety is our first priority. We actively organize fire drills, conduct fire safety trainings, and provide personal protection equipment and firefighting equipment to ensure the safety of all cemeteries.

Fire Prevention Facilities in Anhui Hefei Dashushan Culture Cemetery

Build a mini-sized fire station equipped with professional fire-fighting equipment: 6 sets of fire helmets, firefighting clothing, rubber boots, safety ropes, and filter gas masks.

At each gate, fire equipment distribution maps are in place to locate the fire prevention facilities in the centery.

Equipped with 32 dry powder fire extinguishers in office area.

Equipped with 3 fire-fighting pools, 2 gasoline water pumps, 3 electric water pumps, and 20 fire hoses in the cemetery

3 fire exits in different escape dilections.

Establish comprehensive fire emergence response plans

Appoint responsible personnels for fire prevention and build up fire prevention team at all cemeteries

Set up fire prevention spots in different locations where professional fire equipment is in place.

Daily inspection around the cemeteries and keep records

Check fire equipment regularly and replace or maintain timely

Regular inspection of potential electricity hazards in office areas

Cooperate with the fire department, and organize employees to conduct fire drills each year

Strictly implement the Cemeteries Management Method, Project Notice, Materials Entry and Exit Records and other policies to reduce the risk of fire

Actively cooperate with the fire department to check potential fire hazards, and apply for Hot Work Permit and other relevant documents

Prohibit fires and firecrackers, and place fire warning signs in prominent locations

Use artificial lakes in the cemeteries as a fire emergency water source



Operational safety

Fu Shou Yuan regulates the process of operational safety through a series of effective measures. In addition, we have complete hardware support and operational safety permit system to ensure the work safety of every employee at Fu Shou Yuan. Every year, we organize employee health examinations in accordance with laws and regulations and formulate detail injury prevention plans in response to all potential work-related accidents. During the reporting period, no work-related injury occurred at Fu Shou Yuan.



At Wuyuan Wanshoushan Cemetery, in order to reduce the impact of summer rainstorms, sandbags are equipped for emergencies.





In upholding the sustainable development principles, Fu Shou Yuan puts great effort into maintaining relationships with customers and suppliers, and have made great achievements. At the same time, we want to further promote the development of the whole death care industry through our participation and guidance, and to ensure every company fulfill its own social responsibility.

Compose the Chapter of Win-win

Manager Sun's company has been cooperating with Fu Shou Yuan for 15 years. When Fu Shou Yuan became the new leader of the death care industry in China, we created more business opportunities for Manager Sun's company. 5.1 Supplier Relationships

In order to save resources, control risks, improve working efficiency, and drive our suppliers to improve sustainable development together, we integrate sustainable development concepts into supply chain management. We consider sustainable development as the basic criteria to select and evaluate suppliers, and grow up with them to improve their own ESG management level.



and Related Product Procurement Measures. These documents integrate the management and evaluation systems of local subsidiaries for bidding and procurement and clarify the centralized supplier management processes for our Engineering Management Center. For products in the same category, we have at least three different supplier candidates s to ensure a stable supply chain. Through the above measures, we standardized our procurement process, strengthened our procurement management and optimized our procurement channels. By the end of 2017, the Group has a total of 567 suppliers.





Supplier Assessment

We established the List of Qualified Suppliers according to product categories of our current suppliers. All suppliers on the list must be evaluated by Fu Shou Yuan's supplier management team and inspected by the Financial Department.

Every year, according to the principles of "quantitative assessment, fair competition, and survival of the fittest", our supplier management team evaluates the performance of supplier projects (batches), including service quality, delivery time, price, service promptness, etc. Then, the qualified suppliers are divided into three levels. Higher-level suppliers will receive priority of future procurement, while unqualified ones will be phased out.

When inspecting product quality of suppliers, we also pay attention to upgrading their sustainable development management. Fu Shou Yuan takes initiatives to require stone suppliers to implement environmental-protection measures, including installing sound-proofing equipment as well as drainage and settling basins. In addition, we also encourage suppliers to recycle water as well as to avoid the direct discharge of waste water.

Supplier Access

Before evaluating potential suppliers, we usually organize supplier inspections, including but not limited to, documentation review and on-site inspection.

Through a series of inspection indicators, we phase out unqualified and uncertified suppliers in order to avoid production in individual workshops and to improve product quality.



Cooperation with Suppliers

We are dedicated to maintaining long-term and stable cooperation with suppliers. On one hand, by inspecting all the suppliers in our supplier list every year, we phase out unqualified or non-compliance suppliers, and replace them with better ones. On the other hand, we strengthen cooperation with excellent suppliers who value quality, culture, and sustainable development, and expand cooperation areas and promote employment. We present awards to outstanding suppliers and invite them to participate in industry seminars to achieve a win-win result.



5.2 Customer Satisfaction

With the change in public consumption patterns and the advancement of society, people's needs and expectations of the death care industry are becoming increasingly high, which means we must provide better services if we want to win customers' satisfaction and trust. This is a long journey to go. In addition to actively communicating with customers to understand their needs and establish long-term relationships, we must also evaluate our own performance on a regular basis.

When providing services, we also pay great attention to customers' privacy, so we strictly prohibit employees from disclosing customers' personal information to third parties.

Offline Services

As a death care service provider. our priority is to respect the deceased under the principle of "the deceased come first". which reflects our respect for life and humanity. At the same time, for the grieving relatives, we not only try our best to satisfy their reasonable needs, but also to support and console them emotionally and psychologically in order to relieve their sorrow. During burial services, we actively instruct customers about related processes to make the funeral much smoother. With our warm service, our employees become

reliable and trustworthy people for relatives of the deceased. We also formulate considerate service process to make our customers feel earnestness and sincerity from us.

Durina the reporting period. focusing on how to improve "farewell" and "memorial" quality, we launched a series of in-depth and popular thematic activities. including pre-need funeral contracts, personalized farewell ceremonies, new product development, diversified memorial methods, etc., which won excellent reputation for the Group.

Online Communication

Through our official website, two official Weibo accounts, 24 official WeChat accounts, and other online communication approaches, we share the newsletters of the Group and the industry, and our thoughts about life. Moreover, we established a platform to interact with customers and make sure their needs and suggestions can be responded in a fast and convenient way..

Dealing with Customer Complaints

Recording History by Sound Storytelling via the Internet

Sound is an important approach for people to hear the world, send information, and share emotion. In order to help more people understand history, to spread stories of life and memories of the past, and to arouse people's "resonance with the times", in September 2017, Shanghai Fu Shou Yuan, together with Fu Shou Yuan Memorial Museum, broadcasted on Himalayan FM, a large online platform for audio sharing. By the end of 2017, we had published 16 audio programs, including 2 albums, Shanghai's Excellent Predecessors, and My Father's Generation. These recordings were completed by our museum staff through the processes of interviewing, recording, and editing, which enabled the experiences and memories of our predecessors to be permanently stored and widely shared online.

After services, we seek feedback from all customers by questionnaires, in which they can rate their satisfaction with our services. We regularly summarize customer complaints and comments to immediately identify the unsatisfied issues in our services. Suggestions from customers are gathered and sorted by region and business department, and finally written into an annual satisfaction study report. We pay close attention to feedback from customers, and provide corresponding responses in our annual service quality goals to improve our service quality and reputation amongst customers. For face-to-face complaints, we have formulated detailed Customer


Complaint Guidelines which presents the routines to handle complaints until settled.

We also offer a complaint hotline and an online platform for feedback. Once we receive a complaint, we immediately appoint responsible staff to verify and make corrections. For potential serious mistakes, we make compensation and promise to be supervised at any time in the future in order to provide our customers a satisfactory experience and stay in trust with us.

We continuously improve service quality and actively deal with customer feedback and complaints in order to satisfy our customers' needs and even exceed their expectations. In recent years, we have maintained a high and continuously improving level of customer satisfaction, as presented in the following chart:

While realizing the Group's own development, Fu Shou Yuan also actively takes on social responsibilities in the areas of humanities, charity, environmental protection, public welfare, etc. Therefore, Fu Shou Yuan continues to be devoted to the public welfare and charity, and helps to promote community development and social welfare through practical actions. While offering burial and commemorative services for special groups, such as the single elderly, the poor body donors, and police officers who died of duty, we also provide a variety of public welfare support, including student aid, volunteer clinics, and anti-cancer clubs for disadvantaged groups in the community. With the above effective measures, Fu Shou Yuan has received several social and public welfare awards and honors, earning outstanding reputation from the society.

We are prepared to take on more social responsibilities

On June 24th, 2017, Wuyuan County in Jiangxi Province suffered unprecedented heavy rainfall, which triggered a rare flood. The incident is still fresh in the memory of Mr. Feng, general manager of Wuyuan Wanshoushan Cemetery.

"The flood has drowned the entire downtown of the county, and also threatened Wanshoushan Cemetery. Under such emergency circumstance, rather than escape, our employees showed their courage and determination to fight against the flood. Under the rainstorm, we used sandbags to set barriers for key areas in the cemetery before the flood arrived, and effectively isolated the flood from the buildings.

When the threats of the cemetery has just been eliminated, we were immediately informed that, as the rainstorm continued, the damage in Wuyuan County was becoming severe. Many residents became homeless and could only be transferred to temporary shelters, and there was also a food shortage. We immediately contacted the Civil Affairs Bureau to express our intention of all possible assistance. We led employees to work overtime to make food boxes and sent them to the victims overnight. Over the next week, more than 1,500 boxes carrying our conviction to serve and contribution to the community were delivered to the hands of the victims. I felt very fulfilled to express the humanistic love culture of Fu Shou Yuan to the community!"

6.1 Public Responsibility

As a leader of the death care industry and with a strong sense of social responsibility, Fu Shou Yuan adheres to the public welfare philosophy of serving the community and society.

For over 20 years, Fu Shou Yuan has actively taken part in all kinds of social and public welfare activities, including charitable donations, poverty alleviation, disaster relief, mental health assistance. environmental protection, life education, and many other fields. We organized and participated in the 2017 "World United for Life" global commemorative activities, the "Filial Piety and Love" variety show on the "Double Nine" festival, the "Calligraphy Inheriting Family Tradition, Remembrance to Honor Ancestors" calligraphy activity, and many other public welfare and charity activities. Through this charity walk project, Fu Shou Yuan hopes to spread the values of respecting life and embodying humanism so that more people can understand the love and integration of our philosophy of life, and make the society warmer and the life better.

Through a series of cultural activities, we are promoting the funeral culture philosophy of "saying goodbye to the physiological lives but greeting the spiritual lives" to the public.

The Silent Walkathon is a cool and warm creative charity activity. Around the "Double Eleven" day in 2017, Shanghai Fu Shou Yuan, Henan Fu Shou Yuan, and Liaoning Guanlingshan Cultural Cemetery jointly organized a life exploration and caring event to encourage volunteers to walk 12 km in silence in the Fu Shou Yuan Humanism Memorial Park, on the purpose of feeling life and death.

One of the volunteers said, "Starting to walk 12 km in the cemetery and then leaving the Fu Shou Yuan by car, all the scenes along the way are like a movie. Through the whole road, I hear the sound of my breathing and the wind, and gradually I feel my heart beats. The beginning of the activity also represents the beginning of the entire life, and when returning to the starting point, we seem to have reached the elder age just as sunset. I realized that we should live well in every moment of every day. Life is not always smooh, but we should not waste time!"



"Death Talk" – Born to Die and Awe for Life

At the end of 2017, we invited more than 40 teachers, students and international students from tier-2 colleges and the International Education College of Shanghai University of Traditional Chinese Medicine to attend the "Life Education for Universities – Death Talk" activity. The journey to "Learn to Bid Farewell" breaks silence and aims to guide people to respect and have awe for life.





6.3 Historical Responsibility

Fu Shou Yuan calls on the whole society to remember history and not forget the hard work of our predecessors. We actively carried out cemetery construction and commemorative activities for celebrities, martyrs, and influential individuals. We established the Shanghai Fu Shou Yuan Humanistic Memorial Museum, the "Predecessors and City Memory" cultural forum, the Family History of the Masses series book contributions, and the "Humanism Walk – Visiting the City Memories of Shanghai", and other humanist public activities. We hope to inherit the spirit of influential individuals and predecessors through our activities.

The special industry we operate in gives us a special historical mission. In our internal journals, we publish historical and cultural stories and celebrity biographies on a regular basis. We also created Shanghai celebrity culture stamps and took the initiative to take responsibility for documenting the development of families, cities, and nations, leaving precious memories for future generations.

"Appreciate the Wonderfulness of Life and Collect City Memory" Shanghai Fu Shou Yuan Humanistic Memorial Museum

Every life that comes to the world is equal. However, there are some outstanding individuals who differ from the crowd as they are more virtuous or brilliant. For more than a decade, Fu Shou Yuan has collected and shared the life stories of deceased prominent community members and elites of generations. We may not have collected valuable treasures, but life and experience are the greatest treasures for us. Each of their belongings is engraved with the glory of life and the memory of cities, which is worthy of descendants' respect and inheritance.

Shanghai Fu Shou Yuan Humanistic Memorial Museum is the first professional museum in China's cultural memorial field that integrates the functions of collection, exhibition, research, exchange, education and is equipped with firstclass facilitates. Covering an indoor exhibition area of 2,000 square meters, the museum, through the theme halls of "A Psalm of Life" and "Stories of Life", presents the approximately one hundred modern Shanghai celebrities that rest in Fu Shou Yuan. In the past seven years, Shanghai Fu Shou Yuan Humanistic Memorial Museum is free to the public. When visiting the museum, visitors can also enjoy free guide service, film & TV viewing, book reading, themed lectures, educational activities and so on. The museum has become a familiar public cultural place for citizens.









The Opening of "Chang Hsueh-liang Memorial Hall"

As a patriotic general in Liaoning Province, Chang Hsuehliang was famous in history for initiating the Xi'an Incident. However, he was buried in a foreign country after his death. The people of his hometown were eager to see that General Chang could rest in peace in Liaoning. In this context, we took the initiative to visit the United States and invite the descendants of Chang Hsueh-liang to our cemetery, which eventually led to this good event. The Guanlingshan Cultural Cemetery invested 6 million RMB to build the Shaoshuai Tomb in November 2016 and invested nearly 20 million RMB to reconstruct the Puyuan Hall into the Chang Hsueh-liang Memorial Hall to display Chang Hsueh-liang's centennial life. With an area of 2,900 square meters, the memorial hall officially opened to the public on June 18, 2017. Fu Shou Yuan hopes that through our own efforts, more

people can remember history, learn the good character and spiritual strength from martyrs and predecessors. We also hope to stimulate people's positive feelings of "paying tribute to martyrs, wise men, and ancestors" and take our own historical responsibility.



Over twenty years ago since the establishment of Fu Shou Yuan more than 600 celebrities have rested in our cemeteries. We also set up several collective memorial platforms, such as New Fourth Army Square, Memorial Wall for Deceased Criminal Police, Monument for Organ Donors, etc. Also, we held regular commemorative activities and exhibitions. This new development approach has gradually changed the public stereotype of the death care industry.





6.4 Industrial Responsibility

An outstanding company leads the growth of the industry. Fu Shcu Yuan continues to learn advanced death care culture and concepts from home and abroad, and specially set up the Fu Shou Yuan Life-Service College. Through introducing, lecturing, and implementing advanced death care concepts, we have trained more senior management professionals for the industry and promoted the sound development of enterprises and the whole industry. Fu Shou Yuan has been organizing bi-annual training programs on modern cemetery development for several years, sharing management concepts and experience with peers. During the reporting period, Fu Shou Yuan joined two domestic and six international death care industry associations. On an annual basis, we organized international expos and forums for peers and invite them to our cemeteries for visit, study and ideas exchange. We took the responsibility to direct and promote the development of China death care industry.
