POSITIVE PROFIT ALERT

This announcement is made by Landing International Development Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) is pleased to inform shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2018 and the information currently available to the Board, it is expected that the Group may record a significant increase in the net profit for the six months ended 30 June 2018 by approximately 500% as compared to the same period last year. The expected increase in profit is mainly attributable to the increased revenue contributed from gaming business in Jeju, South Korea, after the relocation of Landing Casino from Hyatt Regency Jeju Hotel to Jeju Shinhwa World on 25 February 2018.

The information contained in this announcement is only based on the preliminary review on the unaudited consolidated management accounts of the Group for the six months ended 30 June 2018 and the information currently available to the Board. It should be noted that the Company is in the process of finalising its interim results for the six months ended 30 June 2018 and such results may be subject to amendments as appropriate. Shareholders and potential investors are advised to read carefully the Company’s interim results announcement for the six months ended 30 June 2018 for further details, which is expected to be published on 2 August 2018.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
