ANNOUNCEMENT AND NOTICE OF TERMINATION, VOLUNTARY DEAUTHORISATION AND DELISTING

The termination of the Terminating Products and the deauthorisation of the Terminating Products will become effective on 8 August 2018. The delisting of the Terminating Products from the SEHK will also become effective from 9:00 a.m. on 8 August 2018.

Reference is made to the Announcement and Notice dated 3 April 2018 titled “Announcement and Notice of the Proposed Cessation of Trading, Termination, Voluntary Deauthorisation and Delisting and Waiver from Strict Compliance with Certain Provisions of the Code” (the “**First Announcement**”), and the Announcement dated 30 July 2018 and entitled “Final Distribution Announcement”, both issued by CSOP Asset Management Limited (the “**Manager**”), the manager of the Trust and the Terminating Products. Capitalised terms not defined in this Announcement shall have the same meanings as defined in the First Announcement.

The purpose of this Announcement and Notice is to inform the investors that the Trustee and the Manager formed an opinion on 6 August 2018 that the Terminating Products have no outstanding contingent or actual assets or liabilities. The termination process of the Terminating Products has also been completed.

Furthermore, the SFC has approved the deauthorisation of the Terminating Products (the “**Deauthorisation**”) and the SEHK has approved the delisting of the Terminating Products from the SEHK (the “**Delisting**”). The Deauthorisation will become effective on 8 August 2018 (the “**Termination Date**”) and the Delisting will also become effective from 9:00 a.m. on the Termination Date. Following the deauthorization, the Terminating Products will no longer be regulated by the SFC and will not be available for public distribution in Hong Kong. The documentations regarding the Terminating Products previously

issued to investors should be retained for personal use only and not for public circulation.
