This announcement is made by CW Group Holdings Limited (in provisional liquidation) (the “**Company**”) pursuant to Rule 13.09 of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 21 June 2018, 22 June 2018, 26 June 2018, 27 June 2018, 28 June 2018, 2 July 2018, 4 July 2018, 5 July 2018, 8 July 2018, 9 July 2018 and 11 July 2018 in relation to, among other things, the HK Winding-Up Petition regarding CW Advanced Technologies Limited (In provisional liquidation) (“**CWATL**”). Capitalised terms used in this announcement, unless otherwise defined, shall have the same meanings as those defined in the announcements of the Company dated 26 June 2018 and 8 July 2018.

#### **UPDATES ON THE HK WINDING-UP PETITION REGARDING CWATL**

The Board announces that the hearing of the HK Winding-Up Petition regarding CWATL was held on 29 August 2018 before the High Court of Hong Kong. No winding-up order was made at the hearing and the hearing of the HK Winding-Up Petition has been further adjourned to 24 October 2018. Meanwhile, steps have been taken for BOC HK to be substituted as the petitioner under the HK Winding-Up Petition after CWATL’s withdrawal of the HK JPL Appointment Application.

The Company will make further announcement(s) in accordance with the Listing Rules as and when necessary in relation to any material developments in relation to the matters disclosed in this announcement.
