### 報告範圍

本報告聚焦本集團之化妝品和時裝業務分 類在二零一七年四月一日至二零一八年三 月三十一日(「本年度」)之營運。報告範圍 覆蓋香港和澳門之各零售店舖,相關辦公 室及倉庫,以及位於汕頭之生產廠房,與 化妝品和時裝業務相關的營運(簡稱「各 營運點」)。本集團將不斷提升內部資料收 集程序,逐步擴大披露範圍。

本報告最後一章附有完整索引,以便讀 者按聯交所上市規則附錄二十七所載《環 境、社會及管治報告指引》閱讀本報告。

This report is the second Environmental, Social and Governance Report (the "Report") published by Veeko International Holdings Limited (the "Company") which reports the performance of the Company and its subsidiaries (hereinafter as the "Group") in its environmental, social and governance aspects.

This Report, which is prepared in both Chinese and English, has been uploaded to the website of the Stock Exchange of Hong Kong Limited (the "Stock Exchange") and the Company's website at www.irasia.com/listco/hk/veeko/index.html.

#### **Reporting Scope**

The Report focuses on the operations of cosmetics and the fashion business segments of the Group from 1st April, 2017 to 31st March, 2018 (the "Year"). The reporting scope covers the retail stores in Hong Kong and Macau, relevant offices and warehouses, as well as the production plants located in Shantou, of which the operations are related to the cosmetics and fashion businesses (hereinafter referred to as the "Operation Points", and each an "Operation Point"). The Group will continuously enhance its internal data collection process and subsequently expand its scope of disclosure.

A complete index is enclosed in the last chapter for the reader's easy reference to the Environmental, Social and Governance Reporting Guide as set out in Appendix 27 of the Rules Governing the Listing of Securities on the Stock Exchange when reading the Report.

The Group complies with the relevant environmental laws and regulations applicable to the Operation Points and has formulated an "Environmental Protection Policy Statement" demonstrating its commitment to protecting the environment.

本報告涉及的業務範圍主要屬於零售店 舖、辦公室、倉庫及生產廠房。其主要排 放物包括:使用燃油車輛產生的空氣排放 物、電力消耗間接產生的溫室氣體、污水 及固體廢物。本集團生產廠房的污水會經 過自行建設的過濾池處理後才排放。各零 售店舖、辦公室及倉庫亦避免使用即棄產 品以減少廢棄物;以及簡化工作流程,以 減少出差公幹及溫室氣體排放。部份營運 點亦設置回收箱,委托回收商定期收集回 收物料。

本集團本年度委託顧問公司進行碳評估, 以量化其營運產生的溫室氣體排放(或稱 「碳排放」);量化的過程參考香港環保署 和機電工程署編製的指引<sup>1</sup>及中華人民共 和國國家發展和改革委員會發佈的指南<sup>2</sup>。

- Minimising air pollutant and greenhouse gas emissions from business operations;
- Evaluating greenhouse gas emissions from business operations by using internationally recognised standards or equivalent local standards, and disclosing such to the public; and
- Preventing and minimising waste production.

The business scope covered in the Report mainly belongs to retail stores, offices, warehouses and production plants, whose major emissions include: air emissions from fuel vehicles, greenhouse gas indirectly generated from electricity consumption, as well as sewage and solid waste. The sewage from the production plants of the Group will be discharged after being treated by a self-built filter tank. Retail stores, offices and warehouses also avoid the use of disposable products to reduce waste. Work processes are streamlined to reduce business trips and greenhouse gas emissions. Recycling bins are also placed at some Operating Points, and recyclers are commissioned to collect recyclables on a regular basis.

The Group has commissioned a consultancy firm to conduct a carbon assessment to quantify the greenhouse gas emissions (or "carbon emissions") generated by its operations during the Year. The process of quantification is undertaken with reference to the guidelines prepared by the Hong Kong Environmental Protection Department and the Electrical and Mechanical Services Department<sup>1</sup>, and the guidelines issued by the National Development and Reform Commission of the People's Republic of China<sup>2</sup>.

針對碳排放的主要來源,本集團將繼續評 估、紀錄及每年披露其溫室氣體排放及其 他環境數據,並以本年度的數據作基準, 與往後數據作比較,從而檢討現行措施之 成效,有助日後進一步制定減排目標。有 關空氣污染物,香港及汕頭廠房的車輛均 產生氮氧化物、硫氧化物及顆粒物等廢 氣。 With respect to the main sources of carbon emissions, the Group will continue to assess, record and disclose its greenhouse gas emissions and other environmental data on an annual basis, and compare it with future data to review the effectiveness of its existing measures. Such initiative will facilitate the formulation of emission reduction targets in the future. Regarding air pollutants, vehicles in both Hong Kong and Shantou production plants generate waste gases such as nitrogen oxides, sulphur oxides and particulates.

Throughout the Year, the Group has complied with relevant laws and regulations, such as the Environmental Protection Law of the People's Republic of China (《中華人民共和國環境保護法》), the Water Resources Protection Law (《水資源保護法》), and the Waste Disposal Ordinance applicable in Hong Kong. The Group is not aware of any violation of laws or regulations in connection with emissions matters.

### **Use of Resources**

The Group fully understands that rational use of resources forms an integral part of sustainable development. The Group undertakes to:

- Adopt the principles of reduced use, reuse and recycle to improve the efficient use of energy, paper, water, and other resources in its business operations;
  - Cultivate a culture of environmental protection within the Group to enhance employees' environmental awareness;
    - Develop environmental protection goals that are achievable and measurable;

雷力為本集團耗用最多的能源,主要來自 空調、辦公室照明及電器的運行。本集團 致力督促僱員實行多方面的節約措施。有 關節能,部分營運點透過內部規程及內部 通訊等渠道持續向僱員推廣節能習慣,例 如劃分辦公區域以靈活控制個別區域的照 明系統、在午膳和非辦公時間時關掉公共 地方(例如接待處、茶水間、洗手間和通 道等)不必要的照明設施及空調裝置,以 及在各店舖陸續更換LED燈。有關用水, 部份營運點會監測其用水量,及透過定期 檢查水管及水龍頭,及時維修漏水設備; 部份營運點更進一步採用具一級用水效益 標籤的水龍頭,及制定節水目標,減少用 水。針對生產的原材料,如衣物所使用的 布料,生產廠房會透過排圖減少布料剩料 及邊角料損耗。廢布料亦會交付至專業回 收公司作循環再用。

本集團計劃於下一年度採取更多節約措施,如在燈掣附近貼上「節約能源」標貼以 作提示;裝設動作感應器或感光器於辦公 室房間、會議室、茶水間及洗手間等,以 控制燈光開關;及考慮制定節能及節水目 標。

### 環境及天然資源

基於本集團的業務性質,業務的日常營運 對環境並無重大不利影響。展望將來,本 集團將持續評估業務營運的環境風險以制 定應對措施,並定期檢視和更新環境保護 政策。 Review the implementation of this policy statement on a regular basis to ensure its effective implementation.

Most of the energy consumed by the Group is electricity, which is mainly derived from the operations of air conditioners, office lighting and electrical appliances. The Group is committed to urging employees to implement various energy-saving measures. Regarding energy conservation, certain Operating Points have been promoting energy-saving habits among employees continuously through internal procedures and internal communication channels. Such habits include dividing office areas to flexibly control lighting systems in individual area, turning off unnecessary lighting and air conditioning at public places (such as reception areas, pantries, washrooms and corridors, etc.) during lunch time and non-office hours, as well as replacing lighting equipment with LED lights at retail stores gradually. As for water usage, some Operation Points have monitored its water consumption and have promptly repaired leaking equipment by examining the water pipes and faucets in a regular manner. Some Operation Points have further used faucets with grade 1 water efficiency label, and have formulated water saving goals to reduce water usage. As for raw materials for production such as fabrics used for clothing, the production plants have arranged the layout draft to minimize their leftovers and scraps. Waste fabrics will also be delivered to professional collection companies for recycling.

The Group plans to adopt more energy-saving measures in the coming year, such as putting a "Save Energy" label near the light switches as a reminder, installing motion sensors or light sensors in office rooms, conference rooms, pantries and washrooms, etc., to control the turning on and off of lighting, and considering the setting up energy-saving and water-saving goals.

#### **Environment and Natural Resources**

Based on the nature of the Group's business, the day-to-day operations of the business have no material adverse impact on the environment. Looking forward, the Group will continue to assess the environmental risks of its business operations to develop corresponding measures and regularly review and update its environmental protection policies.



## Employment and Labour Practice 僱傭及勞工常規

本集團遵守各營運點所有適用的法律及法 規,並針對本集團運營期間的具體情況制 定了《僱傭及勞工常規政策聲明》,致力為 所有僱員提供一個沒有任何歧視和騷擾、 多元化及關注健康及安全的工作環境。 The Group complies with all laws and regulations applicable to the Operating Points and has formulated the "Employment and Labour Practice Policy Statement" according to the specific circumstances arisen during the course of operation of the Group. The Group is committed to providing to all employees a workplace with no discrimination and harassment, with diversity, and with attention to health and safety.

### Employment

The Group regards talent as the key to success and sustainable development. The Group complies with the employment laws and regulations applicable to the Operation Points and provides that:

- Job advertisements should be published with identical selection criteria and neutral language;
- A job evaluation system should be established to ensure that employees are treated equally in promotion, job transfer, training, career development, dismissal and layoff;
- Messages related to equal opportunities, anti-discrimination and anti-harassment should be promoted to employees through internal communications; and
- Employees should be provided with internal guidance and training in relation to equal opportunities, anti-discrimination and anti-harassment.

Throughout the Year, the Group has complied with relevant laws and regulations, such as the Labour Contract Law of the People's Republic of China applicable in the Mainland China, the Employment Ordinance applicable in Hong Kong, and the Labour Relations Law applicable in Macau. The Group is not aware of any violation of laws or regulations in connection with employment matters.

In the future, the Group will develop procedures to address issues concerning equal opportunities, anti-discrimination and anti-harassment, and will monitor the implementation of equal opportunity measures to ensure their effective practice, and will review and update its relevant measures regularly.

### 僱傭

本集團視人才為企業走向成功及維持可持 續發展的關鍵。本集團遵守各營運點的僱 傭法律及規例,並規定:

### 健康及安全

為打造健康及安全的工作環境,本集團已 訂立安全作業的流程和指引,盡量減低僱 員在工作場所受傷、染病或受到職業性危 害的機會。本年度,本集團遵守相關法律 及規例,如適用於中國內地的《中華人民 共和國安全生產法》、適用於香港的《職 業安全及健康條例》,以及適用於澳門的 《商業場所、辦事處場所及勞務場所之衛 生與安全總規章》。本集團並無發現與健 康和安全相關的違法或違規個案。

展望未來,本集團計劃在部份營運點成立 健康與安全工作小組,負責協調及監察健 康與安全措施的實施,確保其切實執行, 並舉辦職業健康培訓以提高僱員的健康意 識。

### 發展及培訓

為了幫助僱員提升工作技能及提高營運效 率,以及提供僱員個人發展的機會,本集 團除了為新入職僱員提供培訓課程外,亦 建立了識別僱員培訓需求的系統,針對僱 員對行業和專業知識及技術的需要,提供 相應的內部培訓課程。部份營運點亦提供 學費資助,鼓勵僱員報讀外部培訓課程, 並為僱員進行年度工作表現評核。展望未 來,本集團將在各營運點定期檢視和更新 發展與培訓相關措施,以回應僱員需求。

### Health and Safety

In order to create a healthy and safe working environment, the Group has established procedures and guidelines for safe operation to minimize the chance of employees being injured, infected or exposed to occupational hazards in the workplace. Throughout the Year, the Group has complied with relevant laws and regulations, such as Work Safety Law of the People's Republic of China applicable in the Mainland China, Occupational Safety and Health Ordinance applicable in Hong Kong, and General Regulation of Working Safety and Hygiene of Office, Service and Commercial Establishment applicable in Macau. The Group is not aware of any violation of laws or regulations in connection with health and safety.

Looking forward, the Group plans to set up a health and safety working group at some of its Operating Points. The working group is responsible for the coordination and monitoring of the implementation of health and safety measures to ensure their effective practice. It will also organize occupational health training to enhance the employees' health awareness.

### **Development and Training**

In order to help employees improving their working skills and enhancing operational efficiency, as well as to provide employees with personal development opportunities, the Group has also established a system to identify employee training needs in addition to providing training courses for new employees. The system focuses on the employees' needs in relation to industry knowledge, expertise, and technical know-how, and provides them with corresponding internal training programmes. Some Operating Points also provide tuition fee subsidies to encourage employees to attend external training courses. Annual performance assessments are also administered to employees. Looking ahead, the Group will regularly review and update the measures in relation to development and training at the Operation Points in response to the needs of its employees.

### 勞工準則

本集團遵守各營運點的相關勞動法律及法 規,禁止童工及強制勞工。本集團在招聘 指引中訂明招聘時的文件檢查要求,確保 在聘用任何僱員前,徹底檢查相關文件, 核實其年齡及身份,避免聘用童工、強迫 勞工、擔保(包括負債擔保)或契約勞工、 非自願獄中勞役、被拐賣勞工或奴隸勞 工。一旦發現誤聘童工,本集團會立即將 童工帶離工作場所,以確保其安全,並與 其解除僱傭關係。

本年度,本集團遵守相關法律及規例,如 適用於中國內地的《中華人民共和國勞動 合同法》、適用於香港的《僱傭條例》,以 及適用於澳門的《勞動關係法》。本集團並 無發現任何關於童工或強制勞工的違法或 違規個案。

本集團未來將在各營運點為人力資源部 門,特別是招聘人員開展培訓,並考慮成 立防止童工工作小組,負責協調相關措施 的落實情況。

### Labour Standards

The Group complies with relevant labour laws and regulations at the Operating Points and prohibits child labour and forced labour. In its recruitment guidelines, the Group sets out the document inspection requirements for its recruitment process to ensure that the relevant documents are thoroughly inspected before the employment of any employee, so as to verify their age and identity, and to avoid employing child labour, forced labour, guarantees (including liability guarantees) or indentured labour, involuntary prison labour, trafficked labour or slave labour. Once child worker is found to be misappropriated, the Group will immediately remove the child worker from the workplace to ensure its safety and will terminate the employment relationship with the individuals concerned.

Throughout the Year, the Group has complied with relevant laws and regulations, such as the Labour Contract Law of the People's Republic of China applicable in the Mainland China, the Employment Ordinance applicable in Hong Kong, and the Labour Relations Law applicable in Macau. The Group is not aware of any violation of laws or regulations in connection with child labour or forced labour.

In the future, the Group will conduct training at the Operation Points for the human resources departments, especially recruiters, and will consider setting up a child labour prevention working group to coordinate the implementation of relevant measures.

## Operation Management 營運管理

本集團遵守各營運點所有適用的法律及法 規,並制定了《供應鏈管理、產品責任及 反貪污政策聲明》,致力在日常營運中妥 善管理有關環境及社會的風險。 The Group has complied with all applicable laws and regulations at the Operating Points and has formulated the "Supply Chain Management, Product Responsibility and Anti-Corruption Policy Statement" to properly manage its environmental and social risks in daily operations.

### 供應鏈管理

作為一家負有社會責任的企業,妥善管理 供應鏈至關重要。本集團承諾:

- 嚴格選擇供應商,並對其表現進 行定期檢視;
- 識別供應鏈的環境及社會風險, 並制定相應措施;
- 把供應商的環保及社會表現納入 評核標準;及
- 確保與供應商持續溝通及適時提 供支援。

本集團部份營運點已建立風險評估流程, 識別供應鏈的環境及社會風險、亦已制定 環保採購政策,以及制定涵蓋環境保護和 社會關懷事宜的供應商實務守則。本集團 未來將逐步在各營運點全面實施上述流 程、政策及守則,推動供應商履行企業社 會責任。

### **Supply Chain Management**

Proper management of the supply chain is essential for being a socially responsible enterprise. The Group undertakes to:

- Strictly select suppliers and conduct regular inspections of their performances;
- Identify the environmental and social risks of the supply chain and develop appropriate measures;
- Incorporate the environmental and social performance of suppliers into the assessment criteria; and
- Ensure continuous communication with suppliers and provide support in a timely manner.

Some of the Group's Operating Points have established a risk assessment process to identify the environmental and social risks associated with the supply chain, developed environmental-friendly procurement policies, and have established a code of practice for suppliers covering the issues on environmental protection and social care. The Group will fully implement the above-mentioned processes, policies and practices at the Operating Points gradually, procuring its suppliers to fulfil their corporate social responsibilities.

- 採取充分的措施,維護及保障知 識產權。

目前,本集團已制定產品質量檢查體系, 及訂立內部質量監控標準;同時,亦留意 各營運點有關產品安全的法規修訂,確保 產品符合相關法規。在零售業務範圍內, 本集團於發票中訂明產品售後退換服務承 諾。為保障客戶的個人資料,本集團亦採 取資料保安措施,防止未經授權或意外存 取、轉移、刪除、遺失或使用客戶的個人 資料。除此以外,本集團亦已建立投訴機 制,提供客戶反映意見的渠道。

本年度,本集團遵守與產品責任相關的法 律及規例,如適用於中國內地的《中華人 民共和國民法通則》、《中華人民共和國產 品質量法》、《中華人民共和國消費者權益 保護法》、適用於香港的《消費品安全條 例》及《貨品售賣條例》,以及適用於澳門 的《商法典》。本集團並無發現任何與產品 責任相關的違法或違規個案。

### **Product Responsibility**

The Group operates the fashion production and retail business as well as the cosmetics retail business. The Group values every customer and strives to provide satisfactory services to customers through continuous improvement of service quality. The Group undertakes to:

- Provide customers with services which are health and safety secured;
- Realise its promotional and sales commitments on advertisement and product labels;
- Respect the legal privacy rights of the customers when collecting, storing, using and transmitting their personal data;
- Take adequate measures to properly keep the personal data of its customers;
- Formulate remedial measures to timely and effectively respond to customer data disclosure incidents, if any; and
- Apply adequate measures to maintain and protect intellectual property rights.

At present, the Group has established a product quality inspection system and set up internal quality control standards. At the same time, attention has also been paid to the revision of the regulations on product safety for the Operation Points to ensure that the products are in compliance with relevant regulations. Within the scope of the retail business, the Group provides the after-sales and return service commitments in the invoice for its products. To protect the personal data of customers, the Group also adopts data security measures to prevent unauthorized or accidental access, transfer, deletion, loss or use of customers' personal data. In addition, the Group has also established a complaint mechanism to provide customers with channels to present their views.

Throughout the Year, the Group has complied with the laws and regulations in relation to product responsibility, such as General Principles of the Civil Law of the People's Republic of China, Product Quality Law of the People's Republic of China, and Law of the People's Republic of China on Protection of Consumer Rights and Interests applicable in the Mainland China, Consumer Goods Safety Ordinance and Sale of Goods Ordinance applicable in Hong Kong, as well as the Commercial Code applicable in Macau. The Group is not aware of any violation of laws or regulations in connection with product responsibility.

In the future, the Group will conduct customer satisfaction surveys and improve the quality of products and services based on the results of customer satisfaction surveys. It will further enhance its compliance in connection with the use of customer data, which includes to ensure that customers are fully aware of the purpose of collecting customer information, and the information will only be used for the agreed purposes, as well as to provide customers with consistent, accurate, honest and fair information in all marketing channels.

### **Anti-corruption**

In order to maintain a fair, ethical and efficient business and work environment, and to prevent any form of corruption, the Group undertakes to:

- Create a culture of integrity within the Group and enhance employees' awareness towards anti-corruption;
- Ensure continuous communication with employees and customers on anti-corruption policies and implementation; and
- Take measures to prevent bribery, extortion, fraud and money laundering in its business operations.

Throughout the Year, the Group has complied with relevant laws and regulations, such as the Criminal Law of the People's Republic of China applicable in the Mainland China, the Prevention of Bribery Ordinance applicable in Hong Kong, the Criminal Code and the Law for Prevention and Suppression of Bribery in the Private Sector applicable in Macau. The Group is not aware of any violation of laws or regulations in connection with corruption.

The Group has established an investigation procedure for suspected corruption cases and established a complaint mechanism to promptly deal with and respond to complaints and suggestions in relation to corruption. In the future, the Group will fully establish a benefit declaration process for the Operation Points and include provisions related to anti-corruption in its employee handbook.
