On 21 November 2018, Ms So Kit Yee Anita of Ernst & Young Transactions Limited and Mr Koo Chi Ho Andrew of Ernst & Young (China) Advisory Limited were appointed as joint and several liquidators (the “Liquidators”) of the Company pursuant to a Regulating Order granted by the High Court of Hong Kong. The Liquidators prepared this monthly return according to the books and records available to them.
