# VOLUNTARY ANNOUNCEMENT BUSINESS UPDATE — STRATEGIC COOPERATION FRAMEWORK AGREEMENT

This announcement is made by China Saite Group Company Limited (the "Company", together with its subsidiaries, the "Group") on a voluntary basis to inform the shareholders of the Company and potential investors of the latest business development of the Group.

The board of directors ("**Directors**") of the Company is pleased to announce that on 20 January 2019, the Company entered into a strategic cooperation framework agreement ("**Strategic Cooperation Agreement**") with Angang Construction Consortium Co., Ltd. (鞍 興建設集團有限公司)("**Angang Construction**").

#### STRATEGIC COOPERATION FRAMEWORK AGREEMENT

According to the Strategic Cooperation Agreement, the parties will base on their strength in their respective businesses to strategically cooperate in complementing both parties' project supply, market development, market management, technology exchange and project investment.

Summary of the scope of cooperation is set out as follows:

1. The Company shall preferably disclose large-scale construction information derived from its sales channels and customer relationships to Angang Construction and utilise the Company's advantages on human resources, customer network, geographical connections and information channels, etc. to actively cooperate with Angang Construction to undertake projects.
- 3. Both parties have leading technical research results, production methods, installation technologies, etc. in areas where they have mutual interest to research and develop. They have their own leading technical advantages and numerous well-protected patented technologies in different in-depth topic research directions. As cooperation partners, both parties are given priority to use the results of the other party.
- 4. Both parties shall mutually provide their advantages such as technology and managerial talents, sales network, customer relationships, manufacturing bases, erectors and geographical location impact, etc. to develop areas where they have common interest.

#### INFORMATION ON THE GROUP AND ANGANG CONSTRUCTION

The Group is an integrated steel structure and prefabricated construction solution service provider headquartered in Yixing, Jiangsu Province, the People's Republic of China. It has an operation history of over 20 years. The Group's integrated construction solution services are customized to meet the technical specifications and requirements of different projects, and span from fabrication to assembly of steel structure parts and prefabricated construction materials at workshops, and to the installation of materials onsite.
