Compliance Management

In the process of production and operation, Tianneng follows all kinds of world-wide laws and regulations, social moral, internal rules and commercial ethics conscientiously and strictly.

In line with "Fair Competition and Operation with Good Faith", Tianneng insists on operation which abides by the law from beginning to end, pays taxes according to law conscientiously, opposes all unfair competition and eradicates all kinds of commercial corruption behaviors resolutely, respects staff. clients, stockholders, suppliers and competitors, protects its own and also respects for others' intellectual property, affords social responsibility, accepts supervision of government and the public initiatively.

At the same time, Tianneng is equipped with legal department which provides legal supports for all business activities, checks various of internal rules and regulations, drives upgrade of information-based contract management, carries out irregular investigation activities, checks, coordinates and deals with legal risk problems inside and outside in the process of management. In 2018, full coverage of legal review of contracts related to great decision-making, purchase and capital construction has realized.

Independent Audit

Tianneng builds audit supervisory committee to further complete system, makes and releases Audit System of Tianneng Group, Rules of Debating of Audit Supervisory Committee of Tianneng Group and a series of regulations, widely promotes overall process and full coverage audit jobs, carries out economic activities and functional management focusing on audit, supervisory, inspection, evaluation acknowledgement and further management of internal control and risks prevention, specifically including financial and assets audit, operation and management audit, internal control and risks prevention audit, projects and investment audit and so on, Audit jobs shall not be interfered with any other department or individual, and could be appointed by employing external audit institutions when it is necessary, for example, Hongkong Deloitte & Touche LLP is hired to provide financial statement audit and verification of net assets each year. In 2018, various kinds of special audits and investigations including performance audit and economic responsibility audit amount to more than 90.





Anti-corruption

Tianneng insists to oppose all kinds of behaviors such as corruption, bribery, abuse of power for personal gain and so on, builds anti-commercial bribery mechanism, sets up complaint channels, survey and corrosion prevention mechanism, implements "Sunshine Project" actively, and forges "Incorrupt Tianneng" with all strength. In 2018, Tianneng has revised Monitoring and Management Measures of Tianneng Group and Staff Red Line Management Accountability System of Tianneng Group, formulated Operation Management Accountability System of Tianneng Group, optimized supervisory working process, managed people and affairs according to system, and held more than 30 integrity education trainings covering 5000 staff all year round. Besides, Tianneng has enhanced supervision on bidding and large contracts for 350 times all year round.

Safe Establishment

Tianneng sets up special project team for safe establishment, builds great safety system actively, reinforces comprehensive control of internal risk, and constructs a higher safe, harmonious and stable environment which could provide important guarantee for high quality and sustainable development of the company.

Safety Production

Safety production is the precondition and foundation of sustainable development of Tianneng. In 2018, Tianneng has reinforced construction of safety production responsibility system, advanced safety production standard tasks, made great efforts to check and solve hidden danger, pushed safety production systematize, normalize and scientific.In the meantime, Tianneng strengthens construction of emergency rescue system, through prevention and control mechanism of the trinity including people's defense, technical prevention and material prevention, optimizes risk evaluation and monitoring and warning system, and makes sure full coverage of control in the process of production.

Protection of Staff's Rights and Benefits

Tianneng regards staff as the biggest fortune of enterprise, respects staff and pays attention to their development, through creating "a Platform, a School, a Family and an Army", improves staff's sense of belonging, happiness and accomplishment. In 2018, Tianneng has been rewarded as "National Employment and Social Security Advanced Private Enterprises".



Tianneng implements quality idea of "Quality First and Customer Orientation" all the time. Recent years, Tianneng has been exploring new path of total quality management and lean management applications, built and put life cycle green quality management system into force. Through unceasing improvement of management, technology and process, the quality of products is more stable and keeps improving, at last, "sealed lead-acid battery for electric bicycle", "lead-acid battery for electric road vehicles" and a variety of products has passed certification of "Zhejiang Manufacture", besides, Tianneng had the honor to win "National Quality Credit Benchmarking Typical Enterprise" in 2018.

In regard to quality management, Tianneng pays attention to process control that means each production chain is strictly guarded and controlled from material purchase to finished products in the market, ianneng fully implements uality responsibility ystem, according to verall quality policy, does ot only insist on total uality responsibility, but lso breaks goals and esponsibilities down to very level, commits to ach manager of related epartments including urchase, technology, nanufacture, service and

ry team makes irregular tour of supervision for suppliers, on-site quality management of each production base and carries out jobs related to quality improvement. Meanwhile, Tianneng organizes a series of activities such as "Quality Month", "Gold-Idea" and so on, strengthens sense of responsibility and quality of the whole staff, improves their abilities of quality management, and then drives products' quality







Basic Employment Protection

Tianneng obeys all regulations in Labor Law, carries out equal employment strictly and makes sure 100% legal compliance. All staff must sign labor contract on entry day and company pays for 5 social insurances and house fund according to the regulations. Staff enjoys marriage leave, pregnancy leave and so on according to law. Company organizes and holds congress of workers and staff each year to discuss big issues related to workers' rights and interests.

At the same time, Tianneng follows Law on Production Safety, Law on Prevention and Control of Occupational Disease and other related laws and regulations, through establishing and completing occupation health safety management system, improves working condition on and on, makes sure to provide a safe, comfortable and healthy working environment. Besides, Tianneng conducts employee occupational health monitoring each year and sets up employee health records.

Talent Development

Tianneng takes talents for the first resource of supporting enterprise development, relying on "Tianneng University", actively builds an enterprise-level talent incubator, puts effort into talent discovery, training and output.

Company pays attention to staff training and carries out all kinds of training activities actively. In 2018, Tianneng has organized top managers to pursue advanced studies, set up financial management practice class for general managers, international talents training camp and so on, which amounts to 45 times of training covering 3000 staff.

Tianneng provides two development channels of management and professional skills, sets up two modes of "Vertical Promotion" and "Horizontal Development", offers more promotion and development opportunities for staff, and helps them realize self-fulfillment.

Salary and Welfares

Tianneng promises to make sure that staff's average income rises gradually in a planned and proportionate way under the premise of enterprise's sustainable development and salary system equipped with competitive advantage than in the same industry all the time. Tianneng really concerns about staff's life, devotes to solve their basic problems such as house, transportation, children's education and so on by establishing staff dormitories in more than one production bases as well as staff dining halls, besides, provides daily multi-shift, multi-route shuttle service for the convenience of employees.

Personnel Encouragement

Tianneng constantly improves encouragement system, actively explores innovation of mode, forges communities of interest thoroughly, stimulates staff's internal capability fully, and provides impetus for staff to realize higher achievement, create greater value and gain more returns.  - **3)** Tianneng releases voluntary announcement irregularly of the latest development of production and management, such as major cooperation projects, technology breakthrough and company operation and improvement in order to increases investors' confidence for company.
 - **4)** Updating company news and industry trends monthly so as to make investors command information of company and industry immediately;
 - **5)** Company provides official website for information disclosure www.tianneng.com.hk which allows investors around the world to command the latest trends of the company;
- 6) Company holds stockholders' conference at least once a year to listen to investors' and stockholders 'suggestion and increases communication between listed company and investors.

Within the scope of distribution, franchisers share the right of usage for company brand and sales right for products, while company provides support of products, service and training and helps them to promote. At the same time. Tianneng builds SAP and other information platform, realizes high effective collaboration, which is convenient for franchisers to order online and obtain real-time order information and schedule after sale. Modules of platform keep the data separate in order to make sure the privacy and safety of information.

Comprehensive Response

At the same time when terminal shops provide service offline, Tianneng builds 400 service hotlines,

In order to response to service quickly, Tianneng sets up service branch offices relying on marketing service effectiveness greatly. Company has also built VIP customer service system to provide point to point service for vehicle manufacturers.

Customer Satisfaction Investigation

Tianneng builds complete customer satisfaction management system, carries out customer satisfac-Meanwhile, Tianneng organizes marketing staff to pay a return visit via measures of telephone, fax, email and interview irregularly to collect customers' opinions and suggestions. Up to December 31, 2018, Tianneng has been authorized national patents amounting to 2320, of which 315 patents are for invention, and taken part in making and revising 79 international, national and industrial standards.

Green Intelligent Manufacturing

Tianneng practices the idea of "Two Mountains" unswervingly, starts with green product, green workshop, green factory, green garden, green standard, green supply chain and so on, runs green development idea through the whole process of designing, manufacturing, packaging, transportation, using and disposal of products, realizes product lifecycle management.

In recent years, Tianneng takes Environmentally Conscious Manufacturing for its main line, actively pushes forward digital transformation, relying on technological innovation, puts efforts into human substitution by machine, integrates informatization with industrialization, with the help of internet, big data, cloud computing and other measures, establishes flexible intelligent manufacturing platform and the platform driven by big data cloud, forges industrial chain of Environmentally Conscious Manufacturing with all strengths, boosts transformation and upgrading of storage battery industry and its green development. Project of "Lead Carbon Battery Digital Workshop" has successfully been on the list of intelligent manufacturing pilot demonstration projects in 2018.

Before this, on the list of three batches of green manufacturing published by Ministry of Industry and Information Technology of the People's Republic of China, four sub companies of Tianneng were selected on the list of green factories, three were awarded as demonstration enterprise of green supply chain management, and eight products were chosen to be on the list of green design products.

Circular Economy

Tianneng performs responsibilities and extended obligation actively, as early as 2009, has invested to build circular economy industrial park, and forged international advanced harmless recycle base of waste battery and recycled lead demonstration project actively.

At present, Tianneng has set up a standardized working mode of lead-acid battery recycling and a standardized system of lead-acid battery recycling circular economy, built a closed-loop green industry chain integrating production, recycling, smelting and re-production, realized more than 99% of metal recovery rate of waste battery. 99% of recovery rate of plastic and 100% of spent acid.

In the meanwhile, Tianneng promotes and replicates the operation mode of Tianneng Cycle Industrial Park on a national scale, speeds up reasonable layout in mature areas, and constantly expands the recycling business segment.

Construction of Recycling System

In recent years, as the large-scale application of lead storage battery in the fields of electric bicycles, automobiles and storage energy, lead storage battery and recycled lead industry has developed rapidly. The recycle and reuse of waste lead storage battery has high value for resource and environment. Relevant state departments has revised and introduced a series of policy and measures, laws and regulations, particularly the promulgation and implementation of "System Pilot Work Scheme of Centralized Collection and Cross-Regional Transshipment of Lead Storage Battery by Production Enterprises" has further standardized and completed recycling system of waste lead storage battery, and has provided important guarantee for healthy and orderly development of this industry.

Tianneng executes in strict rotation in relevant state policy and requirement, explores new path for recycling of waste lead storage battery actively, relying on current sales network, self-owned recycling company, integrates external qualified resources and expands recycling business of waster lead storage battery, speeds up the construction of large logistics, forges stereomodel of combination of self-recycling, joint recycling and recycling delegation. Currently, Tianneng has reached strategic cooperation with recycling, disposition and transportation companies in national key provinces and cities.

Green Development

New energy lithium battery industry is ready to move on. In 2018, Tianneng has finished construction of Battery Cell workshop intelligent manufacturing project, and a variety of products has passed the authentication at provincial level. "Ternary Material Lithium Ion Battery for Electric Vehicles" products gain authorization of usage for brand logo of "Pin". Meanwhile, a series of products such as high-capacity lithium battery, soft-package battery, battery cell, Pack and so on have been developed and come into mass production in order to meet new international demand and market demand.

In the fields of photovoltaic, stored energy and intelligent microgrid, Tianneng has made substantial progress and built distributed photovoltaic power station, first commercial intelligent microgrid lead charcoal energy storage power station and multiple projects, among which distributed photovoltaic power station has been successfully connected to the grid and could realize annual energy output of 2,520,000 kilowatt hours, save standard coal of 881 tons, reduce carbon emission of 2438m³ and sulfur dioxide emission of 73,375 tons, 150KW/1.6MWh project of commercial intelligent microgrid lead charcoal energy storage power station guarantees that customers' electric power increases capacity of 120KW, reduces impact on the power grid and local grid failure rate. 1MW/8MWh project of intelligent microgrid lead charcoal/lithium battery storage power station is also in an orderly advancement.

At the same time, in order to optimize upstream and downstream value chain of new energy industry, create green industry ecology system together, and realize harmonious development of enterprise itself, enterprise and industry, enterprise and environment, Tianneng integrates new energy, new materials, equipment manufacturing, intelligent manufacturing, scientific information service and related projects, and forges green manufacturing industry garden with all strength. At present, the overall construction of the project is in good condition, In October 2018, Tianneng has signed another agreement of project for recycling and reuse of lithium battery with total investment of 600 million on the project signing ceremony of Changxing International Investment and Trade Fair.

Tianneng Group builds three-tier R&D architecture of "Research Institute, Research Branches, Technology & Quality Department" of trinity, makes a series of system including technology check and evaluation, share, encouragement and so on, implements process management, constantly pushes forward platformization, normalization and systematization of research and development, acquires a series of technology achievements, realizes iteration and updating of products, meanwhile drives high quality and effective development of industry.

Tianneng pays attention to technology evaluation and development all the time, through studying, digestion and absorption of advanced technology of industry domestic and overseas, combines practical application of independent innovation, constantly promotes technological innovation and progress, in order to make sure that core technology reaches international advanced level.

Tianneng has built wide range and multidisciplinary cooperation by production, study and research with famous universities and research institutions at home and abroad including University of Berlin, University of Wollongong, Harbin Institute of Technology, Zhejiang University, Zhejiang University of Technology, Nanjing University, Shenyang Battery Research Institute, International Advanced Lead-acid Battery Association (ALABC) and so on, as well as Chery, Kandi and other new energy vehicle companies, Working together on research and development of new energy industries. Tianneng has achieved a series of results on key research and development, and results promotion of new energy power battery, lithium ion battery, solar battery, fuel cell and other projects.

In 2018, Tianneng has finished reviewing and acceptance of six major projects at national and provincial level, broken through a patch of core technology such as power battery, positive electrode formula, battery specific energy, new materials and so on. Multiple projects were chosen as provincial key research and development plan project respectively, and obtained preferred funding by post-doctoral research projects. Academician expert workstation has been awarded provincial excellence.

Industrial Poverty Alleviation

In recent years, Tianneng has played its demonstration and leading role in industry at the same time of rapid development, integrated industrial investment into precise poverty alleviation, taken root in poverty-stricken areas, successively invested and built multiple projects in provinces such as Henan, Anhui, Guizhou and so on, through absorbing local employment, introduced advanced technology and business management level, driven the development of surrounding industries, promoted local economic development and helped poor areas to fight poverty.

In 2018, Tianneng has walked into Taijiang County, located Southeast of Guizhou Province, a national poverty-stricken county in Zhejiang Province, and built Tianneng Group (Taijiang) Circular Economy Industrial Park Project which mainly develops and produces various new type of sealed power lead storage batteries for electric vehicles and special electric vehicles, new large-capacity sealed lead storage batteries for wind energy solar energy storage, electric vehicle and accessories manufacturing, harmless recycling and using of used lead storage batteries, etc.

After the project is completed, it could absorb nearly 2000 employed persons, and more than 600 low income family members as expected, meanwhile, promote the coordinated development of upstream and downstream production, logistics, commerce and trade in Taijiang county, and realize more interest-linked employment out of poverty. It is expected to drive more than 500 poor people to work.

Joint Development of Villages and Enterprises

In the process of development and expansion of enterprise, Tianneng Group has built win-win platform of "Joint Development of Villages and Enterprises" with Xinchuan Village. Meishan Town, Changxing County, in this way, it does not only absorb villagers to be engaged in working in factory, but also guide them to open supporting factories, work on battery marketing, after-sale maintenance service and lead the villagers to work hard to get rich and strive to prosper.

According to incomplete statistics, Tianneng has solved employment of more than 5000 villagers for Xinchuan village and surrounding areas. Two thirds of the villagers are engaging in jobs related to Tianneng, furthermore, many of them are not only the staff of Tianneng, but also the stockholders, which makes their money bags quickly bulged. Currently, the average annual income of villagers in Xinchuan village has passed 100,000 RMB Yuan.

Tianneng takes part in public welfare establishment in villages actively, donates to schools, helps and supports the poor, takes the initiative to do practical things, do good things and solve problems, and donates at least 1 million each year to Xinchuan village, Cumulative donation has reached 40 million which are used for infrastructure construction including road and school construction, sewage treatment, etc. Xinchuan village now has nearly 100% of compulsory education enrollment rate, social security participation rate, public toilet renovation rate, garbage disposal rate, and clean energy utilization rate, and 40% of village greening rate. Besides, earth satellite station is built in the village, and two rebuilt kindergartens. Nowadays, Xinchuan village owns beautiful, clean and tidy scenery, and villagers live a rich and colorful cultural life. Xinchuan village has successively acquired honorable titles of "Huzhou City Civilization Demonstration Village", "Zhejiang Health Village", "Zhejiang Comprehensive Well-off Demonstration Village", and become a model of a new socialist countryside.

Public Benefit and Charity

Tianneng's activities of public benefit and charity mainly focus on disaster relief, poverty alleviation and volunteer service and so on. Company has set up Tianneng non-profit fund in 2016, extracted 0.02 RMB Yuan from per Tianneng battery sold from the secondary market, which effectively helps the win-win partner and cooperative partner to solve problems.

Meanwhile, through measures of enterprise investment and staff donation and so on, Tianneng has set up "Love Fund" which provides economic support for workers' families and their relatives who have difficulties in living.

On the second "Volunteer Service Expo of Learning from Lei Feng" in Changxing County held on March 5th, Tianneng invested 100,000 Yuan to help Changxing County Ethical Fund to be established. Unfortunately, win-win partner Peng Libao in Ganzhou of Jiangxi suffered a fire on July 17th and caused economic losses of nearly 10 million RMB Yuan. Company sent people to the scene for condolences and applied for Tianneng Public Welfare Fund for assistance, meanwhile, launched a donation activity on official platform and collected more than 400,000 on the same day, so as to rebuild his dream and hope. In August, Tianneng Staff Art Troupe walked into Center Nursing Home of Meishan, sent a cool summer to the lonely grandparents in the mountains and talked about household words with constant warmth left.
