### II. MALLS THAT ARE IN OPENING PREPARATION AS OF THE END OF 2018

As of 31 December 2018, the Company had 30 pipeline Portfolio Shopping Malls (of which 22 were Owned Portfolio Shopping Malls and 8 were Leased Portfolio Shopping Malls), and the planned construction area amounted to approximately 3.90 million sq.m. (subject to final construction area approved by government permit document). Among the pipeline Managed Shopping Malls, we have obtained land use rights/land parcels for 361 managed contractual projects.

### III. REVENUE AND GROSS PROFIT MARGIN OF PORTFOLIO SHOPPING MALLS FOR THE YEAR OF 2018

During the Reporting Period, the Portfolio Shopping Malls opened by the Company recorded revenue of RMB7,708,758,450.25, representing an increase of 11.6% as compared with the same period of last year; the gross profit margin was 77.1%, representing an increase of 0.8 percentage point as compared with the same period of 2017.
