Reference is made to the listing document of the Company dated 28/02/2019 (the "Listing Document"). Unless otherwise defined, capitalised terms used herein shall have the same meanings as defined in the Listing Document. As disclosed in the Listing Document, based on 1,077,737,651 shares of Hanison in issue as at the Latest Practicable Date, and assuming that it would remain unchanged on the Record Date, 431,095,060 Shares would be subject to the Distribution and the Company's total issued share capital would be expected to be 431,095,060 Shares upon completion of the Spin-off and Listing. As at the Record Date, the issued share capital of Hanison was increased to 1,090,831,576 shares due to issue and allotment of new shares of Hanison after the Latest Practicable Date upon exercise of the share options under Hanison's share option scheme (adopted on 21/9/2011) by directors and employees of Hanison. Thus, as at the Record Date, 436,332,630 Shares were subject to the Distribution and the Company's total issued share capital as at the Listing Date was 436,332,630 Shares. The Shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited on 19/03/2019.
