本人謹代表董事會提呈無錫盛力達科技股份有限公司（「**本公司**」）及其附屬公司（統稱「**本集團**」或「**盛力達**」）截至二零一八年十二月三十一日止年度（「**年內**」）之經審核年度報告。

二零一八年全球外部經濟環境動盪，但中華人民共和國（「**中國**」）國民經濟依舊運行在合理區間，中國經濟以供給側結構性改革為主線，調整供給結構，推動結構優化、動力轉換和品質提升，國民經濟實現了總體平穩，穩中有進的發展態勢，二零一八年全年國內生產總值首次突破90萬億元大關，比上年增長6.6%，實現了6.5%左右的預期發展目標，好於預期。

二零一八年，由於全球經濟發展遇到諸多困難與不穩定因素，汽車行業的發展在此期間也受到影響，全球汽車產銷量出現同比下降。輪胎行業年內也面臨着很大的壓力，受中國進一步提升環保、原材料漲價、去產能、價格混戰等多重因素影響，輪胎行業進入了整合期、轉型期階段。機遇與危機並存。本集團緊抓市場機遇，積極面對挑戰，使經濟實現向好發展。

### 業務回顧

二零一八年世界經濟增長沒有延續二零一七年各國同步強勁回升的勢頭，在主要發達經濟體中，只有美國經濟增速表現出上升趨勢，歐元區和日本等其他經濟體均出現增速回落現象。新興與發展中歐洲經濟體的經濟增速在二零一八年出現大幅度下降。

On behalf of the board of directors (the “**Board**”), I hereby present the audited annual report of 無錫盛力達科技股份有限公司 Wuxi Sunlit Science and Technology Company Limited\* (the “**Company**”) and its subsidiaries (collectively, the “**Group**” or “**Sunlit**”) for the year ended 31 December 2018 (the “**Year**”).

In 2018, the national economy of the People's Republic of China (the “**PRC**” or “**China**”) continued to develop at a reasonable pace amid the global external economic turmoil. The economy of China focused on the supply-side structural reform in order to adjust supply structure and promote structural optimisation, shift in momentum and quality improvement. As a result, the national economy remained stable in general and was moving in a positive direction. In 2018, the gross domestic product of the PRC reached a new high of RMB90 trillion for the first time, representing an increase of 6.6% over the same period last year, outperforming the expected development target of around 6.5%.

In 2018, the various difficulties and uncertainties in respect of the global economic development hindered the development of the automobile industry, resulting in a year-on-year decrease in the global automobile production and sales. Meanwhile, the tire industry was under huge pressure during the Year. In light of the further emphasis on environmental protection, rising raw material prices, the cutting of excessive industrial capacity, pricing competitions and other factors, the tire industry entered the stages of consolidation and transformation which gave rise to both opportunities and risks. The Group seized market opportunities and took a proactive approach in overcoming the challenges, thus achieving a satisfactory development in the financial performance.

### BUSINESS REVIEW

In 2018, the global economic growth did not sustain the strong impetus for recovery as seen across the globe in 2017. Among those major developed economies, only the economic growth in the United States showed an upward trend, whereas the growth rate declined in the Euro Zone and other economies such as Japan. In addition, the economic growth rates of both emerging and developing European economies dropped significantly in 2018.

我國經濟仍然平穩健康發展，達到了「穩中求穩」的姿態。近幾年，中國汽車行業發展迅猛，穩居全球最大的汽車生產國和新車消費市場，帶動輪胎行業快速發展。二零一八年的中國輪胎行業面臨了很多挑戰，中國輪胎產量出現下滑，據國家統計局數據，二零一八年，中國輪胎產量為8.16億條，相比2017年下降1.1億條，降幅達-11.9%。但出口總量及金額保持微增長。中國海關總署公佈的數據顯示，2017年，中國出口新的充氣橡膠輪胎4.86億條，同比微增0.6%；出口金額人民幣995.75億元，同比增長3.8%。我國仍然是世界輪胎生產大國，第一大輪胎出口國。受益於我國輪胎企業於國際市場上的地位及供給側改革，本集團銷售額比上年同期增長了10.1%，年內毛利上升24.5%至人民幣68,388,000元，本集團二零一八年淨利潤錄得人民幣48,054,000元。

董事會建議派發年內末期股息每股人民幣0.05元。

二零一八年，本集團概無借款，故本集團的資產負債率持續處於低水準，現金流狀況持續良好，維持了穩健的財務狀況。

### 業務發展

二零一九年，「供給側改革」仍將是內地經濟政策的焦點，改革將會逐步深化。其中的首要任務是振興實體經濟，去除過剩產能的同時全面提高產品品質。因此，本集團將從技術品質創新層面來提升產品競爭力，在新常態下，國家鼓勵傳統製造向智慧製造轉變和升級，增長以質為重，董事會對本集團之長遠前景仍持樂觀態度。

In 2018, the Chinese national economy maintained a stable and healthy development and managed to secure a steady growth. In recent years, China's automobile industry experienced a rapid and fierce development, keeping its prominence as the largest automobile producer and the largest new car consumer market in the world. Such development has fuelled the rapid growth of the tire industry. However, the tire industry in China faced a lot of challenges in 2018, and the production volume of tires in China declined. According to the statistics of the National Bureau of Statistics, the production volume of tires in China was 816 million, representing a decrease of 110 million or -11.9% as compared with 2017, while total export volume and amount continued to grow slightly. The data published by the General Administration of Customs of the PRC shows that during 2017, the export of China's new pneumatic rubber tires amounted to 486 million, representing a slight year-on-year increase of 0.6%, and the amount of export reached RMB99.575 billion, representing a year-on-year increase of 3.8%. China is still the world's major tire producer and the largest country of export for tire. Benefited from the position of the Chinese tire enterprises in the international market and the supply-side reform, sales of the Group increased by 10.1% over the same period last year while the gross profit for the Year increased by 24.5% to RMB68,388,000. The Group recorded a net profit of RMB48,054,000 in 2018.

The Board proposes the payment of a final dividend of RMB0.05 per share for the Year.

In 2018, as the Group did not have any borrowings, its gearing ratio continued to be low and cash flow remained in a good condition, maintaining a stable financial condition.

### BUSINESS DEVELOPMENT

In 2019, the "supply side reform" will continue to be the focus of the national economic policy and reforms will gradually be deepened. Among the reforms, the first priority will go to revitalising the real economy and eliminating overcapacity while improving product quality in general. Therefore, the Group will enhance its product competitiveness in terms of technological and quality innovation. Under the new normal, the government encourages the transformation and upgrade of traditional manufacturing to intelligent manufacturing, and emphasises quality improvement. The Board remains optimistic about the long-term prospect of the Group.

## 展望未來

二零一九年，是新中國成立70周年，也是決勝全面建成小康社會關鍵之年。李克強總理在十三屆全國人大二次會議開幕會上作的政府工作報告中給出了二零一九年中國國內生產總值預期目標：6%–6.5%。中國經濟將持續堅持穩中求進的總基調，以供給側結構性改革為主線，深化市場化改革，推進高質量發展。

近幾年，中國汽車行業呈現良好發展態勢，中國汽車保有量龐大，且後續提升空間巨大。一帶一路倡議的實施已強烈刺激着沿線超過60個國家和地區的基礎設施建設及運輸行業，催生了強勁的商用車需求。城鎮化進程、電子商務發展、人口及可支配收入增加均為刺激道路運輸物流增長的需求推動因素。另外我國的輪胎市場70%左右為替代市場，其中，60%為乘用車替換市場。我國有着數量巨大的乘用車保有量，按照3.3年的換胎周期來看，我國每年約有10,860萬條替換輪胎的市場空間，我國的替換輪胎市場空間巨大。所以未來幾年，替換胎市場有望迎來高速增長，這無疑為輪胎替換市場的景氣度增加了砝碼，也將刺激國內胎圈鋼線生產行業增長。

## PROSPECTS

2019 is the 70th anniversary of the founding of the PRC and will be a crucial year in building a moderately prosperous society in all respects. At the opening of the second session of the 13th National People's Congress, Premier Li Keqiang announced an expected goal of 6% to 6.5% increase in the gross domestic product of China in 2019 in the Government Work Report. The economy of China will continue to stick to the general keynote of "seeking improvement while maintaining stability" and emphasise on the supply-side structural reform in order to deepen marketisation reform and to advance high-quality development.

In recent years, the automobile industry in China has been progressing steadily. Vehicle ownership in China is huge and there is still enormous room for growth in subsequent years. With the implementation of the Belt and Road initiative, the infrastructure construction and transportation industries in over 60 countries and regions along the route were stimulated, and thus driving a strong demand for commercial vehicles. In addition, the advancement of urbanisation, development of e-commerce as well as increasing population and disposable income are the growth drivers of the demand for road transportation logistics. Furthermore, around 70% of the tire markets in China are substitution markets, in which 60% are passenger car replacement markets. In view of the huge passenger car ownership in China, there will be a market growth potential of approximately 108,600,000 replacement tires in China each year based on a tire replacement cycle of 3.3 years, creating enormous room for the replacement tires markets in our country. Therefore, in the next several years, the tire replacement market is expected to see a fast growth. This will undoubtedly be a boost to the tire replacement market and stimulate the growth of the domestic bead wire production industry.

## 管理層討論與分析

## Management Discussion and Analysis

### 業務回顧

二零一八年，中國經濟供給側結構性改革深入推進，成效顯著。經濟結構持續優化，新舊動能轉換進一步加快，國民經濟延續總體平穩、穩中向好的發展態勢。輪胎行業卻經歷了環保監管、原材料漲價、中美貿易戰等挑戰，然而機遇與危機並存。二零一九年中國經濟將繼續堅持深化供給側結構性改革，優化經濟結構，淘汰落後產能，不斷推動輪胎行業的結構調整及優化升級。

二零一八年，我國汽車產業面臨較大的壓力，產銷增速低於年初預計，行業主要經濟效益指標增速趨緩，增幅回落。根據中國汽車工業協會（「中汽協」）發佈的最新數據，二零一八年全國汽車產銷分別為2,780.92萬輛和2,808.06萬輛，同比下降4.16%和2.76%。其中乘用車產銷2,352.94萬輛和2,370.98萬輛，同比下降5.15%和4.08%。二零一八年的產銷同期雖有下降，但新能源汽車繼續保持高速增長。據中汽協數據顯示，2018年，新能源汽車產銷分別完成127萬輛和125.6萬輛，比上年同期分別增長59.9%和61.7%。新能源汽車呈現高速增長的態勢，許多企業在新能源汽車領域已經紛紛佈局。本集團作為子午輪胎鋼簾線設備的供應商，在二零一八年積極優化並調整經營策略，強化風險防範和控制，使本集團的經營實現向好發展。

年內，本集團整體業績較二零一七年表現有所增長，本集團銷售額比上年同期增長了10.1%，年內毛利上升24.5%至人民幣68,388,000元，本集團二零一八年淨利潤錄得人民幣48,054,000元。

### BUSINESS REVIEW

In 2018, the economy of the PRC thoroughly deepened the supply-side structural reform with remarkable results. The economic structure continued to improve with conversion of old and new drivers speeding up. As a result, the national economy remained stable in general and was moving in a positive direction. However, the tire industry faced challenges such as environmental regulation, fluctuations in raw material prices and the China-United States trade war while opportunities and risks did co-exist. In 2019, the economy of the PRC will continue to deepen the supply-side structural reform, optimise the economic structure and eliminate obsolete production capacity in order to continuously promote structural adjustment and optimisation of the tire industry.

China's automobile industry was under greater pressure in 2018. The growth of automobiles production and sales were lower than the expectation at the beginning of the year. Major economic indicators of the automobile industry also showed a trend of slowdown. According to the latest data released by China Association of Automobile Manufacturers ("CAAM"), for 2018, production and sales of automobile in China were 27,809,200 vehicles and 28,080,600 vehicles respectively, representing a year-on-year decrease of 4.16% and 2.76%. The production and sales of passenger cars were 23,529,400 vehicles and 23,709,800 vehicles, representing a year-on-year decrease of 5.15% and 4.08%. Although a year-on-year decrease in production and sales was recorded in 2018, the sales of new energy vehicles continued to escalate. According to the data from CAAM, production and sales of new energy vehicles in 2018 were 1,270,000 vehicles and 1,256,000 vehicles respectively, representing an increase of 59.9% and 61.7% as compared with the same period last year. As new energy automobile showed a trend of fast growth, many enterprises started their development in the new energy vehicle sector. The Group, as a radial tire steel cord equipment supplier, has actively optimised and adjusted its operating strategies and strengthened its risk prevention and control, which enabled the Group's business to have a satisfactory progress in 2018.

The overall performance of the Group during the Year showed a growth as compared to 2017. Sales of the Group increased by 10.1% as compared to the same period of last year and gross profit for the Year increased by 24.5% to RMB68,388,000. The Group recorded a net profit of RMB48,054,000 in 2018.

本集團2018年的收入約為人民幣176,900,000元，較2017年約人民幣160,600,000元上升約人民幣16,300,000元（或約10.1%），主要源於下游行業擴張及市場需求增長。

**電鍍黃銅鋼絲生產線。**電鍍黃銅鋼絲生產線於2018年的銷售收入約為人民幣63,000,000元，較2017年約人民幣21,300,000元增長約196.2%。於2018年有4套電鍍黃銅鋼絲生產線獲客戶接納，而2017年則有2套獲客戶接納。該增幅主要源於市場對成套生產線的需求上升。

**其他生產線。**其他生產線於2018年的銷售收入約為人民幣15,400,000元，較2017年約人民幣20,400,000元下跌約24.5%，主要由於涉及較不複雜生產工序的其他生產線售價下跌所致。

**單機。**單機於2018年的銷售收入約為人民幣72,600,000元，較2017年約人民幣95,000,000元下跌約23.5%，原因為單機銷量下跌，而已售出單機數目由2017年的576套倒退至2018年的565套。

Our revenue increased by approximately RMB16.3 million or approximately 10.1% to approximately RMB176.9 million for 2018 from approximately RMB160.6 million for 2017. The increase is mainly due to the expansion in downstream industry and growth in market demand.

**Brass electroplating wire production lines.** Revenue from sales of brass electroplating wire production lines increased by approximately 196.2% to approximately RMB63.0 million for 2018 from approximately RMB21.3 million for 2017. 4 sets of brass electroplating wire production lines were accepted by the customers in 2018 while 2 sets were accepted by the customers in 2017. The increase was mainly due to the increase in market demand for the completed set of production lines.

**Other production lines.** Revenue from sales of other production lines decreased by approximately 24.5% to approximately RMB15.4 million for 2018 from approximately RMB20.4 million for 2017. The decrease was mainly due to the decrease in the sales price of other production lines with less complicated manufacturing process.

**Standalone machineries.** Revenue from sales of standalone machineries decreased by approximately 23.5% to approximately RMB72.6 million for 2018 from approximately RMB95.0 million for 2017. The decrease was due to the decrease in sales quantity in the standalone machineries, with the number of standalone machineries being sold declined from 576 sets in 2017 to 565 sets in 2018.

修模設備、零部件及配件。修模設備、零部件及配件於2018年的銷售收入約為人民幣23,000,000元，較2017年約人民幣21,600,000元增長約6.5%，主要源於向客戶提供的設備改裝服務增加。

**租金收入。**租金收入來自於2018年及2017年出租給第三方的本集團投資物業。由於2018年每月租金上升，故租金收入增加。

#### 毛利及毛利率

毛利由2017年約人民幣54,900,000元增加約24.5%至2018年約人民幣68,400,000元。整體毛利率由2017年約34.2%上升至2018年約38.7%，主要原因為銷售組合中電鍍黃銅鋼絲生產線的比例較高，其毛利率亦相對較其他產品高。

#### 其他收入

本集團的其他收入由2017年約人民幣500,000元增加約288.1%至2018年約人民幣2,000,000元，主要由於已收增值稅退稅增加所致。

#### 銷售開支

本集團的銷售開支由2017年約人民幣4,900,000元減少約5.6%至2018年約人民幣4,600,000元，主要由於運輸開支下降所致。

#### 行政開支

本集團的行政開支由2017年約人民幣26,700,000元上升至2018年約人民幣30,100,000元，主要由於專業費用增加所致。

*Mould repairing equipment, component parts, and accessories.* Revenue from sales of mould repairing equipment, component parts, and accessories increased by approximately 6.5% to approximately RMB23.0 million for 2018 from approximately RMB21.6 million for 2017. The increase was primarily due to the increase in equipment modification services provided to customers.

*Rental income.* Revenue from rental income arose from the Group's investment properties, which were rented to third parties in 2018 and 2017. As the rental price per month increased during 2018, the rental income has increased.

#### Gross profit and gross profit margin

Our gross profit increased by approximately 24.5% from approximately RMB54.9 million for 2017 to approximately RMB68.4 million for 2018. Our overall gross profit margin increased from approximately 34.2% for 2017 to approximately 38.7% for 2018, mainly due to a higher proportion of the brass electroplating wire production lines in the sales mix with its relatively higher gross profit margin as compared to other products.

#### Other income

Our other income increased by approximately 288.1% from approximately RMB0.5 million for 2017 to approximately RMB2.0 million for 2018, primarily due to more value-added tax refunds received.

#### Selling expenses

Our selling expenses decreased by approximately 5.6% from approximately RMB4.9 million for 2017 to approximately RMB4.6 million for 2018, primarily due to the decrease in transportation expenses.

#### Administrative expenses

Our administrative expenses increased from approximately RMB26.7 million for 2017 to approximately RMB30.1 million for 2018. This is primarily due to the increase in professional fees.

**金融資產減值虧損撥回淨額**

本集團的金融資產減值虧損撥回淨額由2017年約人民幣9,600,000元減少至2018年約人民幣8,400,000元，主要由於因採納香港財務報告準則第9號而令應收款項減值撥備增加所致。

**其他收益 — 淨額**

於2018年，本集團錄得其他收益淨額約人民幣10,100,000元，而2017年則錄得其他收益淨額約人民幣3,700,000元。其他收益主要包括出售按公平值計入損益的金融資產的收益及外匯收益。

**財務收入 — 淨額**

於2018年，本集團錄得財務收入淨額約人民幣4,500,000元，而2017年則錄得財務收入淨額約人民幣3,500,000元。財務收入增加主要源於銀行利息收入。

**所得稅開支**

於2018年，本集團錄得所得稅開支約人民幣10,600,000元，而2017年的所得稅開支則約為人民幣7,200,000元。本集團僅會在很有可能於日後可獲得應課稅溢利以供使用暫時性差異時，方確認遞延所得稅資產。

**貿易應收款項**

本集團的貿易應收款項總額由2017年12月31日約人民幣170,700,000元減少約17.8%至2018年12月31日約人民幣140,300,000元，主要是由於向客戶採取更為嚴緊的收款政策，且隨着下游行業擴張，我們客戶的還款能力有所增強。同時於2018年，本集團收回已減值貿易應收款項約人民幣18,200,000元。貿易應收款項撥備由2017年末約人民幣72,500,000元下降至2018年末約人民幣61,300,000元。

**Net reversal of impairment losses on financial assets**

Our net reversal of impairment losses on financial assets decreased from approximately RMB9.6 million for 2017 to approximately RMB8.4 million for 2018, primarily due to the increase in allowance for impairment of receivables from the adoption of HKFRS 9.

**Other gains — net**

The Group recorded net other gains of approximately RMB10.1 million in 2018, compared with the net other gains of approximately RMB3.7 million in 2017. Other gains mainly included gains on disposal of financial assets at fair value through profit or loss and foreign exchange gains.

**Finance income — net**

The Group recorded a net finance income of approximately RMB4.5 million in 2018, compared with the net finance income of approximately RMB3.5 million in 2017. The increase in finance income was mainly due to the bank interest income.

**Income tax expense**

The Group recorded income tax expense of approximately RMB10.6 million for 2018, compared with the income tax expense of approximately RMB7.2 million for 2017. The Group recognised the deferred income tax assets only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

**Trade receivables**

Our gross trade receivables decreased by approximately 17.8% from approximately RMB170.7 million as at 31 December 2017 to approximately RMB140.3 million as at 31 December 2018. The decrease was primarily due to the adoption of more stringent collection policy over the customers and the increase of repayment ability of our customers resulting from the extension in downstream industries. Meanwhile, the Group collected approximately RMB18.2 million impaired trade receivables during 2018, and the allowance for trade receivables decreased from approximately RMB72.5 million at the end of 2017 to approximately RMB61.3 million at the end of 2018.

#### 存貨

本集團的存貨由2017年末約人民幣92,600,000元減少約29.3%至2018年末約人民幣65,500,000元，主要原因為2018年末的未完成銷售合約較2017年有所減少。

#### 貿易應付款項

本集團的貿易應付款項由2017年末約人民幣29,100,000元減少約27.3%至2018年末約人民幣21,200,000元，主要由於我們於年內減少採購原材料所致。

#### 流動資金及財務資源

##### 現金狀況及可動用資金

年內，本集團透過經營現金流量撥付營運資金，維持穩健的流動資金狀況。

於2018年12月31日，本集團的現金及銀行結餘總額約為人民幣278,100,000元（2017年12月31日：約人民幣227,500,000元），包括現金及現金等值項目約人民幣134,800,000元（2017年12月31日：約人民幣71,900,000元）、有限制現金約人民幣10,900,000元（2017年12月31日：約人民幣49,800,000元）及定期存款約人民幣132,400,000元（2017年12月31日：約人民幣105,800,000元）。

於2018年12月31日，本集團的流動比率為6.4（2017年12月31日：3.8）。流動比率上升主要源於貿易及其他應付款項以及合約負債減少所致。

本集團的資產負債比率（按總借款除以總權益計算）為零（2017年12月31日：零）。

於2018年及2017年12月31日，本集團處於強勁淨現金狀況。本集團擁有充足及隨時可用的財務資源滿足一般營運資金需要及可見將來的資本開支。

#### Inventories

Our inventories decreased by approximately 29.3% from approximately RMB92.6 million at the end of 2017 to approximately RMB65.5 million at the end of 2018, mainly because the unfinished sales contracts at the end of 2018 decreased as compared with those in 2017.

#### Trade payables

Our trade payables decreased by approximately 27.3% from approximately RMB29.1 million at the end of 2017 to approximately RMB21.2 million at the end of 2018, primarily due to a decrease in our purchase of raw materials during the Year.

#### LIQUIDITY AND FINANCIAL RESOURCES

##### Cash position and fund available

During the Year, the Group maintained a healthy liquidity position, with working capital being financed by our operating cash flows.

As at 31 December 2018, the total cash and bank balances of the Group were approximately RMB278.1 million (31 December 2017: approximately RMB227.5 million), comprising cash and cash equivalents of approximately RMB134.8 million (31 December 2017: approximately RMB71.9 million), restricted cash of approximately RMB10.9 million (31 December 2017: approximately RMB49.8 million) and time deposits of approximately RMB132.4 million (31 December 2017: approximately RMB105.8 million).

As at 31 December 2018, the current ratio of the Group was 6.4 (31 December 2017: 3.8). The increase was mainly due to the decrease of trade and other payables and contract liabilities.

The gearing ratio of the Group (calculated as total borrowings divided by total equity) was zero (31 December 2017: zero).

The Group was in a strong net cash position as at 31 December 2018 and 2017. The Group has sufficient and readily available finance resources for general working capital requirement and foreseeable capital expenditure.



### 借款

於2018年12月31日，本集團概無任何借款(2017年12月31日：無)。

### 資本開支

於2018年，本集團的資本開支約為人民幣2,500,000元(2017年：約人民幣2,100,000元)，約人民幣200,000元用於興建樓宇及約人民幣2,300,000元用於購置機器及設備。

### 資本架構

年內，本集團的資本架構概無變動。本集團的資本僅由普通股組成。

### 外幣風險

外匯風險來自並非以實體功能貨幣計值的商業交易或已確認資產或負債。

本集團於中國營運，大部分交易以人民幣計值及結算，惟若干貿易應收款項、現金及現金等值項目以及定期存款以美元計值，須承受外幣換算風險。

倘美元兌人民幣升值／貶值5%，而所有其他變數維持不變，則本集團截至2018年12月31日止年度的淨業績應因以美元計值的各項金融資產而增加／減少約人民幣3,912,000元(2017年：人民幣3,025,000元)。

年內，本集團並無採用任何金融工具作對沖目的。管理層將繼續監察外幣風險，並於適當時候採取審慎措施。

### Borrowings

As at 31 December 2018, the Group had no borrowings (31 December 2017: Nil).

### CAPITAL EXPENDITURES

In 2018, the Group's capital expenditures amounted to approximately RMB2.5 million (2017: approximately RMB2.1 million) which was related to the construction of buildings of approximately RMB0.2 million and the purchase of machineries and equipments of approximately RMB2.3 million.

### CAPITAL STRUCTURE

There has been no change in the capital structure of the Group during the Year. The capital of the Group only comprises ordinary shares.

### FOREIGN CURRENCY RISK

Foreign exchange risk arises when transaction or recognised assets or liabilities are denominated in a currency that is not the entity's functional currency.

The Group operates in the PRC with most of the Group's transactions denominated and settled in RMB, except that certain trade receivables, cash and cash equivalents and time deposits are denominated in US dollar ("USD") which are exposed to foreign currency translation risk.

If the USD had strengthened/weakened by 5% against the RMB while all other variables had been held constant, the Group's net result for the year ended 31 December 2018 would have been approximately RMB3,912,000 better/worse (2017: RMB3,025,000), for various financial assets denominated in USD.

During the Year, the Group did not use any financial instruments for hedging purposes. The management will continue to monitor foreign currency risk and adopt prudent measures as and when appropriate.

#### 上市所得款項淨額的用途

本公司的H股於2014年11月11日（「**上市日期**」）在香港聯合交易所有限公司（「**聯交所**」）上市（「**上市**」）。經扣除包銷佣金、費用及上市相關開支後，上市所得款項淨額約為209,500,000港元（相等於約人民幣165,300,000元）。

為了提高本公司暫時閒置募集資金的使用效率，董事會在確保不影響已承擔專案建設和有關興建資金使用計劃的情況下，擬使用部分暫時閒置募集資金購買理財產品，以提高資金收益，提升本公司暫時閒置募集資金的使用效率和效果，繼而進一步提高本公司整體收入，為本公司和股東整體謀取更好的投資回報。有關上市所得款項淨額用途變更的更多詳情，請參閱本公司日期為2016年3月29日的公告（「**該公告**」）。

於2018年6月8日舉行的本公司股東週年大會上，董事會獲授權於由授出批准起計一年內隨時行使決策權力，利用合共不超過人民幣35,000,000元的暫時閒置募集資金購買理財產品。由於董事會獲授以暫時閒置募集資金購買理財產品的權力將於相關批准後滿一年時到期，故本公司即將舉行的股東週年大會上將提呈一項特別決議案以更新該授權。有關授出該等授權的詳情，請參閱本公司日期為2018年4月23日的通函。

連同理財產品將產生的收入，本公司將按其日期為2014年10月30日的招股章程（「**招股章程**」）及該公告所述，繼續動用上市所得款項淨額興建位於中國江蘇省無錫的新生產設施（「**無錫新設施**」）及將於無錫新設施成立的新研發中心（「**新研發中心**」）以及其他用途。

#### USE OF NET PROCEEDS FROM THE LISTING

The Company's H shares have been listed (the "**Listing**") on The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") since 11 November 2014 (the "**Listing Date**"). The net proceeds from the Listing after the deduction of underwriting commissions, fees and listing-related expenses amounted to approximately HK\$209.5 million (equivalent to approximately RMB165.3 million).

With a view to improving efficiency in the use of the Company's temporary idle raised proceeds, on the condition that the construction of the committed projects and planned usage of the proceeds for such construction will not be affected, the Board has proposed to utilise part of the temporary idle raised proceeds to purchase wealth management products in order to increase the capital revenue, improve the efficiency and effectiveness in the use of the Company's temporary idle raised proceeds, which in turn shall further enhance the overall revenue of the Company and pursue better investment return to the Company and the shareholders as a whole. For more details regarding the change of use of net proceeds from the Listing, please refer to the announcement of the Company dated 29 March 2016 (the "**Announcement**").

At the annual general meeting of the Company held on 8 June 2018, the Board was authorised, within one year commencing from the approval, to exercise the decision-making power regarding purchase of wealth management products by utilising temporary idle proceeds for not more than RMB35 million in aggregate at any time. Since the authority granted to the Board to purchase wealth management products with the temporary idle proceeds will expire one year after such approval, a special resolution will be proposed at the forthcoming annual general meeting of the Company to renew such authority. For details of the grant of such authorities, please refer to the circular of the Company dated 23 April 2018.

Together with the income to be generated from the wealth management products, the Company will continue apply the net proceeds from the Listing for the construction of the new manufacturing facility located in Wuxi, Jiangsu Province of the PRC (the "**New Wuxi Facility**") and the new research & development centre to be established in the New Wuxi Facility (the "**New Research & Development Centre**") and for other purposes in accordance with the prospectus of the Company dated 30 October 2014 (the "**Prospectus**") and in the Announcement.

## 展望

二零一九年中國供給側改革繼續深化，將會維持經濟穩中向好的態勢，輪胎行業將會加速出清落後產能，加快行業整合轉型，我國輪胎行業整體結構將不斷優化。大浪淘沙，輪胎行業將向集團化、多元化、差異化不斷發展，為輪胎企業走向更加強大奠定基礎。本集團將抓住行業發展變化，抓住市場機遇，通過始終如一的嚴謹管理，成本控制及精益生產，致力維持本集團的領先地位。

## PROSPECTS

In 2019, China's supply-side reform will continue to deepen and the national economy will remain stable with improvements. The Chinese tire industry will step up the elimination of obsolete production capacity and the adjustments and transformation of the tire industry in order to continuously optimise the overall structure of the industry. As a result, only the fittest could survive and the tire industry will continue to develop towards centralisation, diversification and differentiation, thereby strengthening the foundation of tire enterprises. Through consistent and precise management, cost control and lean manufacturing, the Group will seize the market opportunities brought by the development of the industry in order to successfully maintain the leading position of the Group.

此外，隨着我國經濟快速發展和道路建設的大幅提速，汽車工業、交通運輸業和工程機械業得到快速發展，從而推動中國汽車保有量增加。截至二零一八年底，全國汽車保有量達2.4億輛，比二零一七年增加2,285萬輛，增長10.51%。汽車保有量持續增長，帶動輪胎需求穩步提升。一帶一路倡議的實施已經強烈刺激着沿線超過60個國家和地區的基礎設施建設及運輸行業，催生了強勁的商用車需求。城鎮化進程、電子商務發展、人口及可支配收入增加均為刺激道路運輸物流增長的需求推動因素。因此，由於商用車數量的增加以及貨運里程延長引致的輪胎磨損，配套及替換輪胎市場將進一步發展，又將刺激國內胎圈鋼線生產行業增長。

隨着政府對環保監管的力度不斷加大，新能源汽車市場不斷興盛，本集團在此大環境下將迎來更多機遇與挑戰。集團將不斷審視及關注行業趨勢而採取策略性導向，將加大技術開發，持續對現有生產線進行升級，改善集團產品及生產流程的工藝與質量，以提高子午輪胎線的產能。此外，本集團亦積極拓展國內外市場，穩定和擴大現有市場佔有率，以鞏固本集團的長期可持續增長及盈利能力。

### 僱員及薪酬資料

於2018年12月31日，本集團僱用合共138名（2017年12月31日：147名）全職僱員，當中包括行政、財務、內部審核、研發、技術應用、品質控制、製造、採購、銷售及營銷員工。截至2018年12月31日止年度，本集團的僱員薪酬總額約為人民幣16,800,000元（2017年：約人民幣17,600,000元）。

In addition, rapid growth in both the economy in China and the number of national road construction projects supported the fierce development in the automobile, transportation and mechanical engineering industries, leading to the increase in automobile ownerships in China. As at the end of 2018, automobile ownerships in China reached 240 million, representing an increase of 22,850,000 vehicles or 10.51% as compared with 2017. Continuous growth in automobile ownerships also drove the demand for tires. With the implementation of the Belt and Road Initiative, the infrastructure construction and transportation industries in over 60 countries and regions along the route were stimulated, thus driving a strong demand for commercial vehicles. In addition, the advancement of urbanisation, rapid development of e-commerce as well as increasing population and disposable income are the growth drivers of the demand for road transportation logistics. As a result, with the increasing number of commercial vehicles and continuous wearing of tires due to ever-increasing transportation frequency, the markets of accessories and tire replacement will be further developed, and the growth of the domestic bead wire production industry will also be stimulated.

As the government is tightening environmental regulation and the new energy vehicle market continues to prosper, the Group will face more opportunities and challenges in this environment. The Group will review and keep abreast of industry trends and take strategic steps accordingly. The Group will also strengthen technological development, upgrade its existing production lines, improve the quality of the Group's products and production processes in order to enhance the production capacity of radial tire cord. In addition, the Group will actively explore domestic and overseas markets, and maintain and expand its existing market share, in order to strengthen the Group's long-term sustainable growth and profitability.

### EMPLOYEE AND REMUNERATION INFORMATION

As at 31 December 2018, the Group employed a total of 138 full-time employees (31 December 2017: 147), including administration, finance, internal audit, research and development, technical application, quality control, manufacturing, procurement, sales and marketing staff. For the year ended 31 December 2018, the Group's total employee remuneration was approximately RMB16.8 million (2017: approximately RMB17.6 million).

本集團的薪酬政策乃基於個別僱員的表現制定並定期檢討。本集團亦會因應盈利情況及員工表現，酌情發放花紅予僱員以鼓勵彼等為本集團作出貢獻。有關制定本集團執行董事薪酬方案的薪酬政策主要宗旨在於讓本集團按所達致的公司目標將彼等的補償與業績掛鉤，藉此挽留及激勵執行董事。

本公司已成立薪酬委員會，以檢討本集團的薪酬政策以及董事及本集團高級管理人員整體薪酬的架構，其中已考慮到本集團的經營業績、個人工作表現及相若的市場慣例。

本集團十分重視聘用及培訓優秀人才，透過向新僱員提供入職培訓計劃及向現有僱員提供持續內部培訓，提升彼等的行業、技術及產品知識、職業道德以及於行業品質標準及工作安全標準方面的知識。此外，本集團鼓勵僱員報讀高階課程及考取專業資格。

本集團有信心其僱員將繼續為本集團的成功打造堅實基礎，並將繼續為客戶提供高水準服務。

本集團未曾因勞資糾紛或大量員工流失而導致正常業務營運出現任何受阻情況。董事認為，本集團與員工維持非常良好的關係。

於2018年12月31日，本集團概無任何重大或然負債(2017年12月31日：無)。

The Group's remuneration policies are formulated based on the performance of individual employees and are reviewed regularly. Subject to the Group's profitability and the staff performance, the Group may also provide a discretionary bonus to employees as an incentive for their contribution to the Group. The primary goal of the remuneration policy with regard to the remuneration packages of the Group's executive Directors is to enable the Group to retain and motivate executive Directors by linking their compensation with performance as measured against corporate objectives achieved.

A remuneration committee is set up for reviewing the Group's remuneration policy and structure of all remuneration of the Directors and senior management of the Group, having regard to the Group's operating results, individual performance and comparable market practices.

The Group places great emphasis on recruiting and training quality personnel by providing orientation programmes to the new employees and on-going internal training to the existing employees to enhance their industry, technical and product knowledge, their work ethics as well as their knowledge of industry quality standards and work safety standards. Furthermore, the Group encourages its employees to take advanced courses and to obtain professional certifications.

The Group is confident that its employees will continue to provide a solid foundation for the success of the Group and will maintain a high standard of service to our customers.

The Group has not experienced any disruption of its normal business operations due to labour disputes or significant turnover of staff. The Directors consider that the Group has maintained a very good relationship with its staff.

### CONTINGENT LIABILITIES

As at 31 December 2018, the Group did not have any significant contingent liabilities (31 December 2017: Nil).

於2018年4月19日、2018年4月20日、2018年4月21日及2018年4月22日，本公司與獨立第三方山東勝通房地產開發有限公司（「賣方」）訂立多份買賣協議，據此，本公司同意購買而賣方同意出售中國山東省東營市墾利區廣興路269號同興花園的166個住宅單位（「該等物業」），總代價為人民幣74,347,796元（相等於約92,934,745港元）（「收購事項」）。該等物業作住宅單位及配套設施（包括停車庫及儲藏室）的總建築面積分別為18,920.94平方米及3,331.19平方米。

賣方為於中國成立的有限責任公司。

#### SIGNIFICANT INVESTMENTS

Save and except for the wealth management products as disclosed under paragraph headed “Discloseable Transactions in relation to Subscription of Wealth Management Product — Structured Deposit” and the properties held for sale as disclosed under paragraphs headed “Major Transaction in relation to Acquisition of Properties” and “Properties held for Sale” of this report, the Group had no significant investments held during the Year.

#### MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES, ASSOCIATES AND JOINT VENTURES

During the Year, the Group had no acquisition or disposal of subsidiaries, associates or joint ventures.

#### MAJOR TRANSACTION IN RELATION TO ACQUISITION OF PROPERTIES

On 19 April 2018, 20 April 2018, 21 April 2018 and 22 April 2018, the Company and an independent third party 山東勝通房地產開發有限公司 (Shandong Snton Real Estate Development Co., Ltd\*) (the “Vendor”) entered into sale and purchase agreements, pursuant to which the Company agreed to purchase and the Vendor agreed to sell 166 residential units of Tong Xing Garden, No. 269 Guanxing Road, Kenli District, Dongying City, Shandong Province, the PRC (the “Properties”) at an aggregate consideration of RMB74,347,796 (equivalent to approximately HKD92,934,745) (the “Acquisition”). The Properties have a total gross floor area of 18,920.94 square metres and 3,331.19 square metres for the residential units and ancillary facilities (including car parking spaces and storage rooms), respectively.

The Vendor is a limited liability company established in the PRC.

Before the Acquisition, an aggregate amount of RMB74,347,796 (equivalent to approximately HKD92,934,745) for the purchase of equipment under the Company’s trade receivables from 山東勝通鋼簾線有限公司 (Shandong Snton Steelcord Co., Ltd.\*) (“Shandong Snton Steelcord”) remained outstanding.

為收回未償還款項及降低壞賬風險，本公司已同意向賣方（山東勝通鋼簾線的關聯公司）購買該等物業，以抵銷山東勝通鋼簾線的未償還金額。於進行收購事項後，山東勝通鋼簾線有關購置設備的未償還金額人民幣74,347,796元（包括約人民幣8,706,825元的壞賬減值金額）將獲悉數償付。本公司相信相比任何其他收回未償還款項的方法，進行收購事項更具效率，所耗費的時間也較少。

由於有關收購事項的一個或多個相關百分比率（定義見聯交所證券上市規則（「**上市規則**」））超過25%但低於100%，故根據上市規則第十四章，收購事項構成本公司一項主要交易，並因此須遵守上市規則第十四章下的通知、刊發公告及股東批准規定。

就董事於作出一切合理查詢後所深知、盡悉及確信，概無本公司股東（「**股東**」）或彼等各自任何聯繫人於收購事項中擁有任何重大權益。因此，倘召開股東大會以批准收購事項，概無股東將須放棄表決權。根據上市規則第14.44條，可接受股東給予書面批准代替召開股東大會。本公司已取得一組緊密聯繫股東（即張德剛先生、張德強先生及張靜華女士）的收購事項書面批准，彼等分別持有43,221,504股、29,983,104股及4,027,392股股份，佔本公司已發行股本的33.77%、23.42%及3.15%。張德剛先生、張德強先生及張靜華女士為家族成員及一致行動人士，彼等合共持有77,232,000股股份，佔本公司已發行股本約60.34%。故此，本公司將不會就批准收購事項召開股東大會。

In order to recover the outstanding amount and to reduce the risk of bad debts, the Company agreed to purchase the Properties from the Vendor, a related company of Shandong Snton Steelcord, to set off the amount outstanding from Shandong Snton Steelcord. After the Acquisition, the outstanding amount of RMB74,347,796 (inclusive of the bad debt impairment amount of approximately RMB8,706,825) for the purchase of equipment by Shandong Snton Steelcord would fully be repaid. The Company believes that the Acquisition is more efficient and less time consuming than any other ways for the recovery of the outstanding amount.

As one or more of the relevant percentage ratios (as defined under the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”)) in respect of the Acquisition exceeds 25% but is less than 100%, the Acquisition constitutes a major transaction for the Company under Chapter 14 of the Listing Rules and is therefore subject to the notification, publication and shareholders’ approval requirements under Chapter 14 of the Listing Rules.

To the best of the knowledge, information and belief of the Directors, having made all reasonable enquiries, no shareholder of the Company (the “**Shareholder**”) or any of their respective associates have any material interest in the Acquisition. As such, no Shareholder would be required to abstain from voting if a general meeting were convened to approve the Acquisition. Pursuant to Rule 14.44 of the Listing Rules, a written shareholders’ approval may be accepted in lieu of a general meeting. Written approval of the Acquisition has been obtained from a closely allied group of Shareholders, namely Mr. Zhang Degang, Mr. Zhang Deqiang and Ms. Zhang Jinghua, who respectively holds 43,221,504 shares, 29,983,104 shares and 4,027,392 shares, representing 33.77%, 23.42% and 3.15% of the issued share capital of the Company. Mr. Zhang Degang, Mr. Zhang Deqiang and Ms. Zhang Jinghua are family members and persons acting in concert, and they collectively hold 77,232,000 shares, representing approximately 60.34% of the issued share capital of the Company. Accordingly, no general meeting of the Company will be convened for the purpose of approving the Acquisition.

The Group currently holds 100% interest in the Properties. The Group has an intention to sell the Properties and, accordingly, such rights are recognised as properties held for sale upon the completion of the transfer of the title of the Properties from the Vendor to the Company on 29 May 2018. For more information regarding the Properties, please refer to paragraph headed “Major Transaction in relation to Acquisition of Properties” of this report.

#### CHARGE ON GROUP ASSETS

As at 31 December 2018, the cash deposits in the amount of approximately RMB10.9 million (31 December 2017: approximately RMB49.8 million) were pledged to banks as security for notes payable and letter of guarantee for export sales. Save for that, the Group did not have any charges on its assets as at 31 December 2018 or 31 December 2017.

#### FUTURE PLANS FOR MATERIAL INVESTMENTS AND EXPECTED SOURCE OF FUNDS

In the future, the Group will continue to implement its diversified development strategy and proactively search for potential investment opportunities.

Save as disclosed in the Prospectus or elsewhere in this report, the Group had no future plans for material investments and expected source of funds as at 31 December 2018.

In January 2013, Mr. Zhang was accredited by 中國共產黨澄江街道工作委員會澄江街道辦事處 (Chengjiang Road Office of the Chengjiang Road Working Committee of the Communist Party of China\*) as the “明星企業家” (Star Entrepreneur\*) for the year 2012. ## Corporate Governance Report

### 遵守企業管治守則

董事會致力秉持高水平的企業管治及商業道德，並確信這對提升投資者信心及給予股東最大回報而言至關重要。董事會不時檢討其企業管治常規，以符合權益人日益提高的期望、遵守日益嚴緊的監管規定，並履行其對卓越企業管治的承諾。

董事會經審閱本公司的企業管治常規及上市規則附錄十四所載企業管治守則及企業管治報告（「**企業管治守則**」）的相關規例後，信納本公司於年內已遵守企業管治守則條文。

### 遵守董事進行證券交易的標準守則

本公司已採納上市規則附錄十所載上市發行人董事進行證券交易的標準守則（「**標準守則**」）作為本公司董事及監事進行證券交易的行為守則。經本公司向其全體董事及監事作出具體查詢後，本公司全體董事及監事確認，彼等已各自於年內一直全面遵守標準守則所載的規定標準。

因受聘於本公司而可能管有有關本公司證券的內幕消息的任何本公司僱員或任何本公司附屬公司董事或僱員，亦已被要求於標準守則禁止其買賣本公司證券時，不要進行任何買賣，猶如彼為一名董事。

### COMPLIANCE WITH CORPORATE GOVERNANCE CODE

The Board is committed to upholding a high standard of corporate governance and business ethics in the firm belief that they are essential for enhancing investors' confidence and maximising shareholders' returns. The Board reviews its corporate governance practices from time to time in order to meet the rising expectations of stakeholders, comply with increasingly stringent regulatory requirements and fulfill its commitment to excellence in corporate governance.

After reviewing the Company's corporate governance practices and the relevant regulations of the Corporate Governance Code and Corporate Governance Report (the "**CG Code**") as set out in Appendix 14 to the Listing Rules, the Board is satisfied that the Company has complied with the CG Code provisions for the Year.

### COMPLIANCE WITH MODEL CODE FOR SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers as set out in Appendix 10 to the Listing Rules (the "**Model Code**") as the code of conduct regarding securities transactions by the Directors and supervisors of the Company. Upon making specific enquiries of all the Directors and supervisors of the Company, each of the Directors and supervisors of the Company confirmed that he/she has fully complied with the required standards set out in the Model Code throughout the Year.

Any employee of the Company or director or employee of any subsidiary of the Company who, because of their office in the Company, are likely to be in possession of inside information in relation to the securities of the Company, have also been requested not to deal in securities of the Company when he/she would be prohibited from dealing by the Model Code as if he/she were a Director.

## 董事會

董事會現時包括兩名執行董事張德剛先生及張德強先生，兩名非執行董事張靜華女士及高峰先生，以及三名獨立非執行董事劉朝建先生、高富平先生及何育明先生。張德剛先生為董事會主席。

彼等的履歷詳情及（如適用）親屬關係載於本年報第22至32頁「董事、監事及高級管理層簡歷」一節。列明董事角色及職能以及獨立非執行董事身份的董事名單可於本公司網站查閱。

執行董事兼董事會主席張德剛先生為張德強先生及張靜華女士（分別為執行董事兼本集團總經理以及非執行董事）的胞弟。除已披露者外，董事會成員之間並無任何其他財務、業務、親屬或其他重大／相關關係。

董事會制訂本集團的整體目標及策略，監察及評估其營運及財務表現，並審閱本集團的企業管治準則，亦就年度及中期業績、主要交易、董事委任或連任、投資政策、股息及會計政策等事宜作出決定。董事會已將執行其業務策略及管理本集團業務日常營運的權力及責任轉授予執行董事及高級管理層成員。董事會定期檢討所轉授的職能及權力，以確保有關轉授仍屬合適。

## BOARD OF DIRECTORS

The Board is committed to providing effective and responsible leadership for the Company. The Directors, individually and collectively, must act in good faith in the best interests of the Company and its shareholders. The Board has established four Board committees, being the Audit Committee, the Remuneration and Appraisal Committee, the Nomination Committee and the Strategic Committee (each a “**Board Committee**” and collectively the “**Board Committees**”), to oversee different areas of the Company’s affairs.

The Board currently comprises two executive Directors, namely Mr. Zhang Degang and Mr. Zhang Deqiang, two non-executive Directors, namely, Ms. Zhang Jinghua and Mr. Gao Feng, and three independent non-executive Directors, namely, Mr. Liu Chaojian, Mr. Gao Fuping and Mr. Ho Yuk Ming, Hugo. Mr. Zhang Degang is the chairman of the Board.

Their biographical details and their family relationships (where applicable) are set out in the section headed “Biographies of Directors, Supervisors and Senior Management” on pages 22 to 32 in this annual report. A list of the Directors identifying their roles and functions and whether they are independent non-executive Directors are available on the Company’s website.

Mr. Zhang Degang, an executive Director and the chairman of the Board, is the brother of Mr. Zhang Deqiang and Ms. Zhang Jinghua, who are the executive Director and general manager of the Group, and the non-executive Director, respectively. Save as disclosed, there are no other financial, business, family or other material/relevant relationships among the members of the Board.

The Board sets the Group’s overall objectives and strategies, monitors and evaluates its operating and financial performance and reviews the corporate governance standard of the Group. It also decides on matters such as annual and interim results, major transactions, Directors’ appointments or re-appointments, investment policies, dividend and accounting policies. The Board has delegated the authority and responsibility for implementing its business strategies and managing the daily operations of the Group’s businesses to the executive Directors and the members of senior management. The functions and powers that have been delegated are reviewed periodically to ensure that they remain appropriate.

The Board is also responsible for developing, reviewing and monitoring the policies and practices on corporate governance and legal and regulatory compliance of the Group, and the training and continuous professional development of the Directors and senior management. The Board also reviews the disclosures in the Corporate Governance Report to ensure compliance.

All Board members have separate and independent access to the Group's senior management to fulfill their duties. Independent professional advice can be sought to assist the relevant Directors to discharge their duties at the Group's expense upon their request. During the Year, all Directors are provided with monthly updates on the Company's performance and financial position to enable the Board as a whole and each Director to discharge their duties.

All Directors are required to declare to the Board upon their first appointment of directorships or other positions which they are concurrently holding at other companies or organisations. These interests are updated on an annual basis and when necessary.

#### DIRECTORS' AND OFFICERS' INSURANCE

The Company has arranged appropriate insurance cover in respect of potential legal actions against its Directors and officers.

## 主席及行政總裁

董事會主席與行政總裁職權分離，不由同一人擔任，以確保更有效的制衡，從而達到更良好的企業管治。張德剛先生擔任董事會主席一職，主要負責本集團整體策略、規劃及業務發展。張德強先生擔任本集團總經理，主要負責本集團營運。

## 獨立非執行董事的獨立性

獨立非執行董事的角色乃向董事會提供獨立及客觀的意見，為本集團提供足夠的制約及平衡，以保障股東及本集團整體利益。彼等於董事會及該等董事委員會上積極提供獨立客觀的見解。

本公司已遵照上市規則第3.10(1)及3.10A條，委任三名獨立非執行董事，佔董事會人數超過三分之一。其中一名獨立非執行董事具備上市規則第3.10(2)條所規定的適當會計專業資格或相關財務管理專長。

各獨立非執行董事已根據上市規則第3.13條以書面形式向本公司提交其年度獨立身分確認書。根據該等確認書的內容，本公司認為全體獨立非執行董事均為獨立，其獨立判斷不會受到任何關係的重大影響。

## 該等董事委員會

董事會獲得該等董事委員會(包括審核委員會、提名委員會、薪酬與考核委員會及戰略委員會)支援。各董事委員會均有經董事會批准的明確書面職權範圍，涵蓋其職責、權力及職能。該等職權範圍於本公司網站可供查閱。

## CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The roles of the chairman of the Board and chief executive officer are separate and are not performed by the same individual as this ensures better checks and balances and hence better corporate governance. Mr. Zhang Degang holds the position of the chairman of the Board, who is primarily responsible for the overall strategies, planning and business development of the Group. Mr. Zhang Deqiang serves as the general manager of the Group, who is primarily responsible for the operations of the Group.

## INDEPENDENCE OF INDEPENDENT NON-EXECUTIVE DIRECTORS

The role of the independent non-executive Directors is to provide independent and objective opinions to the Board, giving adequate control and balances for the Group to protect the overall interests of the shareholders and the Group. They serve actively on the Board and Board Committees to provide their independent and objective views.

In compliance with Rules 3.10(1) and 3.10A of the Listing Rules, the Company has appointed three independent non-executive Directors, representing more than one-third of the Board. One of the independent non-executive Directors has the appropriate professional qualifications in accounting or related financial management expertise as required by Rule 3.10(2) of the Listing Rules.

Each independent non-executive Director has submitted an annual confirmation in writing of his independence to the Company pursuant to Rule 3.13 of the Listing Rules. Based on the contents of such confirmations, the Company considers that all independent non-executive Directors are independent and free of any relationship that could materially interfere with the exercise of their independent judgement.

## BOARD COMMITTEES

The Board is supported by a number of the Board Committees, including the Audit Committee, Nomination Committee, Remuneration and Appraisal Committee and Strategic Committee. Each Board Committee has its defined and written terms of reference approved by the Board covering its duties, powers and functions. Their terms of reference are available on the Company's website.

審核委員會的主要職責是協助董事會就財務申報系統、風險管理及內部監控系統是否有效及維持與本集團外聘核數師關係提供獨立意見、監督審核過程，以及履行董事會委派的其他職責及責任，其中包括審閱本集團的中期及年度報告。

**(i) Audit Committee**

The Audit Committee was established with terms of reference in compliance with the CG Code. The Audit Committee consists of three Directors, namely Mr. Ho Yuk Ming, Hugo (independent non-executive Director), Mr. Liu Chaojian (independent non-executive Director) and Mr. Gao Feng (non-executive Director). Mr. Ho Yuk Ming, Hugo, who has appropriate professional qualifications and experience in accounting matters, was appointed as the chairman of the Audit Committee.

The principal responsibilities of the Audit Committee are to assist the Board in providing an independent view of the effectiveness of the financial reporting system, risk management and internal control systems, relationship with external auditor of the Group, overseeing the audit process and performing other duties and responsibilities as assigned by the Board. These include reviewing the Group's interim and annual reports.

During the Year, the Audit Committee has, inter alia, reviewed the consolidated financial statements of the Group for the six months ended 30 June 2018 and for the year ended 31 December 2017, respectively, including the accounting principles and practices adopted by the Group, the report prepared by the external auditor covering major findings in the course of the audit, the selection and appointment of the external auditor as well as the risk management and internal control systems of the Group.

Subsequent to the end of the Year, the Audit Committee has reviewed the consolidated financial statements for the Year.

提名委員會的主要職責為至少每年檢討董事會的組成，包括其架構、人數及多元性，以確保董事會具備適合本集團業務所需的均衡專業知識、技能及經驗。提名委員會亦負責考慮及向董事會推薦具備合適資格可擔任董事會成員的人士、監察董事繼任安排及評核獨立非執行董事的獨立性。提名委員會在物色具備合適資格可擔任董事會成員的人選時，亦會考慮董事會多元化政策，而董事會將檢討董事會多元化政策，為實施董事會多元化政策訂立可計量目標並加以檢討，以及監察達成有關目標的進度。

董事會於2015年3月採納董事會多元化政策。本公司明白及信納董事會多元化能提升表現質素的裨益。甄選人選將以一系列多元化範疇為基準，包括但不限於性別、年齡、文化及教育背景、種族、專業經驗、技能、知識及服務任期。最終將按人選之長處及可為董事會帶來之貢獻而作決定。

董事會已於2018年8月24日採納提名政策，載列本公司甄選董事會成員潛在人選的提名準則及程序。該提名政策有助本公司實施董事會多元化，並提升董事會效能及企業管治水平。

#### (iii) Nomination Committee

The Nomination Committee was established with terms of reference in compliance with the CG Code and comprises three Directors, namely Mr. Zhang Degang (executive Director), Mr. Ho Yuk Ming, Hugo (independent non-executive Director) and Mr. Gao Fuping (independent non-executive Director). Mr. Zhang Degang is the chairman of the Nomination Committee.

The principal responsibilities of the Nomination Committee are to review the composition of the Board, including its structure, size and diversity, at least annually to ensure that it has a balance of expertise, skills and experience appropriate to the requirements of the business of the Group. It is also responsible to consider and recommend to the Board any suitably qualified person to become a member of the Board, monitor the succession planning of Directors and assess the independence of independent non-executive Directors. The Nomination Committee will also give consideration to the board diversity policy (the “**Board Diversity Policy**”) when identifying suitable qualified candidates to become the members of the Board, and the Board will review the Board Diversity Policy, so as to develop and review measurable objectives for implementing the Board Diversity Policy and to monitor the progress on achieving these objectives.

The Board adopted the Board Diversity Policy in March 2015. The Company recognises and embraces the benefits of having a diverse Board to enhance the quality of its performance. Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board.

The Board has adopted the nomination policy (the “**Nomination Policy**”) on 24 August 2018 which sets out the nomination criteria and procedures for the Company to select candidate(s) for possible inclusion in the Board. The Nomination Policy could assist the Company to achieve board diversity in the Company and enhance the effectiveness of the Board and its corporate governance standard.

Since the selection of candidates should ensure that diversity remains a central feature of the Board, a range of diverse perspectives, including but not limited to gender, age, cultural and educational background, or professional experience would be considered.

The process to identify potential candidates for the Board would be as follows:

- (1) identifying potential candidates, including recommendations from the Board members, professional search firms and the shareholders of the Company;
- (2) evaluating the candidates based on the approved selection criteria through methods such as reviewing the resume and conducting the background checks;
- (3) reviewing the profiles of the shortlisted candidates and interview them; and
- (4) making recommendations to the Board on the selected candidates.

The Nomination Policy also includes the Board succession plan to assess whether vacancies on the Board would be created or expected due to the Directors' resignation, retirement, death and other circumstances and to identify candidates in advance if necessary. The Nomination Policy will be reviewed on a regular basis.

During the Year, the Nomination Committee has, inter alia, reviewed the structure, size and composition of the Board and assessed the independence of the independent non-executive Directors.

The quorum for a Board meeting is the presence of at least half of the total number of the Directors. A Director may attend the Board meeting in person, or appoint another Director in writing as his proxy to attend the Board meeting. The secretary to the Board is responsible for preparing and keeping the minutes of Board meetings and ensuring that such minutes are available for inspection by any Director.

The Nomination Committee shall, in accordance with provisions of the relevant laws and regulations and the Articles of Association, take into account the practical situations of the Company, consider the selection criteria, selection procedures and terms of office of the Directors, and record and submit the resolutions to the Board for approval. All newly nominated Directors are subject to election and approval at general meetings.

Each of the supervisors has entered into a service contract with the Company for an initial term of three years commencing from the Listing Date. All of the current supervisors have been re-elected for a term of three years at the annual general meeting of the Company held on 8 June 2018. The functions and duties of the board of supervisors include, but are not limited to: reviewing and verifying financial reports and, if in doubt, appointing certified public accountants and practicing auditors to re-examine the Company's financial information; investigate when an unusual operation situation of the Company is discontinued; supervising the performance of the Directors and senior management members, and monitoring whether they had acted in violation of the laws, regulations and Articles of Association in the performance of their duties; requesting the Directors and senior management members to rectify actions which are detrimental to the Company's interests; and exercising other rights given to them under the Articles of Association.

## 公司秘書

## 財務報告

## COMPANY SECRETARY

The Company has engaged in a service contract with an external service provider, Ms. Ho Wing Yan, who was appointed as the company secretary of the Company (the “**Company Secretary**”). Mr. Zhang Degang, the chairman of the Board and executive Director, is the primary corporate contact person of the Company with Ms. Ho.

Being the Company Secretary, Ms. Ho plays an important role in supporting the Board by ensuring good information flow within the Board and that the Board policies and procedures are followed. Ms. Ho is responsible for advising the Board on corporate governance matters and should also facilitate induction and professional development of Directors. During the Year, the Company Secretary has complied with the relevant professional training requirement under Rule 3.29 of the Listing Rules.

## FINANCIAL REPORTING

The Directors acknowledge their responsibility to prepare the Company’s consolidated financial statements which give a true and fair view of the Group’s state of affairs, results and cash flows for the Year and in accordance with the Hong Kong Financial Reporting Standards issued by the Hong Kong Institute of Certified Public Accountants, and the disclosure requirements of the Hong Kong Companies Ordinance. The Company has selected appropriate accounting policies and has applied them consistently based on prudent and reasonable judgments and estimates. The Board considers that the Group has adequate resources to continue in business for the foreseeable future and is not aware of any material uncertainties relating to any events or conditions that may affect the business of the Group or cast doubts on its ability to continue as going concern.

The responsibility of PricewaterhouseCoopers, the Company’s external auditor, with respect to financial reporting is set out in the section headed “Independent Auditor’s Report” in this annual report.

## EXTERNAL AUDITOR AND AUDITOR'S REMUNERATION

PricewaterhouseCoopers has been appointed as the external auditor of the Company. During the Year, the fees paid or payable to PricewaterhouseCoopers in respect of its audit services provided to the Group was RMB1.49 million and no non-audit services were provided.

There was no disagreement between the Board and the Audit Committee on the selection and appointment of the external auditor during the Year under review.

## COMMUNICATION WITH SHAREHOLDERS AND SHAREHOLDERS' RIGHTS

The Company aims to, via its corporate governance structure, enable all its shareholders an equal opportunity to exercise their rights in an informed manner and allow all shareholders to engage actively with the Company. Under the Company's Articles of Association, the shareholder communication policy and other relevant internal procedures of the Company, the shareholders of the Company enjoy, among others, the following rights:

### (i) Participation at general meetings

The general meetings of the Company provide an opportunity for direct communication between the Board and the shareholders of the Company. The Company encourages the participation of the shareholders through annual general meetings and other general meetings where the shareholders meet and exchange views with the Board, and to exercise their right to vote at meetings. The Company shall arrange notices of meetings and circulars containing details on proposed resolutions to be sent to the shareholders no less than 45 days before the relevant meeting. At general meetings, separate resolutions are proposed on each substantial issue, including the election of individual Directors.

### (ii) 向董事會查詢

### (iii) 召開股東特別大會

根據組織章程細則，單獨或合計持有10%或以上股份的股東，有權以書面形式要求董事會召開股東特別大會。在收到要求後十日內，董事會須根據法律、法規及組織章程細則發出有關其是否同意召開股東特別大會的書面回應。

倘董事會同意召開股東特別大會，須於董事會作出有關決議後五日內發出股東大會通告。倘通告變更原有建議，須取得相關股東批准。

倘董事會拒絕召開股東特別大會，或在收到要求後十日內未作回覆，單獨或合計持有10%或以上股份的股東有權以書面要求形式向本公司監事會提議召開股東特別大會。

倘本公司監事會同意召開股東特別大會，須於收到要求後五日內發出股東大會通告。倘通告變更原有建議，須取得相關股東批准。

### (ii) Enquiries to the Board

The Company encourages shareholders to attend shareholders' meetings and make enquiries by either directly raising questions on both operational and governance matters to the Board and Board Committees at the general meetings or providing written notice of such enquiries for the attention of the Company Secretary at the principal place of business of the Company in Hong Kong currently situated at 33rd Floor, Shui On Centre, 6-8 Harbour Road, Wanchai, Hong Kong.

### (iii) Convening extraordinary general meetings

Pursuant to the Articles of Association, shareholder(s) alone or jointly holding 10% or more of the shares have the right to require the Board to convene a shareholders' extraordinary general meeting by a written request. Within ten days after receipt of the request, the Board shall, in accordance with laws, regulations and the Articles of Association, give a written response in respect of whether or not it agrees to convene a shareholders' extraordinary general meeting.

If the Board agrees to convene a shareholders' extraordinary general meeting, a notice of shareholders' general meeting shall be issued within five days after the Board reaches such a resolution. Where the notice alters the original proposal, the approval of the relevant shareholders shall be required.

If the Board refuses to convene a shareholders' extraordinary general meeting, or fails to respond within ten days after receipt of the request, the shareholder(s) alone or in aggregate holding 10% or more of the Shares have the right to propose to the board of supervisors of the Company by a written requisition the convening of a shareholders' extraordinary general meeting.

If the board of supervisors of the Company agrees to convene a shareholders' extraordinary general meeting, a notice of shareholders' general meeting shall be issued within five days after receipt of the request. Where the notice alters the original proposal, the approval of the relevant shareholders shall be required.

Failure of the board of supervisors of the Company to issue a notice of general meeting within the stipulated period shall be deemed as its failure to convene and preside over a general meeting, and shareholder(s) alone or in aggregate holding 10% or more of the Company's Shares for ninety consecutive days or more shall be entitled to convene and preside over the meeting.

The shareholders require to convene an extraordinary general meeting or class meeting shall follow the following procedures:

- (a) Shareholders who separately or jointly hold 10% or more of the shares of the Company carrying voting rights may request the Board to convene an extraordinary general meeting or class meeting by signing a written request or several copies in the same form and to illustrate the proposed resolutions of the meetings. The Board shall convene an extraordinary general meeting or a class meeting as soon as practicable upon receipt of the foresaid written request. The aforesaid amount of shareholding is calculated as of the date of the submission of the written request by the Shareholders.
- (b) A Shareholder's general meeting shall be convened in accordance with the Articles of Association.

All reasonable expenses incurred by convening and holding the aforesaid meeting by shareholders due to the failure of the Board to hold such meeting in response to the aforesaid request shall be borne by the Company. Such expenses shall be deducted from the amounts due by the Company to the Director(s) who have defaulted their duties.

### (iv) Procedures for putting forward proposals at a general meeting

In overseeing and monitoring the business operation of the Company, the shareholders of the Company have the right to put forward proposals and raise inquiries. Shareholders individually or together holding 3% or more of the Company's voting shares have the right to put up ad hoc proposals in writing to the Company for the attention of the Company Secretary at the principal place of business in Hong Kong currently situated at 33rd Floor, Shui On Centre, 6-8 Harbour Road, Wanchai, Hong Kong, and the Company shall include such ad hoc proposals into the agenda for such general meeting if they are the matters which fall within the functions and powers of general meeting.

The contents of the proposals to be raised shall be within the scope of duties of the general meetings. It shall have a clear topic and specific matters to be resolved on, and shall be in compliance with relevant requirements of the laws, administrative regulations and the Articles of Association.

## DIVIDEND POLICY

The Board has adopted the dividend policy (the "Dividend Policy") on 13 May 2014 which sets out the appropriate procedure on declaring and recommending the dividend payment of the Company. The Company takes priority to distributing dividends in cash and shares its profits with the shareholders of the Company. The dividend distribution decision of the Company will depend on, among others, the financial results, the current and future operations, liquidity and capital requirements, financial condition and other factors as the Board may deem relevant. The Dividend Policy will be reviewed on a regular basis.

## CONSTITUTIONAL DOCUMENTS

There was no change in the Articles of Association during the Year.

The Articles of Association is available on the websites of the Stock Exchange and the Company.

## 風險管理及內部監控

年內，審核委員會已與本公司管理層討論與本集團風險管理及內部監控有關的事宜。董事會已遵守企業管治守則所載有關風險管理及內部監控的守則條文。董事會有整體責任評估及釐定本集團為達成戰略目標所願承擔的風險性質及程度，並維持本集團適當及有效的風險管理及內部監控系統。該等系統旨在管理有關未能達成業務目標的風險，並僅可為重大錯誤陳述或缺失提供合理（惟非絕對）的保證。

本公司管理層已在營運、財務及風險控制方面設立一套全面政策、標準及程序，以保障資產不會在未經授權的情況下遭使用或處置；妥善保存會計紀錄；保證財務資料真實可靠，對防範可能發生的欺詐及錯誤提供理想保證。

董事會已持續監察本公司的風險管理及內部監控系統。每年對本集團的風險管理及內部監控系統的有效性的年末檢討已經進行，而該等系統被視為有效及足夠。檢討過程中已進行自我評估及全面風險評估調查。本公司亦設有內部審核機制，以就系統的足夠性及有效性進行分析及獨立評估，訂有程序以確保資料保密及管理實質或潛在的利益衝突，並設計嚴密的內部架構，防範不當使用內幕消息及避免利益衝突。

## RISK MANAGEMENT AND INTERNAL CONTROL

During the Year, the Audit Committee has discussed with the management of the Company the matters relating to risk management and internal control of the Group. The Board complied with the code provisions on risk management and internal control as set out in the CG code. The Board has overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives, and maintaining appropriate and effective risk management and internal control systems for the Group. The systems are designed to manage the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The management of the Company has established a set of comprehensive policies, standards and procedures in areas of operational, financial and risk controls for safeguarding assets against unauthorised use or disposition; for maintaining proper accounting records; and for ensuring the reliability of financial information to achieve a satisfactory level of assurance against the likelihood of the occurrence of fraud and errors.

The Board has overseen the Company's risk management and internal control systems on an ongoing basis. A year end review of the effectiveness of the Group's risk management and internal control systems has been conducted annually and the systems are considered to be effective and adequate. Self-assessment and comprehensive risk assessment surveys have been conducted during the review. The Company also has an internal audit function to carry out the analysis and independent appraisal of the adequacy and effectiveness of the systems, and has procedures in place to keep information confidential and manage actual or potential conflicts of interest. Stringent internal structures have been designed to prevent the misuse of inside information and avoid conflicts of interest.

The Group is committed to promoting sustainable development, which is extremely important to create long-term value for the Group's shareholders, clients, employees, other stakeholders, as well as the general public. The Group cares about the impact of its daily operation on the environment and the society and strives to set a good example for the public; hence in conducting business operation, it also makes great effort to meet the interests of all stakeholders, the economy, the environment, the society and corporate governance and strives to achieve a fine balance.

### ENVIRONMENTAL

#### A1. Policies on emissions of exhaust gas and greenhouse gas, discharges into water and land, and generation of hazardous and non-hazardous wastes

Protecting the environment is one of our key concerns; we are committed to protecting the environment and focusing on environmental protection in our operation, hoping to reduce our long-term negative impact on the environment through close supervision and stringent control.

##### 1. Energy Management

As indirect greenhouse gas emissions, which are generated from our daily electricity power consumption, are the main source of the Group's carbon footprint, we will keep monitoring and disclosing the Group's carbon footprint to find out and control the impact of our daily operation on the environment. At the same time, we will implement the following energy-saving and energy efficiency measures at various office locations to reduce greenhouse gas emissions:

- a. Install high-performance electrical equipments;
- b. Require the purchasing department to purchase energy-efficient products;
- c. Employ automatic lighting control systems;

**2. Waste Management**

In order to lighten the load of landfills, we adopt a responsible waste management policy, including waste avoidance, reducing waste from its source and reuse, recycle and responsible disposal of waste. Our offices should post memos and notices at conspicuous places, encouraging the employees to reduce the production of waste. We have introduced waste separation measures from the sources of:

- a. Waste paper (excluding paper cup, paper plate, etc.);
- b. Metal (including aluminum cans and other metal cans);
- c. Plastics (plastic bottles, containers and packaging materials); and
- d. Other recyclables (such as old clothes, electrical appliances, computers, magazines, etc.).

**1. Reducing electricity consumption**

We will comply with the Group's policies on emissions of exhaust gas and greenhouse gas, discharges into water and land, and generation of hazardous and non-hazardous wastes to reduce electricity consumption.

**2. Paper reduction**

In order to reduce waste paper, we have developed the following measures:

- a. Deploy recycling bins to collect used paper products such as waste papers, posters, letters and envelopes;
- b. Place waste paper recycling bins next to printers for setting aside waste papers from papers that have been printed only on one side and can be reused;
- c. Print on both sides of paper;
- d. Write on both sides of paper;
- e. Bring your own cup and avoid using paper cup;
- f. Reuse stationeries such as file folders and envelopes;
- g. Reuse packaging boxes; and
- h. Ship waste paper, other than those containing confidential information, to scrap paper companies or paper mills for them to be recycled into new paper.

Our finance department shall collect information about the paper products the Company purchased and the waste papers that are shipped to scrap paper companies or paper mills for the management to disclose in the ESG report in each financial year starting from 1 January 2017.

In Hong Kong and the PRC, fresh water is a precious resource. We should economise on water, and try our best to protect water resource, for which we have developed the following measures:

- b. Adopt effective water-saving production methods and instruments;
- c. Check water consumption regularly; and
- d. Minimise water pressure.

4. Green procurement

Green procurement is aimed at reducing environmental load. Quality, cost, delivery time are the main focuses when the Group procures goods or chooses suppliers, but on top of that, we give priority to environmental friendly and energy-saving products. We adopt the following measures:

- a. Give priority to the most energy-efficient products;
- b. Give priority to effective water-saving products;
- c. Require the suppliers to reduce packaging material; and
- d. Remind suppliers that we value environmental protection and energy saving.

##### 1. Salary

We offer competitive pay and benefits to our employees according to their job requirements and individual performance. Each year, Key Performance Indicators will provide direction and guidance to the employees' individual work plan. We also assess the achievements and contributions of the employees to appraise and reward them.

- a. Whenever an employee resigns or is being laid off, the human resources department (“**HR**”) should interview him or her before the termination to find out the reason for the termination;
- b. HR is required to issue employment verification document to the dismissed employee;
- c. When the employer terminates an employee's employment contract, the dismissed employee shall be given due notice or wages in lieu of notice, and his or her annual leave and maternity leave should not be counted towards the notice period;

The Group conducts performance evaluation annually, and provide the staff with appropriate training, and offer job, development and promotion opportunities for outstanding employees based on the assessment result. Under the Group's human resource management system requirements, the HR manager is responsible for carrying out related assessment and training.

4. 未滿18歲的員工不得從事有可能產生危險的工作及於夜間工作，以免影響其學習；

The Group firmly adopts a zero-tolerance policy on child and forced labour, and strictly forbids such conduct which is prohibited by international standards and relevant local regulations of the places in which we operate. In all part of our business operation (including our subcontractors or suppliers), child and forced labour is not allowed and we treat child and forced labour as a serious crime. Our policies on preventing child and forced labour are as follows:

1. Child labour refers to employment of people under 16 years of age, and if any country or region in which the Company or its subsidiary operates has a more stringent definition of child labour, such definition shall prevail;
2. Forced labour refers to people providing labour or service against their will, as a punishment or under threat;
3. Hired employees must be at least 16 years of age. The Group shall never recruit child labour and forced labour, and if it knows that its suppliers or subcontractors employ any child and forced labour, the Group will not conduct business with them anymore;
4. Employees under 18 may not engage in any possible hazardous work and are prohibited from working at night lest it might affect their education;
5. Before hiring any job applicant, HR should take effective procedures to verify his or her age. HR should check documents that can prove the age of the applicant, including government-issued photo identification and birth certificate, driver's license, household register, academic certificates or any other credentials that can prove the date of birth. HR must ensure that the applicant's appearance is consistent with the photograph on the identification card;

6. HR, especially those responsible for recruitment, should take part in prevention training about child and forced labour;
7. If employment of child labour under the legal minimum age is found in the Group, we will see to the best interests of the child, and take the following measures in accordance with the relevant legislations:
  - a. Take the child away from the workplace immediately, and ensure the safety of the child;
  - b. Immediately notify the person in charge of HR to verify all relevant information, confirm whether the child is under 16 years of age, sever labour relations with the child, notify the local social welfare institution, and take remedial measures to protect the child's best interest;
  - c. Send the child to a special occupational health inspection institution to do medical check-up to confirm the child's physical and mental health, and conduct investigation to fully understand the child's situation;
  - d. Provide the child with re-employment when he or she reaches legal minimum age for employment; and

  - c. Send the labour to a special occupational health inspection institution to do medical check-up to confirm the labour's physical and mental health, and conduct investigation to fully understand the labour's situation; and
  - d. Immediately find out the problems in the hiring process of the operating location and take improvement measures within 90 working days.

*Compliance with relevant laws and regulations*

During the Year, the Group has complied with the Labour Law of the PRC (中華人民共和國勞動法) and the Labour Contract Law of the PRC (中華人民共和國勞動合同法) and other relevant laws and regulations on employment in all material respects.

我們重視與供應商發展及維持並期待與他們形成長期合作夥伴關係。我們會以公平及公開為原則採購物料及服務。我們只會與具有共同道德價值及標準的供應商合作，本集團亦支持及鼓勵供應商提高資源運用和推動環保以及履行社會企業責任：

1. 我們提倡以公平及公開為原則之競爭，並以互信為基礎與供應商及承辦商發展及維持長遠關係；
2. 我們以嚴格的道德標準採購物料及服務，以保證製成品之品質，及維持客戶、供應商及公眾對本集團一直以來的信心；
3. 我們對供應商進行審查，根據價格、品質、合適度及需要作出評估，只有評定為合格方可成為我們的認可供應商，我們只向認可供應商採購；
4. 我們定期對供應商進行跟進評估，及在必要時由第三方機構進行審核。當發現供應商有不符本公司之政策或合約要求時，本公司會終止往後的合作直到情況有所改善；

We attach importance to developing and maintaining long-term relationships with our suppliers, and look forward to forming long-term partnerships with them. We will take a fair and open principle on procurement of materials and services. We will only cooperate with the suppliers that share common moral values and standards with us. The Group also supports and encourages the suppliers to promote efficient use of resources and environmental protection and fulfill corporate social responsibility:

1. We advocate the principle of fair and open competition, and develop and maintain long-term relationships with the suppliers and contractors based on mutual trust;
2. We have strict ethical standards in the procurement of materials and services to ensure the quality of the finished products and maintain the continued confidence of the clients, suppliers and general public;
3. We review our suppliers and assess them based on price, quality, suitability and demand, and only those rated as qualified can be our approved suppliers. We only purchase from the approved suppliers;
4. We conduct follow-up assessment on the suppliers and, if necessary, review them through a third party organisation. When a supplier is found to be inconsistent with the Company's policy or contractual requirements, the Company will cease future cooperation until the situation has been improved;
5. In an unprejudiced way, we choose appropriate, capable and responsible suppliers;
6. We support and encourage the suppliers to improve the environmental-friendliness of their products and services, and their employees' benefits and protection;
7. The suppliers must comply with the relevant laws, regulations and contractual obligations; and
8. We adopt effective monitoring and management systems to detect and prevent bribery, fraud or other misconducts in procurement and bidding processes.

##### 產品和服務的健康與安全

我們承諾向客戶提供高質素的產品與服務，有效處理客戶投訴，持續改善服務水平及確保客戶滿意度。因此採取如下措施：

1. 確保產品及服務符合相關法律及標準；
2. 為客戶提供準確的產品資訊及品質優良的產品，並制定相關產品回收政策及售後服務；
3. 若發現產品出現問題，會主動向客戶解釋及尋找雙方滿意的解決方案；及
4. 在處理客戶投訴後妥善存檔，與相關部門檢討有關投訴並制定對策，防止同類投訴再次發生，使本集團的服務質素得以不斷提升。

##### 廣告、標籤及保障客戶資料

客戶資料只會用於業務列明的用途，而不會作與此無關的其他用途。所有僱員應加倍小心處理及使用客戶資料，保障客戶資料，以及遵守個人資料(私隱)條例的法定要求。

##### 遵守相關法律法規

年內，本集團已遵守中華人民共和國安全生產法及有關產品及服務健康與安全、廣告、標籤及隱私的其他相關法律法規。

##### Health and safety of products and services

We are committed to providing the customers with high-quality products and services and settling customer complaints effectively, continuously improving service level and ensuring customer satisfaction. Accordingly, the following measures are taken:

1. Make sure that the products and services comply with related laws and standards;
2. Provide the customers with accurate product information and high-quality products, and develop return policy and after-sale service for related products;
3. Take the initiative to explain the problem and find a mutually satisfactory solution for the customers if there is a problem with a product; and
4. Keep proper records after handling a customer's complaint and arrange the relevant department to review the complaint and develop measures to prevent the recurrence of similar complaints, so that the Group's service quality keeps improving.

##### Advertising, labelling and protection of customer information

Customer information will only be used for specific business purpose and not for other unrelated purposes. All employees should handle and use customer information with extreme caution, protect customer information, and comply with statutory requirements in the Personal Data (Privacy) Ordinance.

##### Compliance with relevant laws and regulations

During the Year, the Group has complied with the Production Safety Law of the PRC (中華人民共和國安全生產法) and other relevant laws and regulations on health and safety, advertising, labelling and privacy of products and services in all material respects.

道德及誠信，是本公司成功的基石。我們對賄賂、勒索、欺詐及洗黑錢行為採取「零容忍」的態度，董事、管理層及員工在日常工作中必須遵守國家及地方政府在防止賄賂、勒索、欺詐及洗黑錢相關的所有法律法規。所有員工都有責任明白及遵守以上防止賄賂、勒索、欺詐及洗黑錢的政策，也有義務向適當人士舉報違反守則的行為。任何人違反守則，將會受到紀律處分。我們會竭力保護作出舉報的員工和所收到的資料。然而，若任何人作出舉報的目的是傷害他人，他們可能會受到紀律處分。

**1. 索取或收受利益**

本集團任何員工(包括董事、管理層及所有全職、兼職、時薪、臨時員工)不可直接、間接或以任何方式，向第三方索取或收受任何形式的利益或做出任何可能被視為賄賂的行為，包括但不限於金錢、禮物、過度的酬酢及款待、旅遊及住宿資助、貸款及作擔保人、延伸的信貸優惠條款、費用、報酬、職位、受僱工作、合約、服務、優待、免除應履行之全部或部分責任等。倘若收受該等利益會妨礙其客觀處事、違反或損害本集團利益、引致偏私或不當行為，僱員應拒絕接受任何直接或間接與本集團業務有關之利益。

Ethics and integrity is the cornerstone of the Company's success. We adopt a zero tolerance approach to bribery, extortion, fraud and money laundering. In their daily work, the Directors, management and staff must comply with all related national and local government laws and regulations on prevention of bribery, extortion, fraud and money laundering. All employees not only have responsibility to understand and comply with the above regulations on prevention of bribery, extortion, fraud and money laundering, but also have obligation to report violation to the appropriate person. Any person, who contravenes the regulations, will be subject to disciplinary sanction. We will make every effort to protect the informer and the received information. However, if an informer's intention is to harm others, they may be subject to disciplinary punishment.

**1. Soliciting or accepting benefits**

Any employee (including the Directors, management and all full-time, part-time, hourly-paid and temporary workers) of the Group cannot, directly, indirectly or in any manner, solicit or accept any form of benefits from a third party, including, but not limited to, money, gift, excessive entertainment and hospitality, subsidized travel and accommodation, loan, pledging as guarantor, extending preferential credit terms, fee, reward, position, employment, contract, service, privilege and exemption of all or part of the responsibilities that ought to be fulfilled or do anything that might be seen as bribery. The employees should reject any direct or indirect interests and benefits relating to the Group's business if such benefits would hamper their objectivity, or the interests of the Group would be harmed or invaded, or causing bias or misconduct.

#### 1. 索取或收受利益 (續)

考慮到在節日、活動及酬酢等日常工作可能會發生的社交中，拒絕收受適度的饋贈會被視為欠缺社交禮儀或不禮貌，員工可根據以下原則考慮收受對方自願提供之利益：

- a. 收受有關利益但不會影響員工之工作表現及決定；
- b. 員工不會感到有需要向饋贈人作出任何回報；及
- c. 員工可公開討論有關利益。

本集團如發現任何員工有任何不當的索取或接受利益行為，將會報警處理以及終止與其僱傭關係。

#### 1. Soliciting or accepting benefits (Continued)

In social events such as festivals, activities, entertainments and other daily routine, refusing to accept a modest gift may be considered impolite or lack of social graces. With that in mind, the employees may consider accepting benefits offered on a voluntary basis under the following principles:

- a. Receiving such benefits will not affect his or her performance and decision;
- b. He or she will not feel the need to reciprocate; and
- c. He or she can openly discuss the benefits.

If the Group finds out any employee's inappropriate behaviour of soliciting or accepting benefits, it will call the police and terminate the labour relations with such employee.

#### 2. 提供利益

在任何情況下，任何員工不得向任何人士或機構提供賄賂或不正當利益，以謀取個人私利或集團利益。本集團如發現任何員工進行提供賄賂行為，將會報警處理以及終止與其僱傭關係。

#### 3. 勒索

任何人如為使自己或另一人獲益，或意圖使另一人遭受損失，而以恫嚇的方式作出任何不當的要求，即屬犯勒索罪。所有員工不得參與、協助、掩飾任何勒索行為，本集團如發現任何員工進行勒索行為，將會報警處理以及終止與其僱傭關係。

#### 4. 欺詐

任何人如使用任何欺騙手段，使自己或另一人獲益，或意圖使另一人遭受損失，即屬犯欺詐罪，常見員工欺詐包括挪用公款、工資詐騙和盜竊任何公司資產。所有員工不得參與、協助或掩飾任何欺詐行為，本集團如發現任何員工進行欺詐行為，將會報警處理以及終止與其僱傭關係。

#### 5. 洗黑錢

洗黑錢指個人或機構，試圖以任何途徑掩飾非法資金來源、或使這些資金看似合法的過程。本集團不會容忍任何員工進行、協助及支援任何形式的洗黑錢行為。

#### 2. Providing benefits

In any case, any employee shall not provide bribe or improper benefits to any person or organisation in order to seek personal gain or group interests. If the Group finds out any employee conducting bribery, it will call the police and terminate the labour relations with such employee.

#### 3. Extortion

Making any unwarranted demand by threat in order to seek benefits for oneself or for another person or with intent to cause loss to another person shall be considered as extortion. All employees shall not participate in, assist in or cover up any kind of extortion. If the Group finds out any employee conducting extortion, it will call the police and terminate the labour relations with such employee.

#### 4. Fraud

Using any means of deception in order to seek benefits for oneself or for another person or with intent to cause loss to another person shall be considered fraud. Common employee fraud includes embezzlement, wage fraud and stealing company assets. All employees shall not participate in, assist in or cover up any fraud. If the Group finds out any employee conducting fraud, it will call the police and terminate the labour relations with such employee.

#### 5. Money Laundering

Money laundering refers to an individual or institution attempting to conceal the source of illicit money, or makes such money looks legitimate in any way. The Group will not tolerate any employee's participation, support, and assistance in any form of money laundering.

**5. 洗黑錢 (續)**

本公司建立反洗黑錢領導小組，總經理任領導小組組長並負責組織反洗黑錢領導小組。反洗黑錢領導小組主要職責包括組織、落實反洗黑錢工作、跟進調查懷疑洗黑錢舉報，組織反洗黑錢培訓、配合監管機關和司法機關對可疑交易資金的調查，以及留意反洗黑錢法律、法規的要求及更新。

反洗黑錢程序包括識別客戶身份、保存交易紀錄、報告及跟進調查可疑交易及反洗錢培訓。

**a. 識別客戶身份**

業務人員在開發客戶時必須樹立高度的反洗錢意識，通過與準客戶的交流，全面瞭解客戶基本信息，做好客戶識別的第一關。客戶成功開發後，亦要跟客戶保持持續聯繫，及時把握客戶最新情況。發現異常情形，及時與相關部門進行溝通。

**b. 保存交易紀錄**

業務人員及會計人員應當保存的客戶身份資料，包括記載客戶身份信息的資料以及反映支付機構對客戶身份識別工作情況的各種紀錄和資料，亦應當保存各交易紀錄，包括關於每筆交易的信息、業務憑證、賬簿以及有關規定要求用以反映交易詳情的文件和其他資料，確保足以重現每筆交易。

**5. Money Laundering (Continued)**

The Company should establish an anti-money laundering team. General manager should be the team leader and responsible for organising the anti-money laundering team. The team's main responsibilities include organising and implementing anti-money laundering tasks, investigating reported money laundering, arranging anti-money laundering training, working with regulatory and judiciary authorities to investigate suspicious transactions of funds, as well as paying attention to requirements and updates in anti-money laundering laws and regulations.

Anti-money laundering procedures include identifying clients, keeping transaction records, reporting and following-up investigation of suspicious transactions, and anti-money laundering training.

**a. Identifying clients**

In dealing with new clients, salespeople must establish a high degree of anti-money laundering awareness, through communication with prospective clients to comprehensively grasp the clients' information, thereby running the first check on the clients. After successfully securing the client, regular contact is required to grasp the clients' updates. If an abnormal situation occurs, the sales person needs to timely communicate with the relevant departments.

**b. Keeping transaction records**

Salespeople and accounting personnel should keep customer identification information, including register customer identification and related information, keep all sorts of records and information reflecting payment authority's customer identification process, and keep transaction records such as each transaction's information, business voucher, ledger and necessary documents and other relevant information to reflect the details of each transaction to ensure that each transaction is traceable.

*c. 報告及跟進調查可疑交易*

業務人員及會計人員若發現可疑交易，應當及時向公司總部反洗黑錢領導小組報告。反洗黑錢領導小組對所有可疑交易報告涉及的交易，進行分析、調查，若有合理理由認為該交易或者客戶與洗黑錢、恐怖主義活動及其他違法犯罪活動有關，會向香港特別行政區政府聯合財富情報組(JFIU)等相關機構舉報。

*d. 反洗黑錢培訓*

全體員工應至少每年進行一次反洗黑錢培訓，培訓內容包括洗黑錢的危害、反洗黑錢法規、員工在反洗黑錢工作的角色、如何識別可疑交易、舉報可疑交易途徑、未遵守反洗黑錢法規可能導致的後果等。

**遵守相關法律法規**

年內，本集團已遵守中華人民共和國反洗錢法、中華人民共和國刑法、中華人民共和國反不正當競爭法及有關賄賂、勒索、欺詐及洗黑錢的其他相關法律法規。

**5. Money Laundering (Continued)**

*c. Reporting and following-up investigating of suspicious transaction*

For salespeople and accounting staff, should they find out a suspicious transaction, they need to report such transaction immediately to the corporate headquarters' anti-money laundering team. The team analyses and investigates all suspicious transactions reported, and if there are reasonable grounds to believe that the transaction or the customer has ties with money laundering, terrorism and other criminal activities, relevant authorities including the HKSAR Government JFIU should be notified.

*d. Anti-money laundering training*

All employees should attend anti-money laundering training at least once a year. The training includes learning the harmful effects of money laundering, anti-money laundering regulations, the role of the employees in anti-money laundering, how to identify suspicious transactions, ways to report suspicious transactions, and the consequences if one fails to comply with anti-money laundering regulations.

**Compliance with relevant laws and regulations**

During the Year, the Group has complied with the Anti-money Laundering Law of the PRC (中華人民共和國反洗錢法), the Criminal Law of the PRC (中華人民共和國刑法), the Anti-Unfair Competition Law of the PRC (中華人民共和國反不正當競爭法) and other relevant laws and regulations on bribery, extortion, fraud and money laundering.



## 社區

### B8. 透過社區參與來瞭解發行人營運所在社區需要和確保其業務活動會考慮社區利益的政策

社區參與對於本集團長遠發展有着重要的價值，我們致力參與促進所處社區的發展及建設活動。我們透過各式各樣的行動來造福社羣，包括進行投資或捐獻金錢、時間、產品、服務、影響力、管理知識等資源。

我們主要透過以下三種途徑參與建設社區：

1. 組織、推動和支持員工參與義務工作，例如定期探訪有需要人士、為弱勢社群安排戶外活動、舉辦公司捐血日等。
2. 捐贈，我們以捐贈金錢、物資或服務的方式，直接支持或資助各個社會服務機構的項目。除本身捐贈外，亦會呼籲公司的持份者（包括僱員和客戶）捐贈予慈善機構。
3. 我們盡力為弱勢人士提供就業機會，並藉此建立雙贏的局面，如透過僱用已經完成再培訓課程的殘疾人士、優先向僱用殘疾人士的供應商採購，或參與各種導師計劃。

## COMMUNITY

### B8. Policies on community engagement to understand the needs of the communities where the issuer operates and to ensure its activities take into consideration the communities' interests

For the Group's long-term development, community participation is important. We are committed to promoting the development and construction activities of the community in which we operate. We benefit the community through a variety of actions, such as investment and contributing money, time, products, services, influence, management knowledge and other resources.

We participate in community building through three main ways:

1. Organise, facilitate and support the staff to take part in volunteer services, such as regularly visiting people who need help, arranging outdoor activities for disadvantaged groups and holding Blood Donation Day.
2. By means of donation, we donate money, goods or services directly supporting or funding projects of various social service agencies. In addition to donation itself, we also appeal to the Company's stakeholders (including the employees and customers) to donate.
3. We endeavour to provide employment opportunities to the disadvantaged and create a win-win situation, such as hiring the disabled people who have completed retraining courses, giving priority to purchasing from the suppliers who hire the disabled people, or participating in a variety of mentorship programs.

本集團於2010年7月14日獲得北京中大華遠認證中心頒發的ISO14001:2004環境管理體系認證證書，該體系運行一直保持良好，2016年下半年依據ISO14001:2015策劃、建立、實施標準轉版的QE管理體系，本集團通過中大華遠認證中心(上海)有限公司進行監視和評審，於2017年8月3日新獲得北京中大華遠認證中心頒發的《環境管理體系認證證書》(證書號：02016E30584R2M)，認證本集團的工業自動化成套設備設計和製造、一般機械零部件的加工的環境管理體系符合GB/T24001-2016/ISO14001:2015《環境管理體系要求及使用指南》。

本集團嚴格控制設備生產過程中產生的廢物和溫室氣體的排放，並確保所有產生的排放物均在本集團經營業務的地區政府規定的環境質量標準內。該等法律、法規及規定包括《中國環境保護法》、《中國大氣污染防治法》、《中國水污染防治法》、《廢物處置條例》(香港法例第354章)及《產品環保責任條例》(香港法例第603章)等。

The Group maintains an effective environmental management system which was awarded an ISO14001:2004 certificate by Beijing ZhongDaHuaYuan Certification Center on 14 July 2010. Furthermore, it has designed, established and implemented an updated version of the QE management system in accordance with ISO14001:2015 in the second half of 2016. This updated system passed the examination and evaluation of ZhongDaHuaYuan Certification Center (Shanghai) Co., Ltd. and was awarded a Certificate of Environmental Management System Certification\* (環境管理體系認證證書) (Certificate No.: 02016E30584R2M) by Beijing ZhongDaHuaYuan Certification Center on 3 August 2017. This certificate confirmed that the environmental management system of both the Group's industrial automatic integrated equipment design and manufacturing business and general machinery components and parts processing business complies with the Requirements and a Practical Guide for an Environmental Management System\* (環境管理體系要求及使用指南) (GB/T24001-2016/ISO14001:2015).

The Group strictly controls the emissions of waste and greenhouse gas from its equipment production processes. It also ensures that all emissions conform to the environmental quality standards stipulated by the local governments of the regions where the Group operates. Relevant laws, regulations and rules include but are not limited to the PRC Environmental Protection Law (中國環境保護法), the Law of the PRC on the Prevention and Control of Atmospheric Pollution (中國大氣污染防治法), the Law of the PRC on the Prevention and Control of Water Pollution (中國水污染防治法), the Waste Disposal Ordinance (Cap. 354 of the laws of Hong Kong) and Product Eco-responsibility Ordinance (Cap. 603 of the laws of Hong Kong).

The increase in greenhouse gas emission is one of the major causes of global warming. In particular, carbon dioxide is the principal greenhouse gas emitted from human activities. The Group strives to reduce burning and improve energy and resource use efficiency in its daily operation so as to manage its greenhouse gas emissions.

#### 污水排放管理

本集團生產車間無需使用水源，本集團僅產生生活污水，生活污水是通過接管污水管送至無錫惠山水處理有限公司進行統一處理。本集團生活污水每年通過無錫碧水藍天環境檢測有限公司的檢測，截至2018年12月31日止年度，生活污水的酸鹼值、化學需氧量、生化需氧量等均處於規定的標準內。

#### Effluents Management

The production workshops of the Group do not require water supply. The Group only produces domestic sewage that is transmitted to 無錫惠山水處理有限公司 for unified treatment through sewage pipelines. The domestic sewage of the Group is tested by 無錫碧水藍天環境檢測有限公司 every year. For the year ended 31 December 2018, the potential of hydrogen (pH), chemical oxygen demand (COD) and biochemical oxygen demand (BOD) of the domestic sewage were all within required limits.

The Group engaged 無錫潤安物業服務有限公司 to transport and handle its domestic waste. As at 31 December 2018, the impact on the environment was negligible with 1,020 bins of waste in total being transported and handled (2017: 1,040). The intensity of non-hazardous waste produced was 3.83 (2017: 3.9).

The Group strived to the policies relating to air and greenhouse gas emissions, discharges into water and land, and generation of hazardous and non-hazardous waste as set out in this ESG report in the annual report in order to mitigate such pollution. They contributed to a reduction on hazardous and non-hazardous waste when compared to the last reporting period.

The Group properly packs its products according to the requirements of the clients before delivery so as to prevent damage during transportation. For the years ended 31 December 2018 and 2017, the types and total packaging material used were as follows:

For the year ended 31 December 2018, the intensity of packaging material used was 0.39 (2017: 0.40).

The daily operation of the Group has no material impact on the environment and natural resources. The Group will continue to adopt and implement the policies on minimising its significant impact on the environment and natural resources as set out in this ESG report in the annual report in order to safeguard the environment and natural resources.

本集團嚴格按照國家的法律法規為全體員工參加了養老、醫療、工傷、生育、失業五大社會保險和住房公積金，參保覆蓋率達100%，並及時、足額繳納社會保險及公積金費用。本集團嚴格執行國家《勞動法》規定的工作時間和休息休假，實行標準工作時間制度，每周工作40小時；在國家法定節假日按法定的天數放假，不能休息或需要加班工作的給予調休或按規定支付加班費；嚴格執行中國法律，充分保障職工帶薪休假的合法權益。依據《職業健康監護技術規範》(GBZ188-2014)要求，本集團對接觸職業病危害員工進行上崗前，在崗期間，離崗時的職業健康檢查，並對檢查中發現的職業禁忌證員工調離了原作業環境。

### Health and Safety

The Group provides compensation to employees suffering from work-related injuries or occupational illnesses in accordance with the laws, rules and regulations of Hong Kong and the PRC in relation to the compensation for employment and occupational illness, including the Employees' Compensation Ordinance (Cap. 282 of the laws of Hong Kong), the Standard of Compensation for Work-Related Injuries of the PRC and the Regulation on Work-Related Injury Insurance of the PRC. The Group may also consider providing compensation beyond statutory requirements to employees who are injured, die or suffer from occupational illness at work. For the year ended 31 December 2018, the Group maintained good production safety with no major work-related injury, accident or death.

The Group maintains all 5 major social security schemes, namely retirement, medical, work-related injury, maternity and unemployment insurance, as well as housing provident fund for all of its employees with 100% participation rate in strict compliance with national laws and regulations. It also makes full and punctual payments to these social security schemes and provident fund. The Group implements standard working hours of 40 hours per week in strict compliance with the working-hour and rest-time requirements under the Labour Law of the PRC (中華人民共和國勞動法). Holidays are provided during national holidays according to statutory requirements while substitute holidays or overtime payments are granted in accordance with the regulations if an employee is required to work on statutory holidays or work overtime. Employees' legal right to paid-leave is fully protected in strict compliance with the laws of the PRC. The Group offers entrance, on-the-job and exit occupational health checks to employees who are exposed to occupational health hazards in accordance with the Technical Specifications for Occupational Health Surveillance\* 《職業健康監護技術規範》(GBZ188-2014), and removes employees who are found in the checks to have occupational illnesses from their original positions.

# 董事會報告

## Report of the Directors

董事欣然提呈本報告連同本集團年內的經審核綜合財務報表。

### 主要營業地點

本公司在中國註冊成立，其香港主要營業地點位於香港灣仔港灣道6-8號瑞安中心33樓。本集團的註冊辦事處及中國主要營業地點位於中國江蘇省無錫惠山經濟開發區堰新東路1號。

### 主要業務

本集團的主要業務是在中國提供製造鋼絲製品的生產線的研發、設計、製造、設備供應、安裝、調試及維修保養服務。附屬公司的主要業務及其他詳情載於綜合財務報表附註17。

### 業務回顧

本集團年內業務回顧載列於本年報「主席報告書」、「管理層討論與分析」、「環境、社會及管治報告」、「五年財務數據摘要」等節及以下段落。

本集團遵守公司條例(香港法例第622章)、上市規則及證券及期貨條例(香港法例第571章)(「證券及期貨條例」)項下有關資料披露及企業管治的規定。自本財政年度完結起至本年報日期，概無發生影響本集團的重要事項。

The Directors are pleased to present this report together with the audited consolidated financial statements of the Group for the Year.

### PRINCIPAL PLACE OF BUSINESS

The Company was incorporated in the PRC and has its principal place of business in Hong Kong at 33rd Floor, Shui On Centre, 6-8 Harbour Road, Wanchai, Hong Kong. The Group's registered office and its principal place of business in the PRC are situated at 1 Yanxin Road East, Huishan Economic Development Zone, Wuxi, Jiangsu Province, the PRC.

### PRINCIPAL ACTIVITIES

The principal activities of the Group are research and development, design, manufacture, equipment supply, installation, testing, repair and maintenance of production lines for manufacturing steel wire products in the PRC. The principal activities and other particulars of the subsidiaries are set out in note 17 to the consolidated financial statements.

### BUSINESS REVIEW

The business review of the Group for the Year is set out in the sections of Chairman's Statement, Management Discussion and Analysis, Environmental, Social and Governance Report, Five-Year Financial Summary of this annual report and the paragraphs below.

The Group complies with the requirements under the Companies Ordinance (Cap. 622 of the laws of Hong Kong), the Listing Rules and the Securities and Futures Ordinance (Cap. 571 of the laws of Hong Kong) (the "SFO") for the disclosure of information and corporate governance. No important event affecting the Group has occurred since the end of the financial year to the date of this annual report.

### 主要風險因素

以下載列本集團面對的主要風險及不明朗因素。

#### 本地及國際法規的影響

本集團的業務營運受政府政策、監管機構制訂的相關法規及指引所限制。未能遵守該等規則及規定可能會被該等機構罰款、修正或暫停業務營運。本集團密切監察政府政策、法規及市場的轉變，並進行研究以評估該等轉變的影響。

#### 第三方風險

本集團部分業務倚賴第三方服務供應商以改善本集團的表現及效率。儘管可從外部服務供應商受惠，但管理層意識到有關營運倚賴性可能造成漏洞，以致受意料之外的差劣服務或服務中斷影響（包括聲譽受損、業務中斷及金錢損失）。為解決該等不明朗因素，本集團僅聘用信譽良好的第三方服務供應商，並密切監察彼等的表現。

有關本集團面臨的其他風險及不明朗因素，請參閱招股章程。

#### 與僱員、客戶及供應商的主要關係

本集團為僱員提供全面的福利計劃、事業發展機會及切合個人需要的內部培訓，以肯定僱員的成就。本集團為所有僱員提供健康安全的工作環境。年內，概無發現任何因工傷而導致的罷工或致命個案。

本集團着重與供應商合作以有效而迅速地滿足我們客戶的需要。各部門與供應商緊密合作，確保招標及採購程序公開、公平及公正地進行。本集團亦於項目開始前向供應商清楚傳達本集團的規定及標準。

### KEY RISK FACTORS

Set out below are the key risks and uncertainties facing the Group.

#### Impact of Local and International Regulations

The business operation of the Group is subject to government policy, and relevant regulations and guidelines established by the regulatory authorities. Failure to comply with the rules and requirements may lead to penalties, amendments or suspension of the business operation by the authorities. The Group closely monitors changes in government policies, regulations and markets as well as conducting studies to assess the impact of such changes.

#### Third-Party Risks

The Group has been relying on third-party service providers in some parts of its business to improve performance and efficiency of the Group. While gaining the benefits from external service providers, the management realises that such operational dependency may pose a threat of vulnerability to unexpected poor or lapses in service including reputation damage, business disruption and monetary losses. To address such uncertainties, the Group engages only reputable third-party service providers and closely monitors their performance.

For other risks and uncertainties facing the Group, please refer to the Prospectus.

#### Key Relationships with Employees, Customers and Suppliers

The Group recognises the accomplishment of the employees by providing comprehensive benefit package, career development opportunities and internal training appropriate to individual needs. The Group provides a healthy and safe workplace for all employees. No strikes and cases of fatality due to workplace accidents are found during the Year.

The Group places great emphasis on working relationships with suppliers to meet our customers' needs in an effective and efficient manner. Our departments work closely with our suppliers to make sure the tendering and procurement process is conducted in an open, fair and just manner. The Group's requirements and standards are also well-communicated to suppliers before the commencement of a project.

本集團重視所有客戶透過各種方法及渠道提供的看法及意見，包括利用商業情報以了解客戶趨勢及需要，並定期分析客戶的反饋。本集團亦進行全面測試及檢查，確保僅向客戶提供優質的產品及服務。

本集團是中國鋼絲製品生產整體解決方案提供商，我們按照鋼絲製品製造商的生產需要和規格，為客戶提供定制和獨特的解決方案。因此，我們可提供一站式的服務，包括承辦成套生產線的建設（包括技術設計、設備供應、安裝及調試）、維修或更換其現有生產線的若干部件或以單機方式供應設備和機器，從而為其現有生產線升級。

我們的主要供應商與本集團的業務關係平均超過3-5年，主要遍佈在華東地區的江蘇、上海、浙江、山東與華中地區的河南。供應商主要是提供按照特定設計製成的度身訂造的零部件、電氣組件。我們最大的供應商是位於華東地區的江蘇省，主要供應的產品是按照特定設計製成的度身訂造的零部件。供應商給予的付款期一般為30-90天，應付款項通常會於信貸期內以電匯或商業匯票進行結算。

本集團主要產品的生產規格及要求而量身定制的，對供應商提供的零部件的品質參數則是非常重要的，本集團制訂了《供應商管理制度》及《供應商認定考核管理規定》，對供應商進行合格評定管理控制，確保本集團所採購的產品滿足規定的要求。對合格的供應商進行連續監督，以保證供應商能長期、穩定地提供合格的產品和服務。

於報告期間，本集團與供應商概無任何重大合同糾紛。

The Group values the views and opinions of all customers through various means and channels, including usage of business intelligence to understand customer trends and needs and regular analysis on customer feedback. The Group also conducts comprehensive tests and checks to ensure that only quality products and services are offered to the customers.

The Group is an integrated production solution provider of steel wire products in the PRC. We provide customised and distinctive solutions to steel wire product manufacturers in accordance with their production needs and specifications. As such, we can provide one-stop service including undertaking the construction of comprehensive production lines (scope of work covering technical design, equipment supply, installation and fine-tuning and testing of the production lines), repair and maintenance or replacement of certain parts within their existing production lines or supply of equipment and machines on a standalone basis to upgrade their existing production lines.

The Group has, on average, over 3 to 5 years of business relationship with the key suppliers, which are mainly located in Jiangsu, Shanghai, Zhejiang and Shandong in Eastern China as well as Henan in Central China. The suppliers mainly manufacture customised parts and components and electrical units according to specific designs. Our largest supplier mainly provides customised parts and components according to specific designs and is located in Jiangsu in Eastern China. In general, suppliers grant a payment term of 30-90 days. Payables are usually settled by electronic remittance or commercial bill of exchange within the credit period.

The Group's key products are customised in accordance with production needs and specifications. The quality of the parts and components provided by the supplies are vital. The Group has formulated the Supplier Management System\* (供應商管理制度) and the Supplier Certification and Assessment Management System\* (供應商認定考核管理規定) to assess, manage and control the suppliers and ensure that the products procured by the Group satisfy its requirement. The Group continuously monitors the qualified suppliers to ensure the long-term and stable supply of satisfactory products and services from them.

During the reporting period, the Group did not have any material contractual dispute with its suppliers.

本集團非常重視客戶的觀點及意見，該等觀點及意見通過多種方式及途徑收集，瞭解客戶趨向及需求，並定期分析客戶回饋意見，以根據客戶需求開發新產品及提供優質的服務。

本集團的客戶包括數家中國領先的鋼絲製品製造商，於過往業績，我們主要客戶有在香港聯合交易所、上海證券交易所以及深圳證券交易所上市的公司。本集團的產品銷往國內外，我們的銷售合同通常規定產品交付日期為自合同簽署日期起計約五至九個月，較長的製造週期主要歸因於產品設計及製造、交付、現場安裝、調試及試產所需的時間。

我們主要的客戶與本集團的業務關係平均超過5年以上，本集團會根據客戶的經營規模、財務狀況進行評估，針對不同等級的客戶給予寬和嚴的信用政策，於過往業績內收款的平均天數，以及就主要生產線及單機所採用的業務模式中不同階段所耗用的平均天數，本集團給予客戶的付款期限為(i)合同簽訂的90天內收取合同價值的20%至30%的預收款，(ii)生產完畢收以合同價值的30%–40%，(iii)安裝調試完成後收取合同價值的20%–40%，(iv)質保金10%一年收取。本集團亦會不斷監察及控制客戶的應收賬款餘額。

於報告期間，本集團概無因客戶出現財務狀況而嚴重延誤或拖欠付款導致任何重大業務損失。

### 主要客戶及供應商

The Group treasures customers' opinions and advice, which are collected in various forms through several channels to understand the customers' preferences and needs. It also regularly analyses the feedback and opinions of the customers so as to develop new products and provide quality services in accordance with their needs.

The Group's customers include several leading steel wire product manufacturers in the PRC. According to our track records, our key customers included companies listed on the Stock Exchange of Hong Kong, the Shanghai Stock Exchange and the Shenzhen Stock Exchange. Apart from domestic sales, the Group also exports its products. Our sales contracts usually provide for a product delivery date of about five to nine months from the contract signing date. The relatively long manufacturing cycle is primarily attributed to the time required for product design and manufacturing, delivery, on-site installation, fine-tuning, testing and trial production.

The Group has, on average, over 5 years of business relationship with the key customers. It offers different credit terms to the customers according to its assessment of their business scales and financial positions. According to the average number of days for receipt of payments, and the average number of days spent on different stages of its business models adopted for the major production lines and standalone machines, the payment terms granted by the Group to its customers requires (i) receipt of 20% to 30% of contract value within 90 days from the contract signing date, (ii) receipt of 30% to 40% of contract value upon completion of production, (iii) receipt of 20% to 40% of contract value upon completion of installation, fine-tuning and testing, and (iv) receipt of quality warranty payment (10%) within one year. The Group continuously monitors and controls the accounts receivable from its customers.

During the reporting period, the Group did not suffer from any material business loss due to material delinquency or default by its customers with financial difficulties.

### MAJOR CUSTOMERS AND SUPPLIERS

During the Year, aggregate sales to the Group's largest and five largest customers accounted for 32.3% (2017: 25.9%) and 88.8% (2017: 77.8%), respectively, of the Group's total revenue for the Year.

For the Year, the Board has proposed a final dividend of RMB0.05 per share (before tax) totalling RMB6.4 million (before tax), subject to approval by the shareholders of the Company at the annual general meeting of the Company to be held on Wednesday, 12 June 2019 (the "AGM"). The final dividend, if approved by the shareholders of the Company at the AGM, will be paid to the shareholders of the Company whose names appeared on the register of members of the Company on Monday, 24 June 2019. Dividends payable to the holders of the Company's domestic shares shall be paid in RMB, whereas dividends payable to the holders of the Company's H shares shall be paid in Hong Kong dollars. Dividends on H share are also subject to PRC Withholding Income Tax. The final dividend will be payable on or around Thursday, 18 July 2019 and a detailed plan of distribution is set out in the circular of the Company dated 23 April 2019.

## TAX REDUCTION AND EXEMPTION (FOR H SHAREHOLDERS)

### Non-resident enterprise shareholders

Pursuant to the enterprise income tax law of the PRC and its implementation rules, which came into force on 1 January 2008 and other relevant rules, where the Company distributes the proposed 2018 final dividend to non-resident enterprise shareholders whose names appear on the register of members for H Shares of the Company, it is required to withhold enterprise income tax at the rate of 10%. Any H Shares registered in the name of non-individual registered shareholders, including HKSCC Nominees Limited, other nominees, trustees or other organizations or groups, will be treated as Shares being held by non-resident enterprise shareholders, and consequently will be subject to the withholding of the enterprise income tax.

If the individual H Share shareholders are residents of those countries which have entered into a tax treaty with the PRC stipulating a dividend tax rate of more than 10% but less than 20%, the Company will withhold and pay individual income tax at the actual tax rate stipulated in the relevant tax treaty. If the individual H Share shareholders are residents of those countries which have entered into a tax treaty with the PRC stipulating a dividend tax rate of 20%, or those countries which have not entered into any tax treaties with the PRC, or under any other circumstances, the Company will withhold and pay individual income tax at the rate of 20% on behalf of these shareholders.

於2018年12月31日，應收賬款為人民幣140.3百萬元，而撥備為人民幣61.3百萬元，得出賬面淨值為人民幣79.0百萬元，佔貴集團於2018年12月31日總資產的11.0%。

As at 31 December 2018, the accounts receivable amounted to RMB140.3 million and provision amounted to RMB61.3 million, resulting in the net carrying amount of RMB79.0 million and representing 11.0% of the Group's total assets as at 31 December 2018.

我們關注此方面，是因為管理層於評估應收賬款減值時作出了大量判斷。

We focused on this area because management made significant judgement in assessment of impairment of accounts receivable.

判斷乃基於管理層進行的預期信貸損失評估。該等評估側重於客戶的以往還款歷史、當前經營狀況、當前還款能力、當前合作關係及可取得的前瞻性資料。

The judgement was based on the expected credit loss evaluations performed by the management. These evaluations focused on the customer's past repayment history, current operation status, current repayment capabilities, current cooperation relationship and available forward-looking information.

## 我們的審計如何處理關鍵審計事項

### How our audit addressed the Key Audit Matter

我們從管理層取得了應收賬款減值評估並抽樣履行了以下程序：  
We obtained the assessment of impairment of accounts receivable from the management and performed the following procedures on a sampling basis:

- 1) 測試應收賬款賬齡狀況的準確性；  
1) Tested the accuracy of the aging profile of accounts receivable;
- 2) 審查客戶的歷史結算並與還款協議(如有)進行比較；  
2) Examined the historical settlement from the customers and compared those to repayment agreements, if any;
- 3) 審查客戶的期後結算情況；  
3) Examined the subsequent settlement from the customers;
- 4) 研究公開可得資料，以識別管理層於評估客戶經營狀況中使用的資料與當前還款能力之間的差異；及  
4) Performed research on public available information to identify any inconsistency with the information management used in the assessment of the customers' operation status and current repayment capabilities; and
- 5) 審查未完成合同並與客戶確認合同條款，以評估與彼等當前的合作關係。  
5) Examined the unfinished contracts and confirmed the contract terms with customers to assess the current cooperation relationship with them.

### 1 本集團的一般資料

無錫盛力達科技股份有限公司(「本公司」)及其附屬公司(統稱「本集團」)的主要業務為製造及銷售一系列用於鋼絲生產線的設備。

本公司為於2006年3月21日在中華人民共和國(「中國」)註冊成立的有限責任公司。於2012年7月24日，本公司根據中國相關法律及法規改制為股份有限公司。本公司註冊辦事處的地址為中國江蘇省無錫惠山經濟開發區堰新東路1號。

於2014年11月11日，本公司股份在香港聯合交易所有限公司(「聯交所」)主板上市。

除非另有註明，否則本綜合財務報表以人民幣千元呈列。

本公司董事會於2019年3月29日批准刊發本綜合財務報表。

### 2 重大會計政策概要

#### 2.1 編製基準

本集團的綜合財務報表已根據所有適用的香港財務報告準則編製。綜合財務報表已按照歷史成本慣例編製，並就按公平值計入損益的金融資產(按公平值列賬)作出修訂。

### 1 GENERAL INFORMATION OF THE GROUP

Wuxi Sunlit Science and Technology Company Limited (the “Company”) and its subsidiaries (together, the “Group”) are principally engaged in the manufacturing and sale of a range of equipment for steel wire production lines.

The Company was incorporated in the People’s Republic of China (the “PRC”) as a limited liability company on 21 March 2006. The Company was converted into a joint stock company with limited liabilities under relevant PRC laws and regulations on 24 July 2012. The address of the Company’s registered office is 1 Yanxin Road East, Huishan Economic Development Zone, Wuxi, Jiangsu Province, PRC.

The Company’s shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) on 11 November 2014.

These consolidated financial statements are presented in Renminbi thousands (RMB’000), unless otherwise stated.

These consolidated financial statements have been approved for issue by the Board of Directors of the Company on 29 March 2019.

### 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

#### 2.1 Basis of preparation

The consolidated financial statements of the Group have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRS”). The consolidated financial statements have been prepared under the historical cost convention, as modified by financial assets at fair value through profit or loss, which are carried at fair value.

#### (a) 分類及計量

##### (b) 金融資產減值

本集團的貿易及其他應收款項須採用香港財務報告準則第9號所規定的新預期信貸損失模型。根據香港財務報告準則第9號，本集團須修改貿易及其他應收款項的減值方法。本集團應用香港財務報告準則第9號簡化方法計量預期信貸損失，就所有貿易應收款項使用全期預期損失撥備。其他應收款項減值按12個月預期信貸損失或全期預期信貸損失計量，視乎信用風險自初始確認以來有否顯著增加而定。更改減值方法對本集團保留盈利的影響於上文附註2.2.2的列表披露。

##### (b) Impairment of financial assets

The Group's trade and other receivables are subject to HKFRS 9's new expected credit loss model. The Group was required to revise its impairment methodology under HKFRS 9 for trade and other receivables. The Group applies the HKFRS 9 simplified approach to measure expected credit losses (ECL) which uses a lifetime expected loss allowance for all trade receivables. Impairment on other receivables is measured as either 12-month expected credit losses or lifetime expected credit losses, depending on whether there has been a significant increase in credit risk since initial recognition. The impact of the change in impairment methodology on the Group's retained earnings is disclosed in the table in note 2.2.2 above.

While cash and cash equivalents, restricted cash and time deposits are also subject to the impairment requirements of HKFRS 9, the identified impairment losses were immaterial.

### 2.3 附屬公司

#### 2.3.1 合併

附屬公司乃由本集團控制的實體(包括結構性實體)。當本集團參與實體的業務，承擔或享有可變動回報，以及有能力運用對實體的權力影響該等回報時，則本集團控制該實體。附屬公司於控制權轉移至本集團之日起合併入賬。附屬公司在控制權終止之日起停止合併入賬。

#### (a) 業務合併

本集團採用收購會計法將業務合併入賬。收購附屬公司的轉讓代價為本集團所轉讓資產、所產生負債及所發行股權的公平值。所轉讓代價包括或然代價安排產生的任何資產或負債的公平值。收購相關成本於產生時列為開支。於業務合併中收購的可識別資產及承擔的負債及或然負債，初步按收購日期的公平值計量。

### 2.3 Subsidiaries

#### 2.3.1 Consolidation

A subsidiary is an entity (including a structured entity) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

#### (a) Business combinations

The Group applies the acquisition method of accounting to account for business combinations. The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred and the equity interests issued by the Group. The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Acquisition-related costs are expensed as incurred. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date.

The Group recognises any non-controlling interest in the acquiree on an acquisition-by-acquisition basis. Non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation are measured at either fair value or the present ownership interests' proportionate share in the recognised amounts of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at their acquisition date fair value, unless another measurement basis is required by HKFRS.

Acquisition-related costs are expensed as incurred.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is re-measured to fair value at the acquisition date; any gains or losses arising from such re-measurement are recognised in profit or loss.

所轉讓代價、被收購人的任何非控股權益金額及於被收購人的任何先前股權於收購日期的公平值超過所收購可識別淨資產公平值的部分入賬列作商譽。如所轉讓代價、已確認非控股權益及已計量先前持有的股權的總額低於議價購買下所收購附屬公司淨資產的公平值，差異直接於綜合收益表確認。

Any contingent consideration to be transferred by the Group is recognised at fair value at the acquisition date. Subsequent changes to the fair value of the contingent consideration that is deemed to be an asset or liability is recognised in accordance with HKAS 39 either in profit or loss or as a change to other comprehensive income. Contingent consideration that is classified as equity is not remeasured, and its subsequent settlement is accounted for within equity.

The excess of the consideration transferred, the amount of any non-controlling interest in the acquiree and the acquisition-date fair value of any previous equity interest in the acquiree over the fair value of the identifiable net assets acquired is recorded as goodwill. If the total of consideration transferred, non-controlling interest recognised and previously held interest measured is less than the fair value of the net assets of the subsidiary acquired in the case of a bargain purchase, the difference is recognised directly in the consolidated income statement.

Intra-group transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. The accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

**(b) Disposal of subsidiaries**

When the Group ceases to have control over a subsidiary, any retained interest in the entity is re-measured to its fair value at the date when control is lost, with the change in carrying amount recognised in profit or loss. The fair value is the initial carrying amount for the purposes of subsequently accounting for the retained interest as an associate, joint venture or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for on the same basis as would be required if the Group had directly disposed of the related assets or liabilities. This means that certain amounts previously recognised in other comprehensive income may be reclassified to profit or loss.

#### 2.3.2 獨立財務報表

於附屬公司的投資按成本扣除減值列賬。成本包括投資的直接歸屬成本。附屬公司的業績由本公司按已收及應收股息入賬。

倘收到於附屬公司投資的股息，而股息超過附屬公司在股息宣派期間的全面收益總額，或投資於獨立財務報表的賬面值超過被投資方淨資產(包括商譽)於綜合財務報表的賬面值，則須對該等投資進行減值測試。

### 2.4 分部報告

經營分部乃以與提交予主要經營決策者的內部報告一致的方式呈報。負責分配資源和評估經營分部表現的主要經營決策者被確定為作出戰略決策的董事會。

### 2.5 外幣換算

#### (a) 功能及列賬貨幣

本集團各個實體財務報表所列項目均以該實體營運所在主要經濟環境的貨幣(「功能貨幣」)計量。綜合財務報表以人民幣呈報，人民幣為本公司的功能貨幣及本集團的呈報貨幣。

#### (b) 交易及結餘

外幣交易按交易日或(在重新計量項目的情況下)估值日的匯率換算為功能貨幣。

因該等交易結算及按年底匯率換算以外幣計值的貨幣資產及負債而產生的匯兌收益及虧損，均於綜合收益表確認。

#### 2.3.2 Separate financial statements

Investments in subsidiaries are accounted for at cost less impairment. Cost includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

### 2.4 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the board of directors that makes strategic decisions.

### 2.5 Foreign currency translation

#### (a) Functional and presentation currency

Items included in the financial statements of each of the entities within the Group are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Renminbi ("RMB"), which is the Company's functional currency and the Group's presentation currency.

#### (b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured.

Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the consolidated income statement.

### 2.6 物業、廠房及設備

所有物業、廠房及設備以歷史成本減折舊列賬。歷史成本包括直接因收購該等項目而產生的支出。

後續成本只有在很可能為本集團帶來與該項目有關的未來經濟利益，而該項目的成本能可靠計量時，方會包括在資產的賬面值或確認為獨立資產(如適用)。其被取替部分的賬面值被終止確認。所有其他維修及保養費用在產生的財政期間內於綜合收益表扣除。

#### (b) Transactions and balances (Continued)

Foreign exchange gains and losses that relate to cash and cash equivalents, restricted cash and time deposits are presented in the consolidated income statement within ‘finance income or expense’. All other foreign exchange gains and losses are presented in the consolidated income statement within “other gains — net”.

### 2.6 Property, plant and equipment

All property, plant and equipment are stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset’s carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to the consolidated income statement during the financial period in which they are incurred.

Depreciation on property, plant and equipment is calculated using the straight-line method to allocate their costs to their residual values over their estimated useful lives, as follows:

Machinery	10 years
Vehicles	4 years
Computer and electronic equipment	3–5 years
Office equipment	5 years
Interior decoration	5 years

Except for the residual values rate of interior decoration which is zero, the residual values rate of other property, plant and equipment are 5%.

The assets’ residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

倘資產的賬面值高於其估計可收回金額，其賬面值即時撇減至可收回金額(附註2.10)。

出售收益及虧損按所得款項與賬面值的差異釐定，並於綜合收益表的「其他收益—淨額」內確認。

在建工程指在建的樓宇、廠房及有待安裝的機器，並按成本扣除減值虧損列賬。直接歸屬於工程的過往開支包括建築成本、廠房及機器的成本及於建築期間產生的適用借貸成本。在建工程項目直至有關資產完成及可作擬定用途前不計提折舊撥備。當有關資產投入使用時，成本轉撥至物業、廠房及設備的不同類別，並按上述政策折舊。

### 2.7 投資物業

投資物業主要由租賃土地和樓宇組成，乃為獲得長期租金收益或作為資本增值或兩者兼備而持有，同時並非由本集團佔用。投資物業按成本減累計減值虧損列賬。投資物業初步以成本計量，其後按成本減累計折舊及累計減值虧損列賬。投資物業乃以直線法按足以在其估計可使用年期20至50年內撇銷其成本的折舊率折舊。於各結算日，本集團會審閱投資物業的剩餘價值及可使用年期，並視乎情況作出適當調整。任何修訂的影響會於出現變動時計入綜合收益表。

### 2.8 土地使用權

土地使用權以成本減累計攤銷及減值虧損列賬。成本指就各廠房及樓宇所在土地的使用權(年期介乎45至50年不等)所支付的代價。土地使用權的攤銷乃於土地使用權期限按直線法計算。

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (note 2.10).

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised within "other gains—net" in the consolidated income statement.

Construction in progress represents buildings, plant and machinery under construction and pending installation and is stated at cost less impairment losses. Historical expenditure that is directly attributable to the construction comprises construction costs, the cost of plant and machinery and applicable borrowing costs incurred during the construction period. No provision for depreciation is made on construction in progress until such time as the relevant assets are completed and ready for intended use. When the assets concerned are brought into use, the costs are transferred to property, plant and equipment categories and depreciated in accordance with the policy mentioned above.

### 2.7 Investment property

Investment property, principally comprising leasehold land and buildings, is held for long-term rental yields or for capital appreciation or both, and that is not occupied by the Group. Investment properties that are stated at cost less accumulated impairment losses. Investment property is initially measured at cost and subsequently carried at cost less accumulated depreciation and accumulated impairment losses. Investment properties are depreciated on a straight-line basis, at rates sufficient to write off their costs over their estimated useful lives of 20 to 50 years. The residual values and useful lives of investment properties are reviewed, and adjusted as appropriate at each balance sheet date. The effects of any revision are included in the consolidated income statement when the changes arise.

### 2.8 Land use rights

Land use rights are stated at cost less accumulated amortisation and impairment losses. Cost represents consideration paid for the rights to use the land on which various plants and buildings are situated for periods varying from 45 to 50 years. Amortisation of land use rights is calculated on a straight-line basis over the period of the land use rights.

無形資產指按估計可使用年期(不超過五年)攤銷的電腦軟件。

### 2.10 非金融資產減值

需攤銷的資產於有事件或情況轉變顯示賬面值不可收回時檢討有否出現減值。減值虧損按資產的賬面值超出其可收回金額的差異確認。可收回金額以資產的公平值扣除銷售成本與使用價值兩者的較高者為準。於評估減值時，資產按可分開識別現金流量的最低層次(現金產生單位)分組。除商譽外，已蒙受減值的非金融資產在每個報告日檢討該減值是否可以撥回。

### 2.11 投資及其他金融資產

#### 2.11.1 分類

自2018年1月1日起，本集團按以下計量類別將其金融資產分類：

- 其後按公平值計量的金融資產(不論計入其他全面收益或計入損益)；及
- 按攤銷成本計量的金融資產。

分類視乎實體管理金融資產的業務模型及現金流量的合約條款而定。

就按公平值計量的資產而言，收益及虧損將於損益或其他全面收益記賬。就並非持作買賣的權益工具投資而言，則視乎本集團於初始確認之時有否作出不可撤回的選擇，將權益投資以按公平值計入其他全面收益的方式入賬。

本集團只於管理資產的業務模型改變時方會將債務投資重新分類。

### 2.9 Intangible assets

Intangible assets represent computer software, which are amortised over their estimated useful lives not exceeding five years.

### 2.10 Impairment of non-financial assets

Assets that are subject to amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

### 2.11 Investments and other financial assets

#### 2.11.1 Classification

From 1 January 2018, the Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income (OCI) or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or OCI. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income (FVOCI).

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

#### 2.11.2 確認及終止確認

常規購買及出售的金融資產在交易日確認，交易日指本集團承諾購買或出售該資產之日。當收取金融資產產生的現金流量的權利屆滿或已被轉讓，且本集團已將擁有的絕大部分風險及回報轉讓時，金融資產即終止確認。

#### 2.11.3 計量

#### 債務工具

#### 2.11.2 Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

#### 2.11.3 Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss (FVPL) are expensed in profit or loss.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

#### Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are three measurement categories into which the Group classifies its debt instruments:

- Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in the consolidated income statement and presented in other gains/(losses) — net together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the consolidated income statement.

##### 債務工具(續)

- 按公平值計入其他全面收益：持有目的為收取只有本金及利息付款的合約現金流量及出售金融資產的資產按公平值計入其他全面收益。賬面值變動計入其他全面收益，惟減值收益或虧損、利息收入及匯兌收益或虧損於綜合收益表確認。於終止確認金融資產時，以往於其他全面收益確認的累計收益或虧損由權益重新分類至損益，並於綜合收益表中的其他收益／(虧損)確認。該等金融資產的利息收入利用實際利率法計入財務收入。

##### 權益工具

- FVOCI: Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at FVOCI. Movements in the carrying amount are taken through OCI, except for the recognition of impairment gains or losses, interest income and foreign exchange gains and losses which are recognised in the consolidated income statement. When the financial asset is derecognised, the cumulative gain or loss previously recognised in OCI is reclassified from equity to profit or loss and recognised in the consolidated income statement as other gains/(losses). Interest income from these financial assets is included in finance income using the effective interest rate method.
- FVPL: Assets that do not meet the criteria for amortised cost or FVOCI are measured at FVPL. A gain or loss on a debt investment that is subsequently measured at FVPL is recognised in the consolidated income statement and presented net within other gains/(losses) in the period in which it arises.

##### Equity instruments

The Group subsequently measures all equity investments at fair value. Where the Group's management has elected to present fair value gains and losses on equity investments in OCI, there is no subsequent reclassification of fair value gains and losses to profit or loss following the derecognition of the investment. Dividends from such investments continue to be recognised in the consolidated income statement as other income when the Group's right to receive payments is established.

Changes in the fair value of financial assets at FVPL are recognised in other gains/(losses) in the consolidated income statement as applicable. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value.

#### 2.11.4 減值

自2018年1月1日起，本集團對其按攤銷成本列賬的債務工具的相關預期信貸損失將會作出前瞻性評估。所用的減值方法取決於信用風險有否顯著增加。

就貿易應收款項而言，本集團應用香港財務報告準則第9號允許的簡化方法，於初始確認應收款項時同時確認預期全期損失。

其他應收款項減值按12個月預期信貸損失或全期預期信貸損失計量，視乎信用風險自初始確認以來有否顯著增加而定。倘應收款項自初始確認以來信用風險顯著增加，則其減值按全期預期信貸損失計量。

#### 2.11.5 截至2017年12月31日止應用的會計政策

本集團已追溯應用香港財務報告準則第9號，惟選擇不重列比較資料。因此，所提供的比較資料繼續按照本集團以往的會計政策入賬。

#### 分類

截至2017年12月31日止，本集團將其金融資產分類為以下類別：按公平值計入損益的金融資產以及貸款及應收款項。分類乃視乎購入金融資產的目的而定。管理層應在初步確認時釐定金融資產的分類。

#### (a) 按公平值計入損益的金融資產

按公平值計入損益的金融資產為持作買賣的金融資產。倘所收購金融資產主要用於短期出售，則金融資產歸類為此類別。衍生工具除非被指定為對沖項目，否則亦歸類為持作買賣。倘此類別中的資產預期將在12個月內結算，則歸類為流動資產；否則歸類為非流動資產。

#### 2.11.4 Impairment

From 1 January 2018, the Group assesses on a forward looking basis the expected credit losses associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

Impairment on other receivables is measured as either 12-month expected credit losses or lifetime expected credit losses, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivable has occurred since initial recognition, then impairment is measured as lifetime expected credit losses.

#### 2.11.5 Accounting policies applied until 31 December 2017

The Group has applied HKFRS 9 retrospectively, but has elected not to restate comparative information. As a result, the comparative information provided continues to be accounted for in accordance with the Group's previous accounting policy.

#### Classification

Until 31 December 2017 the Group classifies its financial assets in the following categories: at fair value through profit or loss and loans and receivables. The classification depends on the purpose for which the financial assets were acquired. Management determines the classification of its financial assets at initial recognition.

#### (a) Financial assets at FVPL

Financial assets at FVPL are financial assets held for trading. A financial asset is classified in this category if acquired principally for the purpose of selling in the short term. Derivatives are also categorized as held for trading unless they are designated as hedges. Assets in this category are classified as current assets if expected to be settled within 12 months; otherwise, they are classified as non-current.

##### (b) 貸款及應收款項

貸款及應收款項乃於活躍市場上並無報價而附帶固定或可釐定付款金額的非衍生金融資產。此等項目包括在流動資產內，但於報告期末後超過12個月結算或預期將於該期間結算的款項除外。該等資產被分類為非流動資產。本集團的貸款及應收款項包括於資產負債表中列出的「貿易及其他應收款項」(附註2.15)、「有限制現金」、「定期存款」及「現金及現金等值項目」(附註2.16)。

##### 其後計量

於採納香港財務報告準則第9號後，上文所述初步確認時的計量方式並無改變。

於初步確認後，貸款及應收款項其後利用實際利率法按攤銷成本列賬。

按公平值計入損益的金融資產其後按公平值列賬。因「按公平值計入損益的金融資產」類別的公平值變動而產生的收益或虧損在產生期間於綜合收益表內的「其他收益 — 淨額」中呈報。當本集團收取付款的權利確立時，來自按公平值計入損益的金融資產的股息收入於綜合收益表確認，作為其他收入的一部分。

##### (b) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are included in current assets, except for the amounts that are settled or expected to be settled more than 12 months after the end of the reporting period. These are classified as non-current assets. The Group's loans and receivables comprise "trade and other receivables" (note 2.15), "restricted cash", "time deposits" and "cash and cash equivalents" in the balance sheet (note 2.16).

##### Subsequent measurement

The measurement at initial recognition did not change after adoption of HKFRS 9, see description above.

Subsequent to the initial recognition, loans and receivables were subsequently carried at amortised cost using the effective interest method.

Financial assets at FVPL were subsequently carried at fair value. Gains or losses arising from changes in the fair value of the 'financial assets at FVPL' category are presented in the consolidated income statement within 'Other gains — net' in the period in which they arise. Dividend income from financial assets at FVPL is recognised in the consolidated income statement as part of other income when the Group's right to receive payments is established.

##### 按攤銷成本計量的金融資產減值

本集團於每個報告期末評估是否存在客觀證據證明某項金融資產或某組金融資產出現減值。只有存在客觀證據證明，初步確認資產後發生一宗或多宗事件導致出現減值(「虧損事件」)，而該宗(或該等)虧損事件對該項或該組金融資產的估計未來現金流量構成的影響可以可靠估計，該項或該組金融資產方出現減值及產生減值虧損。

減值證據可包括債務人或一組債務人遇上嚴重財政困難、逾期或拖欠償還利息或本金、債務人很有可能破產或進行其他財務重組，以及有可觀察數據顯示估計未來現金流量出現可計量的減少，例如與違約有相互關連的拖欠情況或經濟狀況改變。

對於貸款及應收款項類別，虧損金額乃根據資產賬面值與按金融資產原實際利率貼現的估計未來現金流量(不包括仍未產生的未來信用損失)的現值兩者的差異計量。資產賬面值會削減，而虧損金額則於綜合收益表確認。如貸款或持至到期投資訂有浮動利率，則計量任何減值虧損的貼現率為按合同釐定的當前實際利率。在實際應用中，本集團可利用可觀察的市場價格，按工具的公平值計量減值。

如在後續期間，減值虧損的數額減少，而此減少可客觀地聯繫至於減值確認後發生的事件(例如債務人的信用評級改善)，則之前已確認的減值虧損撥回於綜合收益表中確認。

##### Impairment of financial assets carried at amortised cost

The Group assesses at the end of each reporting period whether there is objective evidence that a financial asset or group of financial assets is impaired. A financial asset or a group of financial assets is impaired and impairment losses are incurred only if there is objective evidence of impairment as a result of one or more events that occurred after the initial recognition of the asset (a "loss event") and that loss event (or events) has an impact on the estimated future cash flows of the financial asset or group of financial assets that can be reliably estimated.

Evidence of impairment may include indications that the debtors or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation, and where observable data indicate that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

For loans and receivables category, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate. The carrying amount of the asset is reduced and the amount of the loss is recognised in the consolidated income statement. If a loan or held-to-maturity investment has a variable interest rate, the discount rate for measuring any impairment loss is the current effective interest rate determined under the contract. As a practical expedient, the Group may measure impairment on the basis of an instrument's fair value using an observable market price.

If, in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised (such as an improvement in the debtor's credit rating), the reversal of the previously recognised impairment loss is recognised in the consolidated income statement.

於有合法強制執行權利抵銷已確認金額並擬按淨額基準結算，或同時變現資產及償付負債時，金融資產及負債予以抵銷，而有關淨額於資產負債表呈報。合法強制執行權利不得以未來事件為依據，且必須可於公司或交易對手出現違約、無力償債或破產時在日常業務過程中強制執行。

### 2.13 存貨

存貨乃按成本與可變現淨值兩者的較低者列賬。成本乃採用加權平均法釐定。製成品及在製品的成本包括原材料、直接人工、其他直接成本及相關生產間接開支(依據正常營運能力而定)，並不包括借貸成本。可變現淨值為在日常業務過程中的估計銷售價，減適用的可變銷售開支。

### 2.14 持作出售物業

持作出售物業乃按成本與可變現淨值兩者的較低者列賬。物業成本包括物業應佔收購成本。於釐定可變現淨值時，會考慮預期變現的銷售價，減適用的可變銷售開支。

### 2.15 貿易及其他應收款項

貿易應收款項指在日常業務過程中就已出售商品或已提供服務應收客戶的款項。如貿易及其他應收款項預期在一年或以內收回，則分類為流動資產；否則按非流動資產呈列。

貿易及其他應收款項初步按無條件的代價金額確認，惟包含重大財務部分的貿易及其他應收款項以公平值確認。貿易及其他應收款項其後利用實際利率法按攤銷成本扣除減值撥備計量。

### 2.12 Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the balance sheet when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the company or the counterparty.

### 2.13 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted average method. The cost of finished goods and work in progress comprises raw materials, direct labour, other direct costs and related production overheads (based on normal operating capacity). It excludes borrowing costs. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

### 2.14 Properties held for sale

Properties held for sale are stated at the lower of cost and net realisable value. Cost of properties comprises acquisition costs attributable to the properties. Net realisable value was determined taking into account the selling price expected to be realised, less applicable variable selling expenses.

### 2.15 Trade and other receivables

Trade receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business. If collection of trade and other receivables is expected in one year or less, they are classified as current assets. If not, they are presented as non-current assets.

Trade and other receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. Trade and other receivables are subsequently measured at amortised cost using the effective interest method, less allowance for impairment.

### 2.16 現金及現金等值項目

在綜合現金流量表中，現金及現金等值項目包括庫存現金、銀行活期存款、原定於三個月或以內到期的其他短期高流通性投資。

### 2.17 股本

普通股歸類為權益。直接歸屬於發行新股或認股權的新增成本在權益中列為所得款項的減少(經扣除稅項)。

### 2.18 貿易應付款項

貿易應付款項指在日常業務過程中向供應商購買貨品或服務的付款責任。如貿易應付款項在一年或以內到期，則分類為流動負債；否則按非流動負債呈列。

貿易應付款項初步以公平值確認，其後利用實際利率法按攤銷成本計量。

When the terms of trade and other receivables that would otherwise be past due or impaired have been renegotiated, trade and other receivables are remeasured using the revised effective interest method determined according to the renegotiated terms and conditions. Any difference between the carrying amounts of trade and other receivables before and after the renegotiation is recognised directly in the consolidated income statement.

### 2.16 Cash and cash equivalents

In the consolidated statement of cash flows, cash and cash equivalents includes cash in hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less.

### 2.17 Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

### 2.18 Trade payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade payables are classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities.

Trade payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

**(a) 當期所得稅**

當期所得稅支出根據本公司及其附屬公司營運及產生應課稅收入的國家於結算日已頒佈或實質上已頒佈的稅法計算。管理層就須詮釋適用稅務規例的情況定期評估報稅表的狀況，並在適用情況下根據預期須向稅務機關支付的稅款設定撥備。

**(b) 遞延所得稅****內部基準差異**

遞延所得稅乃利用負債法就資產和負債的稅基與其於綜合財務報表的賬面值之間的暫時差異確認。然而，若遞延稅項負債因初步確認商譽而產生，則不予確認；若遞延所得稅因在交易(不包括業務合併)中初步確認資產或負債而產生，而在交易時不影響會計或應課稅利潤或虧損，則不記賬。遞延所得稅採用在結算日前已頒佈或已實質上頒佈，並預期於變現有關遞延所得稅資產或結算遞延所得稅負債時適用的稅率(及稅法)釐定。

遞延所得稅資產僅於將來很可能有應課稅利潤抵銷可用的暫時差異時確認。

The tax expense for the period comprises current and deferred tax. Tax is recognised in the consolidated income statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case the tax is also recognised in other comprehensive income or directly in equity, respectively.

**(a) Current income tax**

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Company and Company's subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

**(b) Deferred income tax****Inside basis differences**

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill, the deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

#### (b) 遞延所得稅(續)

##### 外部基準差異

遞延所得稅負債乃就於附屬公司的投資所產生的應課稅暫時差異作出撥備，但假若本集團可控制暫時差異的撥回時間，並於可預見未來可能不會撥回暫時差異的遞延所得稅負債則除外。

遞延所得稅資產就於附屬公司的投資所產生的可扣減暫時差異確認，惟僅限於暫時差異很可能將於日後撥回，且有充足的應課稅利潤抵銷可用的暫時差異的情況。

#### (c) 抵銷

當有合法強制執行權利將當期稅項資產與當期稅務負債抵銷，且遞延所得稅資產和負債涉及由同一稅務機關對應課稅實體或不同應課稅實體徵收所得稅，而有意以淨額基準結算結餘時，則可將遞延所得稅資產與負債互相抵銷。

### 2.20 僱員福利

本集團實行多項離職後計劃，包括界定供款退休金計劃。

#### (a) 退休金責任

界定供款計劃是一項退休金計劃，本集團根據該計劃支付固定供款予一個獨立的實體。倘基金並無足夠資產為所有僱員支付當期及過往期間的僱員服務福利，本集團並無法定或推定責任進一步支付供款。

對於界定供款計劃，本集團以強制性、合同性或自願性方式向公開或私人管理的退休金保險計劃供款。本集團作出供款後，即無進一步付款義務。供款於到期時確認為僱員福利開支。預付供款如可獲現金退款或可減少未來付款，則確認為資產。

#### (b) Deferred income tax (Continued)

##### Outside basis differences

Deferred income tax liabilities are provided on taxable temporary differences arising from investments in subsidiaries, except for deferred income tax liability where the timing of the reversal of the temporary difference is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred income tax assets are recognised on deductible temporary differences arising from investments in subsidiaries, only to the extent that it is probable the temporary difference will reverse in the future and there is sufficient taxable profit available against which the temporary difference can be utilised.

#### (c) Offsetting

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred income taxes assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

### 2.20 Employee benefits

The Group operates various post-employment schemes, including defined contribution pension plans.

#### (a) Pension obligations

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods.

For defined contribution plans, the Group pays contributions to publicly or privately administered pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

#### (b) 離職福利

當本集團於僱員正常退休日期前終止僱傭關係或每當僱員接受自願遣散以換取離職福利時，本集團可給予離職福利。本集團會按以下日期(以較早者為準)確認離職福利：(a)本集團再無可能撤回提供該等福利的提議時；及(b)實體確認重組成本(屬於香港會計準則第37號範圍內)並涉及支付離職福利時。倘提出一項要約以鼓勵自願遣散，則離職福利按預期接受要約的僱員人數計量。在報告期末後超過12個月到期的福利貼現至其現值。

### 2.21 撥備

當本集團需就過去事件承擔現有法定或推定責任，而很可能導致資源流出以履行該責任，並能夠可靠地估計金額時，本集團會就環境恢復、重建成本及法律索償確認撥備。本集團不會就日後經營虧損確認撥備。

倘出現多項類似責任，則會否導致資源流出以履行有關責任，乃經考慮責任的整體類別後釐定。即使同類別責任中任何一項可能流出資源的機會不大，仍會確認撥備。

保證撥備主要指根據過往經驗就質量保證提供保養服務及替換配件的估計成本。

### 2.20 Employee benefits (Continued)

#### (b) Termination benefits

Termination benefits are payable when employment is terminated by the Group before the normal retirement date, or whenever an employee accepts voluntary redundancy in exchange for these benefits. The Group recognises termination benefits at the earlier of the following dates: (a) when the Group can no longer withdraw the offer of those benefits; and (b) when the entity recognises costs for a restructuring that is within the scope of HKAS 37 and involves the payment of termination benefits. In the case of an offer made to encourage voluntary redundancy, the termination benefits are measured based on the number of employees expected to accept the offer. Benefits falling due more than 12 months after the end of the reporting period are discounted to their present value.

### 2.21 Provisions

Provisions for environmental restoration, restructuring costs and legal claims are recognised when: the Group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation, and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Warranty provision mainly represents the estimation cost of providing maintenance services as well as the replacement of accessories in connection with the quality warranty based on past experience.

### 2.22 收入確認

收入乃按已收或應收代價的公平值計量，相等於所供應貨物的應收款項減去折扣、退貨及增值稅後的數額。當本集團每項活動均符合下述特定條件時，本集團確認收入。本集團會根據過往經驗並考慮客戶類別、交易種類和每項安排的特點作出估計。

#### (a) 貨品銷售額

本集團主要從事生產及銷售一系列鋼絲製品生產線的設備及單機。當貨品的控制權均轉移至客戶，即通常在(1)交付產品予客戶；(2)完成安裝及現場調試(若銷售合同有此規定)；及(3)客戶已接收設備且並無任何其他未履行責任時，本集團會確認銷售設備產生的收入。

#### (b) 租金收入

投資物業租金收入按租期以直線法於綜合收益表內確認。

#### (c) 財務部分

對於向客戶轉讓所承諾貨品與客戶付款之間為期超過一年的合約，交易價與銷售貨品的收入金額須就金錢的時間價值調整。

### 2.23 利息收入

利息收入乃採用實際利率法確認。當一項貸款及應收款項出現減值時，本集團會將其賬面值減至其可收回金額(即按工具的原訂實際利率貼現的估計未來現金流量)，並繼續將所貼現的金額列作利息收入。已減值貸款及應收款項的利息收入按原訂實際利率確認。

### 2.22 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable, and represents amounts receivable for goods supplied, stated net of discounts returns and value-added taxes. The Group recognises revenue when specific criteria have been met for each of the Group's activities as described below. The Group bases its estimates on historical experience, taking into consideration the type of customer, the type of transaction and the specification of each arrangement.

#### (a) Sales of goods

The Group is principally engaged in manufacturing and sale of a range of equipment for steel wire production lines and standalone machineries. Revenue from sales of equipment is recognised when the control of the goods has been transferred to the customer, which is usually upon (1) delivery of products to the customer; (2) completion of the installation and on-site testing (if required in the sale contract); and (3) the acceptance by the customer of the equipment without any further unfulfilled obligation.

#### (b) Rental income

Rental income from investment property is recognised in the consolidated income statement on a straight-line basis over the term of the lease.

#### (c) Financing components

For contracts where the period between the transfer of the promised goods the customer and payment by the customer exceeds one year, the transaction price and the amount of revenue from the sales of goods is adjusted for the time value of money.

### 2.23 Interest income

Interest income is recognised using the effective interest method. When a loan and receivable is impaired, the Group reduces the carrying amount to its recoverable amount, being the estimated future cash flow discounted at the original effective interest rate of the instrument, and continues unwinding the discount as interest income. Interest income on impaired loans and receivables are recognised using the original effective interest rate.

向本公司股東分派的股息在股息獲本公司股東或董事(以適用者為準)批准的期間內在本集團及本公司的財務報表確認為負債。

本集團的業務令其須承受各類財務風險：市場風險(包括外匯風險以及現金流量及公平值利率風險)、信用風險及流動資金風險。本集團的整體風險管理計劃專注於金融市場的不可預測性，並力求減輕對本集團財務表現造成的潛在不利影響。

#### (a) 市場風險

##### (i) 外匯風險

外匯風險來自非以實體功能貨幣計值的交易或已確認資產或負債。

本集團於中國境內營運，大部分交易以人民幣計值及結算，惟若干貿易應收款項及銀行存款以美元計值，承受外幣換算風險。本集團並無使用任何金融工具對沖外匯風險。

### 2.24 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to costs are deferred and recognised in the consolidated income statement over the period necessary to match them with the costs that they are intended to compensate.

### 2.25 Dividend distribution

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's and the Company's financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

## 3 FINANCIAL RISK MANAGEMENT

### 3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, cash flow and fair value interest rate risk), credit risk and liquidity risk. The overall risk management program of the Group focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on financial performance of the Group.

#### (a) Market risk

##### (i) Foreign exchange risk

Foreign exchange risk arises when transactions or recognized assets or liabilities are denominated in a currency that is not the entity's functional currency.

The Group operates in mainland China with most of the Group's transactions denominated and settled in RMB, except that certain trade receivables and bank deposits are denominated in US dollar ("USD") which are exposed to foreign currency translation risk. The Group had not used any financial instrument to hedge the foreign exchange risk.

If the USD had strengthened/weakened by 5% against the RMB while all other variables had been held constant, the Group's net result for the year ended 31 December 2018 would have been approximately RMB3,912,000 better/worse (2017: RMB3,025,000), for various financial assets denominated in USD.

##### (ii) Cash flow and fair value interests rate risk

As the Group has no significant interest-bearing assets (other than bank balances and cash, details of which have been disclosed in Note 25). The Group's has no interest-bearing liabilities as at the year-end date.

##### (b) Credit risk

Credit risk arises from bank deposits, financial assets at FVPL and trade and other receivables. The carrying amounts or the undiscounted nominal amounts, where applicable, of each class of these financial assets represent the Group's maximum exposure to credit risk in relation to the corresponding class of financial assets.

為管理信用風險，銀行存款和按公平值計入損益的金融資產存放於具有良好信譽的金融機構／由具有良好信譽的金融機構發行。

本集團已制訂政策確保產品售予信貸紀錄良好的客戶。本集團透過密切審查多項指標以評估客戶的信譽，當中包括其財務及營運狀況(包括客戶的生產設施是否全面運作、設施場地、營運規模，以及客戶的物業、廠房及設備投資額)、其信貸評級及市場競爭格局。本集團根據該項評估及相關合同價值，為客戶可結欠款額結餘設定最高限額。本集團的財務部門監察逾期的貿易應收款項，並指示銷售人員跟進追收貿易應收款項。本集團銷售部門亦為每名客戶建立信貸紀錄。與客戶交易相關的紀錄每月更新，以監察截至月底的銷售金額、付款、累計未償還金額、逾期未付金額及累計壞賬。本集團財務部門不時監察及更新客戶貿易應收款項的狀況，跟進貿易應收款項的變動，以及確保到期未付款額不超過給予客戶的最高限額。逾期貿易應收款項的可收回程度定期進行具體審查。有關貿易應收款項減值撥備的詳盡披露載於附註19。本集團一般不會要求貿易債務人提供抵押品。

至於其他應收款項，管理層會依據過往結算紀錄、過往經驗及可取得的前瞻性資料對其他應收款項是否可收回作出定期集體評估及個別評估。

To manage the credit risk, bank deposits and financial assets at FVPL are placed with/issued by highly reputable financial institutions.

The Group has policies in place to ensure that products are sold to customers with appropriate credit history. The Group assesses the creditworthiness of a customer by closely examining a number of indicators which include its financial and operational conditions (including whether the customer's production facilities are in full operation, the site of the facilities, scale of operation, and the customer's amount of investments in property, plant and equipment), its credit rating and competitive landscape of the market. Based on such assessment and the value of the relevant contract, the Group set a maximum balance of amount due allowable for a customer. The finance department of the Group monitors the past due trade receivables and directs the sales personnel to follow up the collection of the trade receivables. The sales department of the Group also set up a credit profile for each customer. Record relating to the transactions with the customer is updated monthly to monitor the amount of sales, payment, accumulated amount outstanding, amount past due and unpaid, and accumulated bad debts made as at the end of the month. The finance department of the Group monitors and updates the customer's trade receivables position from time to time, keeps track of the movement of the trade receivables, and ensures that the outstanding amounts due do not exceed the maximum balance allowable for a customer. Specific review on the recoverability of past due trade receivables is performed on a regular basis and detailed disclosure of allowance for impairment of trade receivables is set out in note 19. Normally the Group does not require collateral from trade debtors.

For other receivables, management makes periodic collective assessments as well as individual assessment on the recoverability of other receivables based on historical settlement records, past experience and available forward-looking information.

The trade and other receivables are subject to the expected credit loss model. While cash and cash equivalents, restricted cash, time deposits are also subject to the impairment requirements of HKFRS 9, the identified impairment loss was immaterial. The expected credit losses of bank acceptance notes and interest receivables are assessed to be low and no loss allowance provision is made as banks have a low risk of default and a strong capacity to meet its contractual cash flow obligations.

The Group applies the HKFRS 9 simplified approach to measure expected credit losses which uses a lifetime expected loss allowance for all trade receivables. Impairment on other receivables is measured as either 12-month expected credit losses or lifetime expected credit losses, depending on whether there has been a significant increase in credit risk since initial recognition. To measure the expected credit losses, trade other receivables have been grouped based on shared credit risk characteristics and the aging of initial recognition.

For individual trade or other receivables which were determined that there was objective evidence that an impairment had been incurred, the expected credit losses were separately reviewed for impairment. The Group considered that there was evidence of impairment if any of the following indicators were present:

- significant financial difficulties of the debtor
- probability that the debtor will enter bankruptcy or financial reorganisation, and
- in a lawsuit with the debtor.

Except for the above individual receivables, the remaining trade and other receivables have been grouped based on shared credit risk characteristics and the aging of initial recognition to measure the expected credit losses.

#### 3.2 資本管理

本集團管理資本的目標旨在保障本集團持續經營的能力，以為股東提供回報及為其他權益人提供利益，並維持最佳資本架構以降低資本成本。

為了維持或調整資本架構，本集團可調整支付予股東的股息金額，向股東退還資本，發行新股或出售資產以減少債務。

與行內同業一樣，本集團根據資產負債比率監控資本。該比率按淨債務除以總資本計算。淨債務按總借款減現金及現金等值項目、定期存款及有限制銀行存款計算。總資本按綜合資產負債表所示之「權益」加淨債務計算。於2018年12月31日，本集團並無外部借款。

#### 3.3 公平值估計

按公平值列賬的金融工具透過不同的估值法計量。該等估值法的輸入值在公平值層級內分為以下三個層級：

#### 3.2 Capital management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

Consistent with others in the industry, the Group monitors capital on the basis of the gearing ratio. This ratio is calculated as net debt divided by total capital. Net debt calculated as total borrowings less cash and cash equivalents, time deposits and restricted bank deposits. Total capital is calculated as "equity" as shown in the consolidated balance sheet plus net debts. As at 31 December 2018, the Group has no external borrowings.

#### 3.3 Fair value estimation

Financial instruments carried at fair value are measured by different valuation methods. The inputs to valuation methods are categorised into three levels within a fair value hierarchy, as follows:

- Quoted prices (unadjusted) in active markets for identical assets or liabilities (level 1).
- Inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly (that is, as prices) or indirectly (that is, derived from prices) (level 2).
- Inputs for the asset or liability that are not based on observable market data (that is, unobservable inputs) (level 3).

The Group's financial assets at fair value through profit or loss are carried at fair value based on level 2 valuation method. There were no transfers between levels 1 and 2 during the year.

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

**4.1 Critical accounting estimates and assumptions**

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

**(a) Current and deferred income taxes**

Significant judgment is required in determining the provision for income tax. There are many transactions and calculations for which the ultimate determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such difference will impact the income tax and deferred tax provision in the period in which such determination is made.

Deferred income tax assets relating to certain temporary differences and tax losses are recognised when management considers to be probable that future taxable profit will be available against which the temporary differences or tax losses can be utilised. Where the expectation is different from the original estimate, such differences will impact the recognition of income tax assets and taxation in the periods in which such estimate is changed.

The Group reviews the carrying amounts of inventories at each balance sheet date to determine whether the inventories are carried at lower of cost and net realisable value. The Group estimates the net realisable value of each inventory, based on its related selling price less additional cost to sale and historical experience on similar inventories. Any change in the assumptions used in making the estimates would increase or decrease the amount of allowance of inventories.
