If the sum of the votes cast is more than the number of H Shares registered in your name(s) to which this form of proxy relates, all the votes cast on such resolution shall be regarded as abstention votes. If no direction is given, your proxy will vote at his/her discretion. Your proxy will also be entitled to vote at his/her discretion on any resolution properly put to the H Shareholders' Class Meeting other than those referred to in the notice convening the H Shareholders' Class Meeting.
- 5. Resolution No. 1 is a special resolution which shall be passed by more than two-thirds of the voting rights held by the holders of H shares of the Company present at the meeting.
- This form of proxy must be signed by you or your attorney duly authorised in writing. In the case of a corporation, the same must be either 6. under its common seal or under the hand of its director(s) or duly authorised attorney(s). If this form of proxy is signed by an attorney of an H Shareholder, the power of attorney authorising that attorney to sign or other authorisation document must be notarised.
- 7. In order to be valid, this form of proxy together with the power of attorney or other authorisation document (if any) must be deposited at the H Share registrar of the Company, Computershare Hong Kong Investor Services Limited, the address of which is set out in note 8 below, not less than 1:00 p.m. on Thursday, 13 June 2019 (or if the H Shareholders' Class Meeting is adjourned, not less than 24 hours before the time fixed for holding the adjourned H Shareholders' Class Meeting.
