### **ABOUT THIS REPORT**

The Group has developed its sustainability strategy with aims to create sustainable values to its stakeholders and has brought positive impact to the environment and society. In order to carry out the sustainability strategy from top to bottom, the Board of Directors (the "Board") of the Group has ultimate responsibility for ensuring the effectiveness of the Group's environmental, social and governance ("ESG") policies. The Board has established dedicated teams to manage ESG issues within each business division in the Group. Designated staff has been assigned to enforce and supervise the implementation of the relevant ESG policies. The Group is also committed to constantly reviewing and adjusting the Group's sustainability policies to satisfy the ever-changing needs of its stakeholders. Details of its management approach in environmental and social aspects can be found in the different sections of this Report. The Group believes that sustainability is essential to the long-term development of the Group.

## SCOPE AND REPORTING PERIOD

### A. ENVIRONMENTAL

The Group pays great attention to protecting the environment and is committed to the long-term sustainability of the environment and community in which it operates. The Group stringently controls its emissions and consumption of resources and complies with all relevant environmental laws and regulations in all operating regions in its daily operation. All operating regions of the Group have implemented effective energy conservation measures to minimise the environmental impact, such as raising the environmental awareness, using resources responsibly, and managing the waste efficiently.

# **A1.** Emissions

During the reporting period, the Group did not note any cases of material non-compliance relating to air and greenhouse gas ("GHG") emissions, discharge into water and land, and the generation of hazardous and non-hazardous waste as required by the applicable laws and regulations.

The Group adopts environmental management system and strictly monitors its projects in all segments to comply with national and local laws and regulations related to environmental protection and pollution control, including but not limited to the followings:

- Environmental Impact Assessment Ordinance (Hong Kong);
- Waste Disposal Ordinance (Hong Kong);
- Environmental Protection Law of the People's Republic of China ("PRC");

# A. 環境

本集團非常重視保護環境,致力於經營所 在地環保及社區的長期可持續發展。本集 團嚴格監控其排放物及資源耗用情況,並 於日常營運中遵守各個經營地區的所有相 關環境法律及法規。本集團各經營地區實 行有效節能措施,盡量減輕對環境的影 響,例如提高環保意識、以負責任態度使 用資源及有效管理廢棄物。

# A1. 排放物

於報告期內,本集團並不知悉任何 與廢氣及溫室氣體排放、向水及土 地的排污以及有害及無害廢棄物的 產生的適用法律及法規有關的重大 不合規情況。

### A1.1 Air Emissions

During the reporting year, gasoline was used for Group-owned vehicles, contributing to the emissions of 11.62 kg of nitrogen oxides ("NO,") and 0.28 kg of sulphur oxides ("SO<sub>x</sub>") and 0.73kg of respiratory suspended particles ("PM").

There were 355.2 tonnes of carbon dioxide equivalent greenhouse gases (mainly carbon dioxide, methane and nitrous oxide) emitted from the Group's operations in the reporting period, with an intensity of 3.14 tCO<sub>2</sub>e per employee.

#### A1.3 Hazardous Waste

0.06 tonnes of hazardous waste, including waste fluorescent lamps, batteries, cleaning products and printing cartridges, were generated during the reporting period.

#### A1.4 Non-hazardous Waste

A total of 6.34 tonnes of non-hazardous waste were generated during the reporting period and they were mainly waste paper and domestic waste such metal, glass, plastic and food waste from daily office operations.

### A1.3有害廢棄物

於報告期內產生0.06噸有害廢 棄物,包括螢火燈、電池、清 潔產品及碳粉匣。

## A1.4 無害廢棄物

於報告期內產生總共6.34噸無 害廢棄物,主要為廢紙及家居 廢棄物,例如來自日常辦公室 運作的金屬、玻璃、塑膠及廚 餘。

#### A1.5 Measures to Mitigate Emissions

Due to business nature, business air travel is necessary for the Group's business operation and growth, nevertheless, teleconferencing is encouraged among employees for internal communications across teams in various regions. Employees are also reminded of energy saving practice at office working environment.

# A1.6 Wastes Handling and Reduction Initiatives

The Group's hazardous waste generation was minimal, and they were handled by either building management office or qualified third parties. In Hong Kong, 24 units of old computer hardware were donated to Cartias Computer Workshop, a training centre established and funded by the government, for their recycling programme during the reporting period.

For non-hazardous waste, the intensity has dropped to 0.06 tonnes per employee (2017: 0.12 tonnes per employee). The Group also highly advocates paperless office. For example, the Hong Kong head office has promoted Office Automation (OA) for electronic/paperless office operation. Documents and information are transmitted electronically to avoid paper consumption. Most network printers were set duplex printing as the default mode when printouts are needed.

## A1.5 減低排放量的措施

基於業務性質,乘坐飛機出外 公幹對於本集團的業務營運及 增長屬必要之舉。然而,本集 團鼓勵不同地區各團隊的僱員 以電話會議進行內部溝通,並 提醒僱員在辦公室工作環境內 執行節能措施。

## A1.6廢棄物處理及減低措施

本集團產生極少有害廢棄物, 而該等有害廢棄物交由樓宇管 理公司或合資格第三方處理。 於報告期內,本集團在香港捐 贈24台舊電腦硬件予明愛電腦 工場的回收計劃。明愛電腦工 場乃一所由政府成立及撥款的 培訓中心。

無害廢棄物的密度下跌至每名 僱員0.06噸(2017年:每名僱 員0.12噸)。本集團亦高度提倡 無紙辦公室。例如,香港總辦 事處已為電子/無紙辦公室自動化。文件及 資料均以電子方式傳遞,避免 耗紙。如有需要列印,大部分 網絡打印機的預設模式均已設 定為雙面打印。

# A2. Use of Resources

To protect the environment, the Group continues to promote eco-friendly behaviours through written guidelines in Employee Handbook to ensure the rational use of resources across the operations. The Group and its employees have responsibility in energy saving and reduction in GHG emissions. Resources shall be used and operated reasonably and with proper and regular maintenance to achieve optimal energy efficiency.

# A2. 資源使用

為保護環境,本集團一直在僱員手 冊載列書面指引,推廣環保行為, 確保在各項營運上合理使用資源。 本集團及其僱員肩負節約能源及減 少溫室氣體排放的責任。必須合理 善用資源並定期進行正規保養,以 達致最佳能源效益。

### A2.2 Water Consumption

Water consumption of the Group's operations was minimal, and water was mostly supplied by the building management office and included in the management fee, thus no consumption record is reported here.

### A2.3 Energy Use Efficiency Initiatives

During this Reporting Period, both consumption intensities for petrol and electricity have significant reduced comparing with 2017. The property investment segment has proactively replaced old fluorescent lamp, ceiling lamp, and high voltage mercury lamp with new energy efficient LED lighting system, the estimated energy saving during 2018 was over 120,000 kWh.

## A2.4 Water Use Efficiency Initiatives

Though the water consumption was minimal, there was no issue in sourcing water that fits for purpose. The Group continuously encourage employees to practice water conservation and implemented various procedures in different business segments, such as:

- Carry out regular leakage tests on water tap, washers and other defects of the water supply system;
- Clean water tank when the water level is relevant low to reduce the water discharge; and
- Reform cooling tower to reduce the water consumption.

# A2.2 耗水

本集團的營運極少耗水,而大 部分水供應來自樓宇管理公 司,並納入管理費內,因此並 無報告耗用紀錄。

# A2.3能源使用效益計劃

於本報告期內,汽油及電力消 耗密度較2017年大幅減少。物 業投資分部主動積極以具新能 源效益的LED照明系統取代舊 式的螢光燈、天花燈及高壓水 銀燈,估計2018年節省的能源 超過120,000千瓦時。

## A2.4 用水效益計劃

儘管耗水極少,在求取適用水 源並無任何問題,本集團一直 鼓勵僱員習慣節約用水,並因 應不同業務分部實施各種程 序,例如:

- 對水龍頭、墊圈及供水
  系統的其他缺陷進行定
  期漏水檢測;
- 於水位相對較低時清理 水缸,減少排水量;及
- 改造冷卻水塔,減少用水。

#### A2.5 Packaging Material

The Group's business did not involve any use of packaging materials, hence no data nor information is being presented in this report.

# A3. The Environment and Natural Resources

# A3.1. Significant Impacts of Activities on the Environment

The Group strictly complied with all local laws and regulations in relation to the environment and the use of natural resources during the year under review. To alleviate its impact on the environment and natural resources, the Group has followed the requirements established by LEED in the development of real estate in Los Angeles. Besides, the Group has also invested in the indoor greening decoration in the lobbies of the properties and in Hong Kong office. Such investment has not only enhanced the decorative and beautifying effect and created a comfortable and excellent surrounding to the leaseholder, but improve the indoor air quality in the properties as well. The Group will continue to adhere to the safety, harmony and green development concept and make unremitting efforts to create a resourcing-saving and environmentallyfriendly corporation in the future.

# A3. 環境及天然資源

#### A3.1.活動對環境的重大影響

The Group has established and implemented various controlling and mitigation schemes. In particular, the Group's real estate development project in Los Angles will pursue the U.S. Green Building Council's (USGBC) LEED ("Leadership in Energy and Environmental Design") certification as a Campus project consisting of a Master site which encompasses the whole property, two LEED-NC v 2009 projects, (the North Tower and South Towers, respectively) and one LEED-CS v 2009 project (retail building). All three projects are required to attain LEED Silver level certification or better.

By committing to follow LEED guidelines, the project demonstrates a comprehensive improvement on various environmental criterial including site plan, water efficiency, energy & atmosphere, material & resources, and indoor environmental quality. 本集團已制定並實施不同監控 及緩解計劃。其中,本集團的 洛杉磯房地產開發項目將作為 一個校園項目申請美國綠色樓 宇理事會(USGBC)的LEED(「能 源和環境設計標準」)認證,而 主地盤包括整個物業、兩個 LEED-NC(新建築) v 2009項目 (北大樓及南大樓)及一個 LEED-CS(結構體) v 2009項目 (零售樓宇)。三個項目全部要 求達到LEED銀級認證或以上。

藉遵從LEED指引,該項目在多 個環境要素均取得全面提升, 包括地盤規劃、用水效益、能 源及大氣、材料及資源以及室 內環境質素。

本集團亦遵守地方政府就僱員 福利強制實施的僱員社會保障 計劃相關法律及法規。中國僱 員亦獲提供房屋津貼。本集團 的人力資源部根據最新法律及 法規定期審閱及更新相關公司 政策。

#### Recruitment and Promotion

During the reporting period, the Group has set an annual recruitment plan to manage its recruitment process. To attract high calibre candidates, the Group offers fair, competitive remuneration and benefits based on the individuals' past performance, personal attributes, job experiences and career aspiration. The Group also references market benchmarks in determining its remuneration and benefit policies. The Group attracts candidates through various measures such as posting information on the Internet, attending recruitment seminars and hire headhunting companies. The Group has established periodicity plans and budgets to run performance evaluation. It reviews employees' performance annually which includes working capability, contribution, advantages, targets and areas that need to be improved. Employees are also appraised with respect to their attendance, guality of work, productivity, working attitude, technical and problem-solving abilities, reliability, communication skills and team work, etc. The working scope and working targets are set according to the evaluation. The Group promotes and mobilizes its staff to motivate outstanding employees with positive job performance, boost the input and initiative of employees in work, so as to enhance the operational efficiency of the Group and meet the needs of business development. All the promotion should be approved by the senior managers and based on employees' performance.

#### 招聘及晉升

於報告期內,本集團訂有一套 年度招聘計劃,管理其招聘程 序。為吸引優秀的應徵者,本 集團按照個人的過往表現、個 人素質、工作經驗及事業抱 **負**,提供公平而具競爭力的薪 酬及福利。此外,本集團於釐 定其薪酬及福利政策時,亦會 參考市場標準。本集團透過不 同措施招攬應徵者,例如在互 聯網登載資料、參與招聘座談 會及聘用獵頭公司。本集團已 制定定期計劃及預算進行表現 評核。本集團每年審視僱員的 表現,包括工作能力、貢獻、 長處、目標及需要改進範疇。 僱員亦會因應其出席率、工作 質素、生產力、工作態度、技 術及解難能力、可靠程度、溝 通技巧及團隊工作等方面接受 評核。工作範圍及工作目標會 按評核訂定。本集團給予其員 工動力及鼓勵,以期激發卓越 僱員的優秀工作表現,提高僱 員的工作投入及士氣,從而提 升本集團的營運效率,滿足業 務發展需要。所有晉升應由高 級經理按照僱員表現審批。

#### Compensation and Dismissal

As talent retention is vital to the future business development of the Group, the Group constantly reviews its compensation packages and performs probationary and regular evaluations according to the overall market environment, profitability of the Group and employee's performance in the past. This ensures that employees are recognised by the Group appropriately with respect to their efforts and contributions. The Group also gives discretionary bonuses to employees according to their performance, and sets share option scheme as a longterm incentive for key management staff. In case of any serious negligence, the employee can be dismissed legitimately at any time. Employees who are about to leave the office should send a written letter to the supervisor of the department and send a copy to Human Resources Department and Administration Department. Meanwhile, any appointment, promotion or termination of employment contract would be based on reasonable, lawful grounds and internal policies, such as staff handbook. The Group strictly prohibits any kinds of unfair or unreasonable dismissals to protect the employee's rights.

#### 薪酬及解僱

由於挽留人才乃本集團未來業 務發展的關鍵,本集團不斷檢 討其薪酬待遇,並根據整體市 場環境、本集團的盈利能力及 僱員的過往表現進行試用及常 規評核。此舉確保僱員的努力 及貢獻獲本集團給予適當肯 定。本集團亦根據僱員表現向 彼等酌情發放花紅,並為主要 管理人員制定購股權計劃作為 長期獎勵。如有任何嚴重疏 忽, 僱員可隨時被合法解僱。 快將離職的僱員應致函部門主 管,並向人力資源部及行政部 發送副本。另外,任何委任、 晉升或終止僱傭合約應按合理 合法的依據及內部政策(例如 員工手冊)進行。本集團嚴格 禁止任何類型的不公平或不合 理解僱,以保障僱員權利。

#### Working Hours and Rest Period

The Group has formulated its own internal policies based on local employment laws for determining working hours and rest period for employees. The Group strictly tracks employees' working hours through Staff Manual. Employees who work at nonoffice hours can receive overtime pay or compensation leave. In addition to basic paid annual leave and statutory holidays stipulated by the employment laws of the local governments, employees may also be offered additional leave entitlements such as marriage leave, sick leave and others.

#### 工作時數及假期

#### Equal Opportunity and Anti-discrimination

As an equal opportunity employer, the Group is committed to creating a fair, respectful and diverse working environment by promoting anti-discrimination and equal opportunity in terms of all human resources and employment decisions. For instance, training and promotion opportunities, dismissals and retirement policies should be irrespective of their gender, age, disability, family status, marital status, sexual orientation, religion beliefs, nationality or any other non-jobrelated factors in all business units. The equal opportunities policy allows zero tolerance to any workplace discrimination, harassment or victimization in accordance to local ordinances and regulations such as U.S. Equal Employment Opportunity Commission's laws and Civil Rights Act of 1964 and Hong Kong's Disability Discrimination Ordinance and Sex Discrimination Ordinance. The Group has set up a standard reporting mechanism and equal opportunities policies in the Staff Handbook to promote a diverse work environment and the Human Resources Department is fully responsible for the strict compliance with national and corporate regulations on assessing, dealing with, recording and taking disciplinary actions on such events.

#### 平等機會及反歧視

The Group has established internal policies in offering additional benefits to employees, including medical insurance, work injury compensation insurance, life insurance, travel insurance and long service payment.

Besides, the Group has also organized a series of activities to enhance the coherence among employees, such as Spring Festival Tea Party, Potluck, Thanks Giving Dinner and Year End Dinner. The Hong Kong head office has also organized Christmas Party and badminton practice for employees. Welcome lunches are always provided for new employees and coffee, fresh fruit and biscuit are available to all employees. The Group firmly believes that a harmonious atmosphere in the office is essential to the high morale and productivity of every employee, and the organisation of different activities could significantly help the Group to create a positive working environment.

#### 其他利益及福利

### *Protecting Employees from Occupational Hazards*

All employees should be aware of the importance of working safety to protect themselves and others (colleagues and clients) from unnecessary accidents or injury. When accidents happen, employees should report to the director of the department and Human Resources Department immediately. The Group also has established internal regulations to protect employees from occupational hazards and provided guidance on how to prevent occupational risks.

#### Providing a Safe Working Environment

During the reporting period, the Group was committed to maintaining a clean, tidy, smoke-free, harmless, non-hazardous, healthy and safe working environment. As stated in the Employee Handbook, evaluations on the working environment shall be conducted to pinpoint potential hazards and analyse the health and safety risks our employees are facing. The Group prohibits smoking and drinking liquor in workplace (including the escalator and toilets), cleans the air-conditioning system and conducts carpet disinfection regularly. Employees should be familiar with the locations of safe exit, fire alarm and fire equipment. The Group has formulated different contingency plans to handle different emergency situations.

#### 保護僱員免受職業性災害

#### 提供安全的工作環境

In the real estate development segment, the general contractor for Los Angeles project has established a comprehensive Site Specific Environmental, Health & Safety (EHS) Manual to ensure that contractors provide a safe work environment and practices. A safety environment shall be maintained jointly by contractors, sub-contractors and their employees and must comply with applicable local, national laws and rules, health and safety legislation and recognised codes, standards and other external requirements in the real estate development projects such as California Code of Regulations. EHS, site-specific conditions and rules developed with the consideration of all significant hazards and their risks, and other items which are important for the safe and efficient operation of the project must be strictly complied and disclosed. The safety and quality of properties are monitored at all stages of construction by general contractor to ensure that they meet the highest standards. This entails a dedication to stringent product safety standards and a focus on health and safety issues in real estate development practices. To ensure safety in the power plants of the energy segment, EHS meetings have been arranged on a regular basis by the Group for the training of subcontractors.

During the reporting period, no workrelated fatalities and lost days due to work injury was recorded in the Group. During the year under review, the Group was not in violation of any of the relevant laws and regulations in relation to providing a safe working environment and protecting the employees from occupational hazards that have a significant impact on the Group. 於房地產開發分部,洛杉磯項 目的總承包商已建立全面的工 地環境、健康及安全手冊,以 確保承包商提供安全的工作環 境及實踐。安全的環境需要承 包商、分包商以及其僱員共同 維護,且房地產開發項目必須 遵守適用地方及國家法律及規 則、健康及安全法例以及獲認 可的守則、標準及其他外部規 定,例如加州法規。須嚴格遵 守及披露環境、健康及安全要 求、特定場地狀況及經考慮所 有重大危險及其風險後所制定 的規則、對項目安全高效運作 至關重要的其他項目。總承包 商於所有施工階段一直監控物 業的安全及質素,以確保符合 最高標準,反映房地產開發業 務對嚴緊產品安全標準的承擔 和對健康及安全問題的重視。 為確保能源電力分部的發電廠 安全,本集團已為培訓分包商 定期安排環境、健康與安全會 議。

#### B3. Development and Training

The Group values training and considers it as a significant means to improve the Groups' overall operational efficiency. It has been emphasized in the Employee Handbook that employees are encouraged to discuss training opportunities related to their job skills and knowledge. The Group offers comprehensive training and development programmes to its staff to strengthen employees' work-related skills and knowledge.

Specifically, the Group provides integrated induction training for newly recruited staff to understand its corporate culture, business processes, work health and safety, management system and group development. For other employees, the Group has held a range of regular trainings and development programmes to encourage lifelong learning, thereby meeting the requirements of different industries. With regard to employees' roles and positions, the Group offered individually tailored trainings to its employees, such as taxation updates, implementation on operating systems, risk control management and business compliance updates, which aims to foster a learning culture that could strengthen employees' professional knowledge and improve working efficiency.

# B3. 發展及培訓

本集團重視培訓,視之為提升 本集團整體營運效率的重要方 法。僱員手冊亦重點鼓勵僱員 探討與其工作技能及知識有關 的培訓機會。本集團向員工提 供全面的培訓及發展課程,增 強僱員與工作相關的技能及知 識。

The Group also encourages employees to attend external trainings for enhancing their competitiveness and expanding their capacity through continuous learning. The Group has established its internal policies on employees' external training, stating that employees who apply for external trainings in advance can get reimbursed for the training fee by the Group.

#### B4. Labour Standards

In pursuance of the Group's human resources management system, national and local laws related to labour standards and rights, there was no child labour nor forced labour working in the Group. No material non-compliance in relation to laws and regulations regarding prevention of child and forced labour was recorded during reporting period.

To combat against illegal employment on child labour, underage workers and forced labour, the Group's human resources staffs require job applicants to provide valid identity documents before confirmation of employment to ensure that the applicants are lawfully employable. If there is any unreal information, the Group will terminate the employment according to relevant laws. The Group has put child labour and compulsory labour policies in its staff manual to eliminate the labour risks. The Human Resources Department of the Group is responsible to monitor and ensure compliance with the latest relevant laws and regulations that prohibit child labour and forced labour.

# 2. **Operating Practices**

#### B5. Supply Chain Management

As a socially responsible enterprise, it is critical and vital for the Group to maintain and manage a sustainable and reliable supply chain that makes minimal negative impacts on the environment and society. Each of the operating subsidiaries within the Group monitors the quality of its suppliers and their supply chain practice on a strict and continuous basis. Due to the nature of the business, the office business involves only a few suppliers, which are hence excluded in this part.

The Group has a stringent tendering policy to select and manage its supply chain. When selecting suppliers, it evaluates supplier capabilities through on-site inspections conducted by its tender team. Potential suppliers are evaluated in terms of product/ service quality, production capacity, reputation, qualification, track records and the social and environmental responsibilities. Suppliers are divided into different groups according to the contract term and production capability for a more effective management.

# 2. 營運慣例

#### B5. 供應鏈管理

作為對社會負責任的企業,維 持可持續及可靠的供應鏈,將 對環境和社會的影響降至最低 對本集團至關重要。本集團旗 下各營運附屬公司定期嚴密監 察供應商的質素及供應鏈慣 例。基於業務性質,辦事處業 務只涉及少量供應商,故不列 入本節。

本集團為挑選及管理供應鏈訂 有嚴格的招標政策。在挑選供 應商時,本集團的招標小組會 進行實地調查,再由本集團 估供應商的能力。潛在供應 會因應產品/服務質紀錄 及環境責任方面接受 。為更有效管理,供應商 根據合約條款及產能被劃分為 不同組別。

The Group strives to reduce adverse impact to the environment in its procurement activities. The product quality standards provided by the Group and the commercial agreement with suppliers have clearly stated the environmental requirements. The Group conducts interviews with suppliers on environmental behaviour to scrutinise whether suppliers have any significant negative environmental impact on the products provided, the number of pollution accidents in the past, and awareness of environmental protection, effective control, reduction and prevention of pollution. Potential suppliers are required to provide a series of qualifications including ISO 9001, ISO 14001 and ISO 18001 and other business documents such as business license, tax registration certificate and financial information for internal evaluation.

To lower the supply chain risk, the Group has established a qualified contractor list and evaluated performances of contractors regularly. In the real estate business segment, the Group has authorized the general contractor to manage its supply chain and engaged external consultant to monitor and test the quality of construction materials such as steel and concrete on a regular basis. It also manages health and safety performances of the contractors through procedures and standards such as Site-Specific Environmental Health and Safety Manual, the Construction Indoor Air Ouality Management and Construction Waste Management Plan. In the energy segment, the Group has organised regular meetings with respect to the EHS aspects, aiming to educate the subcontractors' leaders on the knowledge in business operation, as well as close monitoring on environmental index and site cleanliness. In property investment segment, the Group actively promotes waste reduction per Domestic Garbage Classification and Reduction Policy. Proper communication has been made by the Group's management office with the property owners and tenants. A 24-hour hotline has been provided to reinforce timely and effective communication.

為減輕供應鏈風險,本集團已 建立合資格承包商名單,定期 評估承包商的表現。至於房地 產業務分部,本集團已授權總 承包商管理供應鏈,並委聘外 部顧問定期監察及測試建築材 料(如鋼筋及混凝土)的質量。 此外,本集團亦通過工地的環 境、健康及安全手冊、工程室 內空氣質素管理及工程廢棄物 管理計劃等程序及準則,管理 承包商的健康與安全表現。能 源電力分部方面,本集團定期 召開環境、健康及安全會議, 以向分包商負責人傳授業務營 運方面的知識,並密切監察環 境指數及地盤清潔。物業投資 分部方面,本集團就家居垃圾 分類及減廢政策積極推廣減 廢。本集團管理辦公室已與物 業業主及租戶妥善溝通。本集 團亦提供24小時熱線加強適時 有效通訊。

### B6. Product Responsibility

During the reporting period, the Group did not note any cases of material noncompliance regarding health and safety, advertising, labelling and privacy matters relating to products and services provided as required by related laws and regulations. There were no recalls nor complaints received related to products and service provided.

#### Customer Service

In the property investment segment, the Group negotiated on the lease conditions to provide a satisfactory leasing arrangement for both tenants and property owners. The Group also approaches the tenants, hearing their concerns and identifying the real needs of them. In order to ensure protection of customers in the lease contract, required information contained in the lease contracts and in any form of communication must be factual, accurate and precise statements.

The Group has set service enquiry lines to collect the feedback and complaints from customers. Once there is a complaint, the Group will keep customers in line with the progress and remediation according to the situation. The Group received no complaint in this segment during the year under review.

#### Information Security

The Group has complied with the relevant PRC laws and regulations to ensure that the rights and interests of customers are strictly protected. The Group has built a customer data storage system and only specific staffs can reach the information and data. The Group prohibits the provision of customer information to a third party without authorisation of the customer. The employees are educated to enhance the awareness of the data release risks and have signed the confidentiality agreement. Employees are responsible for keeping business secrets and other proprietary intellectual property rights confidentiality by signing the confidentiality agreement. In addition, the IT department sets restricted connections between office and commercial networks to prevent unauthorized data use, export and copy.

#### Intellectual Property Rights

The Group has complied with laws and regulations that have great impact on the Group such as Patent Law of the PRC, the Trademark Law of the PRC and the Regulation for the Implementation of the Trademark Law of the PRC. The Group has engaged legal advisers to provide legal advice on the protection of intellectual property rights and arranged internal legal personnel to inspect and prevent the infringement of intellectual property rights.

#### 信息保安

#### B7. Anti-corruption

To maintain a fair, ethical and efficient business and working environment, the Group strictly adheres to the local laws and regulations relating to anticorruption and bribery, irrespective of the area or country where its business operates, such as Law of the PRC on Anti-money Laundering and Prevention of Bribery Ordinance in Hong Kong. Foreign Corrupt Practice Act and Money Laundering Control Act of the U.S., and Eradication of Criminal Acts of Corruption on Law of the Republic of Indonesia.

The Group has no tolerance with any kind of corruption. Anti-corruption and Antibribery Policy and Code of Conduct have been developed as effective tools for the Group to define and manage the potential corruptive behaviour. The management of the Group has investigated on any suspicious operation relating to corruption to protect the Group's interest. All employees are expected to discharge duties with integrity and self-discipline and are required to abstain from involving in any bribery, extortion, fraud and money laundering activities or activities which might exploit their positions against the Group's interests, affect business decision or jeopardise independent judgment during business operations. Provision for Anti-corruption is stated in the contractor's contract, which plays an important role in further regulating the contractors' behaviour in the business transactions.

# B7. 反貪污

為保持業務及工作環境公平、 合乎道德及高效,不論業務經 營所在地區或國家,本集團均 嚴格遵守有關反貪污及賄賂的 地方法律及法規,如中華人 馬路例、美國反海外腐敗法及 洗錢防制法以及印尼共和國杜 絕腐敗犯罪行為法。

本集團亦絕不容忍任何形式的 貪污行為。本集團所制訂的反 貪污及反賄賂政策及操守守則 有效地界定並管束潛在貪污行 為。本集團管理層調查所有涉 及貪污的可疑行為以保障本集 團的利益。所有僱員需於履行 其職責時恪守誠信及自律原 則,並不得參與賄賂、勒索、 欺詐及洗錢活動,或於業務營 運過程中利用其職務之便進行 任何損害本集團利益及影響其 作出業務決策或獨立判斷的活 動。承包商合約列有反貪污條 款,以進一步監管承包商於業 務交易中的行為。

The Group has set up internal whistleblowing policy to encourage employees to report any suspicious activities including requesting, receiving or accepting any forms of benefits from any persons, companies or organisations that might be injurious to the interests of the Group. Employees who report any suspicious misconduct or malpractice should provide full details and supporting evidence verbally or in writing to the Risk Management Department, who will discreetly conduct investigations against the reported suspicious or illegal behaviour to protect the Group's interests. The Group advocates a confidentiality mechanism to protect the whistle-blowers against unfair dismissal or victimisation. The Audit Committee shall supervise the enforcement of these procedures.

The Group strictly abides by all laws and regulations related to anti-corruption.
