If the shareholder is a company, it should execute this proxy form under its common seal or by the signature(s) of (a) person(s) authorised to sign on its behalf. **In case of joint shareholdings, any one shareholder may sign this proxy form. The vote of the senior joint shareholder who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint shareholder(s) and for this purpose seniority will be determined by the order in which the names stand in the register of members of the Bank in respect of the joint shareholding.**
- To be valid, this proxy form, together with the power of attorney or other authority, if any, under which it is signed, or a notarially certified copy of such power of attorney or authority, must be completed and deposited at the H Share Registrar of the Bank, Computershare Hong Kong Investor Services Limited, **at least 24 hours before the meeting or adjourned meeting (i.e. not later than 9:30 a.m. on Thursday, 16 May 2019)**. Computershare Hong Kong Investor Services Limited is located at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong. The effective period of appointment of your proxy appointed under this proxy form shall cease upon conclusion of the AGM or any adjourned meeting.
- Completion and delivery of this proxy form will not preclude you from attending and voting at the meeting if you so wish.
- As a token of appreciation for attending the AGM, each shareholder who attend the meeting in person or by proxy will receive a gift set provided by the Bank upon completion of registration. In case a shareholder or proxy represents more than one shareholder to attend the AGM at the same time (including himself/herself), a maximum of THREE gift sets will be given.
