## **QUARTERLY OPERATIONAL UPDATE**

This announcement is published on a voluntary basis by the board of directors (the “**Board**”) of Bestway Global Holding Inc. (the “**Company**”, together with its subsidiaries, the “**Group**”), as part of its ongoing focus on improving transparency for shareholders, to provide an operational update on the business performance of the Group. The Company intends to publish updates of selected operational data for each quarter of its sales year ending on April 30.

### **SALES FOR THE FOURTH QUARTER FOR THE PERIOD FROM MAY 1, 2018 TO APRIL 30, 2019 (THE “2019 SALES YEAR Q4”)**

During the 2019 Sales Year Q4 (for the period from February 1, 2019 to April 30, 2019), the Group’s total sales order (in terms of the sales value), which mainly comprised products listed in the 2019 Season Product Catalogue, increased by 15-20% compared to the corresponding period (a period from February 1, 2018 to April 30, 2018) of the preceding sales year.

### **SALES FOR THE PERIOD FROM MAY 1, 2018 TO APRIL 30, 2019 (THE “2019 SALES YEAR”)**

The Group’s total sales order for the 2019 Sales Year (in terms of the sales value) mainly comprised products listed in the 2019 Season Product Catalogue which amounted to approximately USD1,004 million, representing an increase of 22.6% compared to the preceding sales year (a period from May 1, 2017 to April 30, 2018).
