QUARTERLY UPDATE ON THE STATUS OF FULFILMENT OF THE RESUMPTION CONDITIONS

As a result of delays in the process of renewing the mining licence of the Xiaohuangshan Mine, the resumption of construction has been delayed correspondingly. Nevertheless, a supplemental notice of the fourth meeting of the Directors of the Ministry of Natural Resources of Xinjiang ("MNR") was published on 24 April 2019 which indicates that approval has been given to renew the mining licence (the "Renewal Notice"). According to

the Renewal Notice, MNR has approved the renewal of the mining licence for one year and one month from 30 November 2018 to 31 December 2019.

A fresh resumption proposal ("**Proposal**") was submitted to the Stock Exchange on 25 February 2019. As requested, the Company is in the course of providing additional information and clarification in relation to the Proposal to the Stock Exchange.

ADJOURNMENT OF HONG KONG HEARING

On 19 April 2019, the Hong Kong Court ordered that the Hong Kong winding-up petition hearing be adjourned to 12 August 2019.

ADJOURNMENT OF BERMUDA HEARING

On 3 May 2019 (Bermuda time), the Bermuda Court directed that the Bermuda winding-up petition hearing be adjourned to 12 July 2019 (Bermuda time).

PROGRESS OF CONTEMPLATED SCHEME

On the 8 March 2019 (Bermuda time), the Bermuda Court ordered (amongst others) that the Company be permitted to convene a meeting of creditors to be held on or before 30 June 2019 for the purpose of considering, and if thought fit, approving a Scheme of Arrangement under Section 99 of the Bermuda Companies Act proposed to be made between the Company and its creditors.

On 30 April 2019, the Hong Kong Court has in principle also approved to convene a meeting of creditors for approving a Scheme of Arrangement pursuant to Sections 670, 673 and 674 of the Companies Ordinance (Chapter 622) of the Laws of Hong Kong with certain suggestions to the draft scheme document. The Company is in the course of obtaining the final approval from the Hong Kong Court. The scheme document approved by the Hong Kong Court is also required to be approved by the Bermuda Court.

CONTINUED SUSPENSION OF TRADING

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been halted with effect from 9:00 a.m. on 30 June 2016. Trading in the Shares will remain suspended until further notice.
