- 分發本公司及其附屬公司的通訊；
- 編製統計數據和證券持有人資料；
- 披露有關資料以便就權益索償；及
- 與上述有關的任何其他附帶或相關目的及／或使本公司及香港股份過戶登記處能履行對證券持有人及／或監管機構承擔的責任及／或證券持有人不時同意的任何其他目的。

3. 轉交個人資料

本公司及其香港股份過戶登記處所持有關證券持有人的個人資料將會保密，但本公司及其香港股份過戶登記處可以在為達到上述任何目的之必要情況下，向下列任何人士披露、獲取或轉交(無論在香港境內或境外)有關個人資料：

- 本公司委任的代理人，例如財務顧問、收款銀行和海外主要股份過戶登記處；
- 如證券申請人要求將證券存入中央結算系統、香港結算或香港結算代理人；該等將會就中央結算系統的運作使用有關個人資料；
- 向本公司或香港股份過戶登記處提供與其各自業務營運有關的行政、電腦、電腦、付款或其他服務的任何代理人、承包商或第三方服務供應商；
- 聯交所、證監會及任何其他法定監管機關、政府部門、行政機關、法院或法例、規則或法規規定的其他機構；及

4. 個人資料的保留

證券持有人有權確定本公司或香港股份過戶登記處是否持有其個人資料，並有權索取有關該資料的副本並更正任何不準確資料。證券持有人有權根據其他適用法律要求取得該其他法律下所須的資料或刪除本公司及香港股份過戶登記處不再有任何合法理由使用的資料。依據該條例，本公司及香港股份過戶登記處有權就處理任何查閱資料的要求收取合理費用。但本公司及香港股份過戶登記處不可收取任何適用法律不容的費用。
