5. **Resolution No. 24 is a special resolution which shall be passed by more than two-thirds of the voting rights held by the shareholders of the Company present at the meeting.**
6. This supplemental form of proxy must be signed by you or your attorney duly authorised in writing. In the case of a corporation, the same must be either under its common seal or under the hand of its director(s) or duly authorised attorney(s). If this supplemental form of proxy is signed by an attorney of an H shareholder of the Company, the power of attorney authorising that attorney to sign or other authorisation document must be notarised.

In order to be valid, this supplemental form of proxy together with the power of attorney or other authorisation document (if any) must be deposited at the H share registrar of the Company, Computershare Hong Kong Investor Services Limited, the address of which is set out in note 9 below, not less than 1:00 p.m. on Thursday, 13 June 2019 (or if the AGM is adjourned, not less than 24 hours before the time fixed for holding of the adjourned AGM).
8. This supplemental form of proxy is applicable to the supplemental resolution as set out in the supplemental notice of the AGM dated 20 May 2019 and supplements the original form of proxy. This supplemental form of proxy will not affect the validity of the original form of proxy duly completed by you in respect of the resolutions set out in the notice of the AGM dated 27 April 2019. If you have validly appointed a proxy to attend the AGM but do not complete and deliver this supplemental form of proxy, your proxy will be entitled to vote at his/her discretion on the special resolution set out in the supplemental notice of the AGM dated 20 May 2019.
