**POLL RESULTS OF THE AGM**

The Board of Directors (the “**Board**”) of the Company is pleased to announce that at the annual general meeting of the Company (the “**AGM**”) held on 31 May 2019, all the proposed resolutions as set out in the Notice were duly passed by the Shareholders by way of poll.

The Company’s branch share registrar in Hong Kong, Union Registrars Limited, was appointed as the scrutineer for the vote-taking at the AGM.

As at the date of AGM, the total number of issued shares of the Company entitling the holders to attend and vote for or against all the resolutions at the AGM was 12,801,578,629 Shares. There was no Share of the Company entitling the Shareholder to attend and vote only against any resolutions at the AGM. There were no restrictions on the Shareholders to cast votes on any of the resolutions at the AGM and there was no Shareholder required to abstain from voting at the AGM.
