A Share Stapled Unit is the combination of the following securities or interests in securities which, subject to the provisions in the trust deed constituting Jinmao Hotel, can only be dealt with together and may not be dealt with individually or one without the others: (a) a Unit in Jinmao Hotel; (b) the beneficial interest in a specifically identified ordinary share of Jinmao (China) Hotel Investments and Management Limited ("JCHIML") linked to the Unit and held by Jinmao (China) Investments Manager Limited as legal owner in its capacity as trusteemanager of Jinmao Hotel; and (c) a specifically identified preference share of JCHIML stapled to the Unit.
- 4. Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases. Where the issuer has already made the relevant confirmations in a return published under rule 13.25A in relation to the securities issued, no further confirmation is required to be made in this return.
- 5. "Identical" means in this context:
 - the securities are of the same nominal value with the same amount called up or paid up;
 - they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and
 - they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.
