The Board wishes to inform the shareholders of the Company and potential investors that the Group is expected to record a loss for the year ended 31 March 2019 compared to the profit for the corresponding period in 2018.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Far East Hotels and Entertainment Limited (the “Company”), and together with its subsidiaries (the “Group”), pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “Board”) wishes to inform the shareholders of the Company (the “Shareholders”) and potential investors that the Group is expected to record a loss for the year ended 31 March 2019 compared to the profit for the corresponding period in 2018.

Based on the information currently available, the loss for year ended 31 March 2019 is mainly attributable to a decrease of approximately HK\$8 million in fair value of held-for-trading investments compared to an increase of approximately HK\$12 million for the corresponding period in 2018.

The information contained in this announcement is only a preliminary assessment made by the Board based on the information currently available to the Company. The annual results of the Group have not been finalised and are subject to a further review by the Board and the independent auditor of the Company. Detailed financial information and performance of the Group for the year ended 31 March 2019 will be disclosed in its final results announcement for such financial year which is expected to be published on 27 June 2019.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
