### POSITIVE PROFIT ALERT

This announcement is made by Tiangong International Company Limited (the “Company”, together with its subsidiaries, the “Group”) pursuant to Rule 13.09(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”).

The board of directors of the Company (the “Board”) wishes to inform the shareholders of the Company and potential investors that, based on the preliminary assessment by the management of the Group on the unaudited consolidated management accounts of the Group for the five months ended 31 May 2019 (“Management Accounts”) and the projected revenue to be recognised for the month of June 2019, the Group is expected to have a significant increase of over 60% in its unaudited consolidated net profit for the six months ending 30 June 2019 (the “Period”) as compared to the same period of 2018.

The significant increase in the forecasted Group's unaudited consolidated net profit for the Period was attributable to:

- (i) increase in sales volume of the Group’s die steel segment during the Period due to the increase Group’s market share in the industry; and
- (ii) increase in sales volume of the Group’s titanium alloy segment during the Period due to the increase market demand for titanium alloy products. The result of the titanium alloy segment was derived from Jiangsu Tiangong Technology Company Limited, a 74.03% owned subsidiary of the Group.

The information contained in this announcement is only based on a preliminary assessment by management of the Group on the Management Accounts, which are yet to be finalised and have not yet been reviewed by the Company's auditors or the audit committee of the Company. Further details of the Group's performance will be disclosed when the interim results of the Company for the Period are announced.
