

# CHAIRLADY'S STATEMENT 主席報告

#### Dear Shareholders,

On behalf of the Board, I hereby present the annual report of the Company for FY2019.

## FINANCIAL RESULTS AND PROPOSED FINAL DIVIDEND

In FY2019, the Group recorded revenue of approximately RMB384.3 million. Gross profit margin decreased to 17.9% in FY2019. Meanwhile, profit attributable to the owners of the Company amounted to approximately RMB20.7 million in FY2019. The Board did not recommend the payment of any Final Dividend for FY2019.

#### **ENVIRONMENTAL FACTORS**

According to the economic data published by the National Bureau of Statistics on 21 January 2019, gross domestic product for 2018 amounted to RMB90 trillion, up by 6.6% year-on-year in terms of comparable price. From January to December 2018, investments in real estate development in the PRC amounted to RMB12,026.4 billion, up by 9.5% year-on-year. Among which, residential investment was RMB8,519.2 billion (representing a growth rate of 13.4%) and increased by 4% from 2017. Residential investment accounted for 70.8% of the investment in real estate development.

On 3 April 2018, the State Council issued the "Opinions on Reforming and Improving the Policy for Supply Guarantee and Use of Generic Drugs" amongst others to accelerate and push ahead the consistency evaluation on the quality and efficacy of generic drugs and those already passed the consistency evaluation must be included in the merchandise catalogue in a timely manner. Currently, each region has basically responded and carried out online purchase for those drugs already passed the consistency evaluation. In addition, according to the "Centralised Drug Procurement File in 4+7 Cities"《4+7城市藥品集中採購檔》published on 17 December 2018, the overall purchase amount of the drug categories awarded in 11 cities in the PRC amounted to approximately RMB1,895 million. Through the savings of medical health insurance, the PRC government hopes to maintain the quality of drugs while greatly reducing the drug price and facilitating the substitution of originator drugs with generic drugs. With the reduced drug price and secured usage, the selling costs of pharmaceutical enterprises are greatly reduced. It is believed that it will have a far reaching impact on the pharmaceutical industry particularly the future industry layout of generic drugs.

#### 財務業績及建議末期股息

於二零一九財年,本集團錄得收入約人民幣384.3百萬元。二零一九財年毛利率下降至17.9%。同時,二零一九財年本公司擁有人應佔溢利約人民幣20.7百萬元。董事會並不建議就二零一九財年派付任何末期股息。

#### 環境因素

根據中國國家統計局於二零一九年一月二十一日公佈經濟數據,二零一八年全年國內生產總值中達90萬億元,按可比價格計算比上年增長6.6%。二零一八年一至十二月,全國房地產開發投資120,264億元,比上年增長9.5%。其中,住宅投資85,192億元,增長13.4%,比上年提高4%。而住宅投資佔房地產開發投資的比重為70.8%。

## 主席報告

#### **BUSINESS REVIEW**

To ensure diversified development of the Group and enhance its competitiveness, the Group will continue to actively expand the pharmaceutical inspection and other medical related businesses.

On 26 November 2015, Jiangxi Asia City, a wholly-owned subsidiary of the Company, entered into the subscription agreement (the "**Davi Subscription Agreement**") to subscribe for a 30% equity interest in Davi from an independent third party, Smartway Trading Limited ("**Smartway**"), at a consideration of RMB11.3 million.

In addition, on 30 June 2018, the Group, via Zhejiang IPS, an indirect non-wholly-owned subsidiary, entered into a strategic cooperation agreement with Agilent Technologies China Holding Co. Ltd. ("Agilent") which is the world's leading measurement company and researcher and manufacturer of biological science measuring instruments. Such cooperation enables Zhejiang IPS to share the customer resources of Agilent, and also focus on the drug packaging materials compatibility research project, which is a key element in the generic drug consistency evaluation. The Group will spare no effort in seizing the market opportunities brought by the generic drug consistency evaluation in the PRC.

#### 業務回顧

本集團為確保本集團有多元化發展並提升其競爭力,我們將持續積極擴展藥品檢測及其他醫療相關業務。

於二零一五年十一月二十六日,江西亞洲城(本公司全資附屬公司)訂立認購協議(「大為認購協議」)以從獨立第三方卓威貿易有限公司(「卓威」)認購大為30%之股權,代價為人民幣11.3百萬元。

本集團更於二零一八年六月三十日,透過間接非全資附屬公司浙江美測與安捷倫科技(中國)有限公司 (「安捷倫」)訂立戰略合作協議,後者是全球領先的 測量公司以及生物科學測量儀器的研發及生產商, 有關合作讓浙江美測得以共享安捷倫的客戶資源 並聚焦開展對藥品包裝材料相容性研究項目,此乃 仿製藥一致性評價帶來的商機。

## 主席報告

#### **FUTURE OUTLOOK**

Looking into year 2019, with the objective of achieving "steady growth with progress" of the PRC economy, in terms of real estate investment, the investment scale for 2018 was approximately RMB12 trillion, up by approximately 10% year-on-year.

We believe that "One City One Policy" will be the major direction of the China government which puts forward the setting of a city's primary responsibility for the promotion of a stable and healthy development of the market. The nature of this policy mainly refers to "acting according to circumstances and giving different guidance to different categories of cities" to genuinely stabilize land price and property price. We expect that the overall sales amount of the real estate market across China will decrease. The sales amount of residential properties in the first-tier to fourth-tier cities has showed mixed performance: Despite the gross domestic product of China has revealed a slowdown, the Company believes that this is normal and the impact is minimal.

Besides, the PRC government hopes to facilitate the substitution of originator drugs with generic drugs to achieve savings of medical health insurance fund and ensures that the generic drugs have most of the efficacy of the originator drugs. As a pharmaceutical inspection service provider engaging in consistency evaluation, the Board believes that our pharmaceutical inspection business will benefit from this national policy. The Group will also continue to seek new opportunities and explore potential investment opportunities as appropriate to generate synergies from our existing healthcare business.

#### **APPRECIATION**

Finally, I would like to thank all Shareholders, business partners and customers of the Group for their support and trust over the past year and express my sincere gratitude to the Directors, management team and all employees for their hard work and contribution to the Group.

#### 未來展望

展望二零一九年,實現中國經濟「穩中求進」的目標,就房地產投資而言,二零一八年的投資規模在12萬億元人民幣左右,年同比增長率約為10%。

我們相信「一城一策」將會是政府強調落實城市主體責任,促進市場平穩健康發展的主調。政策的性質主要是指「因地制宜、分類指導」的導向,切實地穩定地價及房價,我們預期中國全國房地產市場的整體銷售額將會下降,而一線至四線城市住宅物業的銷售額呈不同發展。雖然,國內生產總值增長有放緩跡象,本公司相信此乃正常情況及影響不大。

再者,中國政府希望促進仿製藥替代原研而節省醫 保基金,並確保仿製藥擁有原研的大部分藥效。我 們作為提供一致性評價的藥品檢測服務機構,董事 們相信我們藥品檢測業務將會受惠於此國家政策。 本集團亦將繼續不斷尋求新的機會,開拓有潛力的 合適投資機會,與我們現時的大健康業務產生協同 效應。

## 管理層討論與分析

## REVIEW OF FINANCIAL RESULTS FOR FY2019 COMPARED TO FY2018

#### Revenue

In FY2019, the Group recorded revenue of approximately RMB384.3 million, representing an increase of 186.6% from approximately RMB134.1 million in FY2018.

Revenue in FY2019 was primarily derived from the delivery of residential units of townhouse in Nanchang Sino Harbour Kaixuan City (南昌漢港凱旋城) Zone 2 and residential units of Yichun Royal Lake City (宜春御湖城) Phase 2. In FY2018, revenue was mainly attributable to the delivery of residential units and commercial units of Fuzhou Hua Cui Ting Yuan (撫州華萃庭院) Phase 2 and residential units of Yichun Royal Lake City Phase 2. All the above units are located in the PRC.

The following table sets out an analysis of the revenue for (i) residential properties, (ii) commercial properties, and (iii) car parking spaces during FY2019:

#### 收入

於二零一九財年,本集團錄得收入約人民幣384.3 百萬元,較二零一八財年約人民幣134.1百萬元增加 186.6%。

二零一九財年之收入主要來自交付南昌漢港凱旋城 二組團連棟別墅住宅單位及宜春御湖城二期住宅單 位。於二零一八財年,收入主要來自交付撫州華萃 庭院二期住宅單位及商業單位及宜春御湖城二期住 宅單位。上述所有單位均位於中國。

#### **Cost of Sales and Gross Profit Margin**

Cost of sales increased from approximately RMB89.3 million in FY2018 to approximately RMB315.4 million in FY2019. As a higher portion of the revenue of the Group was attributable to the delivery of residential units of town houses in FY2019 as compared with FY2018, which had lower gross profit margin compared with residential units delivered in FY2018, gross profit margin decreased from 33.4% in FY2018 to 17.9% in FY2019.

#### Other Income and Other Gains and Losses

Other income and other gains and losses increased from approximately RMB63.0 million in FY2018 to approximately RMB63.7 million in FY2019 mainly attributable to the net effect of the increase of the net fair value gain on investment properties and the net fair value gain on financial assets at FVTPL with a decrease of government grants.

#### **Selling and Distribution Expenses**

Selling and distribution expenses increased from approximately RMB10.8 million in FY2018 to approximately RMB15.0 million in FY2019. The higher selling and distribution expenses in FY2019 were mainly due to an increase in the marketing expenses incurred for the launch of Sino Harbour • Wu Lin Hui (漢港 • 武林匯) and Sino Harbour • Guanlan (漢港 • 觀瀾) located in Hangzhou City in Zhejiang Province and Yichun City in Jiangxi Province, the PRC, respectively.

#### **Administrative Expenses**

Administrative expenses decreased to approximately RMB43.5 million in FY2019 from approximately RMB48.8 million in FY2018. The decrease was mainly attributable to a decrease in staff cost as well as rental expenses.

#### **Finance Costs**

The Group recorded approximately RMB5.3 million non-capitalised finance costs in FY2019, increased from approximately RMB5.1 million in FY2018. The increase was mainly attributable to the increase of bank and other loans and the effective interest rate during FY2019.

#### **Profit for the Year**

As a cumulative effect of the foregoing factors, the Group recorded a profit before income tax of approximately RMB67.9 million in FY2019, compared to approximately RMB41.3 million in FY2018.

#### **Income Tax Expenses**

Income tax expenses decreased to approximately RMB35.3 million in FY2019 from approximately RMB40.1 million in FY2018. The decrease was mainly attributable to the decrease in deferred income tax for the deferred tax assets recognised in respect of tax losses.

As a result, the Group had recorded a profit after tax of approximately RMB32.6 million in FY2019, compared to approximately RMB1.2 million in FY2018.

## REVIEW OF FINANCIAL POSITION AS AT 31 MARCH 2019

#### **Property, Plant and Equipment**

As at 31 March 2019, the Group had property, plant and equipment of approximately RMB70.8 million, compared to approximately RMB67.7 million as at 31 March 2018. The increase was mainly attributable to the acquisition of equipment during FY2019.

#### **Investment Properties**

As at 31 March 2019, the Group had investment properties at fair value of approximately RMB547.4 million, compared to approximately RMB553.0 million as at 31 March 2018. The decrease comprised mainly the net effect of the disposal and the net fair value gain of the Group's investment properties.

### Intangibles

Intangible assets represented copyright and customer relationships arising from the acquisition of a subsidiary.

#### **Interest in an Associate**

The Group had interest in an associate of approximately RMB4.8 million as at 31 March 2019, compared to approximately RMB4.4 million as at 31 March 2018, which represented a 30% equity interest in Davi as at 31 March 2019 and the share of results of an associate in FY2019.

## Other Financial Assets and Financial Assets at Fair Value Through Other Comprehensive Income

It represented equity interests in a number of entities incorporated in the PRC and 1,170,000 ordinary shares of LongYu, on which the Group does not have control nor significant influence. It increased from approximately RMB28.4 million as at 31 March 2018 to approximately RMB33.4 million as at 31 March 2019 mainly attributable to the fair value gain on equity interests.

#### **Financial Assets at FVTPL**

Financial assets at FVTPL increased from approximately RMB7.7 million as at 31 March 2018 to approximately RMB12.7 million as at 31 March 2019, mainly due to the increases in the fair values of the profit guarantees in Davi and LongYu as well as the put option in relation to the equity interest in Davi.

#### **Pledged Deposits**

Long-term and short-term pledged deposits decreased from approximately RMB230.4 million as at 31 March 2018 to approximately RMB216.4 million as at 31 March 2019. The decrease was mainly due to a decrease in deposits pledged for bank loans and banking facilities granted to the mortgages.

### **Properties Held under Development**

As at 31 March 2019, the Group's properties held under development increased to approximately RMB2,183.1 million from approximately RMB1,664.4 million as at 31 March 2018. The increase was in tandem with the Group's joint venture partner which has designated all the rights and responsibility in relation to the undeveloped project in Yichun, the PRC, to the Group pursuant to the designated operating agreement ("Agreement") entered on 30 March 2018 and the construction progress of "Sino Harbour • Guanlan" and "Sino Harbour • Wu Lin Hui".

#### **Properties Held for Sale**

Properties held for sale increased from approximately RMB243.8 million as at 31 March 2018 to approximately RMB248.6 million as at 31 March 2019, mainly due to the transfer of completed property units from properties held under development for Nanchang Sino Harbour Kaixuan City Zone 2.

#### **Accounts Receivable**

As at 31 March 2019, the Group had no accounts receivable (FY2018: RMB0.3 million). The decrease was mainly due to the recovery of accounts receivable in FY2019.

#### **Prepayments and Other Receivables**

The Group's prepayments and other receivables amounted to approximately RMB180.5 million as at 31 March 2019, compared to approximately RMB268.3 million as at 31 March 2018.

Prepayments and other receivables decreased mainly due to the transfer of deposit paid in relation to the Agreement to properties held under development as well as the prepayments paid to the contractors for the construction of the Group's projects.

#### **Tax Recoverable**

Tax recoverable increased to approximately RMB20.3 million as at 31 March 2019 from approximately RMB17.6 million as at 31 March 2018, mainly attributable to an increase in prepayments of income tax during FY2019.

## Accounts Payable, Accruals, Receipts in Advance and Other Payables and Contract Liabilities

Accounts payable decreased to approximately RMB38.5 million as at 31 March 2019 from approximately RMB52.1 million as at 31 March 2018 due to a decrease in amounts payable to the contractors for construction costs incurred in respect of Fuzhou Hua Cui Ting Yuan and Sino Harbour • Wu Lin Hui.

Accruals and other payables mainly comprised the accrued construction costs and project-related expenses that were based on the progress of project development but were not due for payment.

Accruals and other payables increased to approximately RMB384.1 million as at 31 March 2019 from approximately RMB175.1 million as at 31 March 2018. The increase was due to an increase of the accrued construction cost for Sino Harbour • Wu Lin Hui and Sino Harbour • Guanlan in FY2019. Upon adoption of Hong Kong Financial Reporting Standards ("HKFRS") 15, an opening adjustment was made on 1 April 2018 to reclassify sales deposits and installments received from customers in relation to property sales from "receipts in advance" to "contract liabilities".

Sales deposits and installments received from customers increased from approximately RMB335.5 million as at 31 March 2018 to approximately RMB424.5 million as at 31 March 2019. The increase was mainly due to an increase of pre-sale proceeds from the launch of Sino Harbour • Wu Lin Hui and Sino Harbour • Guanlan.

#### **Deferred Tax Liabilities**

Deferred tax liabilities increased from approximately RMB83.6 million as at 31 March 2018 to approximately RMB84.8 million as at 31 March 2019, mainly attributable to the provision of deferred tax liabilities in respect of fair value gain on investment properties.

#### LIQUIDITY AND FINANCIAL RESOURCES

#### **Cash Position**

#### Cash and Bank Balances

In FY2019, the Group had recorded a net cash inflow of approximately RMB46.2 million from operating activities, mainly attributable to an increase in accruals, receipts in advance and other payables.

Net cash inflow from investing activities in FY2019 was approximately RMB30.2 million, which was mainly due to the disposal of investment properties and decrease in pledged deposits.

Net cash outflow from financing activities in FY2019 was approximately RMB83.9 million, mainly attributable to the repayments of loan principals and interests, which were partially offset by the receipts from new bank loans.

As at 31 March 2019, the Group had cash and bank balances of approximately RMB279.8 million (31 March 2018: RMB222.1 million), of which consisted of cash and cash equivalents of approximately RMB215.3 million (31 March 2018: RMB222.1 million) and bank balances restricted for construction work of approximately RMB64.5 million (31 March 2018: nil), and mostly were denominated in RMB and HK\$.

The Group adopts a prudent funding and treasury policy with regard to its overall business operations. Historically, we have met our capital expenditures, working capital and other liquidity requirements principally from cash generated from our operations and bank and other borrowings. Going forward, we expect to fund our working capital, capital expenditures and other capital requirements with a combination of various sources, including but not limited to cash generated from our operations, bank and other borrowings as well as other external equity and debt financing. The Group's objectives are to maintain a prudent financial policy, to monitor liquidity ratios against risk limits and to maintain a contingency plan for funding to ensure that the Group maintains sufficient cash to meet its liquidity requirements.

#### **FOREIGN CURRENCY RISK**

Most of the Group's transactions are carried out in RMB which is the functional currency of the Company and most of its operating subsidiaries. Exposures to currency exchange rates arise from certain of the Group's cash and bank balances, financial assets at FVTPL, other receivables, other payables and bank loans, which are denominated in HK\$ and US\$. The Group does not use derivative financial instruments to hedge its foreign currency risk. The Group reviews its foreign currency exposures regularly and will consider hedging significant foreign currency exposure should the need arise.

#### **PLEDGE OF ASSET**

As at 31 March 2019, the Group pledged its property, plant and equipment, investment properties, properties held under development, properties held for sale, and bank deposits of approximately RMB1,554.4 million (31 March 2018: approximately RMB1,922.0 million) to various banks to secure loan facilities granted to the Group.

#### (a) Davi (Continued)

Pursuant to the terms of the Davi Subscription Agreement, Smartway had irrevocably guaranteed JX Asia City that the audited net profit after income tax expense per annum of Davi should not be less than RMB7.0 million, RMB9.0 million, and RMB11.0 million for each of the three years ending 31 December 2016, 2017 and 2018 (collectively the "Guaranteed Periods"), respectively; or the aggregate audited net profit after income tax expense should not be less than RMB27.0 million for the Guaranteed Periods (collectively the "Profit Guarantee"). If Davi failed to meet the Profit Guarantee, Smartway was obliged to make the shortfall compensation (the "Shortfall Compensation") to JX Asia City before 31 December 2019. Also, JX Asia City was granted the right, up to 31 December 2019, to resell its entire equity interest in Davi to Smartway at a consideration equivalent to the net investment cost paid by the Group plus a 13% premium amount per annum and net of any dividend and the Shortfall Compensation received during the Guaranteed Periods.

Davi recorded net loss of approximately RMB2.7 million and approximately RMB3.4 million and net profit of approximately RMB0.5 million for the years ended 31 December 2016, 2017 and 2018, respectively, and failed to meet the Profit Guarantee. Pursuant to the Davi Subscription Agreement and discussions with Smartway, the Shortfall Compensation was agreed as approximately RMB8.8 million on 10 June 2019 and to be due on 31 December 2019, and JX Asia City reserves its rights to execute the exiting arrangement until 31 December 2019. The Company will keep its Shareholders and potential investors informed of any further significant development as and when appropriate.

#### (b) LongYu

On 28 September 2017, Zhejiang Sino Harbour, a wholly-owned subsidiary of the Company, entered into a subscription agreement to subscribe for 1,170,000 ordinary shares of LongYu at a consideration of RMB19.9 million (the "LongYu Subscription Agreement").

#### (b) LongYu (Continued)

Pursuant to the terms of the LongYu Subscription Agreement, the guarantor has irrevocably and unconditionally guaranteed Zhejiang Sino Harbour that the audited net profit of LongYu for the financial year ended 31 December 2018 shall be at least RMB25.0 million and in which the non-recurring profit or loss shall not exceed RMB5.0 million. In the event that the audited profit is less than the guaranteed profit (the "Shortfall"), the guarantor shall return the premium portion of the valuation of LongYu (the "Premium Portion") to Zhejiang Sino Harbour. The Premium Portion shall be calculated as follows:

RMB19.9 million x (1 – (16 x audited net profit)  $\div$  RMB400 million)

In the event that the Shortfall is caused by force majeure, the guarantor shall return the Premium Portion to Zhejiang Sino Harbour at a 25% discount, subject to mutual agreement between Zhejiang Sino Harbour and the guarantor. The Premium Portion at a 25% discount shall be calculated as follows:

RMB19.9 million x (1 – (16 x audited net profit)  $\div$  RMB400 million) x 75%

According to the audited financial statements of LongYu published on 30 April 2019, the audited net profit of LongYu for the year ended 31 December 2018 was approximately RMB23.2 million and therefore, failed to meet the profit guarantee of RMB25.0 million to Zhejiang Sino Harbour. Based on the explanation and several discussions with LongYu's management, Zhejiang Sino Harbour and the guarantor mutually agreed that the Shortfall was caused by force majeure. As of the date of this report, the guarantor has made compensation in relation to the Premium Portion at a 25% discount of approximately RMB1.1 million to Zhejiang Sino Harbour in accordance with the abovementioned formula.

#### **FUTURE OUTLOOK**

Looking forward into 2019, the global economy is expected to continue to grow slowly. However, the global trade tensions will pose challenges to the recovery of the global economy. Currently, the Chinese economy undergoes a period of structural adjustment, transformation and upgrading. It is anticipated that China's macroeconomy will maintain its steady growth as a whole. "One City One Policy" will be the major direction of the China government which puts forward the setting of a city's primary responsibility for the promotion of a stable and healthy development of the market. The nature of this policy mainly refers to "acting according to circumstances and giving different guidance to different categories of cities" to genuinely stabilize land price and property price. With the deepened regulation and active development of long-term regulatory mechanism, it is expected that the overall sales amount of the real estate market across China will decrease. During the first quarter of 2019, the cumulative growth of residential price index of 100 cities across China continued to shrink as compared with the last four quarters, but the overall price was relatively stable. In terms of a single month, the price in the previous two months continued to shrink on a monthon-month basis.

#### **FUTURE OUTLOOK (CONTINUED)**

The sales amount of residential properties in the first-tier to fourth-tier cities showed mixed performance: In the first-tier cities, the regulatory guidelines have shifted from managing the demand to increasing the supply. In the first quarter of 2019, commodity housing in the first-tier cities recorded a monthly average area sold of approximately 440,000 sq.m., up by 29% year-on-year. The market has picked up significantly. Single month transactions rose by approximately 50% year-on-year. In the second-tier cities, regulation will continue to tighten and there are still slight opportunities that annual sales amount will make new breakthrough. In the first quarter of 2019, commodity housing in the representative second-tier cities recorded a monthly average area sold of approximately 640,000 sq.m., down by 4.8% year-on-year, among which, Hangzhou and Nanjing both saw a year-on-year decrease but with signs of recovery. The area sold in March 2019 increased steadily year-on-year. In the third-tier and fourth-tier cities, the de-inventory effect is prominent and the actual market demand will decrease accordingly. In the first guarter of 2019, commodity housing in the representative third-tier and fourth-tier cities recorded a monthly average area sold of approximately 270,000 sq.m., down by 10.6% year-on-year, among which, more than 50% of the cities showed a decline in the area sold for such quarter yearon-year. The cooling of the market is increasingly evident. Benefiting from the increases in the overall supply and market demand, selling price is expected to remain stable.

The Group will continue to actively expand the pharmaceutical inspection and stem cell businesses. On 30 June 2018, Zhejiang IPS, a non-wholly-owned subsidiary of the Company, entered into a strategic cooperation agreement with Agilent which is the world's leading measurement company and researcher and manufacturer of biological science measuring instruments. Such cooperation enables Zhejiang IPS to share the customer resources of Agilent, and also focus on the drug packaging materials compatibility research project, which is a key element in the generic drug consistency evaluation. The Group will spare no effort in its top priority of making Zhejiang IPS become a leading contract research organization in the PRC, while targeting the market opportunities brought by the generic drug consistency evaluation in the PRC. The Board is of the view that the stem cell storage and consultation business will remain stable. The Group will constantly seek new opportunities and explore appropriate potential investment opportunities to create synergies with our current healthcare businesses. With a strong financial position of property development, the Group will continue to assess new opportunities in healthcare sector to achieve sustainable growth and to enhance Shareholders' value. However, the Board will remain cautious in the rapidly changing environment.

#### **Policy and Market Risk**

As a key economic pillars industry for the PRC's development, the property sector is more susceptible to the impact of macro-economic and industrial policies. Our Group's performance may be adversely affected by changes of the political, social and economic conditions in the PRC if we are unable to respond to the ever-changing market condition in a timely manner.

#### **Expansion Risk**

While the Group is currently principally engaged in the business of property development, it has been exploring other possible business areas and seeking to expand into new business sectors. However, our experiences may not be applicable to the new business sectors. Our Group's performance may be adversely affected by the failure to expand into new business sectors.

#### Financial Risk

An analysis of the Group's financial risk management is disclosed in note 35 to the Consolidated Financial Statements.

# COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE

Sino Harbour and the Group recognise that good corporate governance establishes and maintains a legal and ethical environment, which is essential for preserving and enhancing the interests of all stakeholders. The Company has applied the principles and complied with all of the code provisions in the Corporate Governance Code during the Year except as disclosed in this report.

### (A) THE BOARD OF DIRECTORS

The Board is primarily responsible for overseeing and supervising the management of the business affairs and the overall performance of the Group. It sets the Group's values and standards and ensures that the requisite financial and human resources support are in place for the Group to achieve its objectives. Currently, the Board comprises seven Directors, including three Executive Directors, Mr. SHI Feng (the Deputy Chairman and the Chief Executive Officer), Mr. WONG Lui and Ms. GAO Lan, a NED Ms. Chan (the Chairlady) and three INEDs, Mr. XIE Gang, Mr. LEE Man To and Mr. HE Dingding. Mr. WONG Lui is the son of Ms. Chan. Save as disclosed above, there is no family or other material relationship among the members of the Board. The biographical details of the Directors are set out on pages 80 to 86 of this annual report.

The Board has adopted a board diversity policy which sets out the approach to accomplish diversity on the Board. The Company recognises that increasing diversity at the Board level will support the achievement of the Company's business objectives and sustainable development.

The Company seeks to accomplish Board diversity through the consideration of a number of factors, such as gender, age, cultural and educational background, professional experience, skills, knowledge and length of service. All Board appointments will be based on merits while taking into account diversity including gender diversity.

All Executive Directors and the NED have entered into service contracts with the Company for a specific term of three years. All INEDs have entered into letters of appointment with the Company for a specific term of one year.

In compliance with Rule 3.10 of the Listing Rules, the Company has appointed three INEDs, one of whom has appropriate professional qualifications in accounting and financial management. Each of the INEDs has confirmed his independence of the Company and the Company considers each of them to be independent in accordance with the guidelines for assessing independence set out in Rule 3.13 of the Listing Rules.

Under the Bye-Laws, the Board is empowered to appoint any person as a Director to fill a causal vacancy or, subject to authorisation by the Shareholders in general meeting, as an additional Director. Where vacancies exist, the Board shall carry out selection process by making reference to the skills, experience, qualification, integrity and time commitments of the proposed candidates.

One-third of the Directors are subject to retirement from office by rotation and re-election at each AGM provided that every Director shall be subject to retirement at least once every three years in accordance with the Bye-Laws.

Ms. Chan is the Chairlady and Mr. SHI Feng is the Chief Executive Officer. The division of responsibilities between the Chairlady and the Chief Executive Officer are clearly divided to ensure a balance of power and authority.

Ms. Chan, being the Chairlady, is responsible for formulating the Company's overall strategies and policies, providing leadership to the Board and ensuring the Board functions effectively. She would ensure complete, reliable and timely information being provided to the Directors and encourage the Directors to actively participate in the Board to act in the best interest of the Company.

Mr. SHI Feng, being the Chief Executive Officer, is responsible for the daily operations of the Company, execution of business policies, strategies, objectives and plans as formulated and adopted by the Board and leading the management of the Company.

### (C) COMPLIANCE WITH MODEL CODE

The Company has adopted the Model Code as its code of conduct for securities transactions by the Directors, senior management and certain employees of the Group (who are likely to be in possession of unpublished inside information in relation to the Company or its securities). The Audit Committee reports to the Board and is delegated by the Board to assess matters related to the financial statements. Under its terms of reference, the Audit Committee is required to perform, amongst others, the following duties:

The Board acknowledges its responsibility for maintaining a sound system of risk management and internal control framework. The controls are to provide reasonable assurance to safeguard the Shareholders' investments and the Group's assets. The systems of risk management and internal control are designed to manage rather than eliminate the risk of failure to achieve business objectives. It can only provide reasonable but not absolute assurance against material misstatement or loss and the review of the Group's risk management and internal control systems should be a concerted and continuing process.

The Group's control environment provides the foundation upon which all other components of risk management and internal control systems are built. It provides discipline and structure, setting the tone of the organisation and influencing the control consciousness of its staff. A weak control environment foundation hampers the effectiveness of even the best designed internal control procedure.

During the Year, the Group has complied with the risk management and internal control code provisions set out in code provision C.2 of the Corporate Governance Code by having adopted a three-tier risk management approach to identify, assess, mitigate and handle risks. The Group has developed and adopted a strategic planning and risk management policy, which is designed to enhance risk management of the Group by identifying, analyzing and evaluating the possible material risks which shall have adverse impact on the achievement of the Group's objectives, including strategic risks, financial risks, market risks, operational risks and legal and regulatory risks. Divisions and department heads are responsible for the first line of defence. They oversee the daily operations of their own business units and are accountable for the conduct and performance of their own operations. Any incidents regarding noncompliance of their operations with regulations and laws, failure to identify or properly manage the risks associated with their business units, which might lead to financial or non-financial losses to the Group, shall be reported to the legal and compliance department and the internal audit department of the Group (the "Internal Audit Function"). As the second line of defence, the Internal Audit Function defines rule sets and models, provides professional advices, develops work plans of internal audit, as well as monitor and review the processes, practices and procedures of internal controls for all business units on a regular basis. It annually prepares internal audit report containing findings and recommendations for improvements in respect of the risk management and internal controls and submits such report to the Audit Committee for review. It also ensures that risks are within the acceptable range and that the first line of defence is effective. As the final line of defence, the Audit Committee, with the professional advices and opinions from the Internal Audit Function, ensures that the first and second lines of defence are effective through constant inspection and monitoring.

The Company is aware of its obligations under Part XIVA of the SFO and the Listing Rules, to handle and disseminate of price-sensitive inside information to the public, after the information has come to the Company's knowledge, as soon as reasonably practicable.

If the Board needs time to clarify details of, and the impact arising from, an event or a set of circumstances before it is in a position to issue a full announcement to properly inform the public, the Board shall consider issuing a "holding announcement". There are circumstances where confidentiality has not been maintained and the Board is not able to make a full announcement or a holding announcement, the Board shall consider applying for a trading halt in its securities until disclosure can be made. All announcements in relation to inside information disclosure should be properly approved by the Board and issued to the public without delay.

### **Noise Mitigation**

4.1.3 At every stage of property development, noise levels generated from construction are regularly assessed and monitored. The contractors are required to implement noise control measures in accordance with the relevant laws and regulations. The Group encourages contractors to adopt low-noise construction machineries to further minimize noise pollution. The purpose is to reduce the environmental impact in all aspects of the Group's operations.

### Waste Management

- 4.1.4 The Group is committed to reduce waste during its operation. To effectively monitor wastes, the Group has begun to collect data on its solid waste emission.
- 4.1.5 Disposal records are regularly monitored by the Group to identify areas of improvements. A transparent and verifiable waste recording system is set up on each property to enable performance monitoring.

Moreover, the staff should be equipped with job-related professional skills through trainings to improve their capability. Be a responsible developer, the Group has been regularly monitored their contractors to ensure if enough trainings are provided to the staff to enhance their knowledge and skills for discharging duties at work.

### 5.3 Providing Healthy and Safe Workplace

5.3.1 The Group believes that it is its responsibility to provide a safe workplace for employees. The employees shall be notified their working conditions by the employer in accordance with the relevant labour law. In addition, authorized permit is needed to access the construction site for the sake of safety enforcement.

### 5.4 Anti-Corruption Mechanism

5.4.1 The Group upholds integrity, fairness, transparency, accountability and tolerates no corruption and fraud. Additionally, the Group is providing a level-playing field to all contractors and suppliers.

By adopting an affordable range of best practices during design and planning stages, the environmental impacts were minimized for constructing a new building as well as improving the environmental quality and user satisfaction.

- 6.3.1 In order to pursuit continuous improvement in quality, the Group has developed its own policy and code of conduct as internal guide for quality control. The guide includes the protection of intellectual property rights and client data. All contractors are expected to follow the same practices.

Revenue from sale of properties held for sale is recognised upon the transfer of control of these properties held for sale to the customers. The revenue recognition is dependent on the contractual arrangements for the sale and the laws in the relevant jurisdiction and may require significant audit effort and management judgement.

#### Other response

Our audit procedures included:

- Reviewing the legal advice provided by the Group's legal advisor, including the legal advisor's interpretation of the applicable laws and the implication on the assessment of the enforceability of the right to payment;
- Assessing the competency, experience and objectivity of the legal advisor engaged by the Group;

Properties held for sale and properties held under development are stated at the lower of their costs and their net realisable values.

The determination of the estimated net realisable value of these properties held for sale and properties held under development is critically dependent upon the Group's estimation of future selling prices and construction costs to complete their projects.

The Group owns a portfolio of investment properties comprising commercial offices and shop units, located in the PRC. Investment properties were significant to the Group as they represented approximately 14.3% of the total assets of the Group as at 31 March 2019.

These investment properties are stated at their fair values based on independent external valuations.

The valuation process involves significant judgement in determining the appropriate valuation methodology to be used, and in estimating the underlying assumptions to be applied. The valuations are highly sensitive to key assumptions applied in deriving at the capitalisation, discount and terminal yield rates i.e. a small change in the assumptions can have a significant impact to the valuation.

#### 1. GENERAL INFORMATION

Sino Harbour Holdings Group Limited (the "Company") was incorporated in Bermuda on 5 January 2011 as an exempted company with limited liability under the Companies Act 1981 of Bermuda. The registered office of the Company is located at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda and the principal place of business of the Company is located at Room 1215, Tower B, Hunghom Commercial Centre, 37–39 Ma Tau Wai Road, Hunghom, Kowloon, Hong Kong.

The principal activity of the Company is investment holding. The principal activities of the Company's subsidiaries are set out in note 16 to the consolidated financial statements.

The consolidated financial statements on pages 95 to 240 have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") which collectively includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKAS") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"). The consolidated financial statements also include the applicable disclosure requirements of the Hong Kong Companies Ordinance and the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules").

The consolidated financial statements of the Group and statement of financial position of the Company for the year ended 31 March 2019 were approved for issue by the board of directors (the "**Board**") on 26 June 2019.

In addition, HKFRS 9 retains the requirements in HKAS 39 for derecognition of financial assets and financial liabilities. However, it eliminates the previous HKAS 39 categories for financial assets of held-to-maturity financial assets, loans and receivables and available-forsale financial assets. The adoption of HKFRS 9 has no material impact on the Group's accounting policies related to financial liabilities and derivative financial instruments. The impact of HKFRS 9 on the Group's classification and measurement of financial assets is set out below.

Under HKFRS 9, except for certain accounts receivable (that the accounts receivable do not contain a significant financing component in accordance with HKFRS 15), an entity shall, at initial recognition, measure a financial asset at its fair value plus, in the case of a financial asset not at FVTPL, transaction costs. A financial asset is classified as: (i) financial assets at amortised cost ("amortised cost"); (ii) FVOCI; or (iii) FVTPL (as defined in above). The classification of financial assets under HKFRS 9 is generally based on two criteria: (i) the business model under which the financial asset is managed and (ii) its contractual cash flow characteristics (the "solely payments of principal and interest" criterion, also known as "SPPI criterion"). Under HKFRS 9, embedded derivatives is no longer required to be separated from a host financial asset. Instead, the hybrid financial instrument is assessed as a whole for the classification.

#### (ii) Impairment of financial assets

The adoption of HKFRS 9 has changed the Group's impairment model by replacing the HKAS 39 "incurred loss model" to the "ECLs model". HKFRS 9 requires the Group to recognised ECLs for accounts receivable, financial assets at amortised cost, contract assets and debt investment at FVOCI earlier than HKAS 39. Cash and cash equivalents are subject to ECLs model but the impairment is immaterial for the current period.

#### Measurement of ECLs

ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall is then discounted at an approximation to the assets' original effective interest rate.

The Group has elected to measure loss allowances for accounts receivables using HKFRS 9 simplified approach and has calculated ECLs based on lifetime ECLs. The Group has established a provision matrix that is based on the Group's historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For other debt financial assets, the ECLs are based on the 12-months ECLs. The 12-months ECLs is the portion of the lifetime ECLs that results from default events on a financial instrument that are possible within 12 months after the reporting date. However, when there has been a significant increase in credit risk since origination, the allowance will be based on the lifetime ECLs. When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECLs, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information and analysis, based on the Group's historical experience and informed credit assessment and including forwardlooking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

The Group considers a financial asset to be in default when: (1) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (2) the financial asset is more than 90 days past due, unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

#### Presentation of ECLs

Loss allowances for financial assets measured at amortised cost are deducted from the gross carrying amount of the assets. For debt investment at FVOCI, the loss allowance is recognised in OCI, instead of reducing the carrying amount of the assets.

#### Impact of ECLs

As mentioned above, the Group applies the HKFRS 9 simplified approach to measure ECLs which recognises lifetime ECLs for all accounts receivable. To measure the ECLs, accounts receivable have been grouped based on shared credit risk characteristics and the days past due. Applying the ECLs model results in immaterial impairment on 1 April 2018 and for the year ended 31 March 2019.

All of the Group's other debt investments at amortised cost are considered to have low credit risk, and the loss allowance recognised during the period was therefore limited to 12 months ECLs. Applying the ECLs model results in loss allowances of RMB3,697,000 on 1 April 2018. The loss allowances increased for RMB260,000 for other receivables during the year ended 31 March 2019.

Hedge accounting under HKFRS 9 has no impact on the Group as the Group does not apply hedge accounting in its hedging relationships.

#### (iv) Transition

The Group has applied the transitional provision in HKFRS 9 such that HKFRS 9 was generally adopted without restating comparative information. The reclassifications and the adjustments arising from the new ECLs rules are therefore not reflected in the statement of financial position as at 31 March 2018, but are recognised in the statement of financial position on 1 April 2018. This mean that differences in the carrying amounts of financial assets and financial liabilities resulting from the adoption of HKFRS 9 are recognised in retained profits and reserves as at 1 April 2018. The Group has adopted HKFRS 15 using the cumulative effect method without practical expedients. The Group has recognised the cumulative effect of initially applying HKFRS 15 as an adjustment to the opening balance of retained profits at the date of initial application (that is 1 April 2018). As a result, the financial information presented for 2018 has not been restated.

The transition to HKFRS 15 had no impact on the opening balance of retained profits.

The amendments also re-characterise the list of evidence in the standard as a non-exhaustive list, thereby allowing for other forms of evidence to support a transfer.

HKFRS 16, which upon the effective date will supersede HKAS 17 "Leases" and related interpretations, introduces a single lessee accounting model and requires a lessee to recognise assets and liabilities for all leases with a term of more 12 months, unless the underlying asset is of low value. Specifically, under HKFRS 16, a lessee is required to recognise a right-of-use asset representing its right to use the underlying leased asset and a lease liability representing its obligation to make lease payments. Accordingly, a lessee should recognise depreciation of the right-of use asset and interest on the lease liability, and also classifies cash repayments of the lease liability into a principal portion and an interest portion and presents them in the statement of cash flows. Also, the right-of-use asset and the lease liability are initially measured on a present value basis. The measurement includes non-cancellable lease payments and also includes payments to be made in optional periods if the lessee is reasonably certain to exercise an option to extend the lease, or not to exercise an option to terminate the lease. This accounting treatment is significantly different from the lessee accounting for leases that are classified as operating leases under the predecessor standard, HKAS 17.

The total operating lease commitment of the Group in respect of rented properties as at 31 March 2019 amounted to approximately RMB673,000. The directors anticipate that the adoption of HKFRS 16 would not result in significant impact on the Group's result but expect that the above operating lease commitments will be recognised as right-of-use assets and lease liabilities in the Group's financial statements.

The Interpretation supports the requirements of HKAS 12, Income Taxes, by providing guidance over how to reflect the effects of uncertainty in accounting for income taxes.

# Amendments to HKFRS 3 - Definition of a Business

Amendments to HKFRS 3 clarify and provide additional guidance on the definition of a business. The amendments clarify that for an integrated set of activities and assets to be considered a business, it must include, at a minimum, an input and a substantive process that together significantly contribute to the ability to create output. A business can exist without including all of the inputs and processes needed to create outputs. The amendments remove the assessment of whether market participants are capable of acquiring the business and continue to produce outputs. Instead, the focus is on whether acquired inputs and acquired substantive processes together significantly contribute to the ability to create outputs. The amendments have also narrowed the definition of outputs to focus on goods or services provided to customers, investment income or other income from ordinary activities. Furthermore, the amendments provide guidance to assess whether an acquired process is substantive and introduce an optional fair value concentration test to permit a simplified assessment of whether an acquired set of activities and assets is not a business.

# Amendments to HKAS 1 and HKAS 8 – Definition of Material

Amendments to HKAS 1 and HKAS 8 provide a new definition of material. The new definition states that information is material if omitting, misstating or obscuring it could reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. The amendments clarify that materiality will depend on the nature or magnitude of information. A misstatement of information is material if it could reasonably be expected to influence decisions made by the primary users.

Save as discussed above, other than HKFRS 16, all new standards, amendments to standards and interpretations issued but not effective are not likely to have significant impact on the Group's consolidated financial statements.

# 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies adopted in the preparation of the consolidated financial statements are summarised below. These policies have been consistently applied to all the years presented unless otherwise stated. The adoption of new and revised HKFRSs and the impacts on the Group's consolidated financial statements, if any, are disclosed in note 2.

#### 3.1 Basis of preparation

The consolidated financial statements have been prepared under the historical cost basis, except for investment properties, financial assets at FVTPL and financial assets at FVOCI which are stated at fair values. The measurement bases are fully described in the accounting policies below.

The financial statements are presented in Renminbi ("RMB") and all values are rounded to the nearest thousand ("RMB'000"), except when otherwise indicated.

It should be noted that the accounting estimates and assumptions are used in preparing these financial statements. Although these estimates are based on management's best knowledge and judgment of current events and actions, actual results may ultimately differ from those estimates. The areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the financial statements are disclosed in note 4.

## 3.2 Basis of consolidation and business combination

The consolidated financial statements incorporate the financial statements of the Company and its subsidiaries (note 3.3) made up to 31 March each year.

Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated statement of comprehensive income from the effective dates of acquisition or up to the effective dates of disposal, as appropriate. Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with those used by other members of the Group.

Acquisition of subsidiaries or businesses is accounted for using the acquisition method. The cost of an acquisition is measured at the aggregate of the acquisition-date fair value of assets transferred, liabilities incurred and equity interests issued by the Group, as the acquirer. The identifiable assets acquired and liabilities assumed are principally measured at acquisition date fair value. The Group's previously held equity interest in the acquiree is re-measured at acquisition-date fair value and the resulting gains or losses are recognised in profit or loss.

The Group may elect, on a transaction-by-transaction basis, to measure the non-controlling interest that represent present ownership interests in the subsidiary either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other non-controlling interests are measured at fair value unless another measurement basis is required by HKFRS. Acquisition-related costs incurred are expensed unless they are incurred in issuing equity instruments in which case the costs are deducted from equity.

Any contingent consideration to be transferred by the acquirer is recognised at acquisition date fair value. Subsequent adjustments to consideration are recognised against goodwill only to the extent that they arise from new information obtained within the measurement period (a maximum of 12 months from the acquisition date) about the fair value at the acquisition date. All other subsequent adjustments to contingent consideration classified as an asset or a liability are recognised in profit or loss.

Changes in the Group's interests in subsidiaries that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the Group's interest and the non-controlling interest are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interest is adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interest. Amounts previously recognised in other comprehensive income in relation to the subsidiary are accounted for in the same manner as would be required if the relevant assets or liabilities were disposed of.

Subsequent to acquisition, the carrying amount of non-controlling interests that represent present ownership interests in the subsidiary is the amount of those interests at initial recognition plus the non-controlling interest's share of subsequent changes in equity. Total comprehensive income is attributed to non-controlling interests even if this results in the non-controlling interest having a deficit balance.

#### 3.3 Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: power over the investee, exposure, or rights, to variable returns from the investee, and the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

#### 3.4 Associates

An associate is an entity over which the Group has significant influence and that is neither a subsidiary nor a joint arrangement. Significant influence is the power to participate in the financial and operating policy decisions of the investee but not control or joint control over those policies.

Associates are accounted for using the equity method whereby they are initially recognised at cost and thereafter, their carrying amount are adjusted for the Group's share of the post-acquisition change in the associates decisions of except that losses in excess of the Group's interest in the associate are not recognised unless there is an obligation to make good those losses.

Profits and losses arising on transactions between the Group and its associates are recognised only to the extent of unrelated investors' interests in the associate. The investor's share in the associate's profits and losses resulting from these transactions is eliminated against the carrying value of the associate. Where unrealised losses provide evidence of impairment of the asset transferred they are recognised immediately in profit or loss.

Any premium paid for an associate above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the associate. Where there is objective evidence that the investment in an associate has been impaired, the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

In the Company's statement of financial position, investments in associates are carried at cost less impairment losses, if any. The results of associates are accounted for by the Company on the basis of dividend received and receivable during the year.

#### 3.4 聯營公司

聯營公司為一間本集團對其擁有重大影響力而並非屬附屬公司或共同安排的實體。重大影響力乃有權參與被投資方之財務及經營政策決定之權力,但並非控制或共同控制該等政策。

#### 3.5 Joint arrangements

The Group is a party to a joint arrangement where there is a contractual arrangement that confers joint control over the relevant activities of the arrangement to the group and at least one other party. Joint control is assessed under the same principles as control over subsidiaries.

The Group classifies its interests in joint arrangements as either:

- Joint ventures: where the Group has rights to only the net assets of the joint arrangement; or
- Joint operations: where the Group has both the rights to assets and obligations for the liabilities of the joint arrangement.

In assessing the classification of interests in joint arrangements, the Group considers:

- The structure of the joint arrangement;
- The legal form of joint arrangements structured through a separate vehicle;
- The contractual terms of the joint arrangement agreement; and
- Any other facts and circumstances (including any other contractual arrangements).

The Group accounts for its interests in joint ventures using the equity method whereby they are initially recognised at cost and thereafter, their carrying amount are adjusted for the Group's share of the post-acquisition change in the joint ventures' net assets except that losses in excess of the Group's interest in the joint ventures are not recognised unless there is an obligation to make good those losses.

Any premium paid for an investment in a joint venture above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the investment in joint venture. Where there is objective evidence that the investment in a joint venture has been impaired the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

The Group accounts for its interest in joint operations by recognising its share of assets, liabilities, revenues and expenses in accordance with its contractually conferred rights and obligations.

The Company's interests in joint ventures are stated at cost less impairment losses, if any. Results of joint ventures are accounted for by the Company on the basis of dividends received and receivable.

#### 3.6 Foreign currency translation

The consolidated financial statements are presented in RMB, which is also the functional currency of the Company.

In the individual financial statements of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined and are reported as part of the fair value gain or loss. Non-monetary items that are measured at historical cost in a foreign currency are not retranslated.

In the consolidated financial statements, all individual financial statements of foreign operations, originally presented in a currency different from the Group's presentation currency, have been converted into RMB. Assets and liabilities have been translated into RMB at the closing rates at the reporting date. Income and expenses have been converted into RMB at the exchange rates ruling at the transaction dates, or at the average rates over the reporting period provided that the exchange rates do not fluctuate significantly. Any differences arising from this procedure have been recognised in other comprehensive income and accumulated separately in the translation reserve in equity.

When a foreign operation is disposed of, such exchange differences are reclassified from equity to profit or loss as part of the gain or loss on disposal.

# 3.7 Revenue recognition (accounting policies applied from 1 April 2018)

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Depending on the terms of the contract and the laws that apply to the contract, control of the goods or service may be transferred over time or at a point in time. Control of the goods or service is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the customer;
- creates or enhances an asset that the customer controls as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If control of the goods or services transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the goods or service.

When the contract contains a financing component which provides the customer a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amounts receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method. For contracts where the period between the payment and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

For revenue from sale of properties and precompletion contracts for the sale of development properties in the ordinary course of business, customers obtain control of the properties when the properties are delivered to and have been accepted. Revenue is thus recognised when the customers accept the properties. There is no other goods or services agreed to be provided in the contract and in practice. There is generally only one performance obligation. Payments are usually received in advance and recognised as contract liabilities. HKFRS 15 did not result in significant impact on the Group's accounting policies.

Interest income is recognised on a timeproportion basis using the effective interest method.

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease terms.

Revenue comprises the fair value of the consideration received or receivable for the sale of properties, rendering of services and the use by others of the Group's assets yielding interest and dividends, net of rebates and discounts. Provided it is probable that the economic benefits will flow to the Group and the revenue and costs, if applicable, can be measured reliably, revenue is recognised as follows:

Revenue arising from sale of properties held for sale is recognised upon the transfer of the significant risks and rewards of ownership of these properties held for sale to the customers. Revenue is recognised upon the transfer of the legal title or the passing of possession to the buyer or a completion certificate by the relevant government authorities, whichever is the later. Deposits and instalments received from customers prior to the date of revenue recognition are included in current liabilities as receipts in advance.

Interest income is recognised on a timeproportion basis using the effective interest method.

Rental income receivable under operating leases is recognised in equal instalments over the periods covered by the lease terms.

#### 3.9 Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to the working condition and location for its intended use. Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other costs, such as repairs and maintenance are charged to the consolidated statement of comprehensive income during the period in which they are incurred.

Depreciation is provided to write off the cost of property, plant and equipment over their estimated useful lives, using the straight line method, at the following rates per annum:

Motor vehicles	20.0%
Buildings	2.5%
Leasehold improvement	25.0%

The assets' residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at each reporting date.

Fully depreciated property, plant and equipment are retained in the financial statements until they are no longer in use.

The gain or loss arising on retirement or disposal is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in the consolidated statement of comprehensive income.

#### 3.10 Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest to earn rental income and/or for capital appreciation. These include land held for a currently undetermined future use and property that is being constructed or developed for future use as investment property.

On initial recognition, investment properties are measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are stated at fair value, unless it is still in the course of construction or development at the reporting date and its fair value cannot be reliably determined at that time.

Fair value is determined by external professional valuers with sufficient experience with respect to both the location and the nature of the investment properties. The carrying amounts recognised in the consolidated statement of financial position reflect the prevailing market conditions at the reporting date.

Gain or loss arising from either a change in fair value or the sale of investment properties is included in the consolidated statement of comprehensive income for the year in which it arises.

For a transfer from properties held under development and properties held for sale to investment properties that is carried at fair value, any difference between fair value of the property at that date and its previous carrying amount is recognised in the consolidated statement of comprehensive income.

#### 3.10 投資物業

投資物業是指為賺取租金收入及/或為資本增值而以租賃權益擁有或持有之土地及/或樓宇,包括就尚未確定未來用途持有之土地及正興建或發展中以於將來作投資物業之用之物業。

投資物業於初步確認時按成本(包括任何應計之直接開支)計量。初步確認後,除非投資物業在報告日期仍然在興建或開發過程中,而當時其公允值不能可靠地確定,否則投資物業按公允值列賬。

Properties under construction or development for future use as an investment property are classified as investment property under construction. If the fair value cannot be reliably determined, the investment property under construction will be measured at cost until such time as fair value can be determined or construction is completed.

When the Group completes the construction or development of a self-constructed investment property, any difference between the fair value of the property at the completion date and its previous carrying amount is recognised in the consolidated statement of comprehensive income.

#### 3.11 Impairment of non-financial assets

At the end of each reporting period, the Group reviews the carrying amounts of property, plant and equipment and investments in subsidiaries, associates and a joint venture to determine whether there is any indication that those assets have suffered an impairment loss or an impairment loss previously recognised no longer exists or may have decreased.

If the recoverable amount (i.e. the greater of the fair value less costs of disposal and value in use) of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised as income immediately.

Value in use is based on the estimated future cash flows expected to be derived from the asset or cash generating unit, discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or cash generating unit.

#### 3.12 Leases

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to use a specific asset or assets for an agreed period of time in return for a payment or a series of payments. Such a determination is made based on an evaluation of the substance of the arrangement and is regardless of whether the arrangement takes the legal form of a lease.

Leases where substantially all the risks and rewards of ownership of assets remain within the lessor are accounted for as operating lease. Where the Group has the use of assets held under operating leases, payments made under the leases are charged to the consolidated statement of comprehensive income on a straight line basis over the lease terms except where an alternative basis is more representative of the pattern of benefits to be derived from the leased assets. Lease incentives received are recognised in the consolidated statement of comprehensive income as an integral part of the aggregate net lease payments made. Contingent rental are charged to the consolidated statement of comprehensive income in the accounting period in which they are incurred.

Leasehold interests in land are up-front payments to acquire the land use right. The payments are stated at cost less accumulated amortisation and any impairment losses. Amortisation is calculated on the straight-line basis over the lease term.

For leasehold interest in land included in properties held under development and properties held for sale, the amortisation of prepaid land lease is capitalised as part of the building costs during the development period but charged to the consolidated statement of comprehensive income for completed properties. Other amortisation of prepaid land lease is expensed.

Certain properties leased out under operating leases are included in the consolidated statement of financial position as investment properties. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised on a straight-line-basis over the lease term. The recognition of rental income is set out in notes 3.7 and 3.8.

When any part of account and other receivables is determined as uncollectible, it is written off against the allowance account.

The amount of the reversal is recognised in profit or loss of the period in which the reversal occurs.

#### Available-for-sale financial assets

These assets are non-derivative financial assets that are designated as available-for-sale or are not included in other categories of financial assets. Subsequent to initial recognition, these assets are carried at fair value with changes in fair value recognised in other comprehensive income, except for impairment losses and foreign exchange gains and losses on monetary instruments, which are recognised in profit or loss.

For available-for-sale equity investments that do not have a quoted market price in an active market and whose fair value cannot be reliably measured and derivatives that are linked to and must be settled by delivery of such unquoted equity instruments, they are measured at cost less any identified impairment losses.

Where a decline in the fair value constitutes objective evidence of impairment, the amount of the loss is removed from equity and recognised in profit or loss.

The Group's financial liabilities include accounts and other payables and bank loans.

#### Bank loans

Bank loans are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting date.

Ordinary shares are classified as equity. Share capital is determined using the nominal value of shares that have been issued.

Share premium includes any premiums received on the issuance of shares over the par value. Any transaction costs associated with the issuance of shares are deducted from share premium (net of any related income tax benefit) to the extent they are incremental costs directly attributable to the equity transaction.

#### (iv) Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer (or guarantor) to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Where the Group issues a financial guarantee, the fair value of the guarantee is initially recognised as deferred income within accounts and other payables. Where consideration is received or receivable for the issuance of the guarantee, the consideration is recognised in accordance with the Group's policies applicable to that category of asset. Where no such consideration is received or receivable, an immediate expense is recognised in profit or loss on initial recognition of any deferred income.

Properties held under development are stated at the lower of cost and net realisable value. Other expenses included (a) those costs that are incurred in bringing the properties held under development to their present location and condition; and (b) a systematic allocation of fixed overheads that are incurred on development of properties. Fixed overheads are indirect costs which remain relatively constant regardless of the size or volume of the development.

Properties held under development are classified as current assets unless the construction period of the relevant property development project is expected to complete beyond normal operating cycle.

#### 3.16 Properties held for sale

In case of completed properties developed by the Group, cost is determined by apportionment of the total development costs for that development project, attributable to the unsold properties. The cost of completed properties held for sale comprises all costs of purchase, cost of conversion and other costs incurred in bringing the inventories to their present location and condition.

Properties held for sale are stated at the lower of cost and net realisable value. Net realisable value is the estimated selling price in the ordinary course of business less estimated selling expenses.

Income tax for the year comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the reporting date between the carrying amounts of assets and liabilities in the financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the reporting date.

An exception to the general requirement on determining the appropriate tax rate used in measuring deferred tax amount is when an investment property is carried at fair value under HKAS 40 "Investment Property". Unless the presumption is rebutted, the deferred tax amounts on these investment properties are measured using the tax rates that would apply on sale of these investment properties at their carrying amounts at the reporting date. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all the economic benefits embodied in the property over time, rather than through sale.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly to equity.

### 3.18 Cash and cash equivalents

Cash and cash equivalents include cash at bank and in hand, demand deposits with banks and short term highly liquid investments with original maturities of three months or less that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, less pledged deposits.

## 3.19 Retirement benefit costs and short-term employee benefits

#### Retirement benefit costs

The Group operates a defined contribution scheme ("MPF Scheme") under the Mandatory Provident Fund Scheme Ordinance which is available to its employees in Hong Kong. Contributions to the MPF Scheme by the Group and employees are made based on a percentage of employees' basic salaries and are charged to the consolidated statement of comprehensive income as they become payable in accordance with the rules of the MPF Scheme.

Pursuant to the relevant regulations in the People's Republic of China (the "PRC"), the Group has participated in a local municipal government retirement benefit scheme (the "Scheme"), whereby the Group is required to contribute a certain percentage of basic salaries of its employees to the Scheme to fund their retirement benefits. The local municipal government undertakes to assume the retirement benefits obligations of all existing and future retired employees in the PRC. The only obligation of the Group with respect to the Scheme is to pay the ongoing required contributions under the Scheme mentioned above. The Group's contributions to the Scheme are expensed as incurred.

#### Short-term employee benefits

Short term employee benefits are employee benefits (other than termination benefits) that are expected to be settled wholly before twelve months after the end of the annual reporting period in which the employees render the related service. Short term employee benefits are recognised in the year when the employees render the related service.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

#### 3.20 Provisions and contingent liabilities

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Contingent liabilities are recognised in the course of the allocation of purchase price to the assets and liabilities acquired in a business combination. They are initially measured at fair value at the date of acquisition and subsequently measured at the higher of the amount that would be recognised in a comparable provision as described above and the amount initially recognised less any accumulated amortisation, if appropriate.

## 3.21 Borrowing costs

Borrowing costs incurred for the acquisition, construction or production of any qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use. A qualifying asset is an asset which necessarily takes a substantial period of time to get ready for its intended use or sale. Other finance costs are expensed.

Borrowing costs are capitalised as part of the cost of a qualifying asset when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are being undertaken. Capitalisation of borrowing costs ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are completed.

#### 3.23 Government Grants

Government grants are recognised when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Grants that compensate the Group for expenses incurred are recognised as revenue in profit or loss on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the Group for the cost of an asset are deducted from the carrying amount of the asset and consequently are effectively recognised in profit or loss over the useful life of the asset by way of reduced depreciation expense.

## 3.24 Intangible assets (Other than goodwill)

(i) Intangible assets acquired separately are initially recognised at cost. The cost of intangible assets acquired in a business combination is fair value at the date of acquisition. Subsequently, intangible assets with finite useful lives are carried at cost less accumulated amortisation and accumulated impairment losses.

Amortisation is provided on a straight-line basis over their useful lives as follows. Intangible assets with indefinite useful lives are carried at cost less any accumulated impairment losses. The amortisation expense is recognised in profit or loss and included in administrative expenses.

Properties held for sale upon transfer to investment properties of the Group were stated at fair value in accordance with the accounting policy. The fair value of the investment properties is determined by a firm of independently qualified professional surveyors and the fair value of investment properties as at the reporting dates and properties held for sale upon transfer to investment properties are set out in notes 14 and 22 respectively. Such valuation was based on certain assumptions, which are subject to uncertainty and might materially differ from the actual results.

## Impairment of accounts and other receivables

The Group's management assesses the collectability of accounts and other receivables by determining future cash flows. This estimate is based on assumptions about risk of default and expected loss rates. A considerable amount of judgment is required in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward-looking estimates. Management will reassess the provision at the reporting date. Where the expectation is different from the original estimate, such differences will affect the carrying value of receivables and thus the impairment loss in the period in which such estimate is changed.

## Net realisable value of properties held for sale and properties held under development

Management determines the net realisable value of properties held for sale and properties held under development by using prevailing market data such as most recent sale transactions and valuation of the projects in its existing partially completed state of construction taking into account cost of work done, and cost to completion from gross development value assuming satisfactory completion.

These estimates require judgement as to the anticipated sale prices by reference to recent sales transactions in nearby locations, rate of new property sales, marketing costs (including price discounts required to stimulate sales) and the expected costs of completion of properties, the legal and regulatory framework and general market conditions. The carrying amounts of the Group's properties held under development and properties held for sale as at 31 March 2019 were approximately RMB2,183,059,000 (2018: RMB1,664,440,000) and RMB248,582,000 (2018: RMB243,761,000) respectively.

### Revenue recognition

Revenue from sales of properties is revenue is recognised at a point in time when the buyer obtains control of the completed property; otherwise, revenue is recognised over time when the Group's performance do not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Due to the contractual restrictions with the customer, the Group shall not change or substitute the property unit or redirect the property unit for another use and thus the property unit does not have an alternative use to the Group. However, it requires management to exercise significant judgement to determine whether there is an enforceable right to payment for performance completed to date, which depends on the terms of sales and purchase agreement and the interpretation of the applicable laws that apply to the contract. The Group has obtained legal counsel opinion regarding the enforceability of the right to payment for sales and purchase agreements. Management uses judgments, based on legal counsel opinion, to classify sales and purchase agreements into those with right to payment for performance completed to date and those without the right.

The Group believes that its recognition basis of sales as set out in note 3.7 is appropriate and is the current practice in the PRC.

The Group is subject to taxation in various jurisdictions. Significant judgement is required in determining the amount of the provision of taxation and the timing of payment of the related taxation. Where the final tax outcome is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in periods in which such determination are made.

The Group is subject to Land Appreciation Tax ("LAT") in the PRC. However, the implementation and settlement of this tax varies among various tax jurisdictions in cities of the PRC, and the Group has not finalised its LAT calculation and payments with any local tax authorities in the PRC. Accordingly, significant judgement is required in determining the amount of the land appreciation and its related LAT. The Group recognised LAT based on management's best estimates according to the understanding of the tax rules.

In the opinion of the directors of the Company, the majority of the Group's operation and centre of management are sourced from its subsidiaries in Jiangxi Province, the PRC, which considered that the operation base of the Group is domiciled in the PRC, as one geographical location and therefore, no analysis of geographical information is presented.

The total revenue from external customers is mainly sourced from the PRC. The total revenue is disclosed in note 6.

There is no single customer that contributed to 10% or more of the Group's revenue for the year ended 31 March 2019 and 2018.

The investment properties included property interest in land located in the PRC with lease terms expiring from 2043 to 2047 (2018: from 2043 to 2047). As at 31 March 2019 and 2018, the building ownership certificates of certain investment properties of the Group have not yet been obtained. In the opinion of the independent PRC legal advisors of the Group, the Group is entitled to obtain the building ownership certificates without legal impediment and is entitled to lawfully and validly use the investment properties during the year.

At 31 March 2019, investment properties of approximately RMB489,319,000 (2018: RMB507,626,000) were pledged against bank loans of the Group (note 27). As at 31 March 2018, building ownership certificates of the Group's investment properties of approximately RMB34,074,000 were placed with the bank as custody (note 27).

Investment properties are leased to non-related parties under operating lease (note 32).

During the year ended 31 March 2019, properties held for sale and with the carrying value of approximately RMB2,782,000 (2018: RMB1,903,000) (note 22) were transferred to investment properties respectively as these properties were under operating lease arrangements with third parties during the year to earn rental, rather than for sale in the ordinary course of business of the Group. The fair value of these properties upon transfer to investment properties was approximately RMB5,523,000 (2018: RMB5,129,000). The total net fair value gain of investment properties approximately of RMB17,861,000 (2018: RMB14,327,000) was credited to profit or loss for the year.

During the year ended 31 March 2019, the Group entered into sale and purchase agreement to sell certain investment properly at a consideration of approximately RMB26,248,000. The investment property has been handed over to the customer during the year.

On 30 March 2018, the Group and Jiangxi HongKeLong entered into a designated operating agreement (the "Agreement"), pursuant to which subject to the fulfilment of certain conditions, Jiangxi HongKeLong Industrial Limited (江西洪客 隆實業有限公司) ("Jiangxi HongKeLong"), which held the remaining 50% equity interests in Jiangxi Ganghong, designate all the rights and responsibility of the management, operation and financing of the Yichun Elderly Apartment undeveloped project (the "Undeveloped Project") to the Group and all the future costs and revenues in relation to the Undeveloped Project will belong to the Group with a compensation of RMB244,000,000 payable by the Group to Jiangxi HongKeLong. As at 31 March 2018, deposit of RMB122,000,000 was paid to Jiangxi HongKelong and the ownership of all assets and liabilities of the Undeveloped Project were remained held by Jiangxi Ganghong as certain conditions under the Agreement had not been fulfilled.

During the year ended 31 March 2019, remaining RMB122,000,000 were paid by the Group to Jiangxi HongKelong and all conditions under the Agreement had been fulfilled. The Agreement became effective and all assets and liabilities of the Undeveloped Project are beneficially owned by the Group.

The contractual arrangement on the Undeveloped Project is determined by the directors of the Company to be acquisition of assets rather than as business combination because the assets acquired did not constitute a business as defined under HKFRS 3 (revised) "Business Combination". The acquisition accounted as purchase of properties held under development and Jiangxi Ganghong ceased to be a joint venture of the Group after the completion date.

# 35. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's activities expose the Group to a variety of financial risks which comprise market risk (including foreign currency risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance. The Group currently does not have any written risk management policies and guidelines. However, the board of directors meets periodically and cooperates closely with key management to analyse and formulate strategies to manage and monitor financial risks.

The Group is not engaged in trading of financial assets for speculative purposes. The most significant financial risks to which the Group is exposed to be described below.

#### (a) Interest rate risk

Interest rate risk relates to the risk that the fair value or cash flows of a financial instrument will fluctuate because of changes in market interest rate. The Group's income and operating cash flows are substantially independent of changes in market interest rates. The Group's interest rate risk mainly arises from deposits at banks, bank and other loans which bore interests at fixed and floating interest rates. Bank and other loans arranged at variable rates and fixed rates expose the Group to cash flow interest rate risk and fair value interest rate risk respectively. The interest rate and repayment terms of the borrowings outstanding at the end of the reporting period are disclosed in note 27.

#### Interest rate sensitivity

If the interest rates had been increased/decreased by 100 basis points at the beginning of the year and all other variables were held constant, the Group's profit after tax for the year and retained profits would increase/decrease by approximately RMB2,174,000 (2018: RMB2,017,000) respectively.

The assumed changes in interest rates are considered to be reasonably possible based on observation of current market conditions and represents management's assessment of a reasonably possible change in interest rate over the next twelve-month period.

The sensitivity analysis included in the financial statements for the year ended 31 March 2018 has been prepared on the same basis.

#### (b) Credit risk

Credit risk refers to the risk that the counterparty to a financial instrument would fail to discharge its obligation under the terms of the financial instrument and cause a financial loss to the Group. The Group's exposure to credit risk mainly arises from granting credit to customers in the ordinary course of its operations. The Group is also exposed to credit risk arising from the provision of financial guarantees and the amounts of which are disclosed in note 33.

In respect of accounts and other receivables, individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Normally, the Group does not obtain collateral from customers.

None of the Group's financial assets are secured by collateral or other credit enhancements.

The Group measures loss allowances for other receivables, bank balances and pledged deposits at an amount equal to lifetime 12 months ECLs. The credit risk on other receivables is limited because the counterparties have no historical default record and the directors expect that the general economic conditions will not significantly change for the 12 months after the reporting date. Applying the ECL model results in loss allowances of RMB3,697,000 on 1 April 2018. The Group's cash and bank balances, pledged deposits and structured bank balances are mainly balances with state-owned banks in the PRC and a reputable bank in Hong Kong. As at 31 March 2019, the Group had approximately 82% bank balances placed with two banks in the PRC.

In respect of accounts and other receivables, the Group is not exposed to any significant credit risk exposure to any single counterparty or any group of counterparties having similar characteristics.

The Company's credit risk is primarily attributable to amounts due from subsidiaries. The credit risk on these financial assets of the Company is limited because the counterparties have no historical default record and the directors expect that the general economic conditions will not significantly change for the 12 months after the reporting date.

### (c) Foreign currency risk

Most of the Group's transactions are carried out in RMB which is the functional currency of most of the group entities. Exposures to currency exchange rates arise from certain of the Group's cash and bank balances, financial assets at fair value through profit or loss, other receivables, other payables and bank loans which are denominated in HK\$, and US\$. The Group does not use derivative financial instruments to hedge its foreign currency risk. ### (d) Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities that are settled by delivering cash or another financial asset. The Group is exposed to liquidity risk in respect of settlement of financial liabilities, including accounts and other payables and bank and other loans, and its financial obligations, and also in respect of its cash flow management.

The cash management of all operating entities is centralised, including the raising of funds to cover expected cash demands. The Group's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer terms.

The table below analyses the Group's financial liabilities based on the remaining contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows.

Specifically, for term loans which contain a repayment on demand clause which can be exercised at the bank's sole discretion, the analysis shows the cash outflow based on the earliest period in which the entity can be required to pay, that is if the lenders were to invoke their unconditional rights to call the loans with immediate effect. The maturity analysis for other bank borrowings is prepared based on the scheduled repayment dates.

The Group manages liquidity risk by maintaining adequate reserves, banking facilities and reserve banking facilities, and by continuously monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and liabilities.
