DECREASE IN LOSS

This announcement is made by Imagi International Holdings Limited (the “Company”, together with its subsidiaries collectively referred to as the “Group”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “Board”) wishes to inform the shareholders of the Company (the “Shareholders”) and potential investors of the Company that based on the preliminary review on the unaudited consolidated management accounts of the Company for the period ended 30 June 2019 (the “Period”) and information currently available to the Board, the Group expects to record a decrease (i.e. less negative) in net loss after tax by approximate 30% as compared to the net loss after tax for the period ended 30 June 2018 (the “Previous Period”). Such decrease in loss is mainly attributable to (i) reduction in net realised and unrealised loss from listed equity from in aggregate of approximately HK\$49 million to approximately HK\$29 million as compared to the Previous Period; (ii) dividend income of approximately HK\$15 million received in the Period; (iii) ceased sharing of profit from joint venture in the Period; and (iv) non-recurring gain from disposal of joint venture of approximately HK\$7 million recorded in the Previous Period. The expected discernible loss has not included any potential provisions/impairment which has to be made subject to the review of the Board and the audit committee of the Company together with the discussion with the independent auditor of the Company.

The Company is still in the process of finalising the interim results of the Group for the Period. The information contained in this announcement is only based on a preliminary review and assessment by the management of the Company with reference to the unaudited consolidated management accounts for the Period and the information currently available, as such the actual results of the Group may be subject to adjustment(s). Shareholders and potential investors of the Company are advised to read carefully the interim results announcement for the Period of the Company which is expected to be published in August 2019 and the subsequent publication of the 2019 interim report of the Company.
