ANNOUNCEMENT

Reference is made to the announcement of Inner Mongolia Energy Engineering Co., Ltd. (the “**Company**”) dated 18 June 2019 (the “**Announcement**”). Unless the contexts otherwise require, capitalized terms used herein shall have the same meanings as defined in the Announcement.

According to the Announcement, the Company expected that PricewaterhouseCoopers Management Consulting (Shanghai) Limited (“**PricewaterhouseCoopers**”) would issue a forensic review report on or before 19 July 2019. Based on the latest situation, since the investigation conducted by PricewaterhouseCoopers has yet to be completed, and some information still require further collection and consolidation, the report could not be issued on 19 July 2019 as scheduled. Based on the current progress, PricewaterhouseCoopers expects to complete the review and issue a forensic review report on or before 20 September 2019.

CONTINUED SUSPENSION OF TRADING

Trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on 18 March 2019 and will remain suspended until further notice, pending the publication of the 2018 annual results of the Company subject to the forensic review results and subsequent necessary further actions.

Potential investors and shareholders of the Company should exercise caution when dealing in the shares of the Company.
