Profit Warning

The board of directors (the “Board”) of Ko Yo Chemical (Group) Limited (the “Company”, together with its subsidiaries, the “Group”) makes this announcement pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The Board wishes to inform shareholders and potential investors of the Company that, although the administrative expenses was decreased for the six months ended 30 June 2019 as compared to that of the same period last year, due to the increase of price the raw material of natural gas, and the market prices of urea, methanol and ammonia were decreased as compared with last year, especially there are large drop in price for products of methanol and ammonia, which in turn leads to the operating gross profit of the Group was greatly decreased and the provision made from the valuation loss of convertible bonds (the “Convertible Bonds”) issued as stated in the announcements dated 31 January 2019 and 15 March 2019, the Board expects that the Group will record a loss in the first half of the financial year of 2019.

With the completion of the issue of Convertible Bonds, the Board is in confident to improve the Group’s overall financial position.

As the Company is in the processing of finalizing its interim results report for the six months ended 30 June 2019 (the “Interim Results Report”), the information in this announcement is based on a preliminary assessment by the Company’s management according to the management accounts of the Group. The details financial information of the Group shall be disclosed in the

Interim Results Report.
