PROFIT WARNING

The Board wishes to inform the shareholders and potential investors of the Company that based on the preliminary review and analysis of the unaudited consolidated management accounts of the Group currently available, the Group is expected to record a loss for 1H 2019 in a range from approximately HK\$5 million to approximately HK\$20 million, as compared to a loss of approximately HK\$22.9 million for 1H 2018.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Neway Group Holdings Limited (“**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (“**Board**”) of directors (“**Directors**”) of the Company wishes to inform the shareholders and potential investors of the Company that based on the preliminary review and analysis of the unaudited consolidated management accounts of the Group currently available, the Group is expected to record a loss for the six months ended 30 June 2019 (“**1H 2019**”) in a range from approximately HK\$5 million to approximately HK\$20 million, as compared to a loss of approximately HK\$22.9 million for the six months ended 30 June 2018 (“**1H 2018**”). The Board considers that such decrease in loss was primarily attributable to the fair value gain of approximately HK\$2 million on held-for-trading investments recorded during 1H 2019 as compared to the fair value loss of 1H 2018 (1H 2018: fair value loss of approximately HK\$22.4 million) and was partially offset by the decrease in fair value gain of investment properties to approximately HK\$330,000 recorded during 1H 2019 as compared to the fair value gain of approximately HK\$10.7 million recorded during 1H 2018.

The Company is still in the process of finalising the consolidated results of the Group for 1H 2019, especially the amount of the impairment loss (if any) on certain trade receivables and the fair value of the Group’s other financial assets. The information contained in this announcement is only a preliminary assessment by the management of the Company based on the unaudited consolidated management accounts of the Group currently available and have not been audited or reviewed by the auditors of the Company. The finalised unaudited consolidated results of the Group for 1H 2019 are expected to be published on 19 August 2019.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
