The reorganisation proposal to change the holding company of the Group from Joyce Boutique Holdings Limited (domiciled in Bermuda) ("JBHL") to Joyce Boutique Group Limited (domiciled in Hong Kong) ("Newco") by way of a scheme of arrangement became effective on 26 August 2019.

Listing of JBHL shares on the Main Board was withdrawn at 9:00 a.m. on Tuesday, 27 August 2019 and dealings in the Newco Shares on the Main Board commenced at 9:00 a.m. on Tuesday, 27 August 2019.
