This announcement is made by Hang Sang (Siu Po) International Holding Company Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders (the “**Shareholders**”) of the Company and potential investors that based on the information currently available to the Board and the preliminary review of the Group’s unaudited consolidated management accounts for the year ended 30 June 2019 (“**FY 2019**”) and as compared with the audited consolidated financial statements for the year ended 30 June 2018 (“**FY 2018**”), the Group’s profit and total comprehensive income for FY 2019 expected to decrease by approximately 87%, as compared with that for FY 2018.

Based on the relevant information currently available to the Board, the expected decrease in the Group’s profit and total comprehensive income for FY 2019 was mainly attributable to the decrease in revenue and gross profit of the Group as customers place orders more cautiously due to uncertainties of global economics.

The information contained in this announcement is based on a preliminary assessment by the Board after considering the information currently available and is not based on any financial data or information that has been reviewed by the auditors or the audit committee of the Company. Shareholders and potential investors are advised to read carefully the interim results announcement of the Company for the year ended 30 June 2019, which is expected to be released by the end of September 2019 and may differ from the information disclosed in this announcement.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
